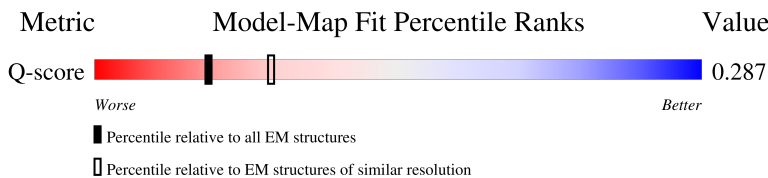
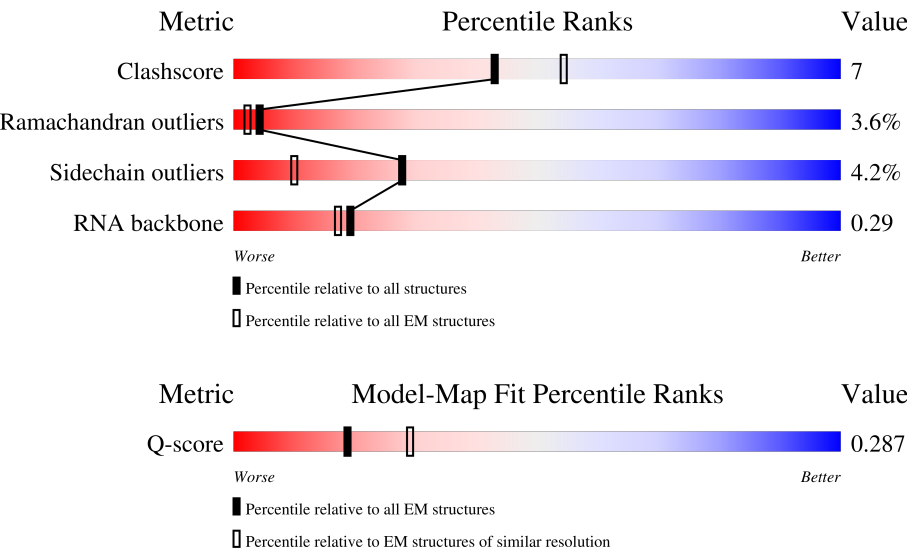

# 1 Overall quality at a glance i

The table below summarises the geometric issues observed across the polymeric chains and their fit to the map. The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$ . The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion  $< 40\%$ ). The numeric value is given above the bar.

## 2 Entry composition

There are 11 unique types of molecules in this entry. The entry contains 46807 atoms, of which 0 are hydrogens and 0 are deuteriums.

In the tables below, the AltConf column contains the number of residues with at least one atom in alternate conformation and the Trace column contains the number of residues modelled with at most 2 atoms.

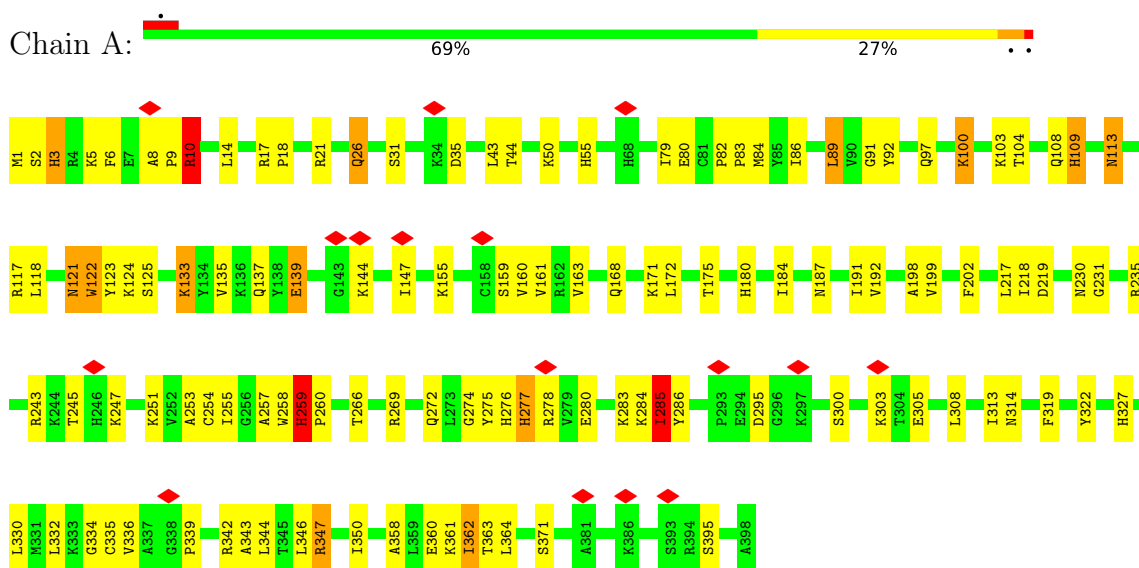

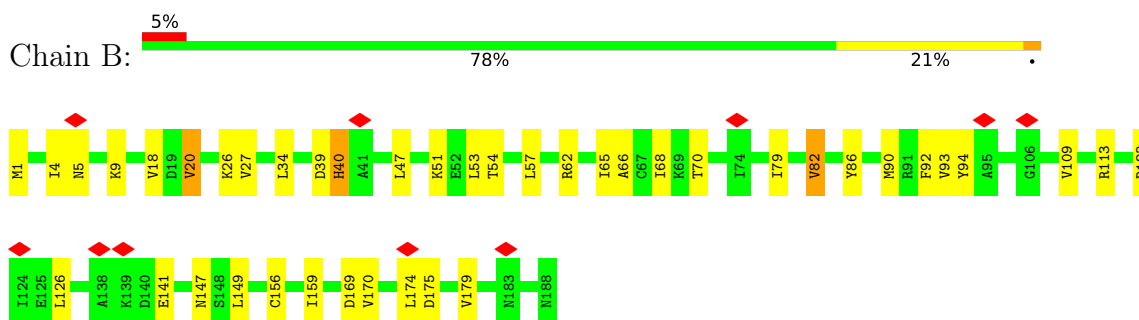
### 3 Residue-property plots

These plots are drawn for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic for a chain summarises the proportions of the various outlier classes displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry and atom inclusion in map density. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. A red diamond above a residue indicates a poor fit to the EM map for this residue (all-atom inclusion < 40%). Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.

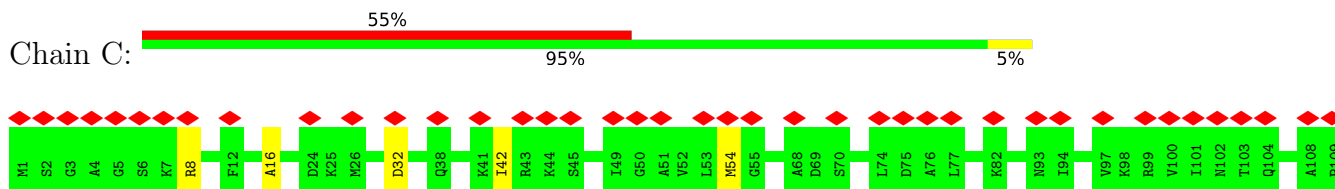
#### • Molecule 1: 60S RIBOSOMAL PROTEIN L3

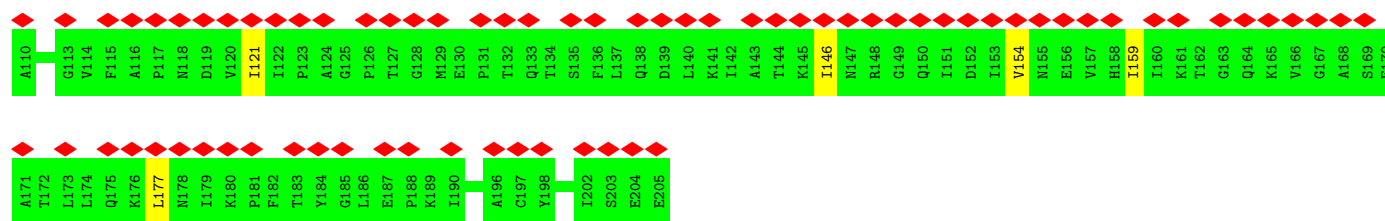


#### • Molecule 2: 60S RIBOSOMAL PROTEIN L9

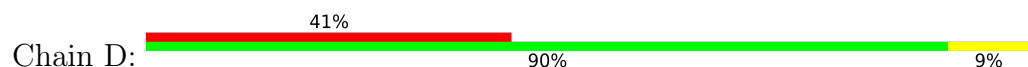

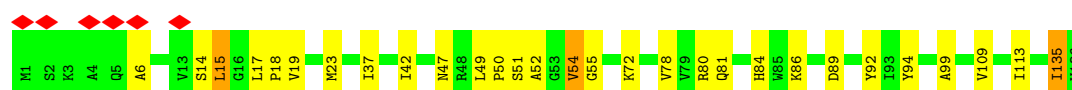
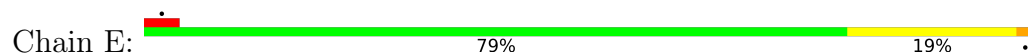




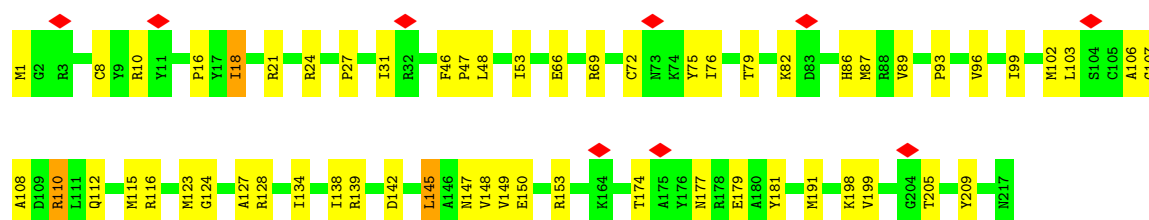
• Molecule 4: 60S RIBOSOMAL PROTEIN L12



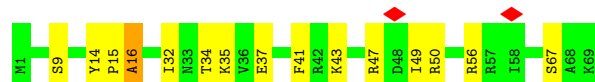
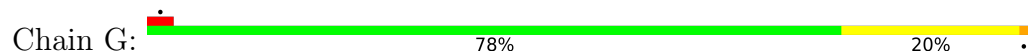

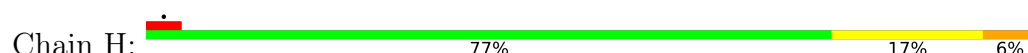
• Molecule 6: 60S RIBOSOMAL PROTEIN L10

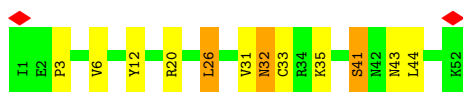


• Molecule 7: 60S RIBOSOMAL PROTEIN L24

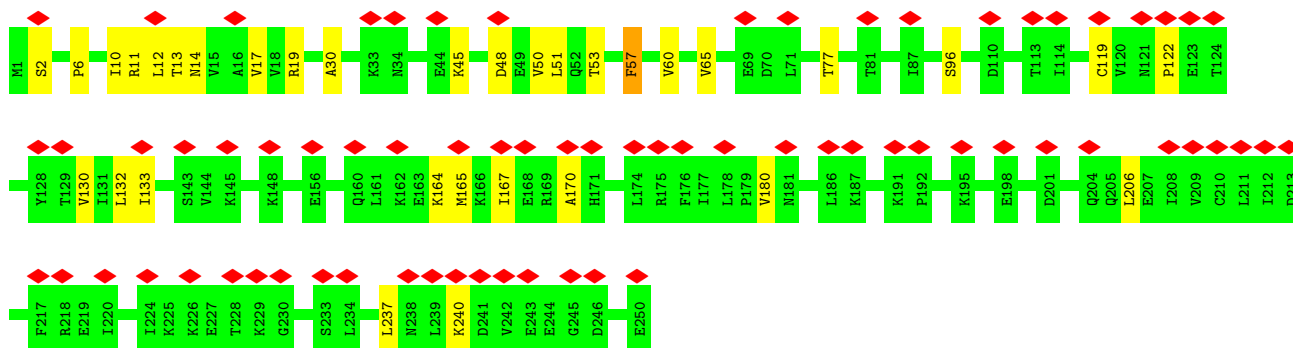
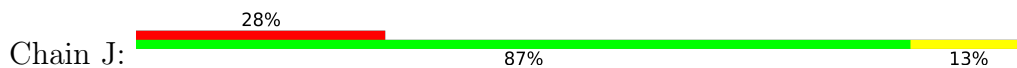


• Molecule 8: UBIQUITIN-60S RIBOSOMAL PROTEIN L40

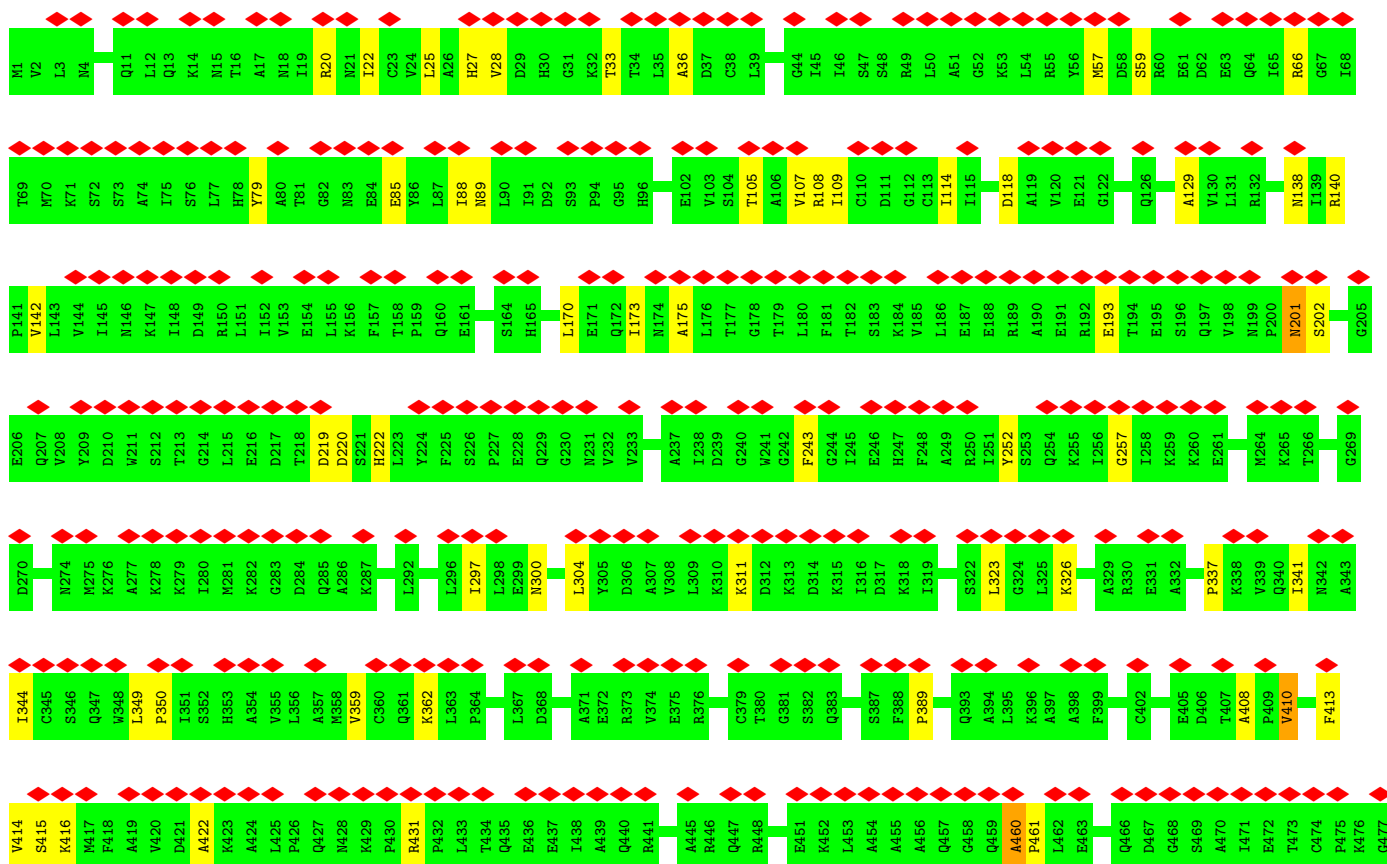
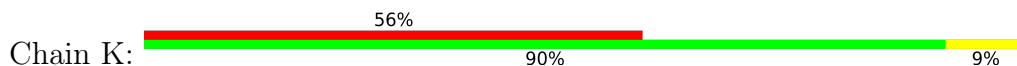




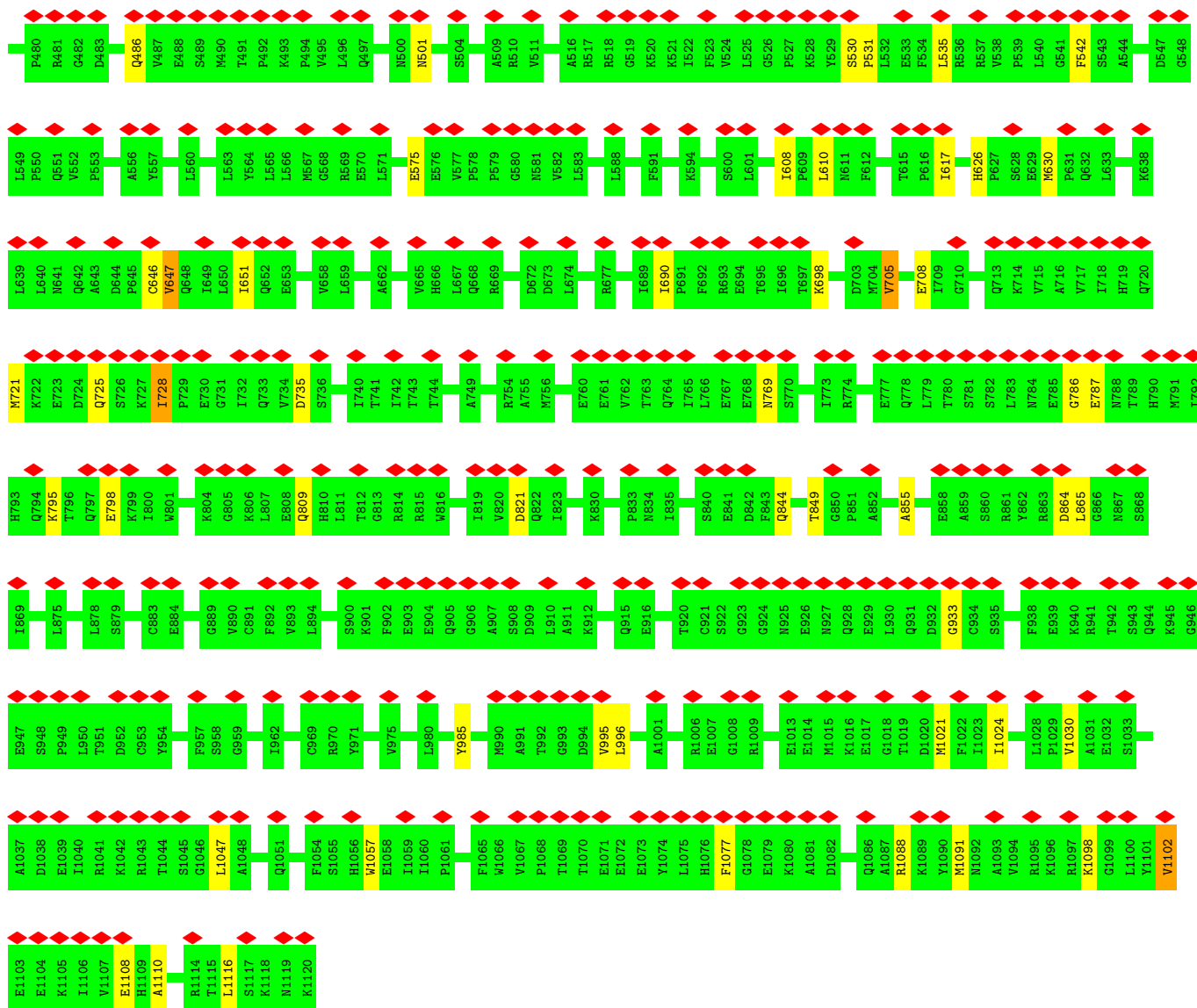
• Molecule 9: RIBOSOME MATURATION PROTEIN SBDS

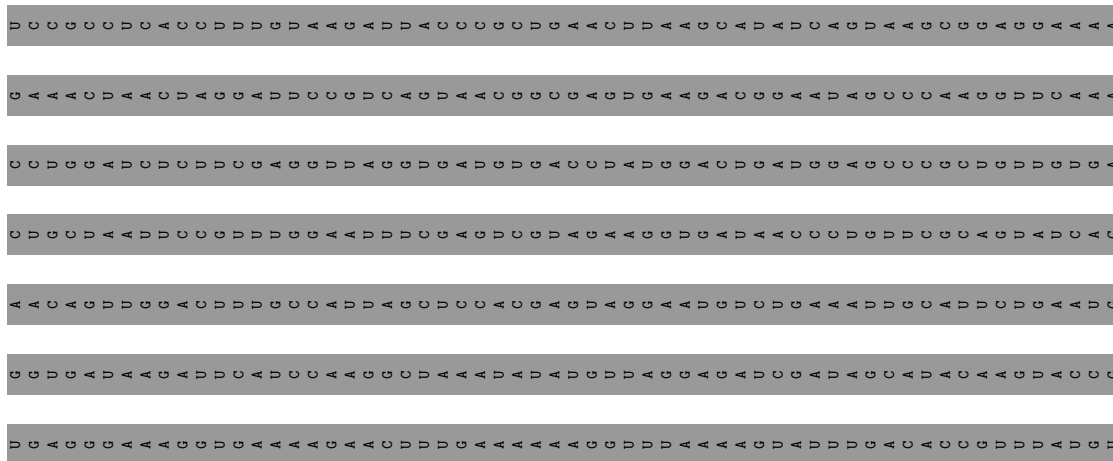






• Molecule 11: 26S RIBOSOMAL RNA

## 5 Model quality

### 5.1 Standard geometry

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with  $|Z| > 5$  is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

## 5.2 Too-close contacts [i](#)

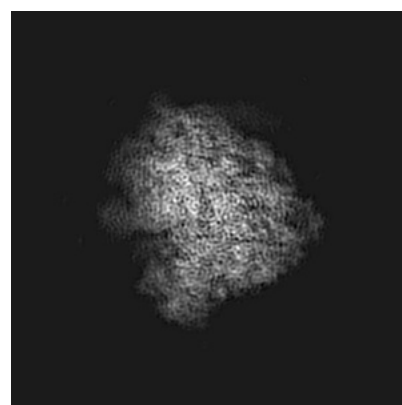

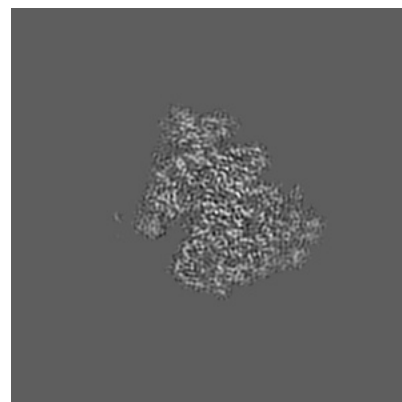

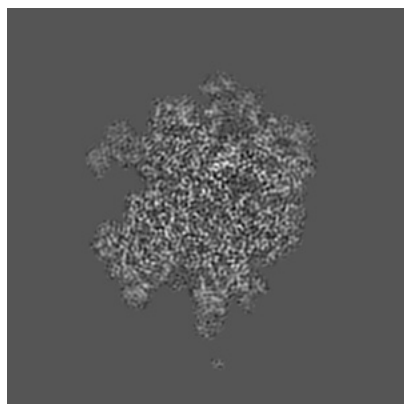

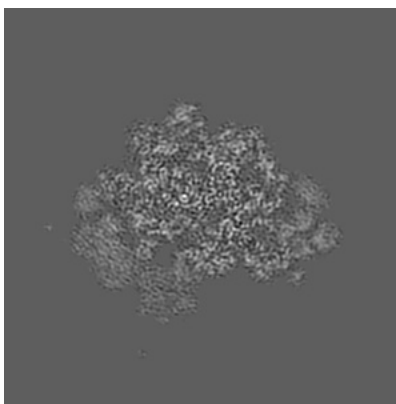

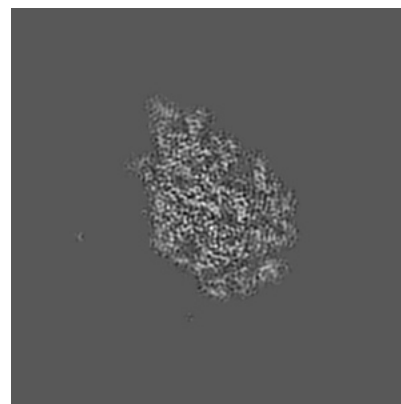

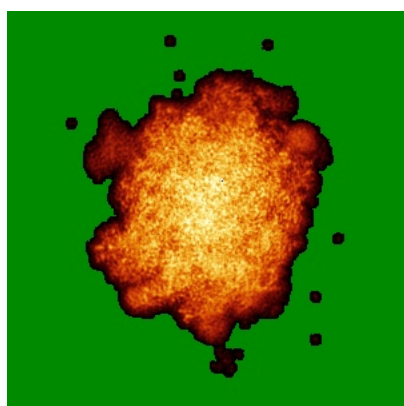

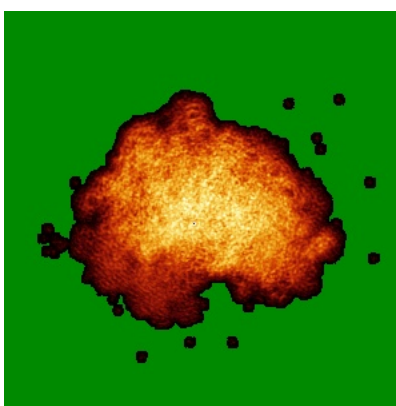

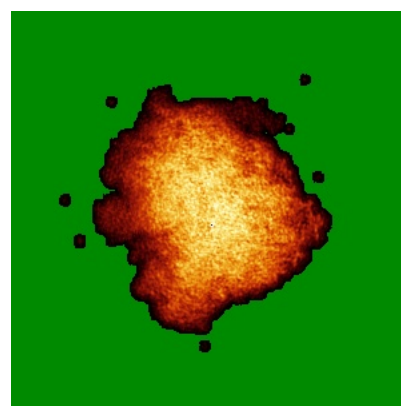

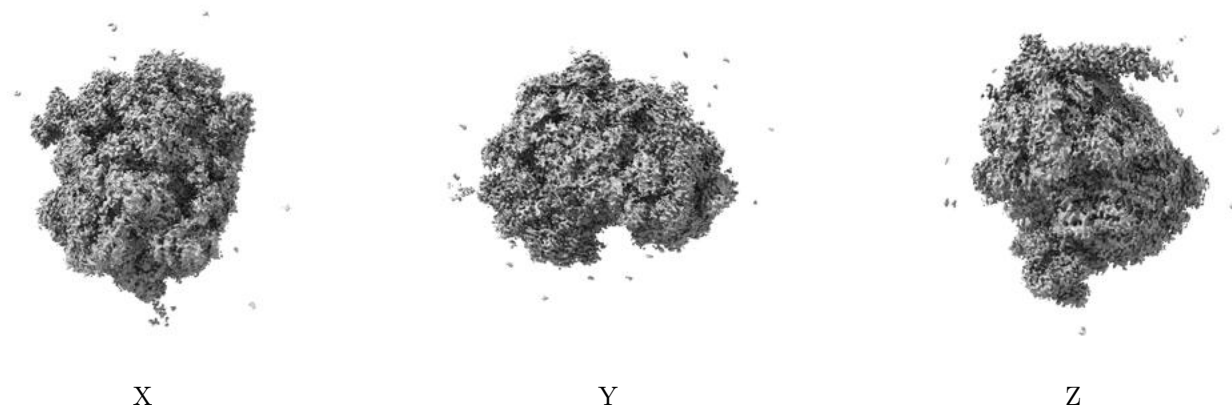

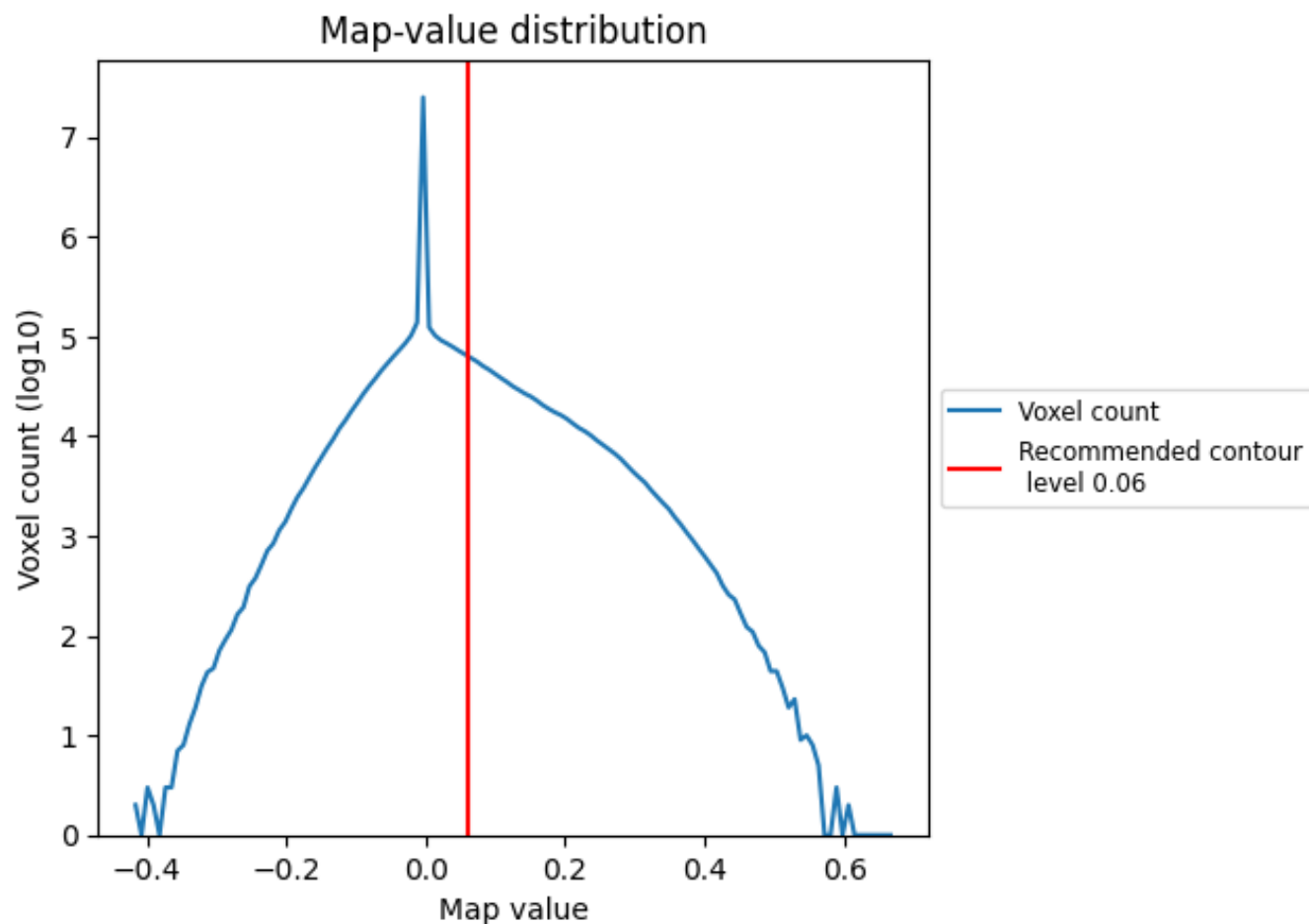

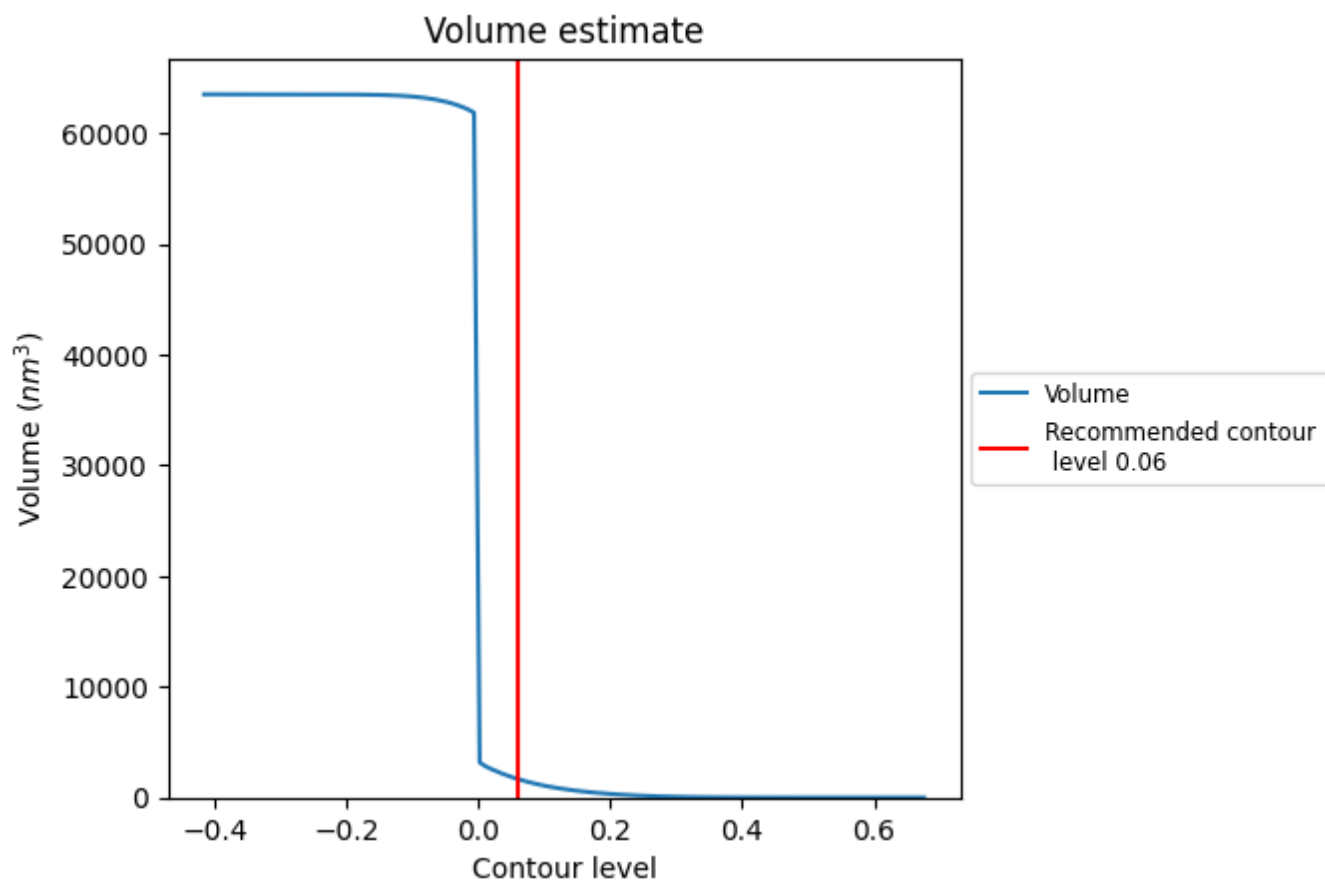

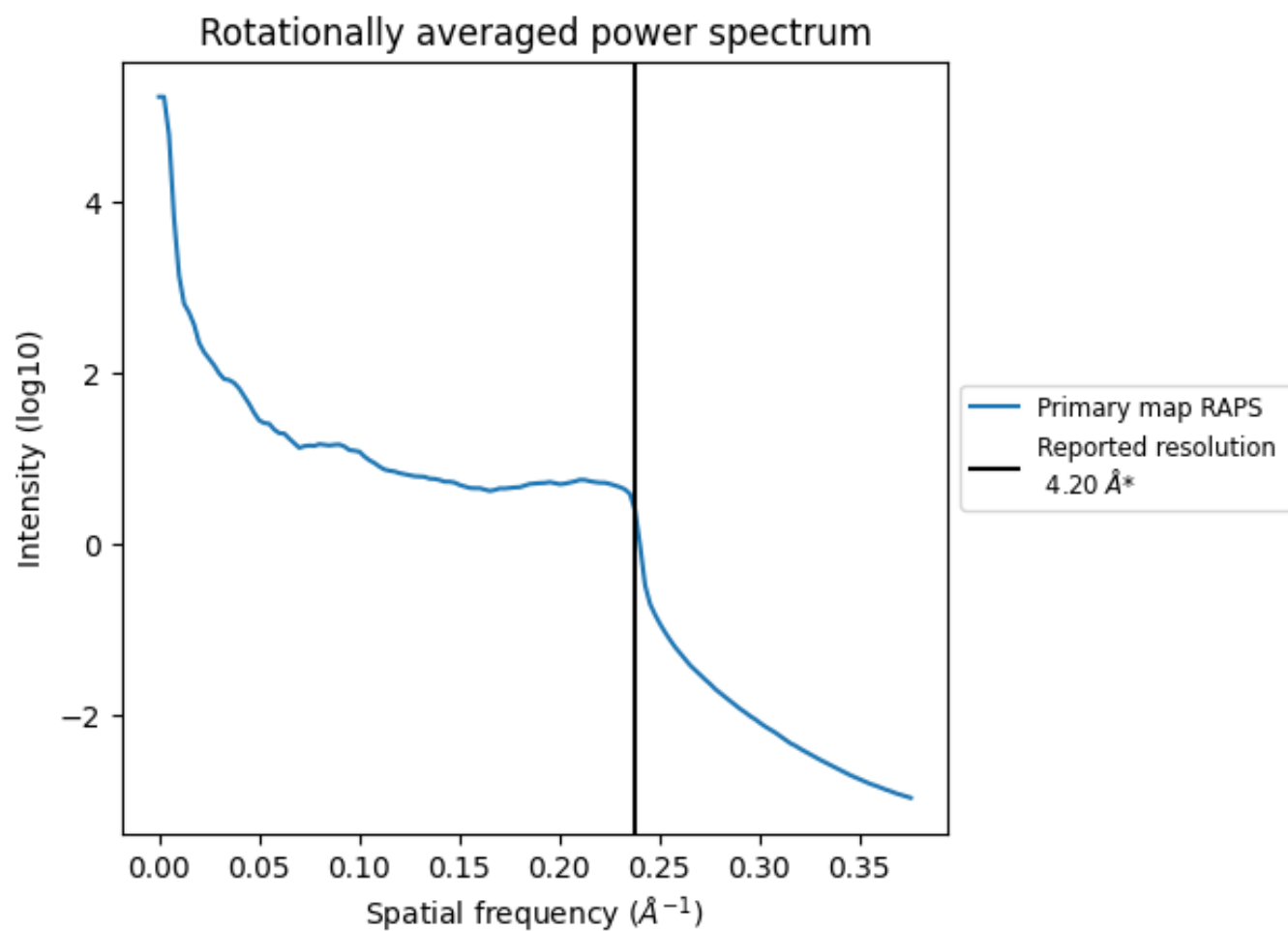


The volume at the recommended contour level is 1667 nm<sup>3</sup>; this corresponds to an approximate mass of 1506 kDa.

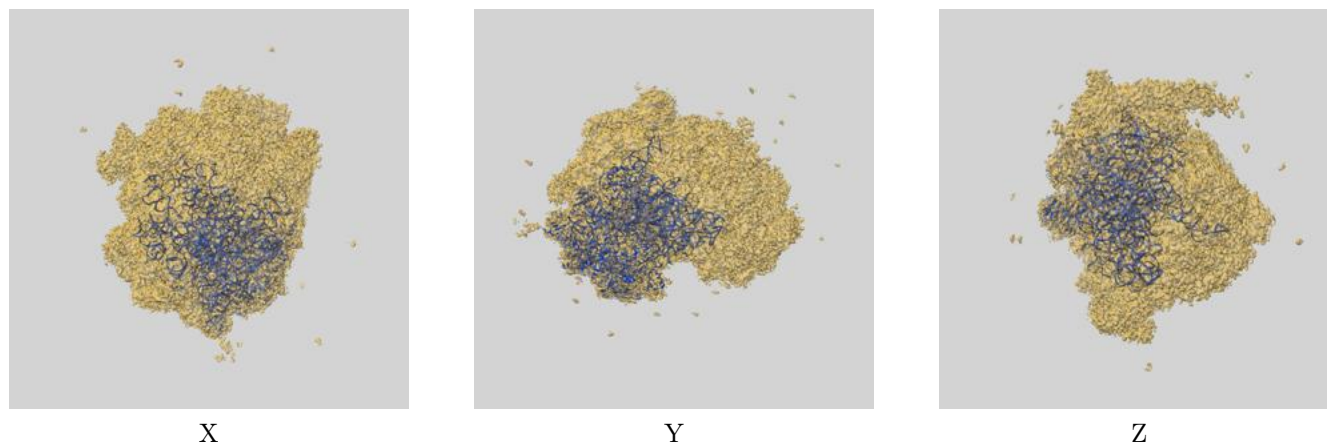

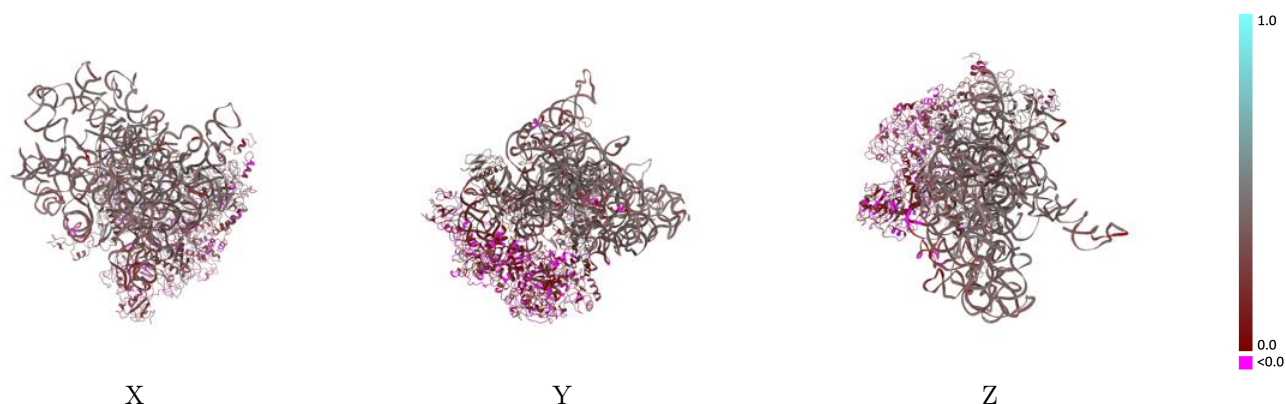

## 9.2 Q-score mapped to coordinate model [i](#)

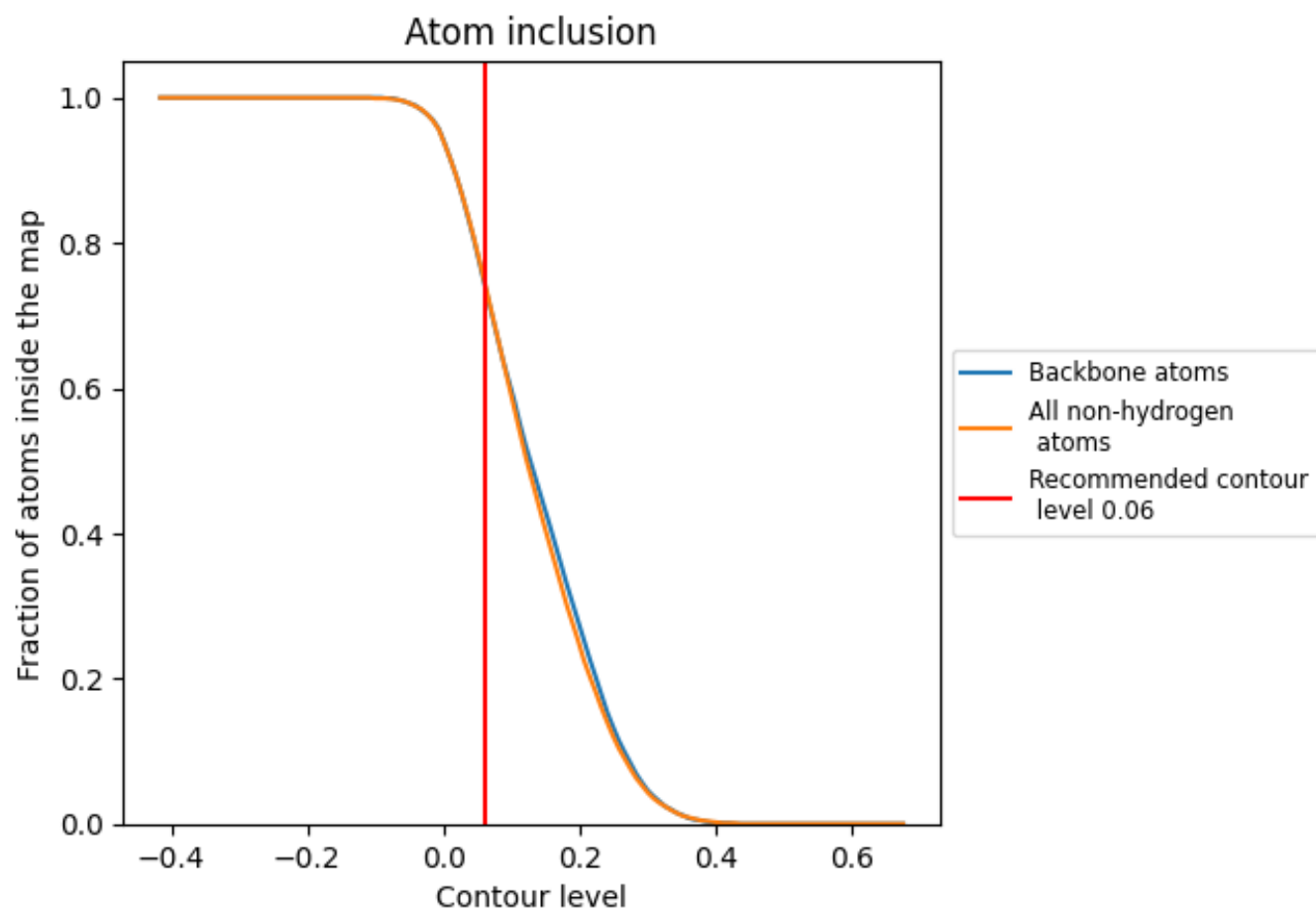

Please note: Q-score is calculating the resolvability of atoms, and thus high values are only expected at resolutions at which atoms can be resolved.
