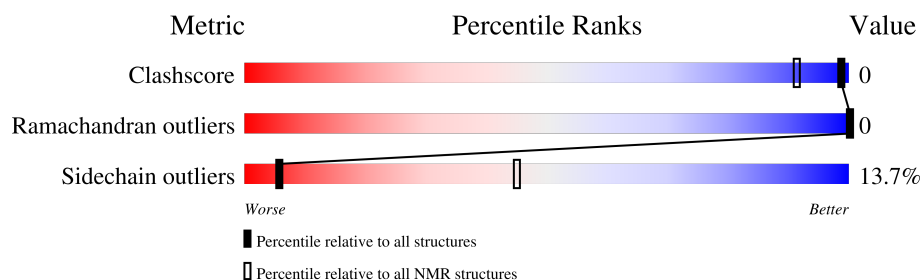
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

*SOLUTION NMR*

The overall completeness of chemical shifts assignment is 86%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$

## 2 Ensemble composition and analysis

This entry contains 20 models. Model 4 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *target function*.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 4 clusters and 3 single-model clusters were found.

### 3 Entry composition [i](#)

There is only 1 type of molecule in this entry. The entry contains 1629 atoms, of which 810 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called Chantal.

## 6 Model quality [i](#)

### 6.1 Standard geometry [i](#)

There are no covalent bond-length or bond-angle outliers.

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

The H(added) column lists the number of hydrogen atoms added and optimized by MolProbity. The Clashes column lists the number of clashes averaged over the ensemble.

#### 7.1.3 Completeness of resonance assignments

The following table shows the completeness of the chemical shift assignments for the well-defined regions of the structure. The overall completeness is 86%, i.e. 963 atoms were assigned a chemical shift out of a possible 1122. 0 out of 12 assigned methyl groups (LEU and VAL) were assigned stereospecifically.

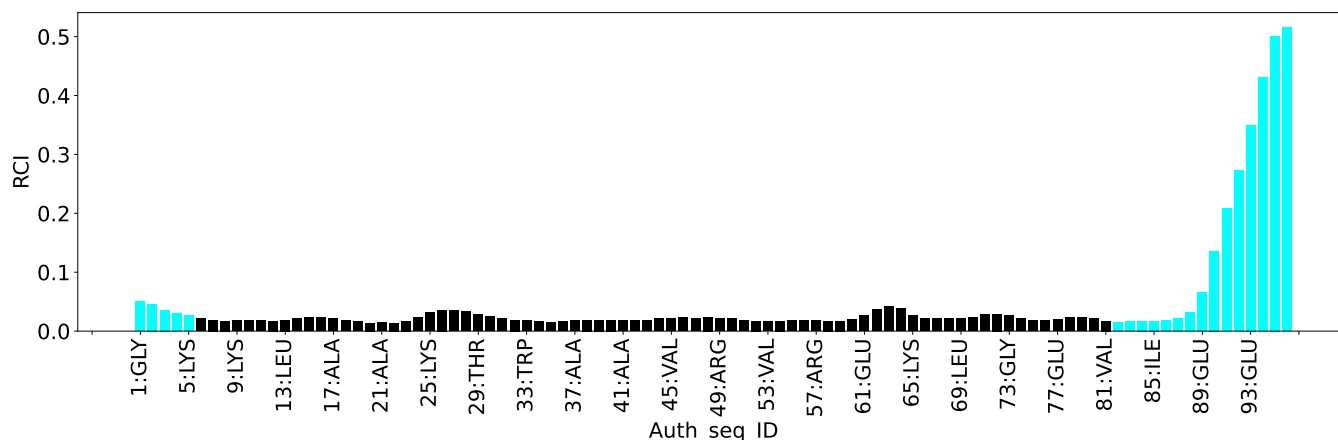

#### 7.1.5 Random Coil Index (RCI) plots [i](#)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition. If well-defined core and ill-defined regions are not identified then it is shown as gray bars.

### 8.2 Residual restraint violations

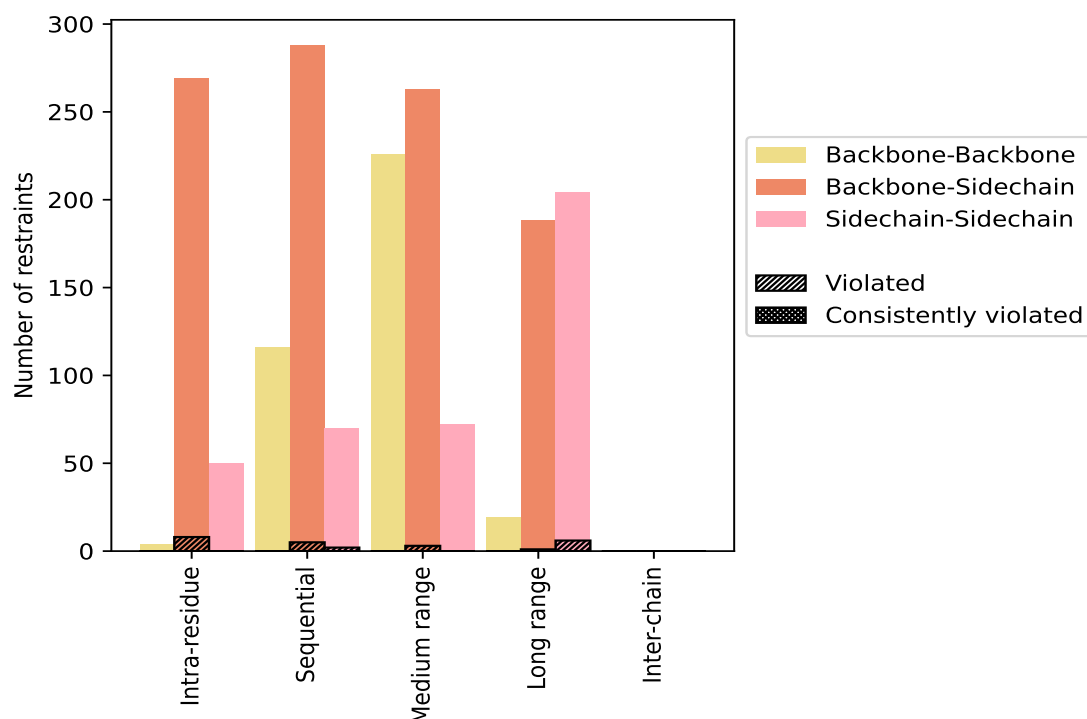

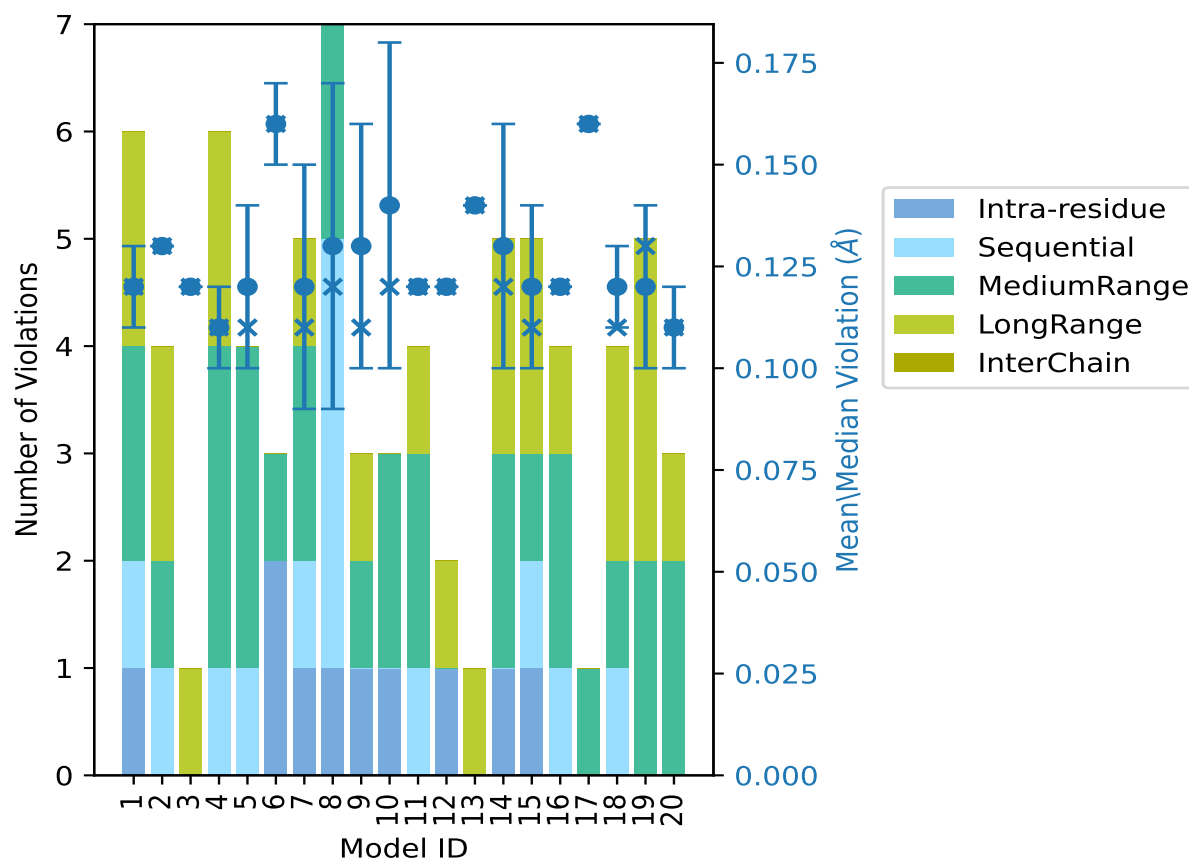

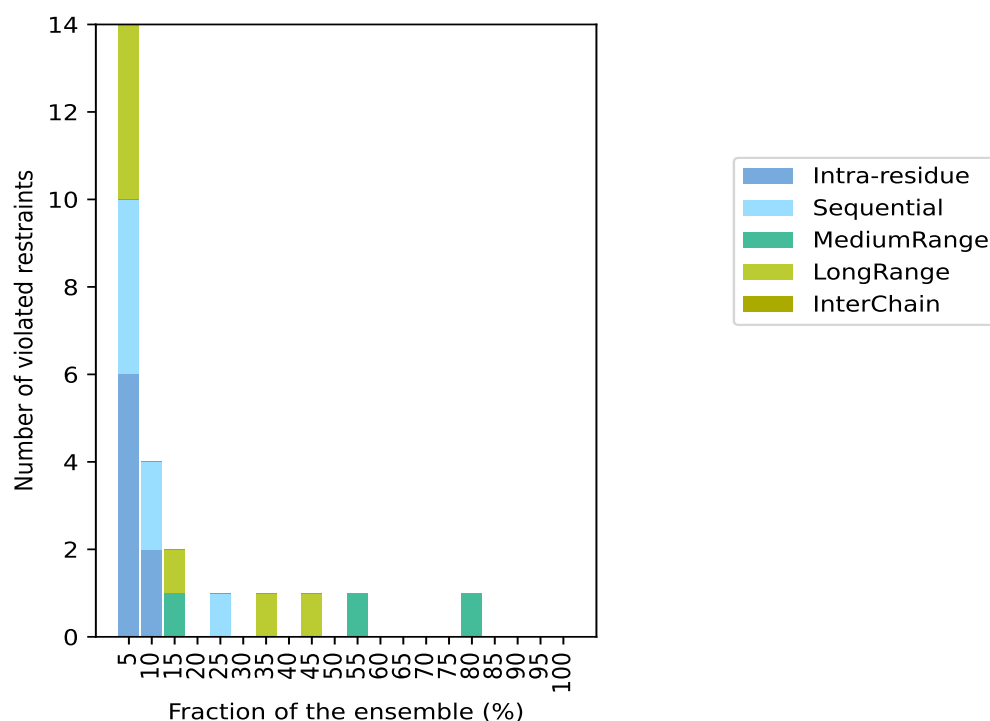

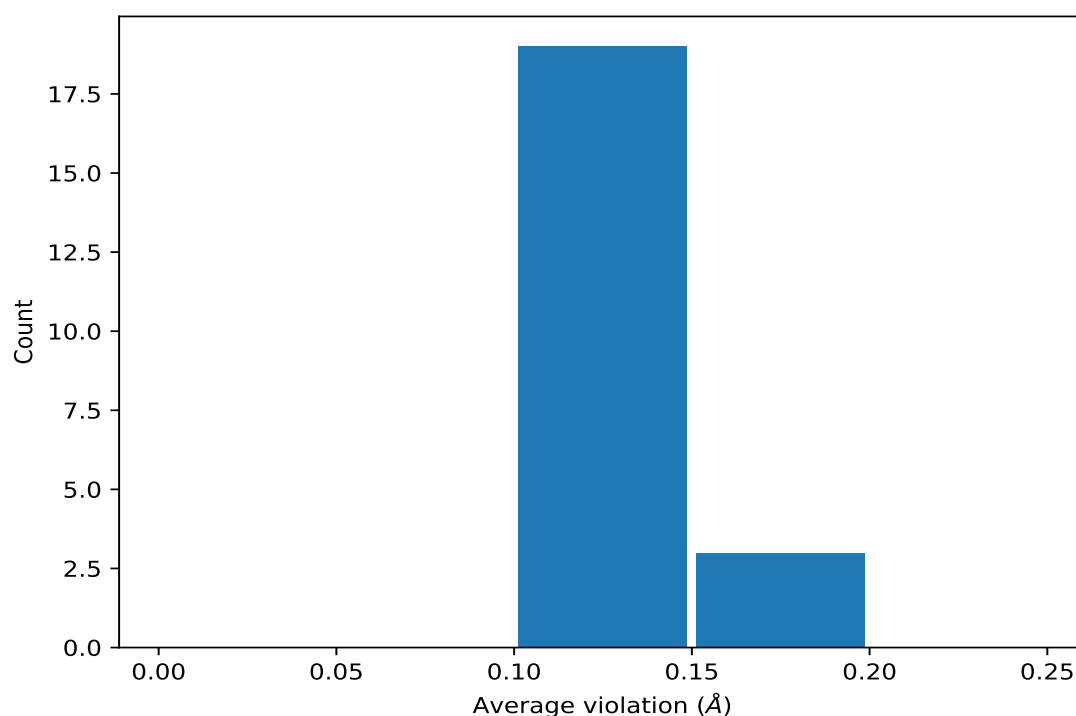

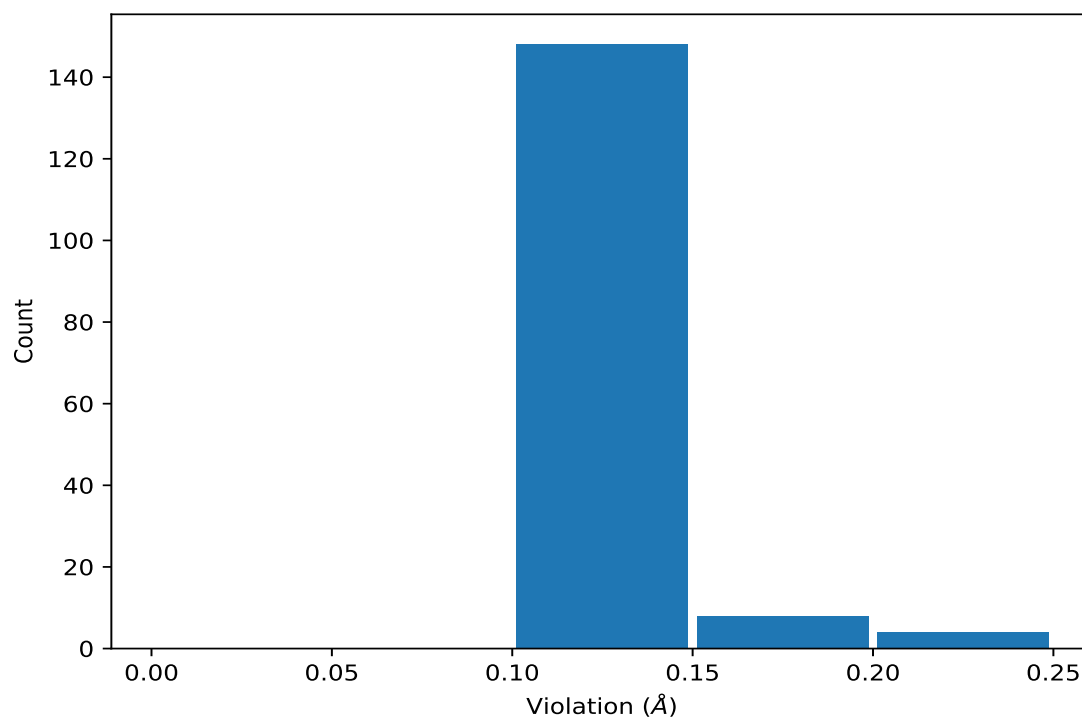

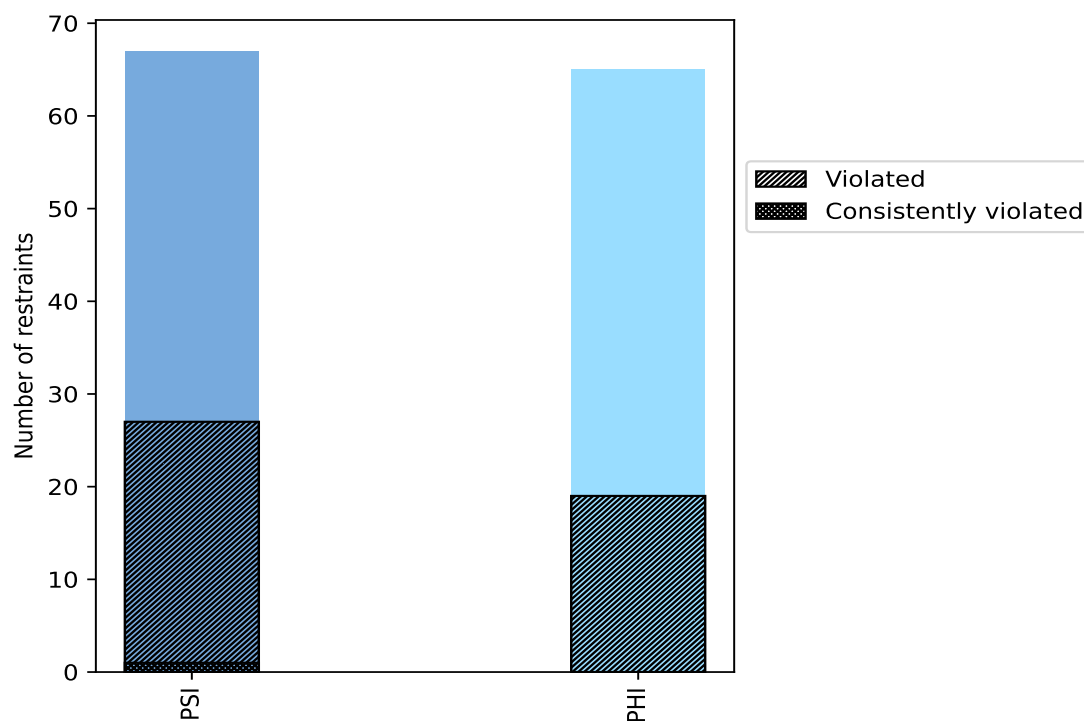

#### 10.1.1 Bar chart : Distribution of dihedral-angles and violations [i](#)



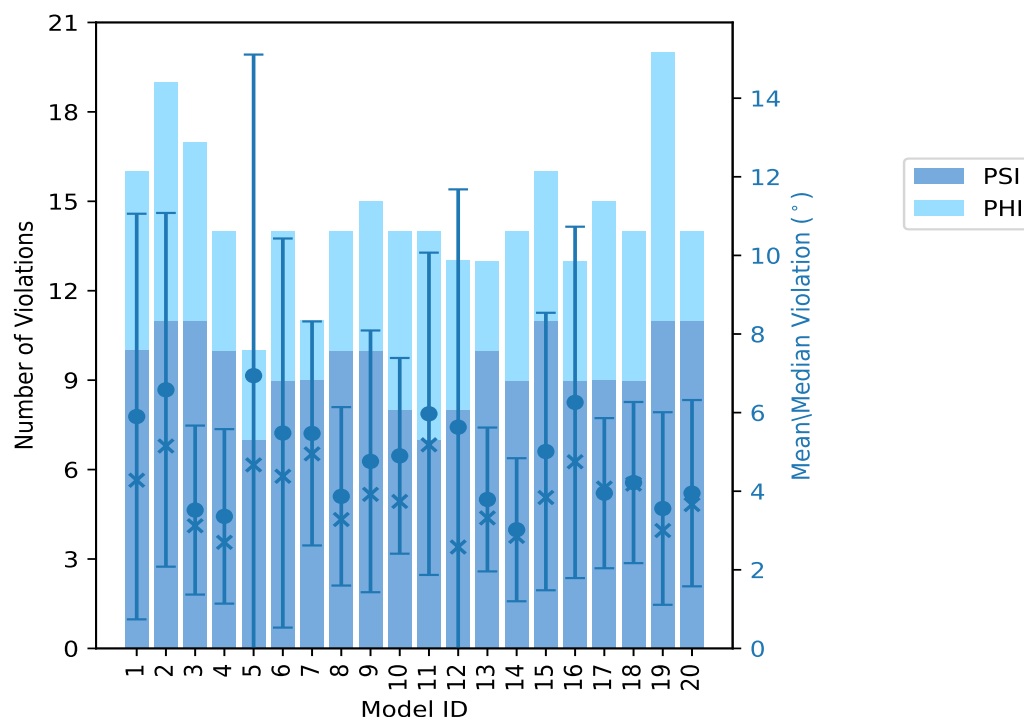

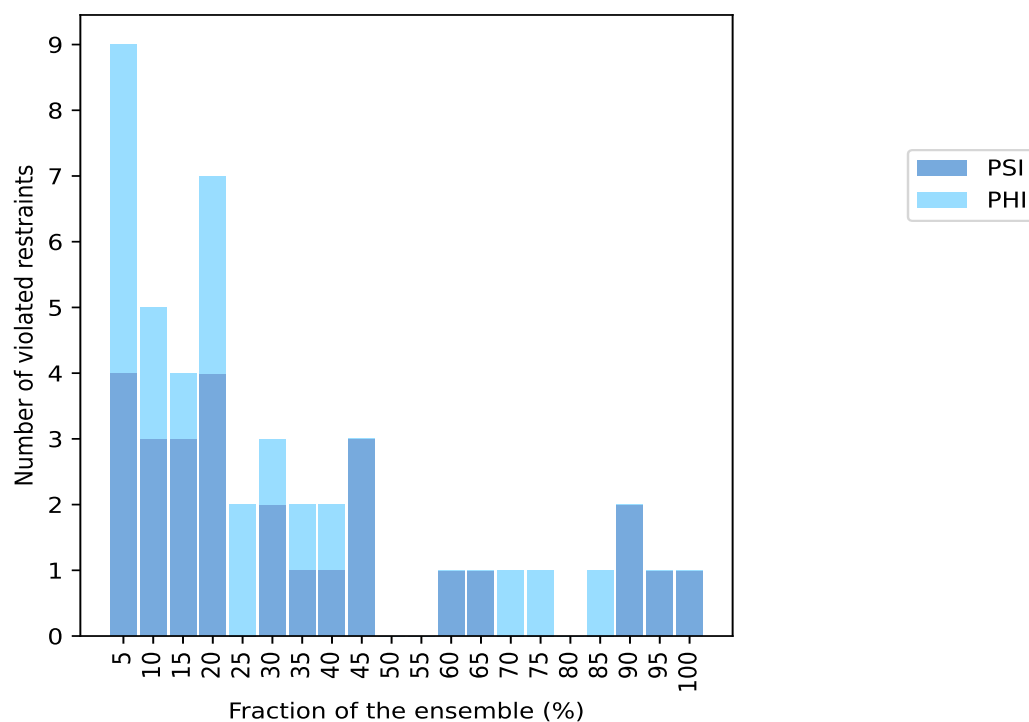

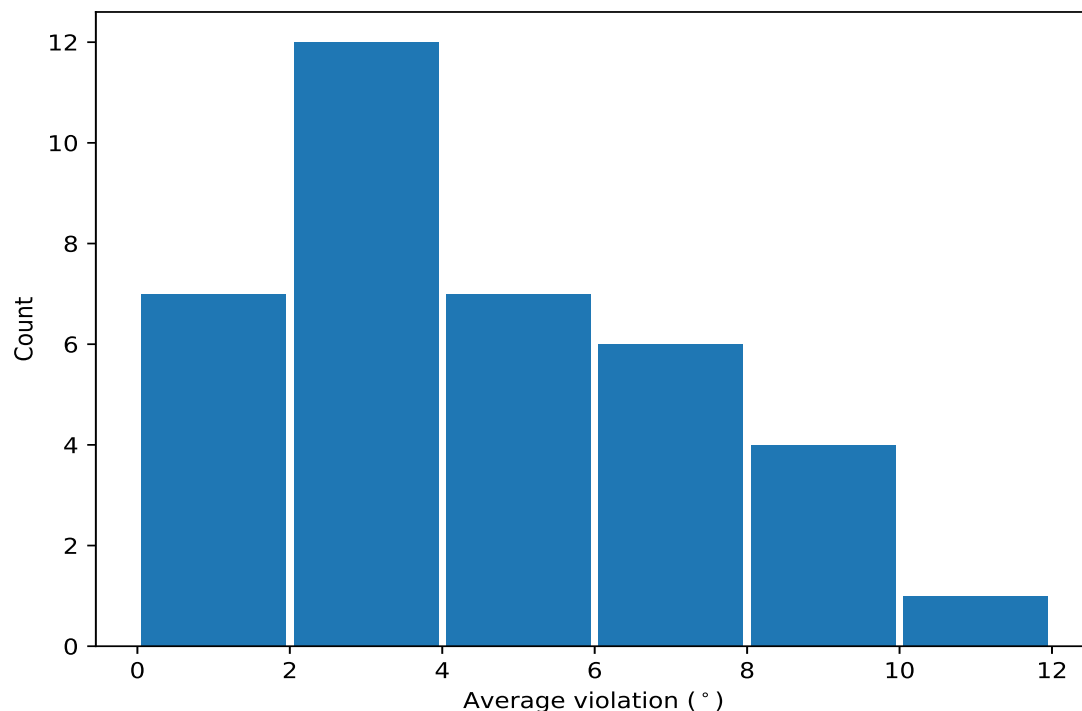

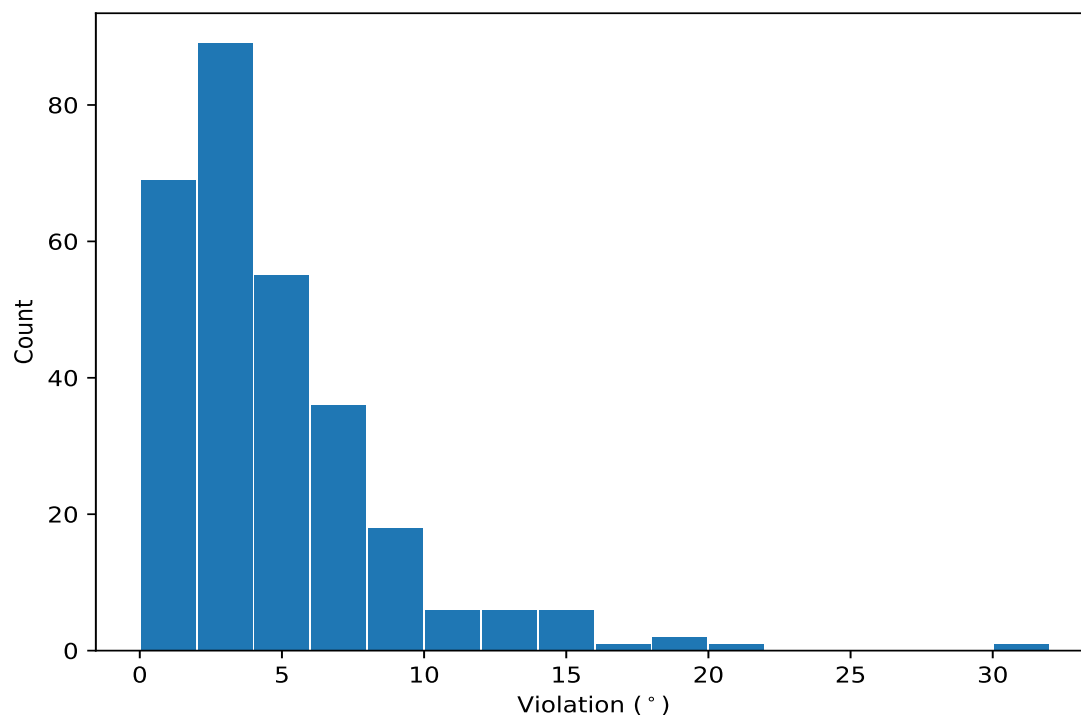
