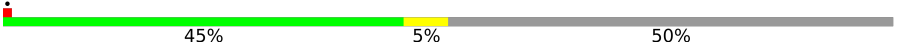

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$ . The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion  $< 40\%$ ). The numeric value is given above the bar.

## 2 Entry composition

There are 12 unique types of molecules in this entry. The entry contains 14573 atoms, of which 0 are hydrogens and 0 are deuteriums.

In the tables below, the AltConf column contains the number of residues with at least one atom in alternate conformation and the Trace column contains the number of residues modelled with at most 2 atoms.

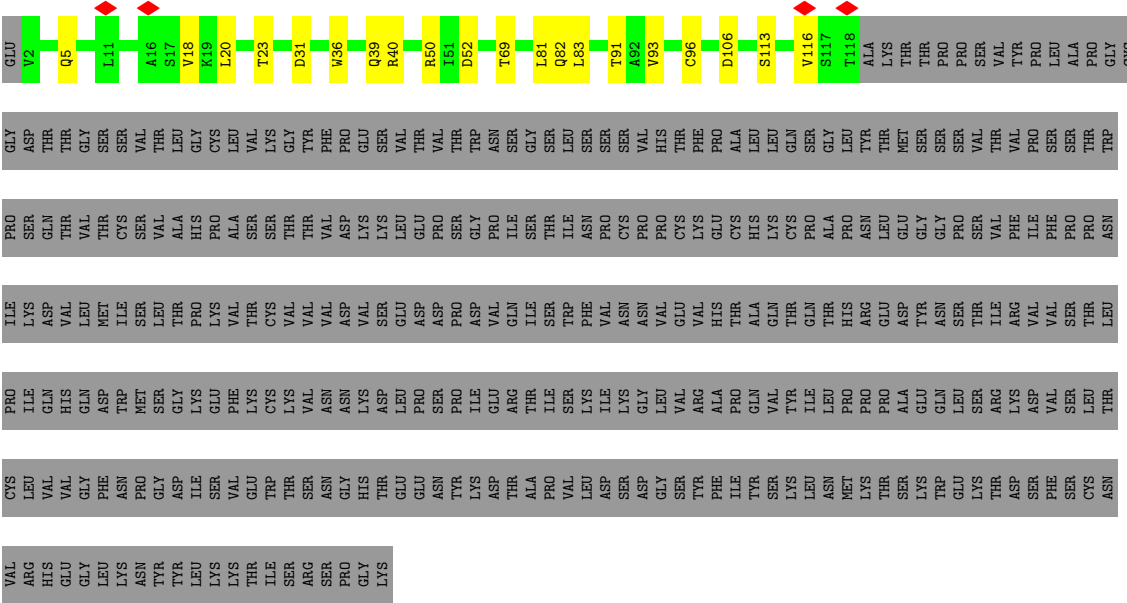




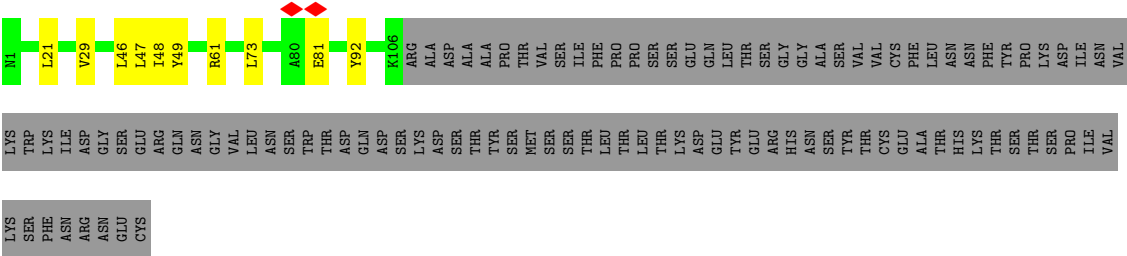




• Molecule 5: IgG2b Fab\_1F4 Heavy Chain

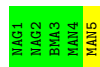

## 5 Model quality

### 5.1 Standard geometry

Bond lengths and bond angles in the following residue types are not validated in this section: ABU, MAN, BMA, PIO, NAG

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with  $|Z| > 5$  is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for all instances of the Ligand of Interest. 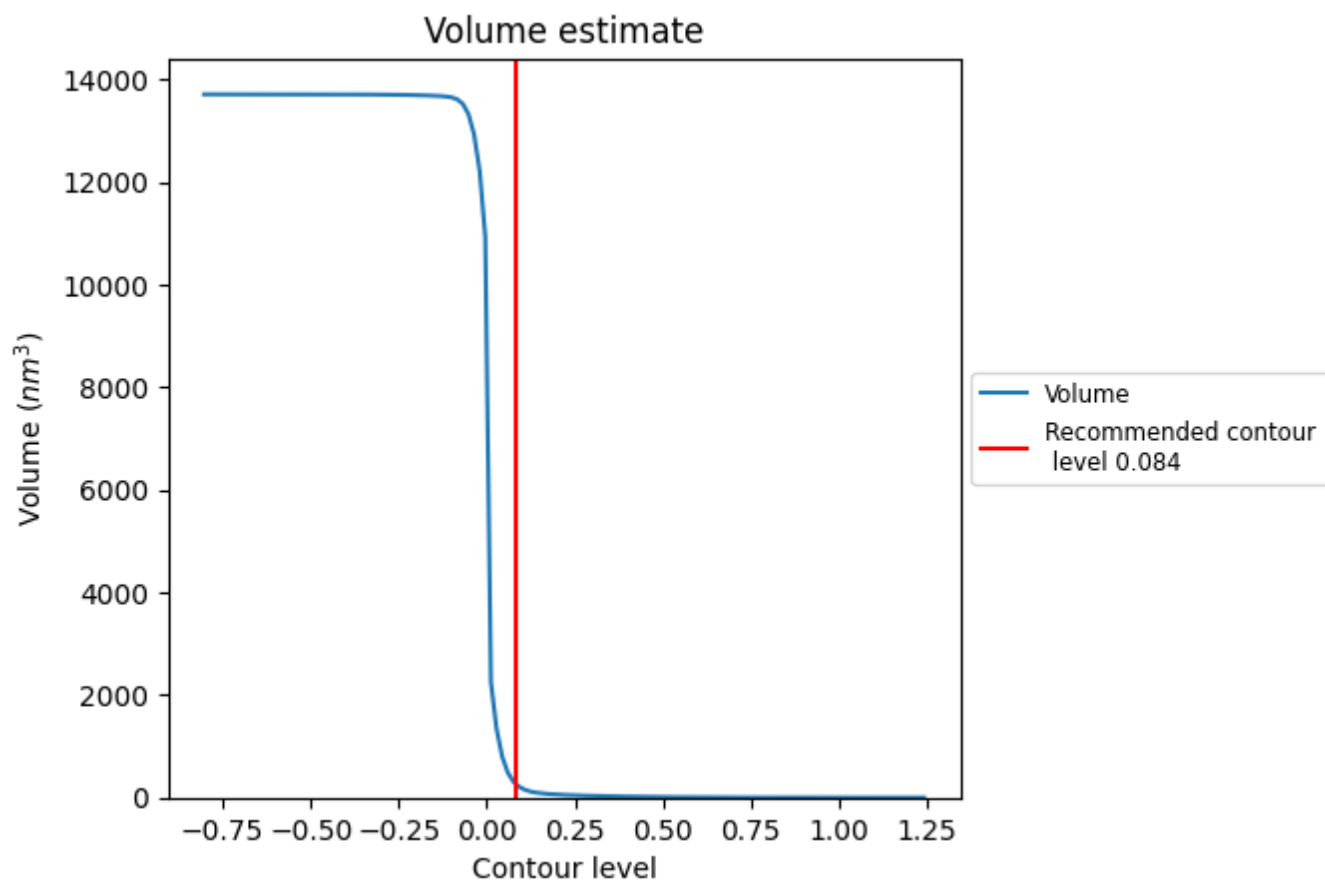

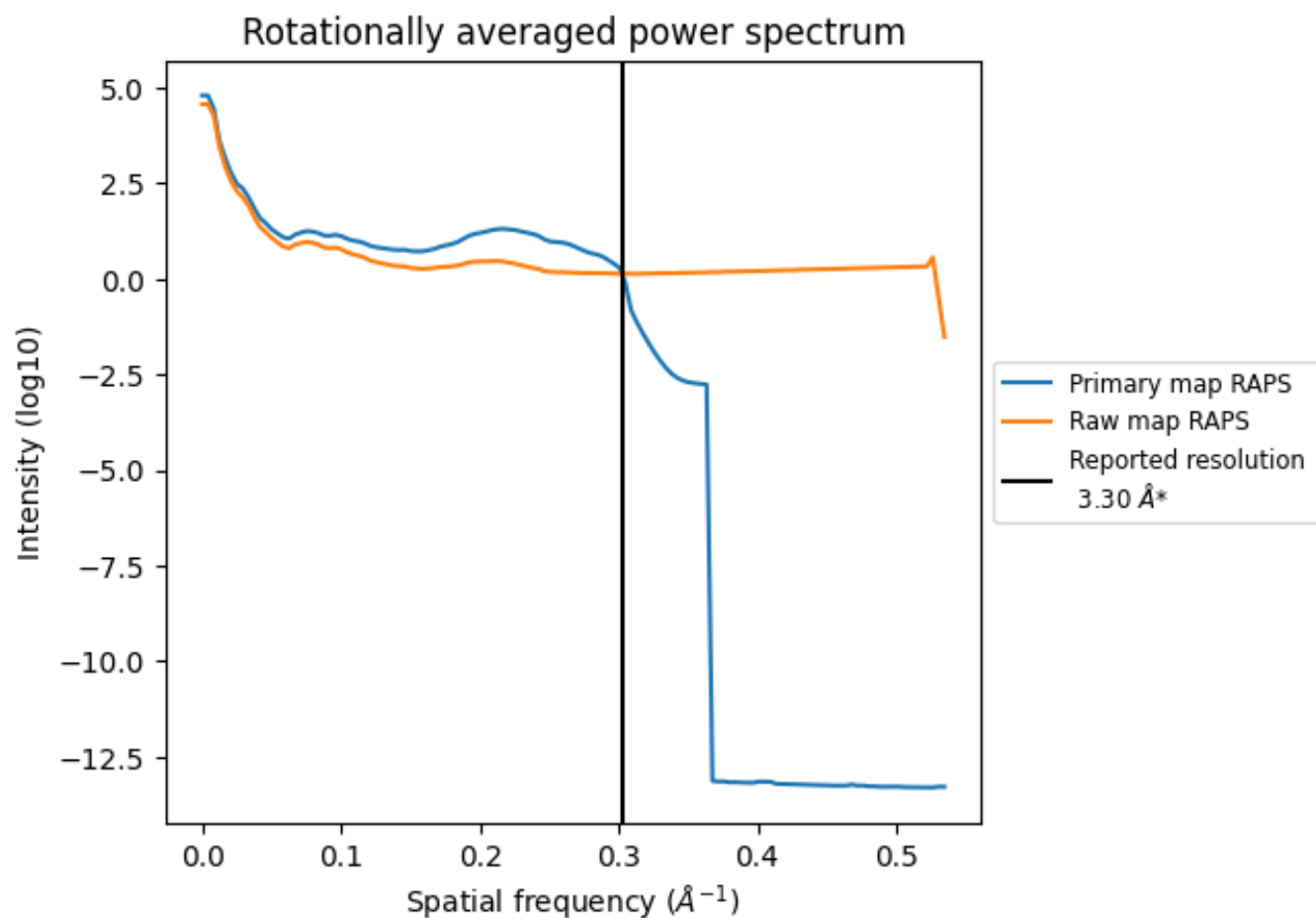

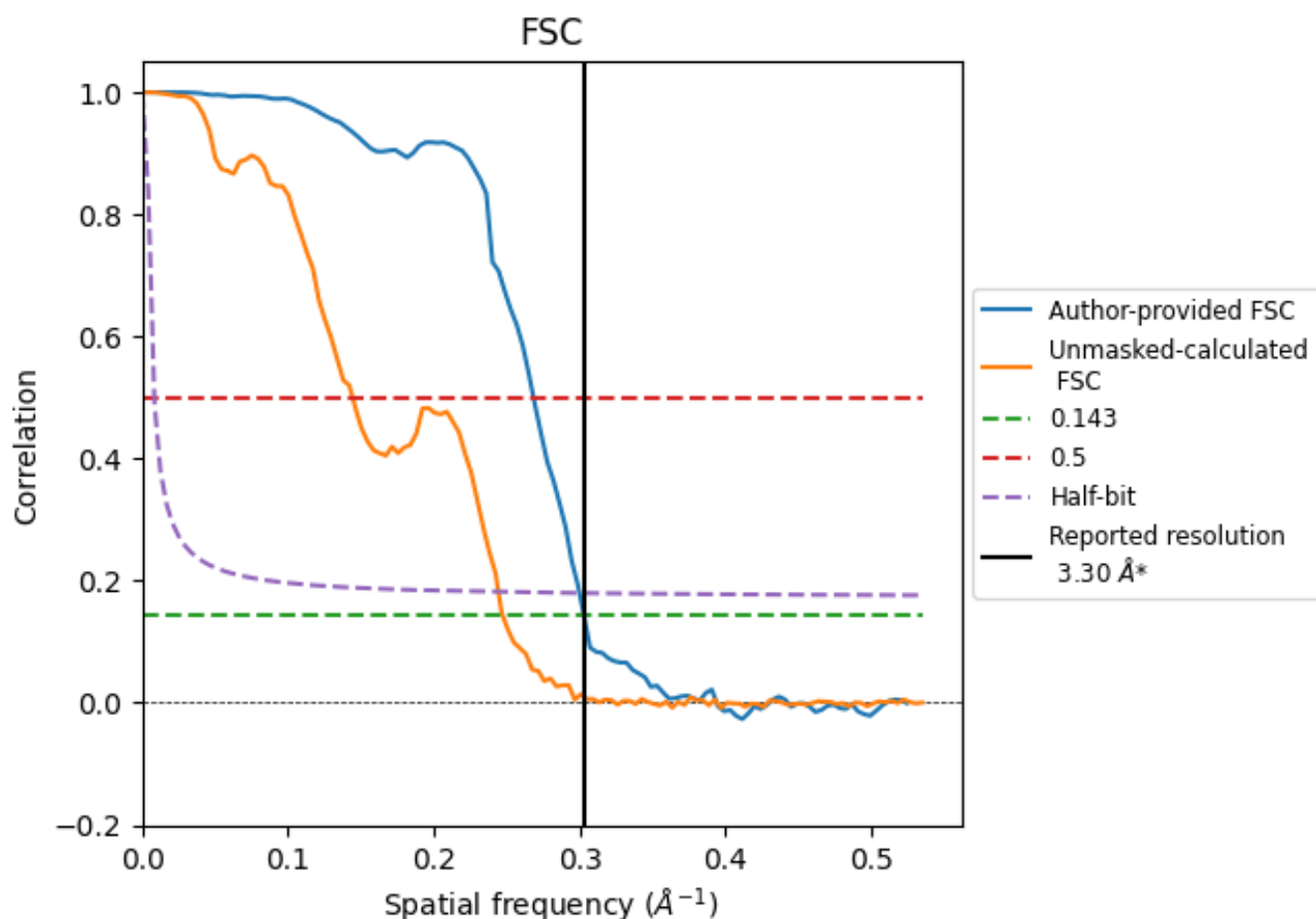

## 8 Fourier-Shell correlation [i](#)

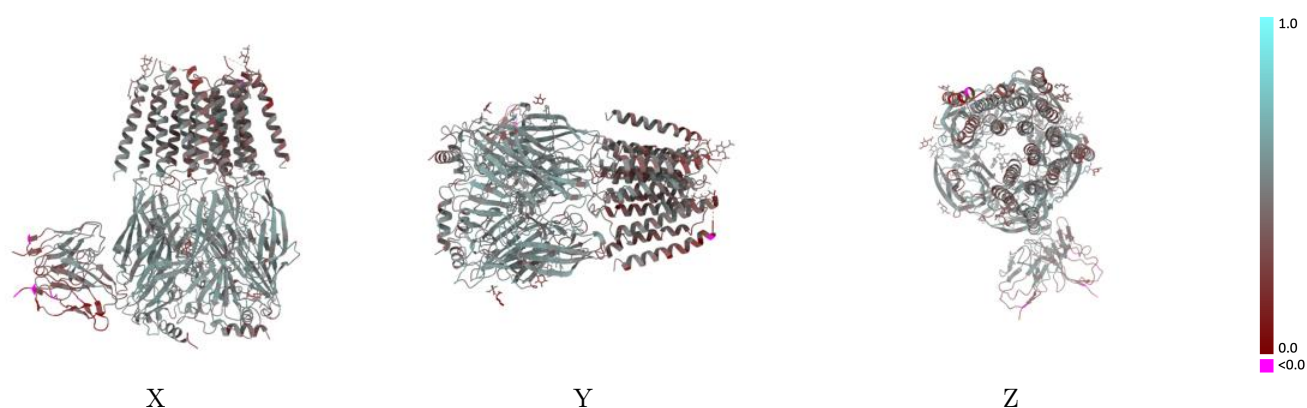

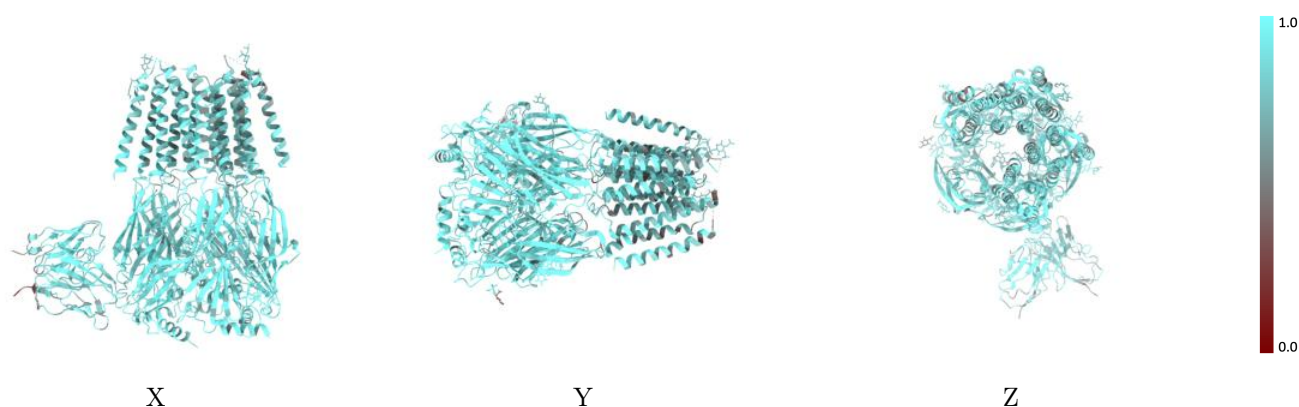

### 9.2 Q-score mapped to coordinate model [i](#)



The images above show the model with each residue coloured according to its Q-score. This shows their resolvability in the map with higher Q-score values reflecting better resolvability. Please note: Q-score is calculating the resolvability of atoms, and thus high values are only expected at resolutions at which atoms can be resolved. Low Q-score values may therefore be expected for many entries.

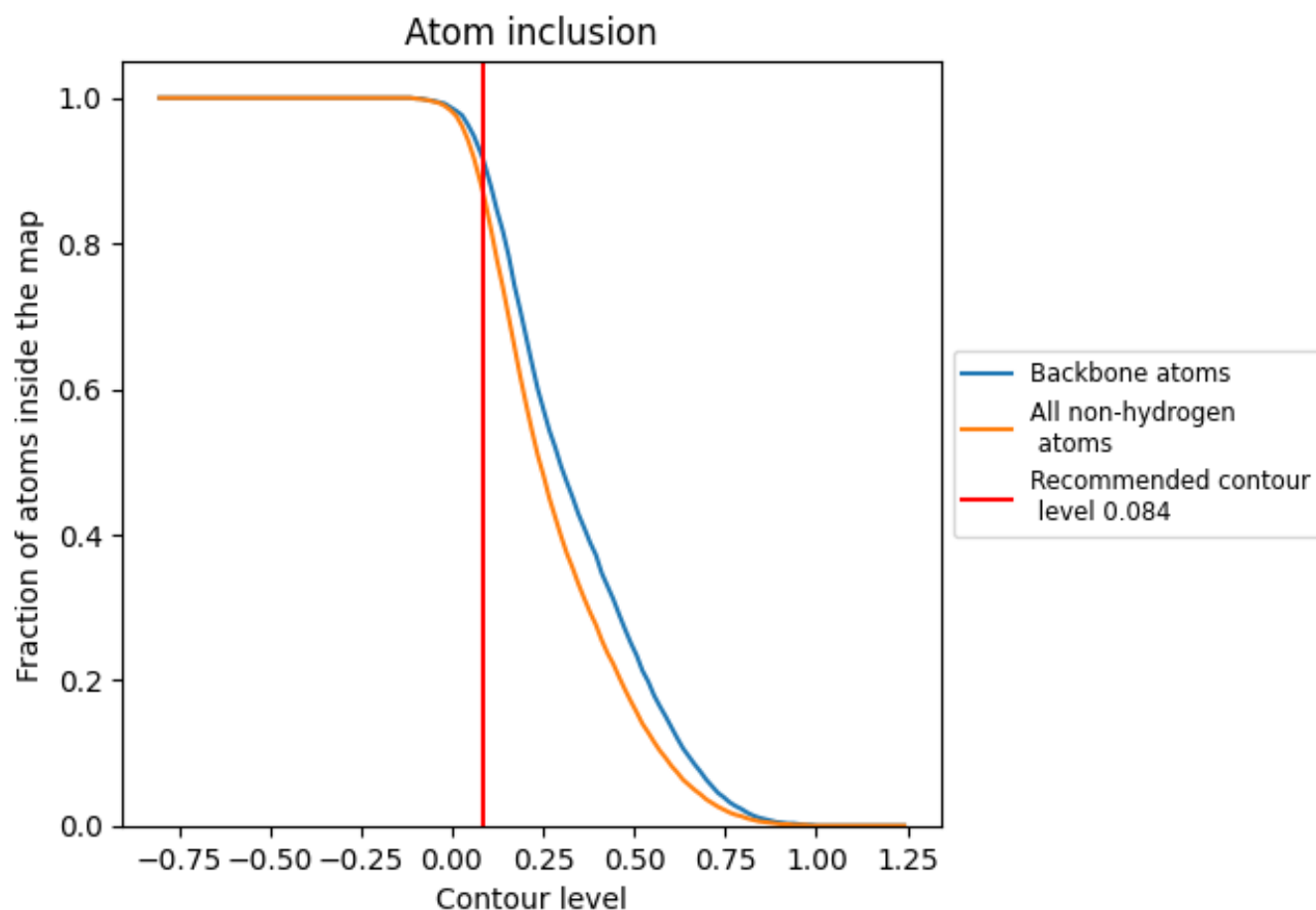
### 9.3 Atom inclusion mapped to coordinate model [i](#)





The images above show the model with each residue coloured according to its atom inclusion. This shows to what extent they are inside the map at the recommended contour level (0.084).

## 9.4 Atom inclusion [i](#)



At the recommended contour level, 92% of all backbone atoms, 87% of all non-hydrogen atoms, are inside the map.
