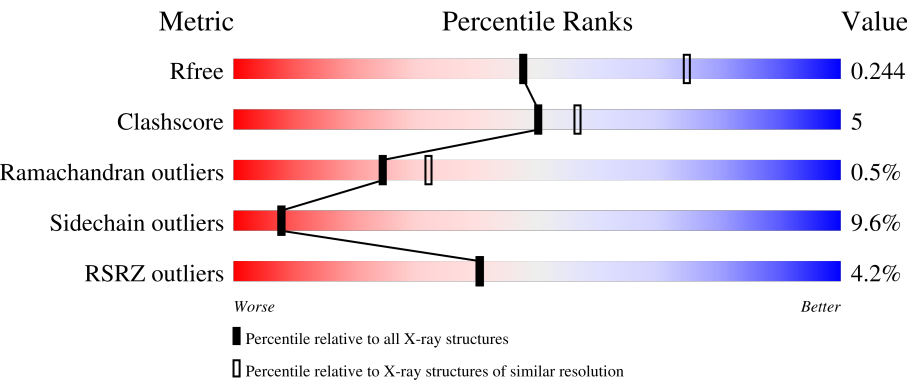

1 Overall quality at a glance i

The following experimental techniques were used to determine the structure:
X-RAY DIFFRACTION

The reported resolution of this entry is 2.45 Å.

The red, orange, yellow and green segments of the lower bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the electron density. The numeric value is given above the bar.

2 Entry composition

There are 8 unique types of molecules in this entry. The entry contains 24500 atoms, of which 0 are hydrogens and 0 are deuteriums.

• Molecule 1: POLYPEPTIDE N-ACETYL GALACTOSAMINYLTRANSFERASE 2

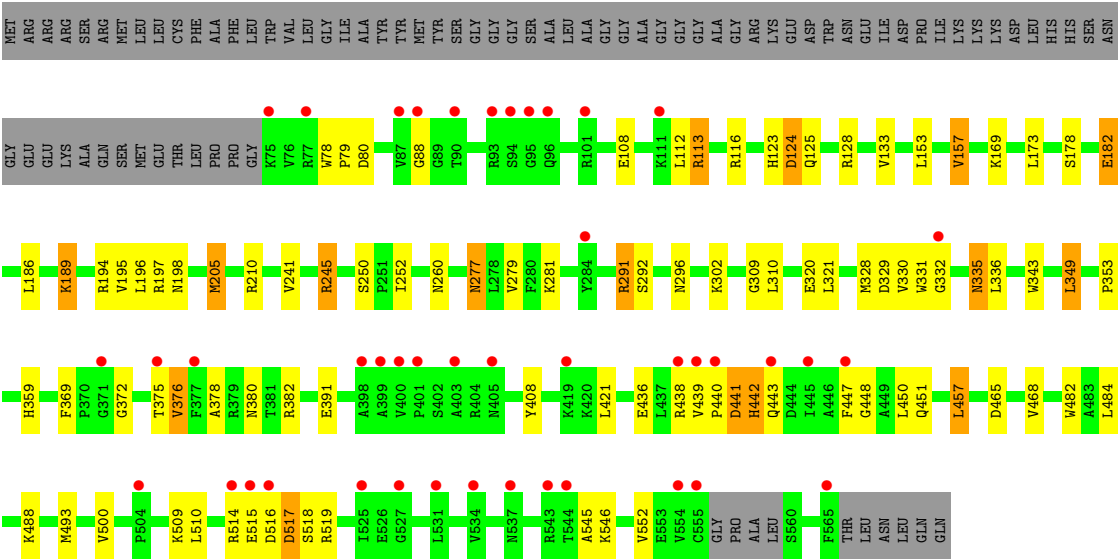

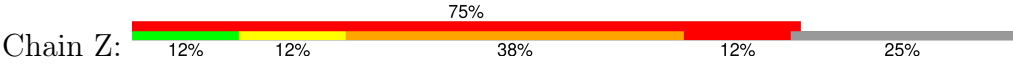




• Molecule 2: PEPTIDE

Xtriage's analysis on translational NCS is as follows: *The largest off-origin peak in the Patterson function is 11.86% of the height of the origin peak. No significant pseudotranslation is detected.*

5 Model quality

5.1 Standard geometry

Bond lengths and bond angles in the following residue types are not validated in this section: UDP, NGA, UD2, MN, EDO

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

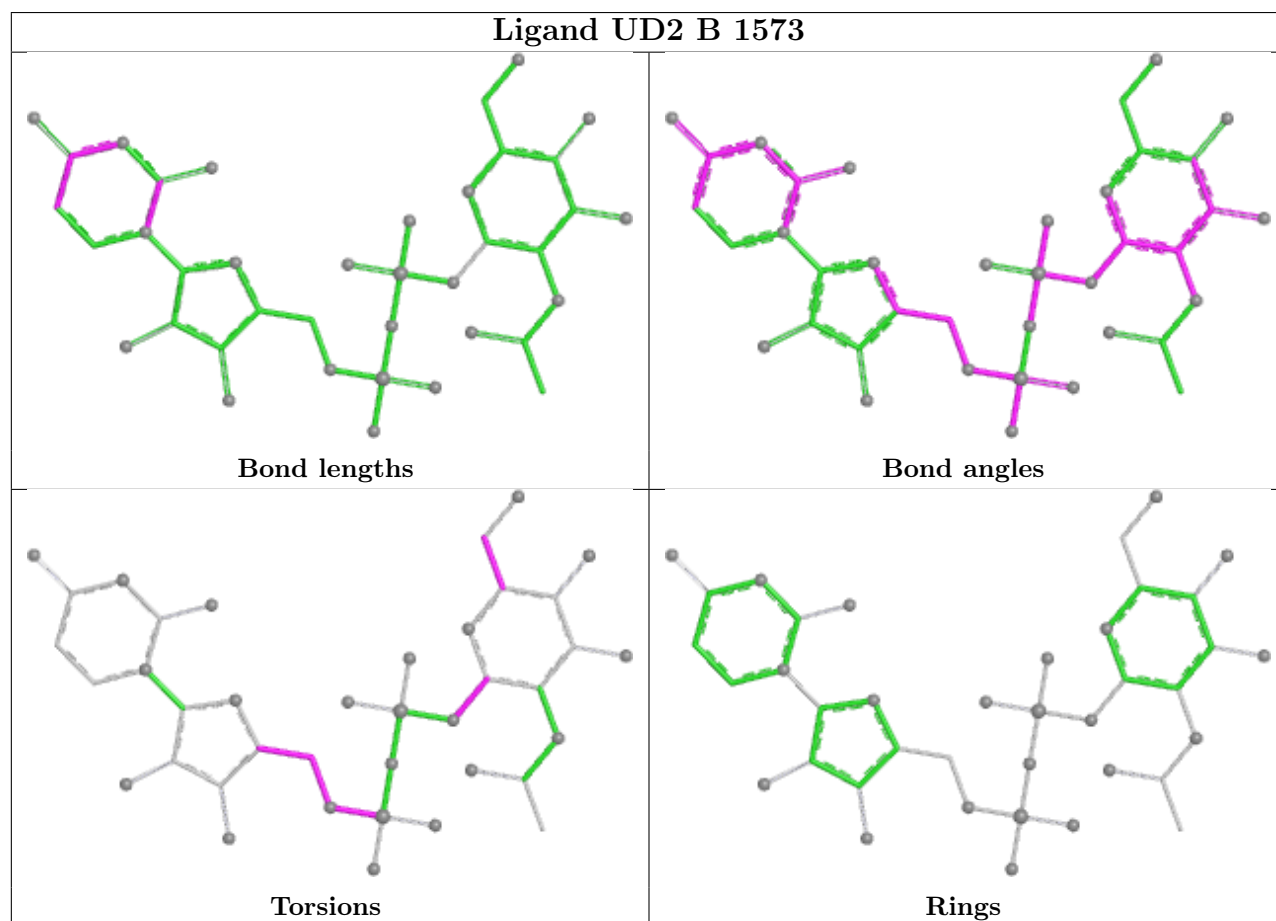

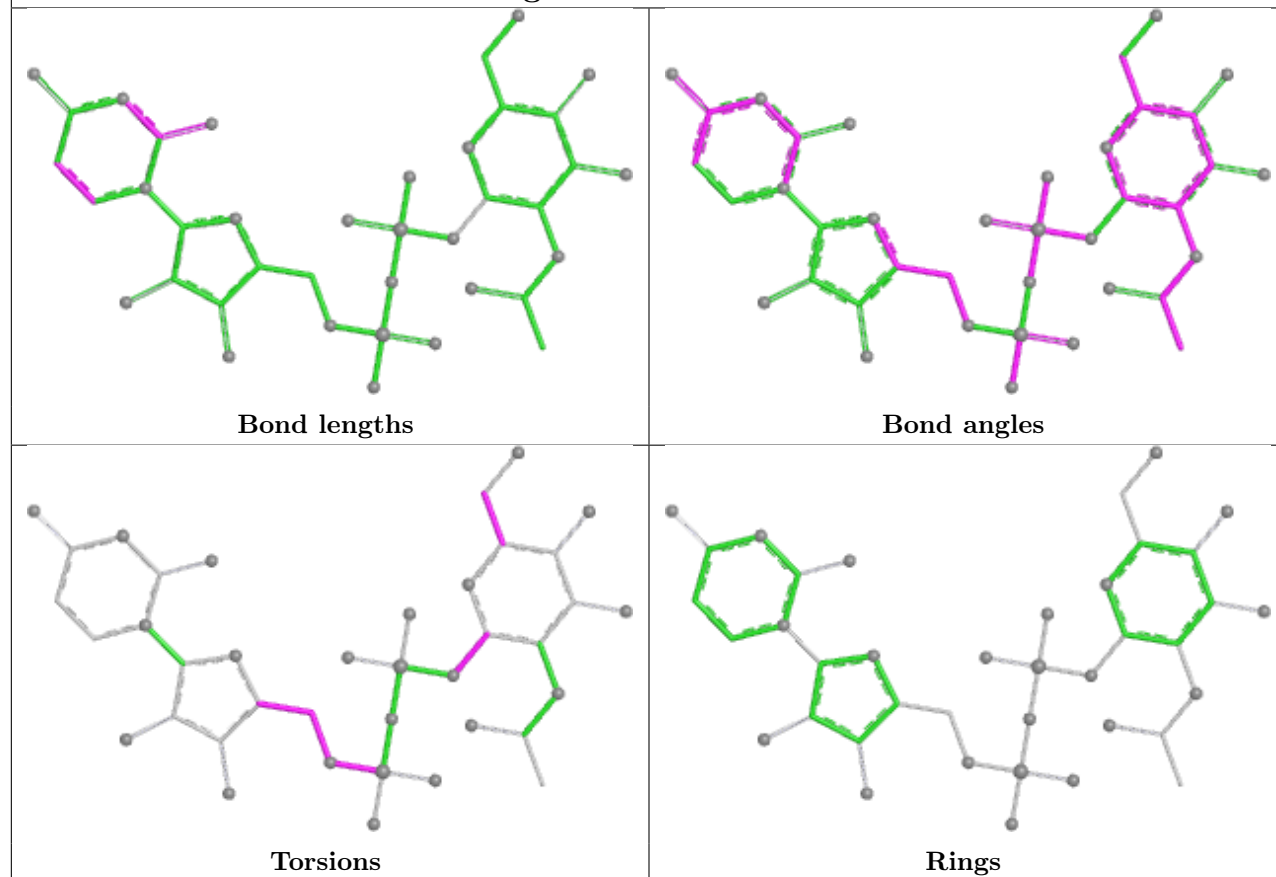

The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths,

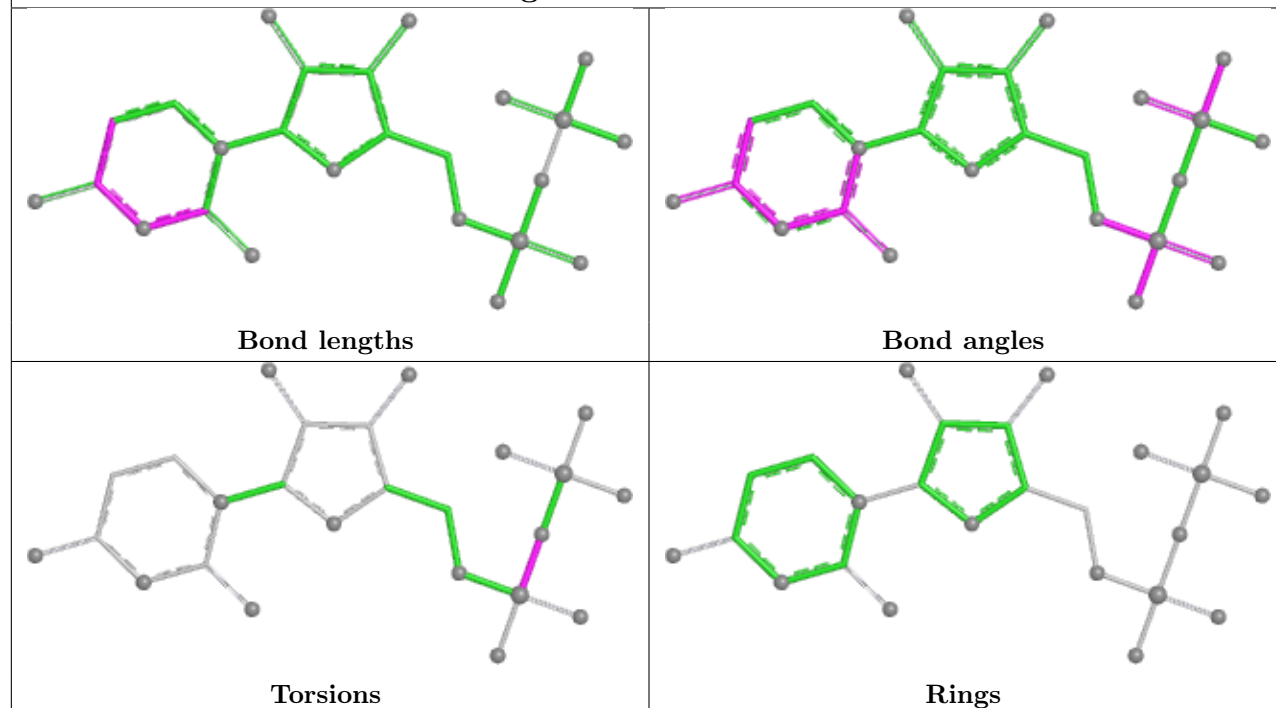

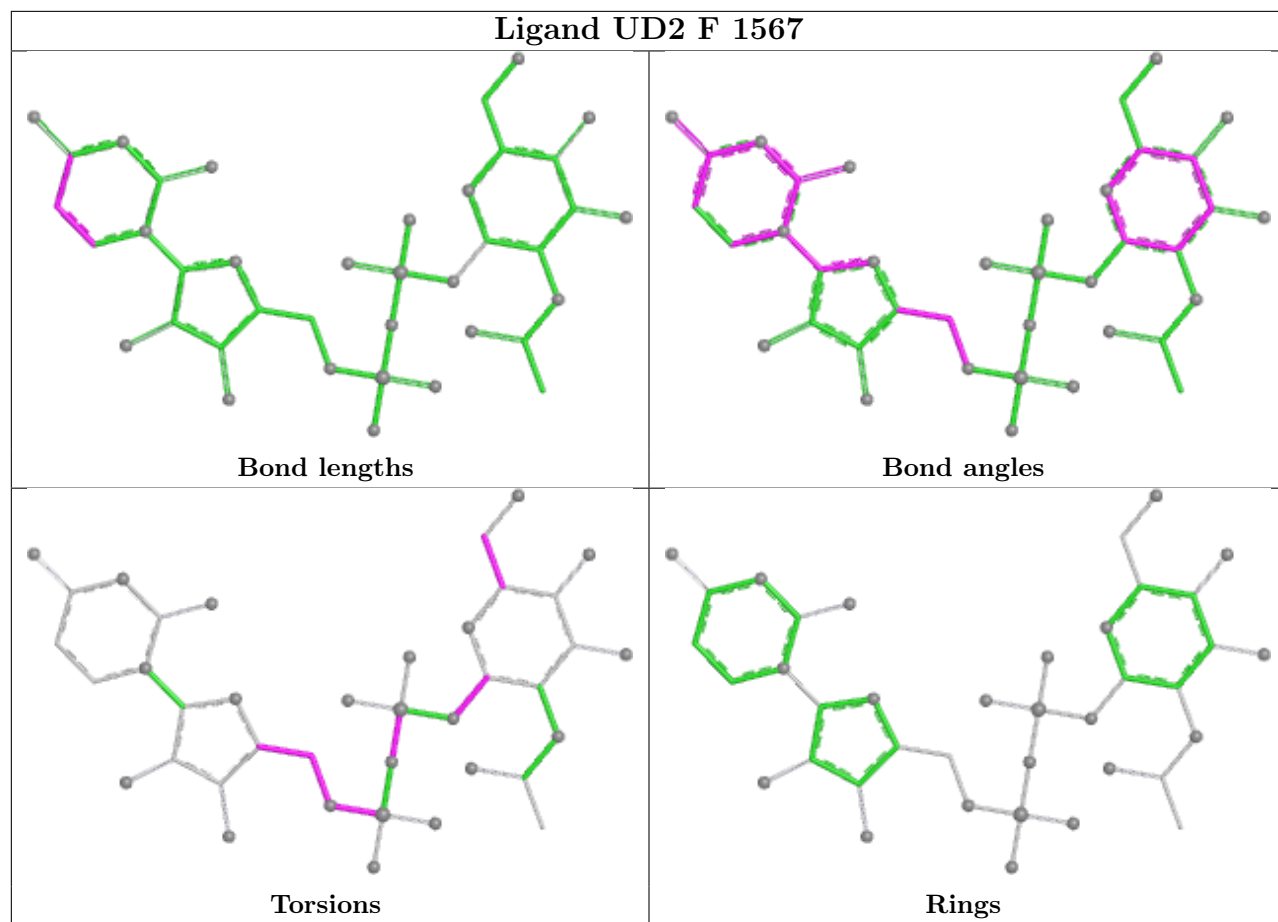


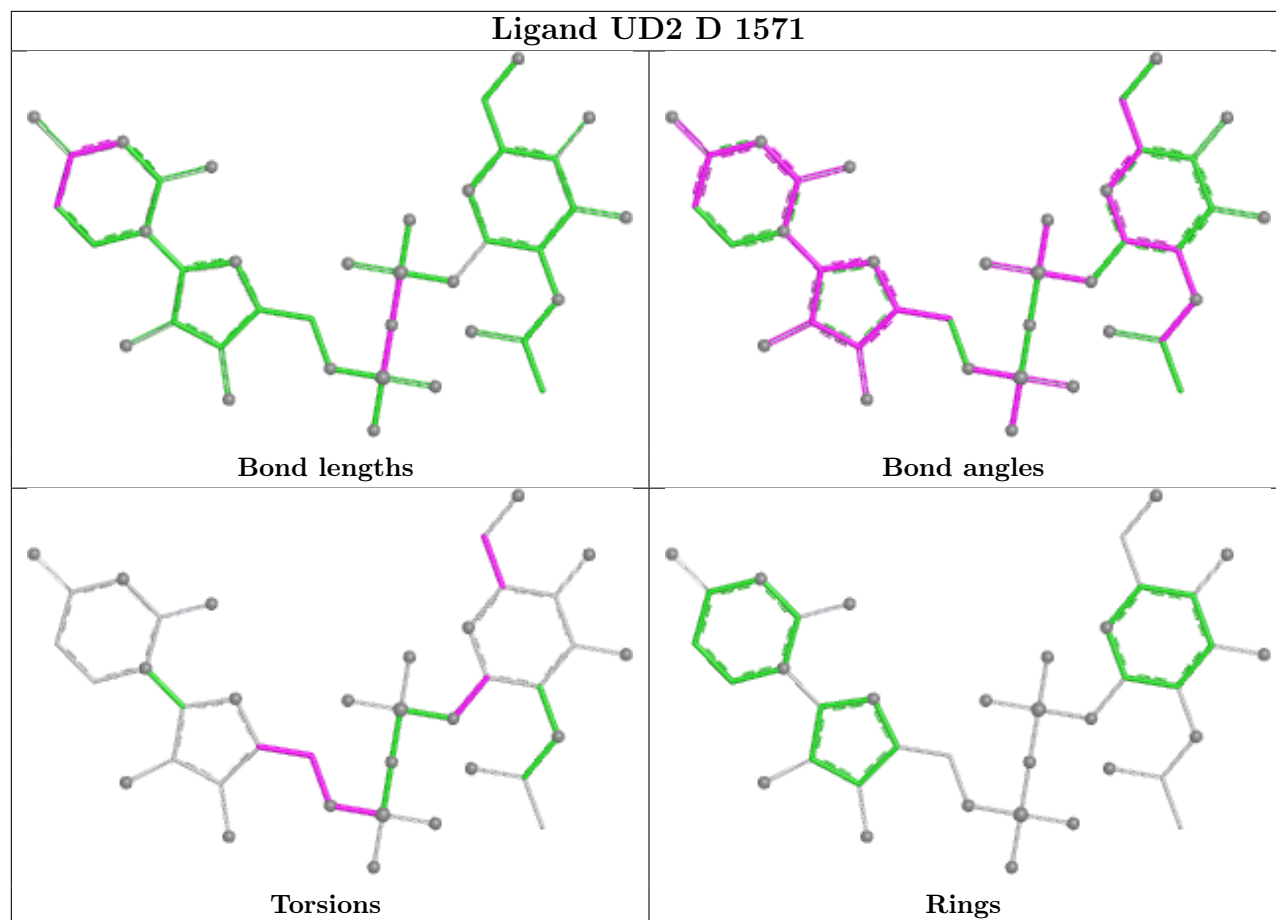
Ligand UD2 A 1574

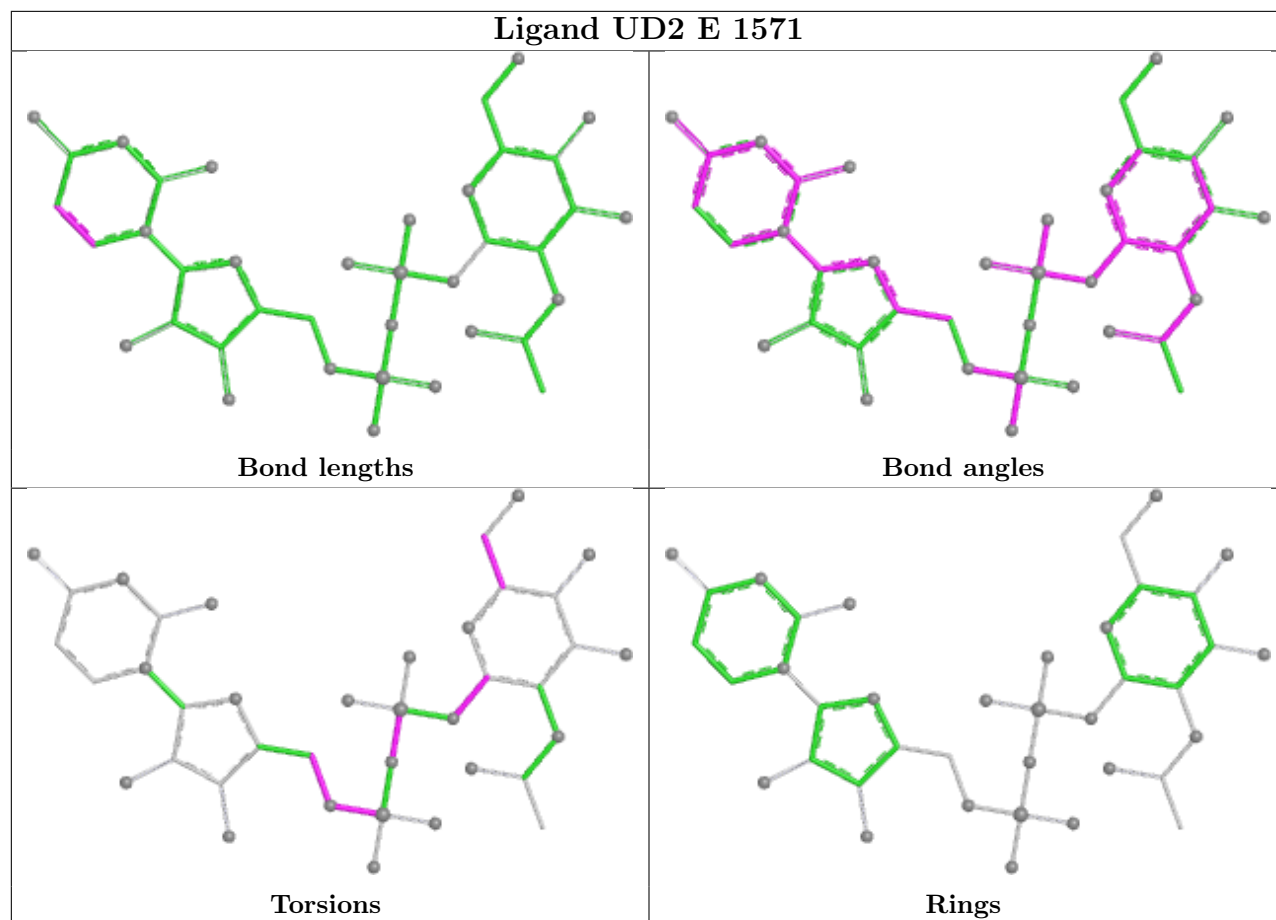


Ligand UDP C 1571

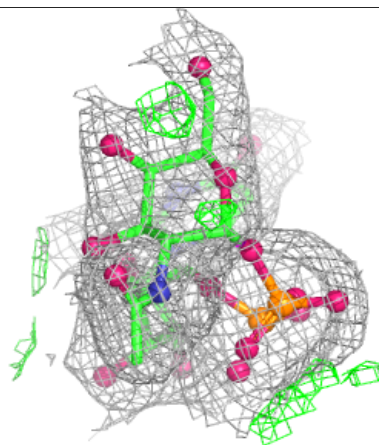
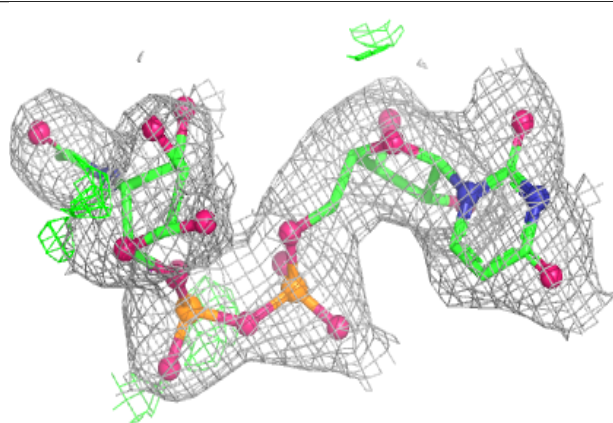
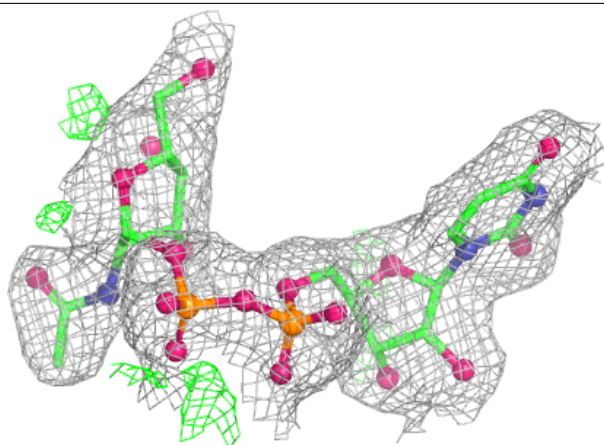
Electron density around UD2 F 1567:

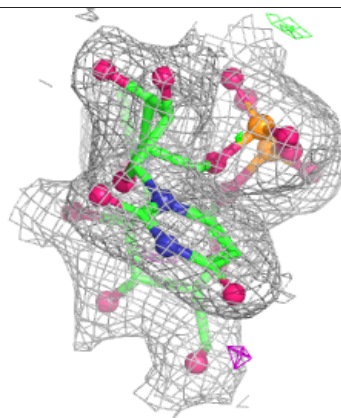
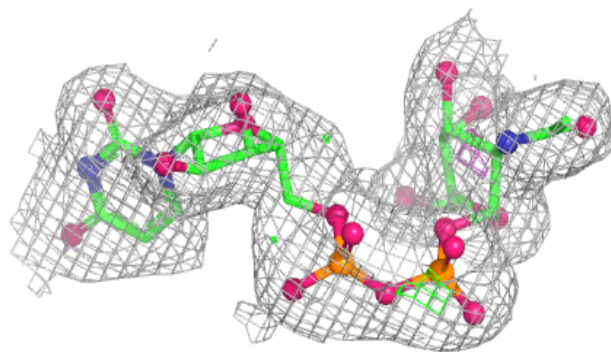
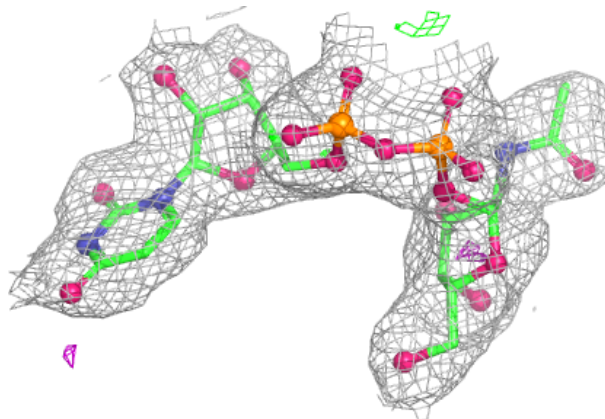
Electron density around UD2 B 1573:

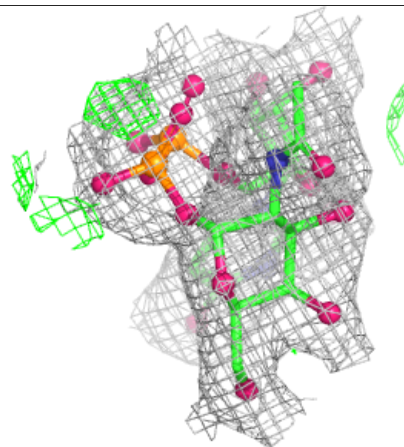
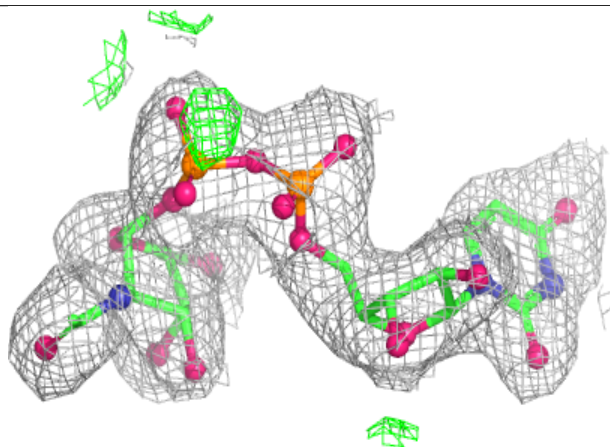
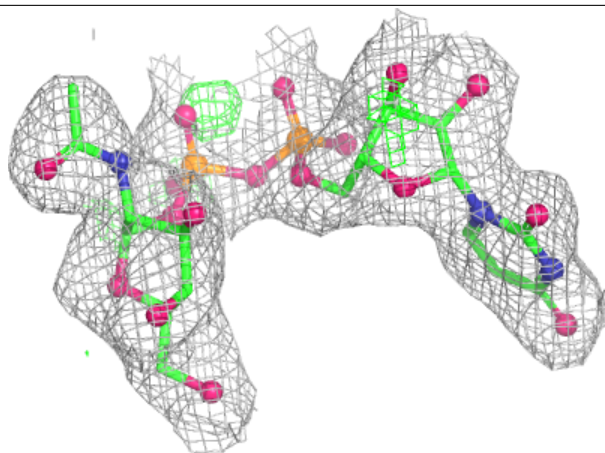
Electron density around UD2 D 1571:

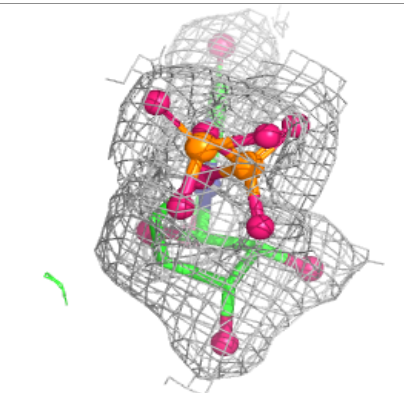
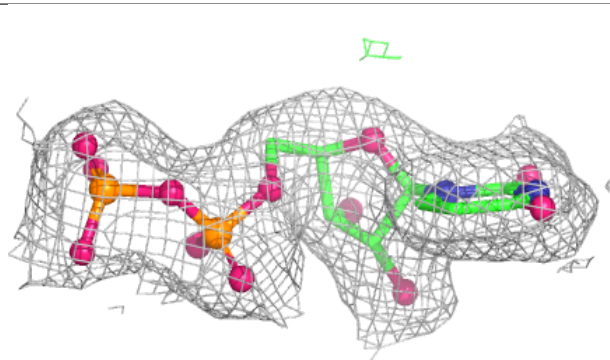
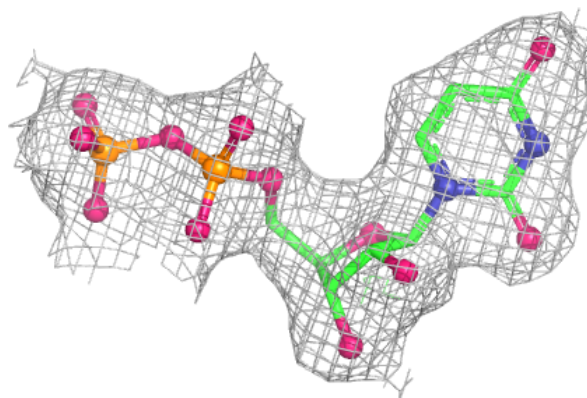


Electron density around UD2 E 1571:

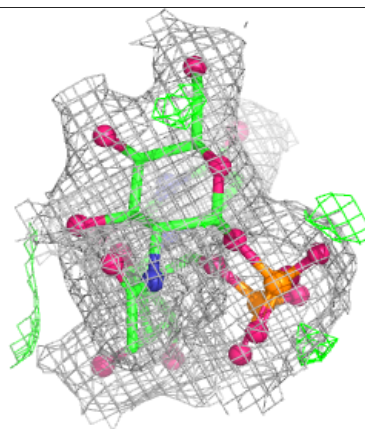
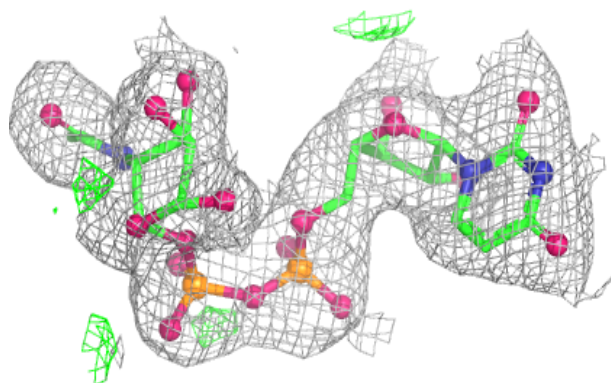
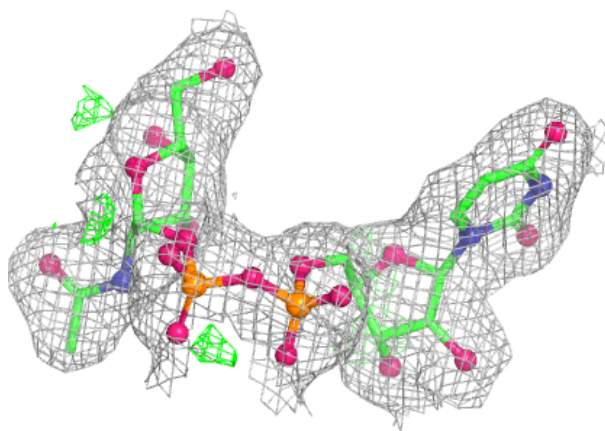
**Electron density around UDP C 1571:**
