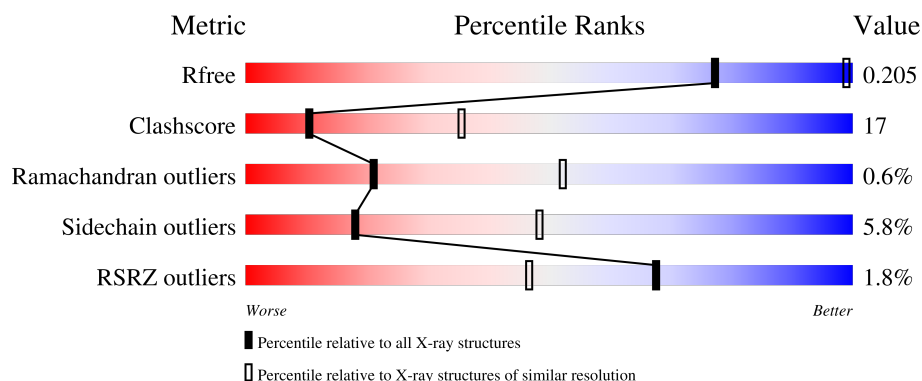
1 Overall quality at a glance

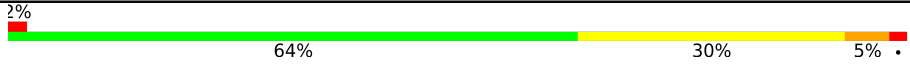
The reported resolution of this entry is 3.10 Å.

The red, orange, yellow and green segments of the lower bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the electron density. The numeric value is given above the bar.

2 Entry composition

There are 11 unique types of molecules in this entry. The entry contains 7293 atoms, of which 0 are hydrogens and 0 are deuteriums.

Xtriage's analysis on translational NCS is as follows: *The largest off-origin peak in the Patterson function is 3.00% of the height of the origin peak. No significant pseudotranslation is detected.*

²Theoretical values of $\langle |L| \rangle$, $\langle L^2 \rangle$ for acentric reflections are 0.5, 0.333 respectively for untwinned datasets, and 0.375, 0.2 for perfectly twinned datasets.

5 Model quality ⓘ

5.1 Standard geometry ⓘ

Bond lengths and bond angles in the following residue types are not validated in this section: U10, CDL, BCL, LDA, SPN, BPH, FE

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

If the average RMSD is greater than 60 degrees and the minimal RMSD between the ring in question and any Mogul-identified rings is also greater than 60 degrees, then that ring is considered an outlier. The outliers are highlighted in purple. The color gray indicates Mogul did not find sufficient equivalents in the CSD to analyse the geometry.

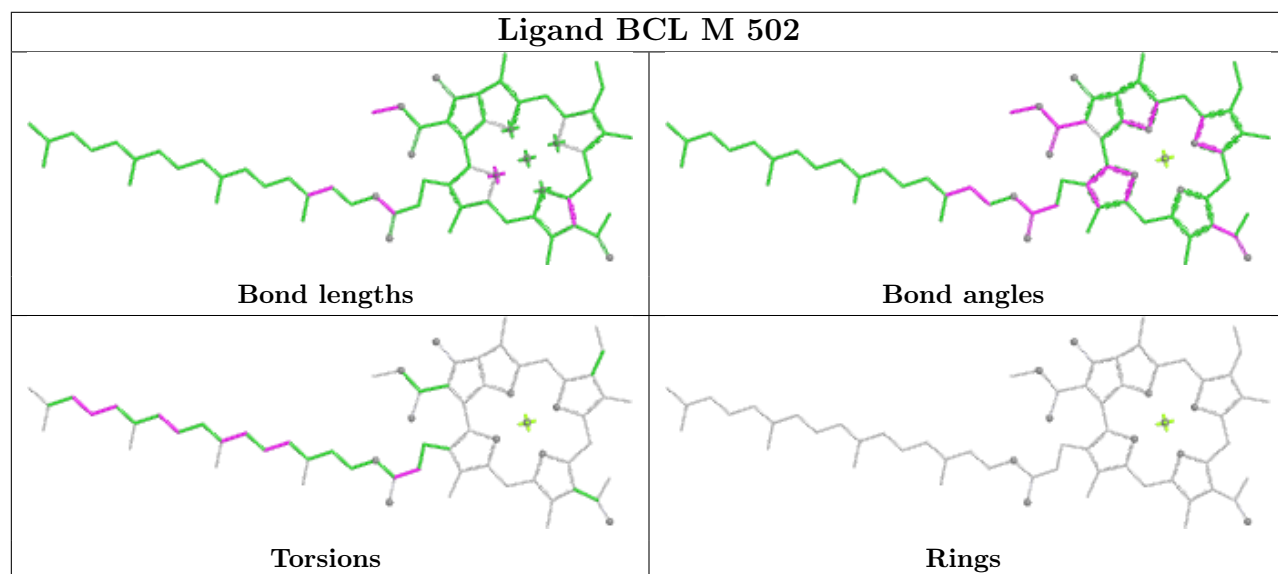


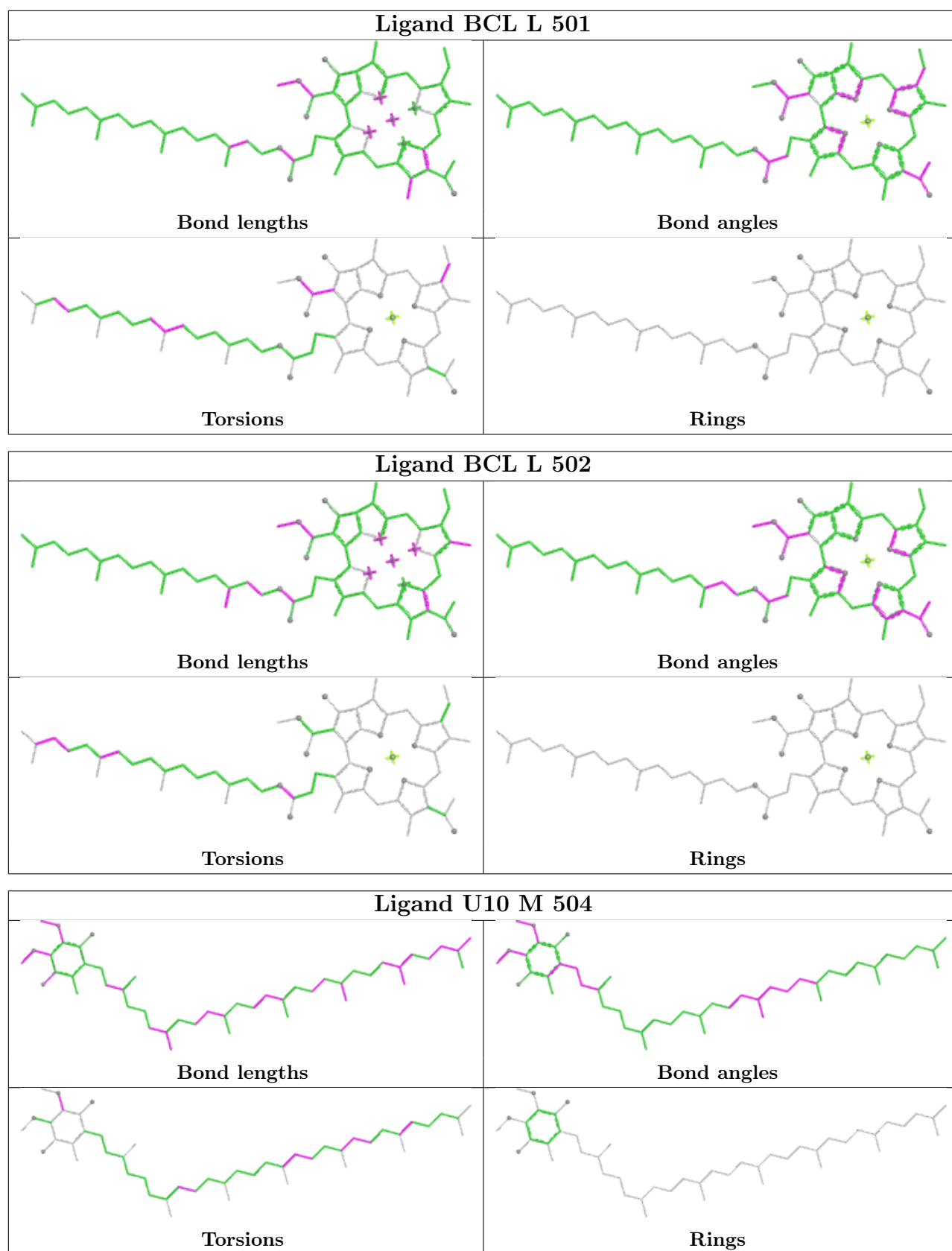


Ligand BPH L 503

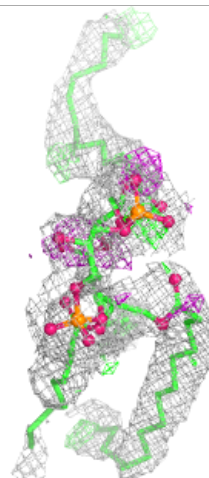
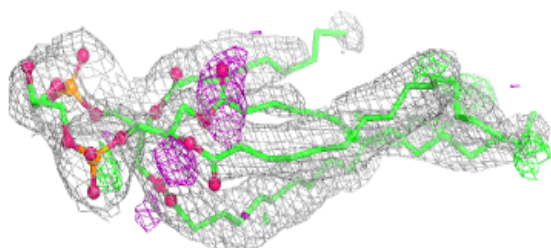
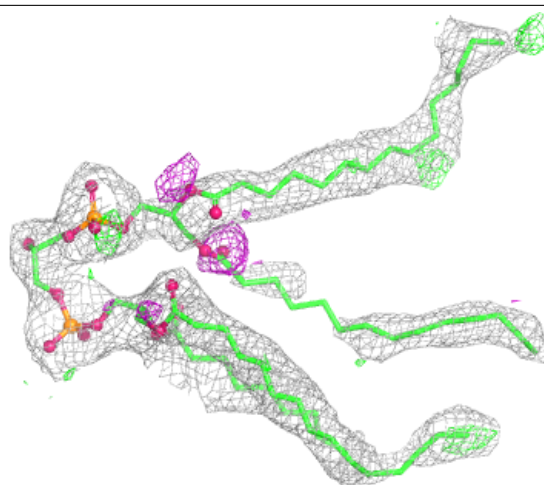
Electron density around U10 L 504:

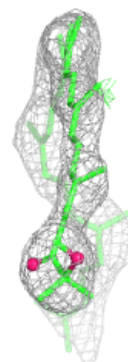
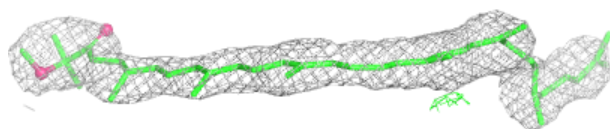
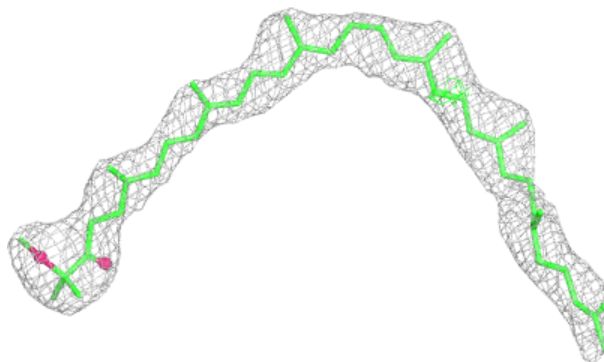
Electron density around CDL M 800:

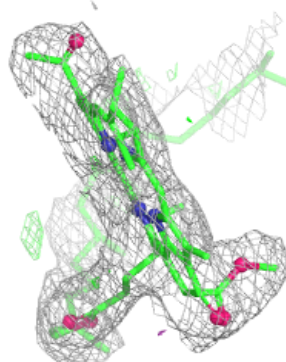
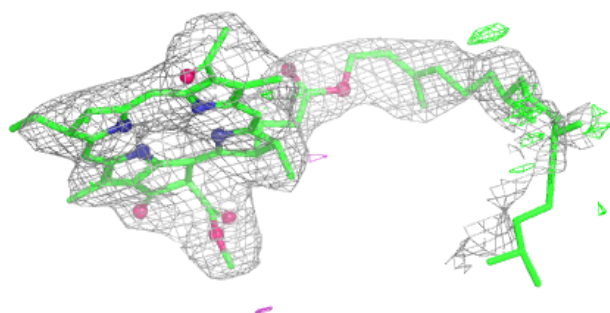
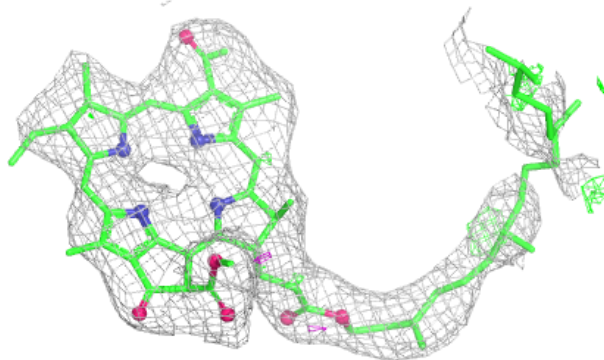


Electron density around SPN M 600:
