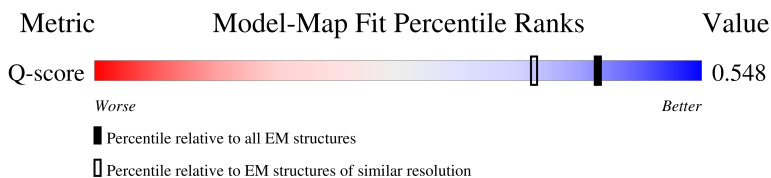
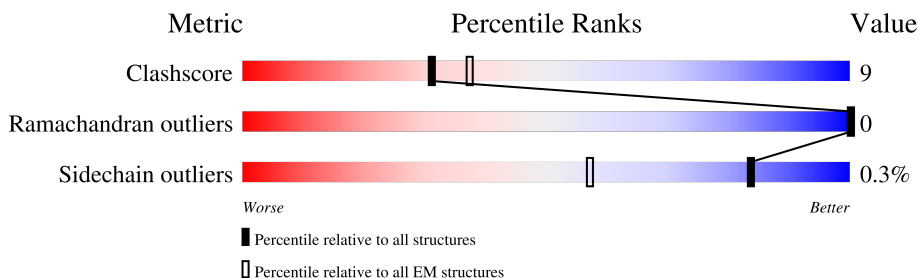
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 2.89 Å.

A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

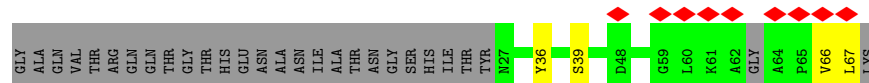
• Molecule 4: Capsid protein VP3

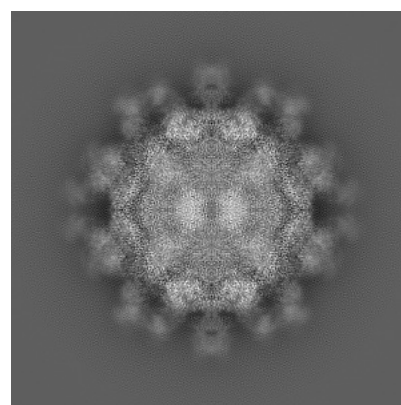

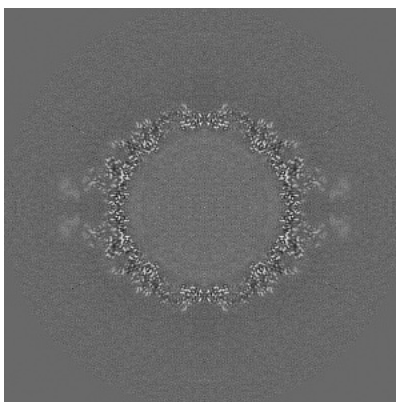
The images above show the map projected in three orthogonal directions.

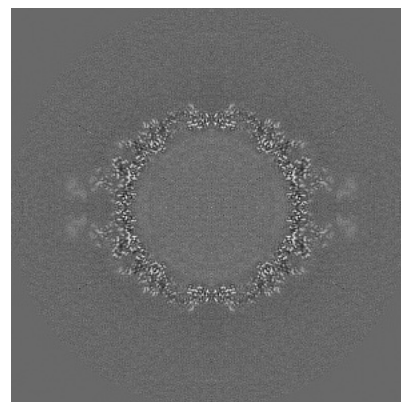

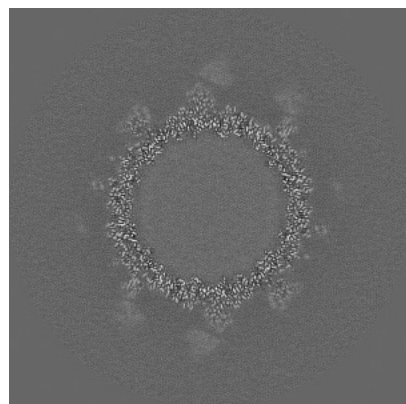

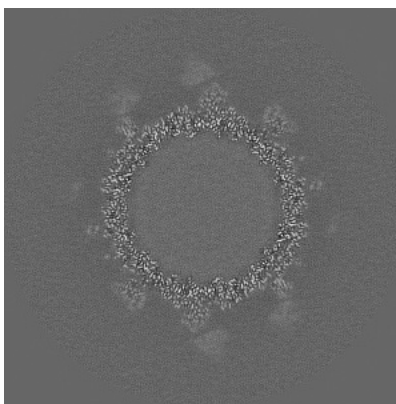
The images above show central slices of the map in three orthogonal directions.

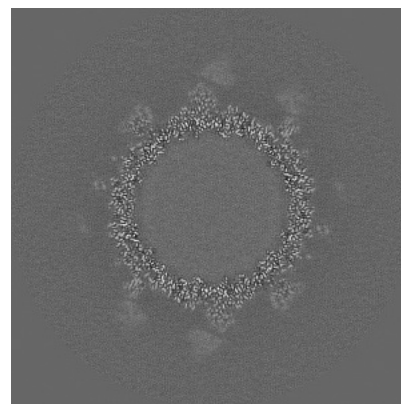

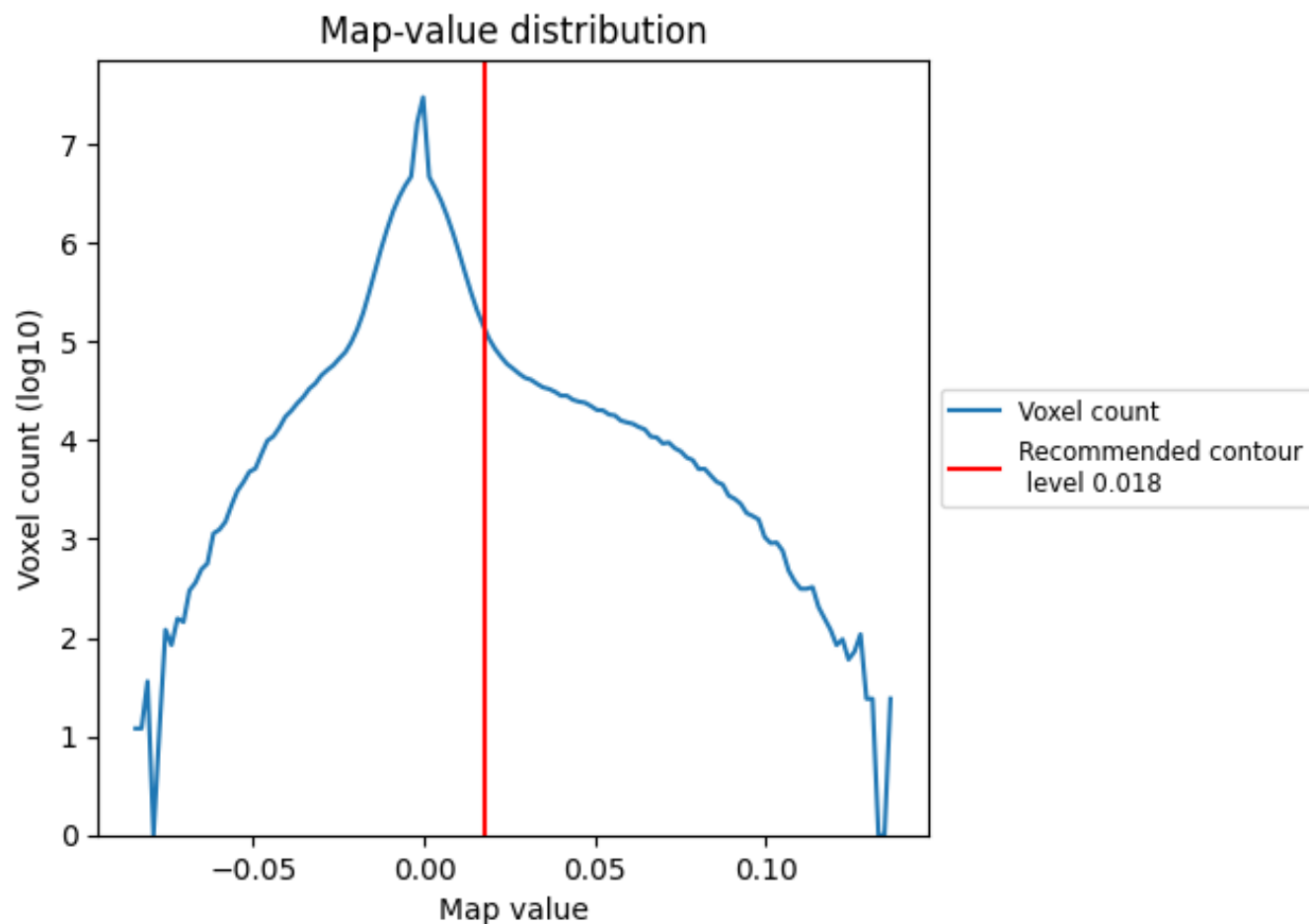

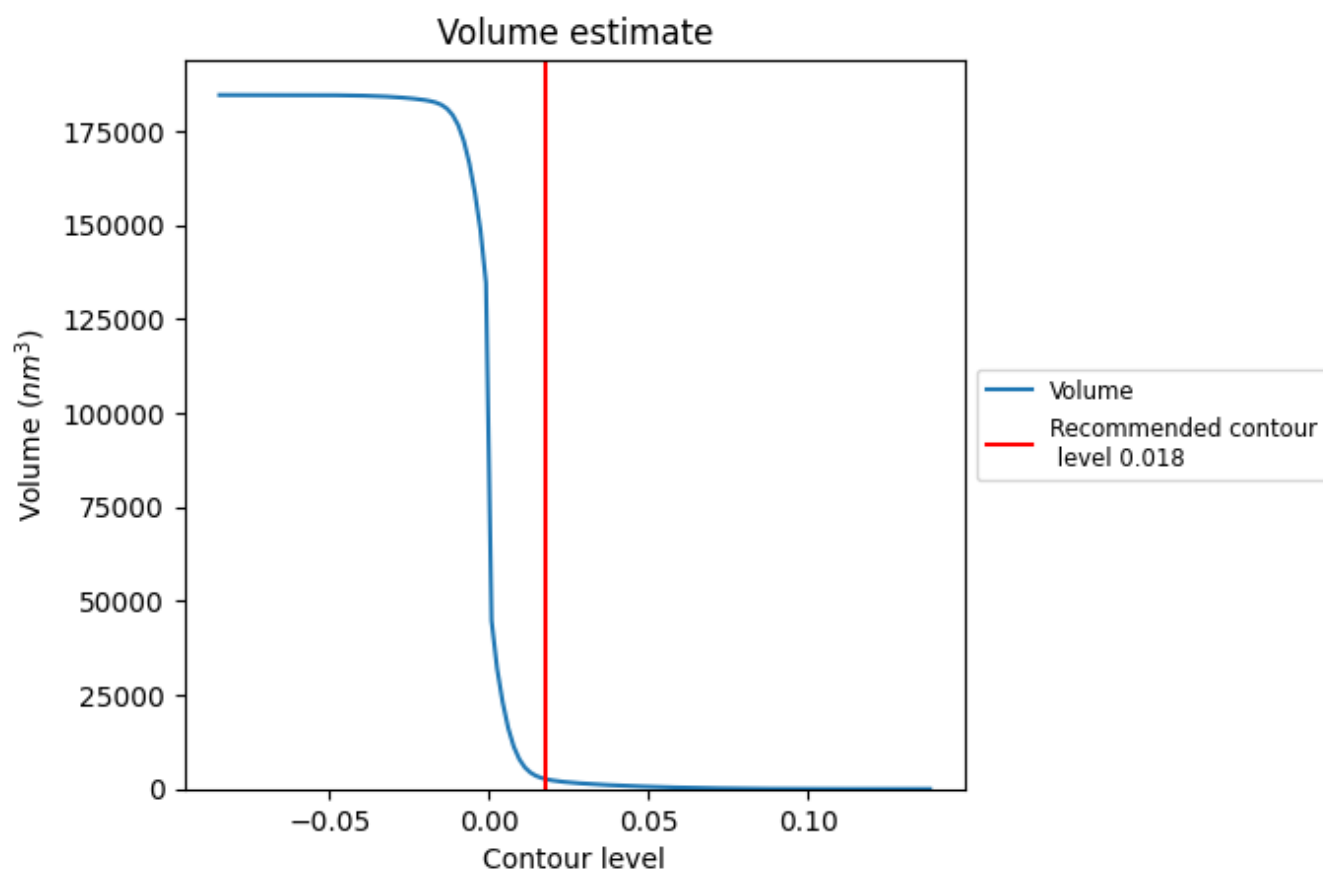

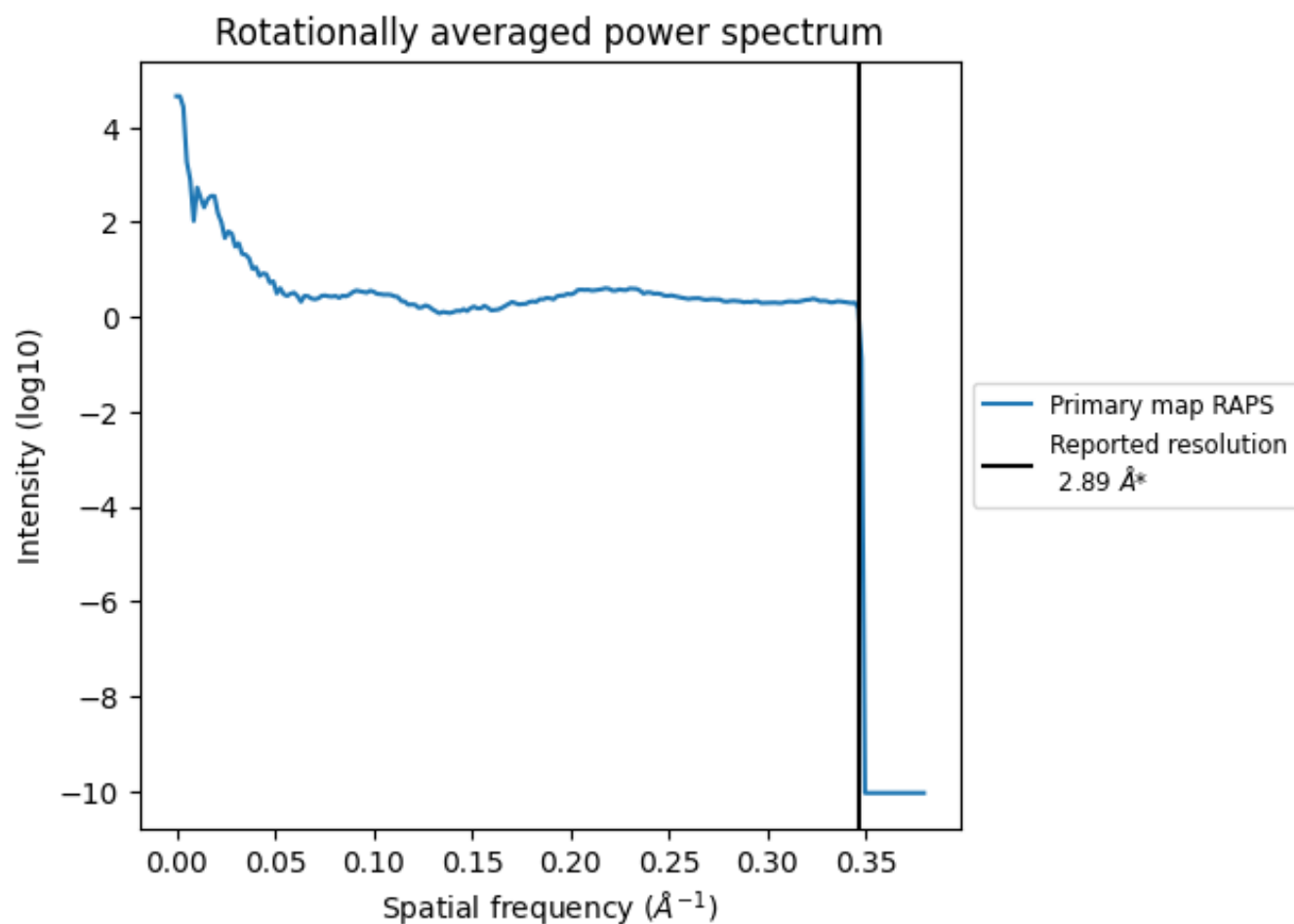
7.2 Volume estimate [i](#)

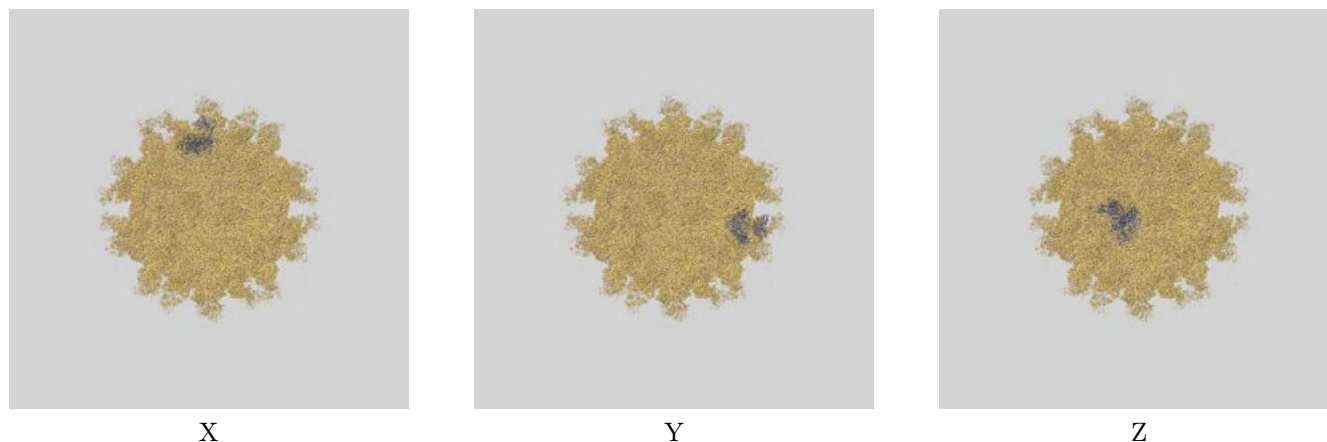

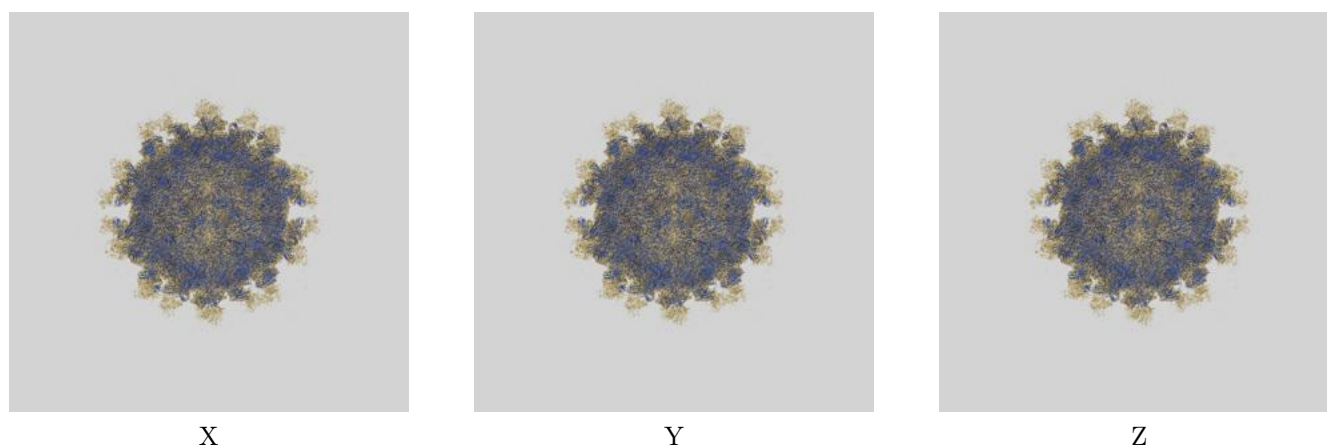

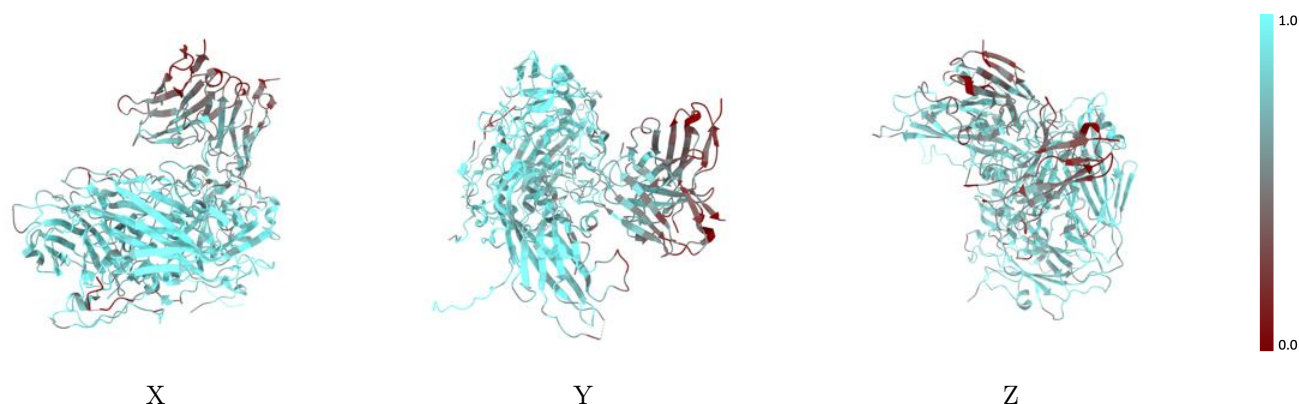

9.2 Q-score mapped to coordinate model [i](#)



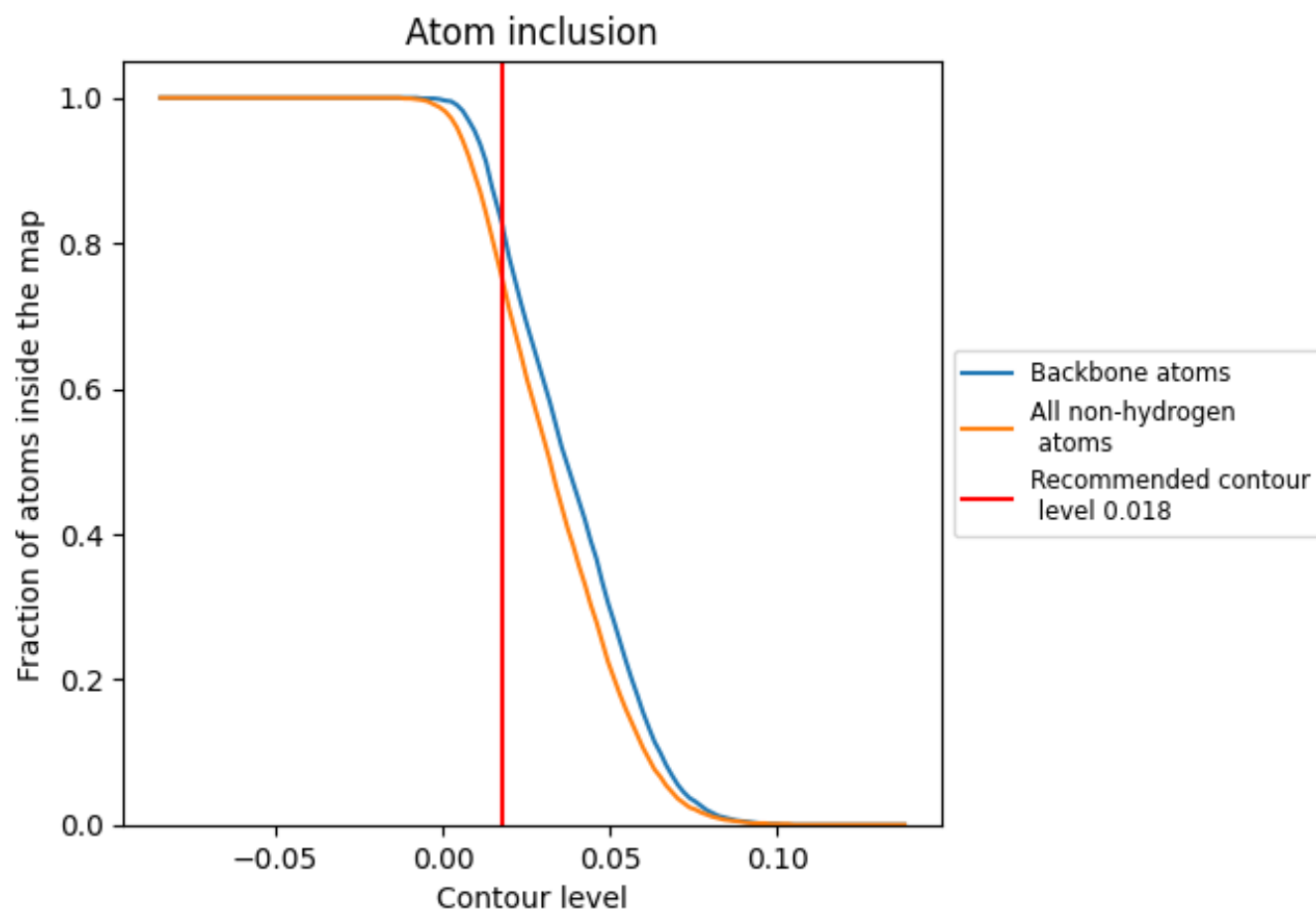
The images above show the model with each residue coloured according to its Q-score. This shows their resolvability in the map with higher Q-score values reflecting better resolvability.
