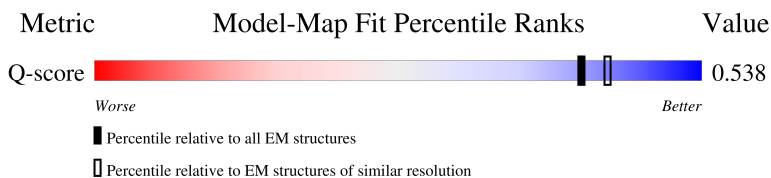
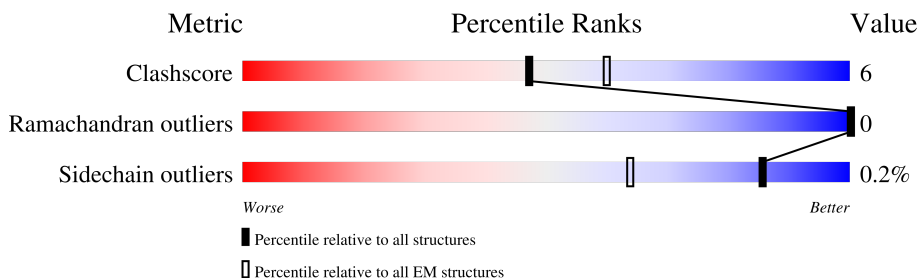
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 3.28 Å.

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

There are 2 unique types of molecules in this entry. The entry contains 29624 atoms, of which 0 are hydrogens and 0 are deuteriums.

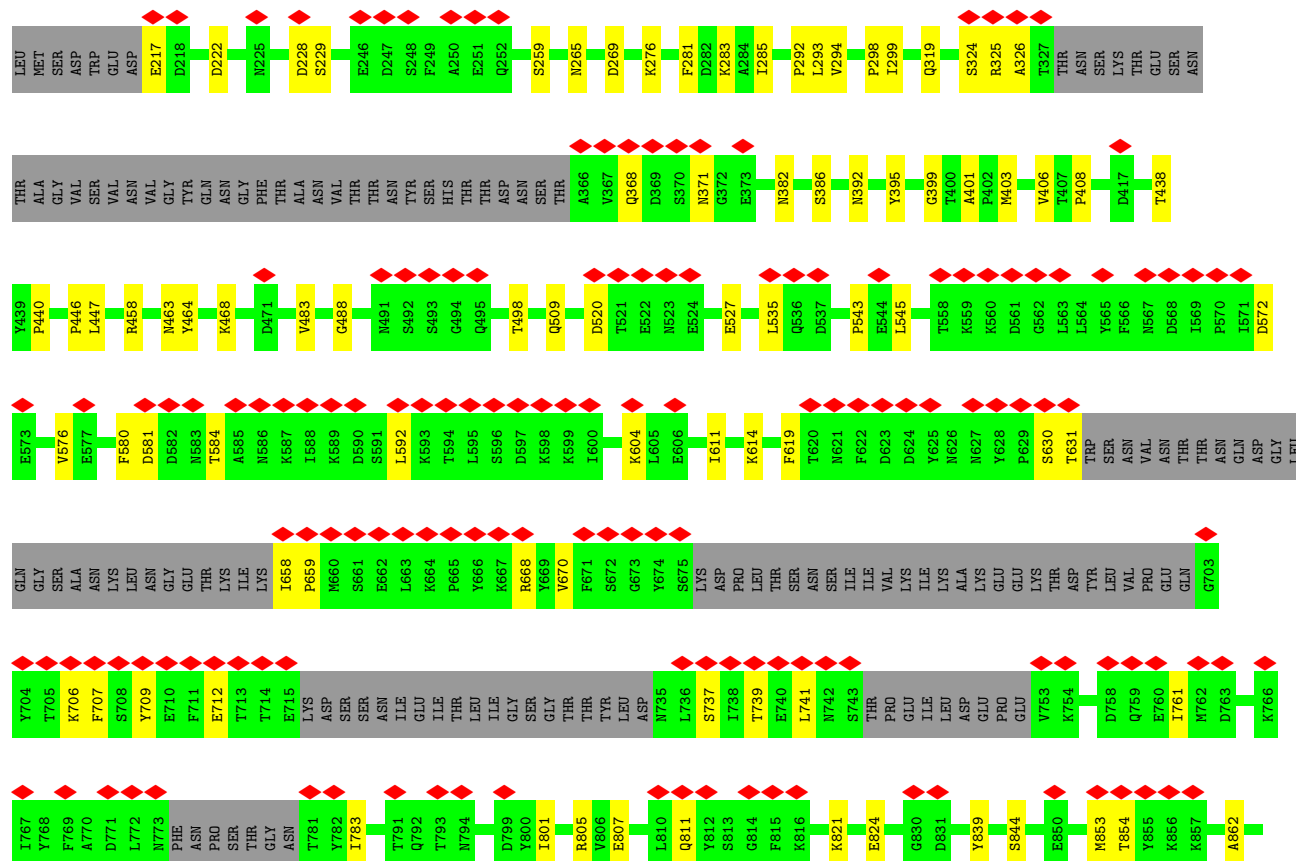

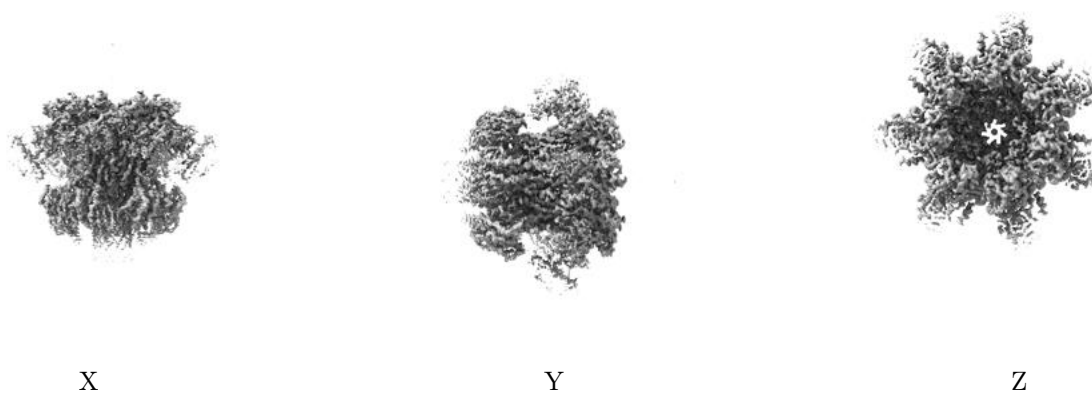

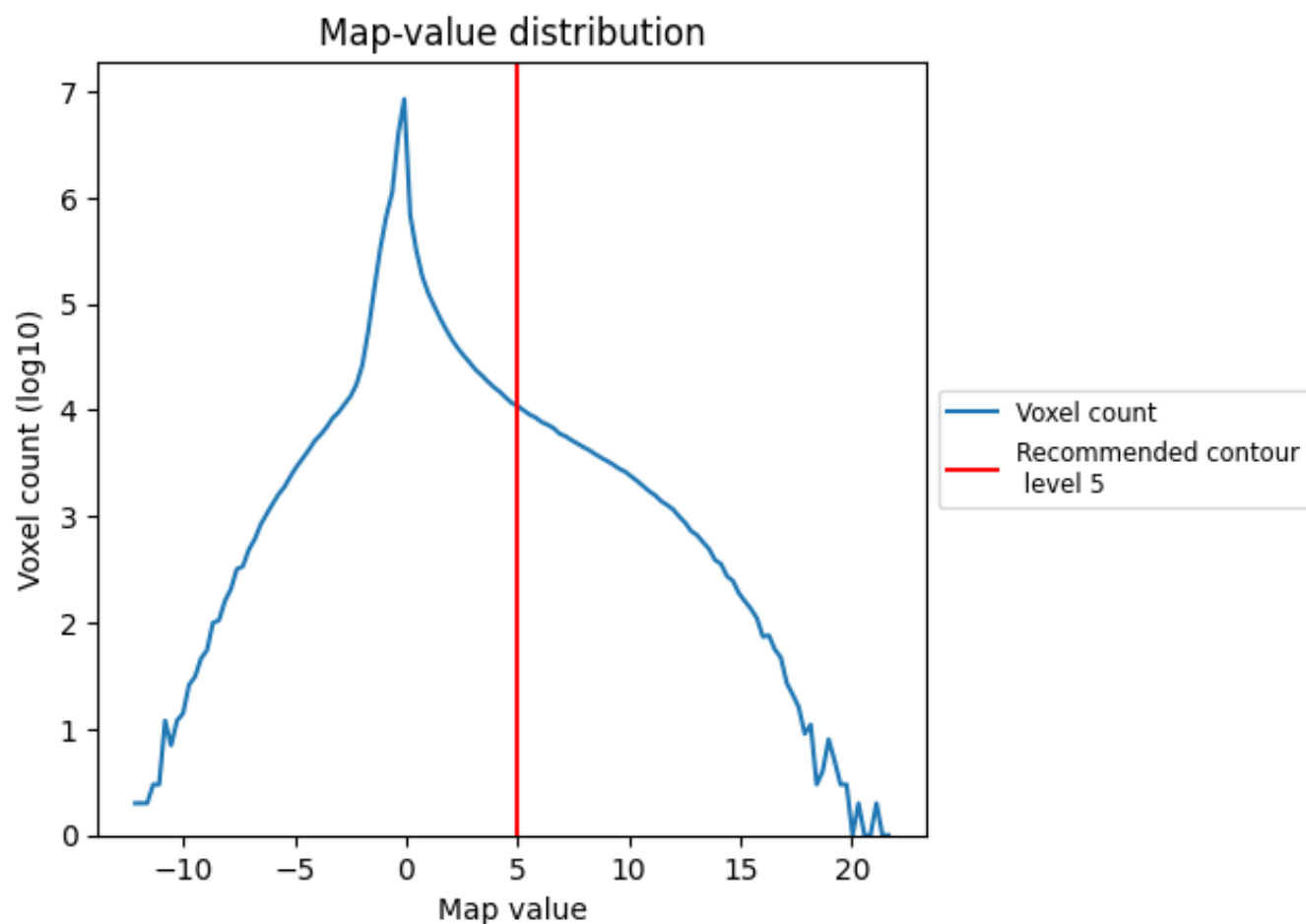

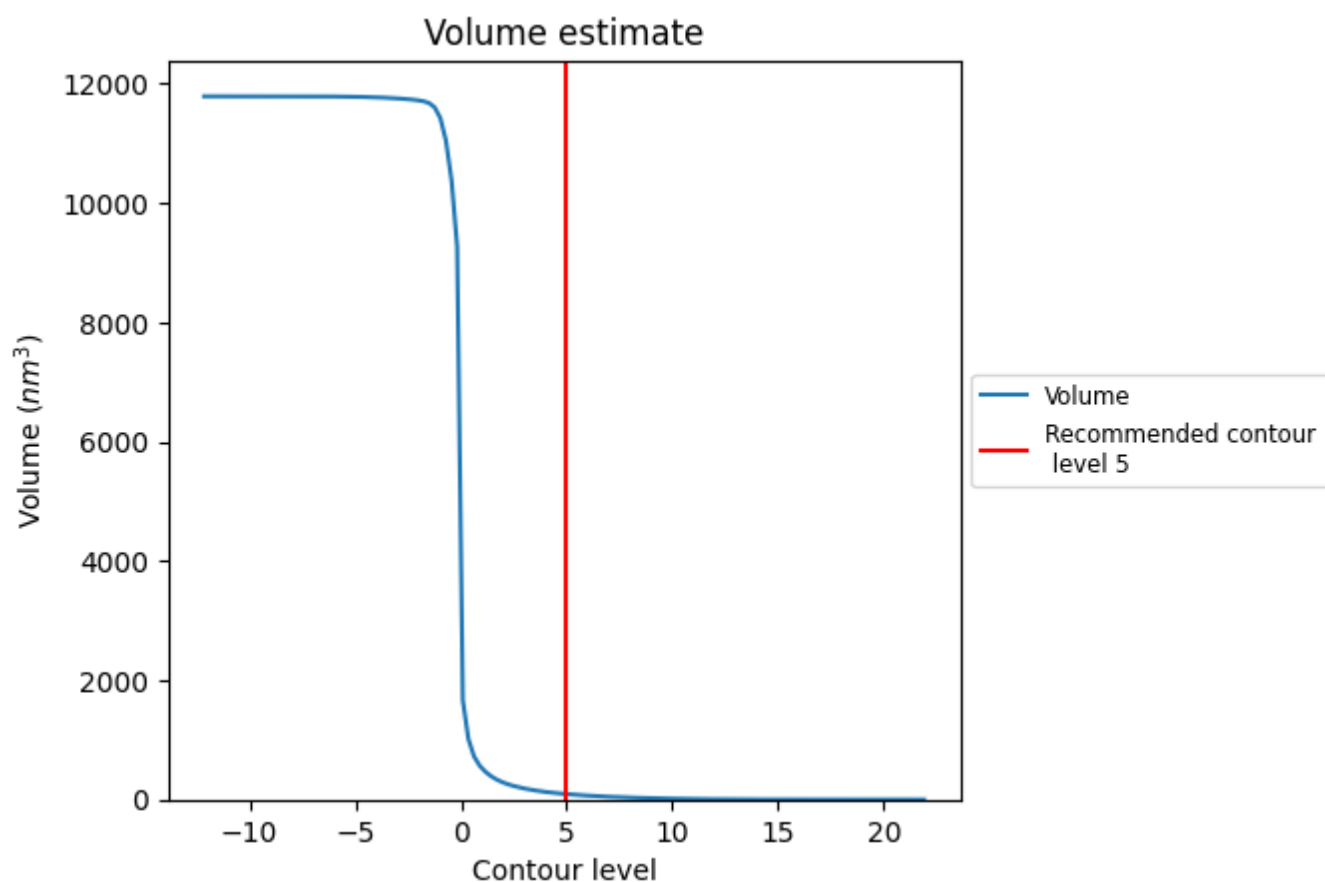

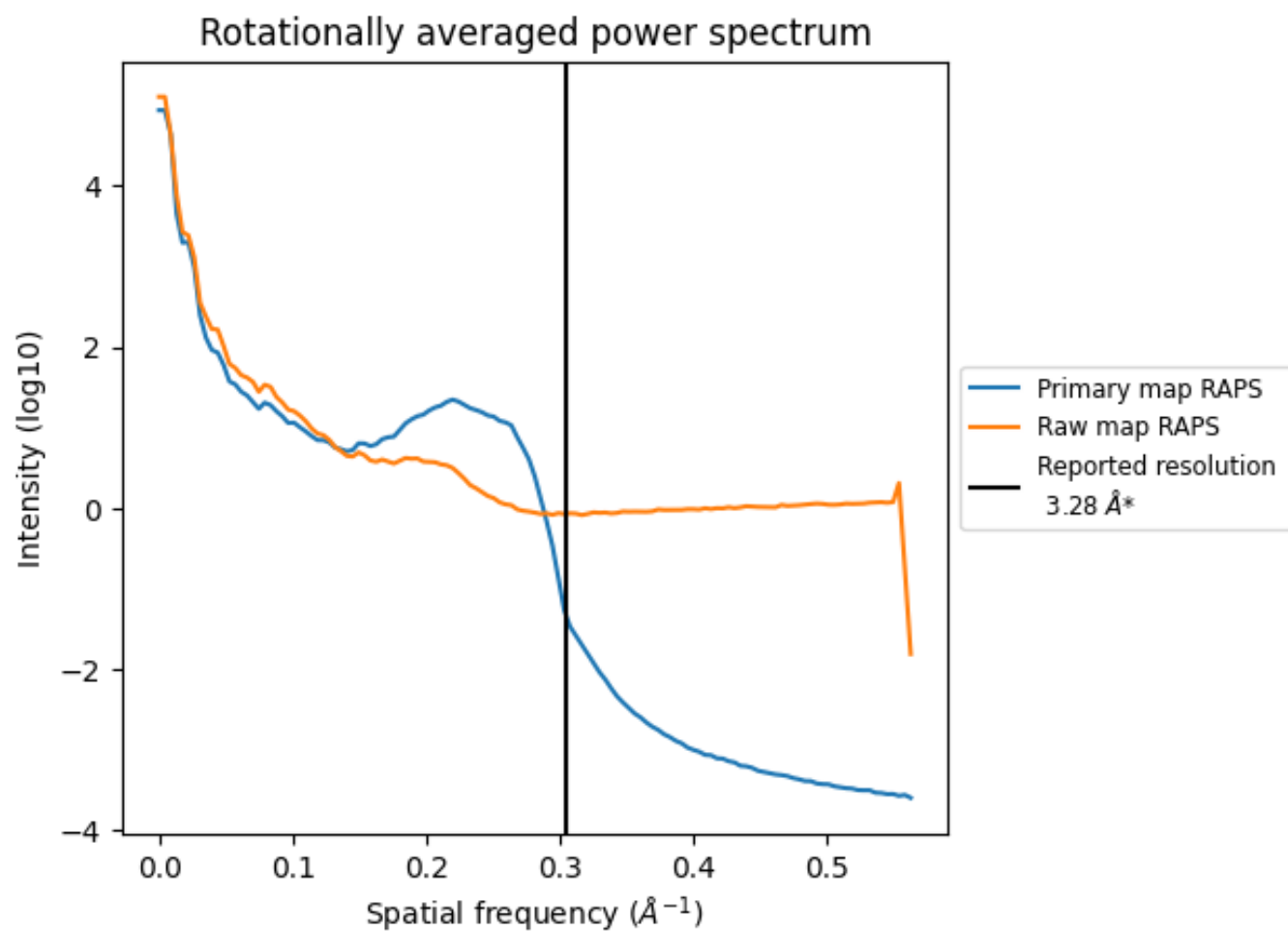

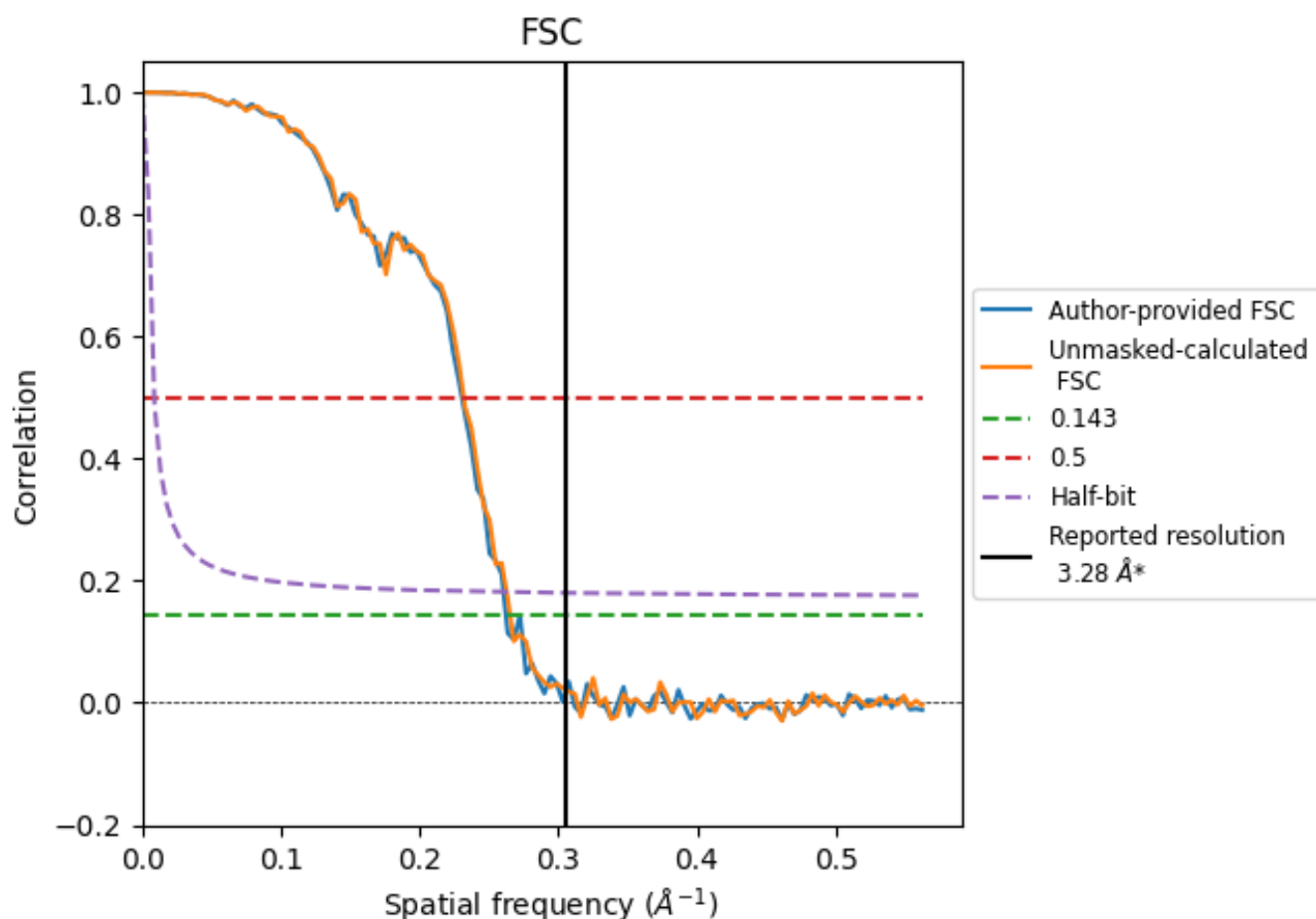

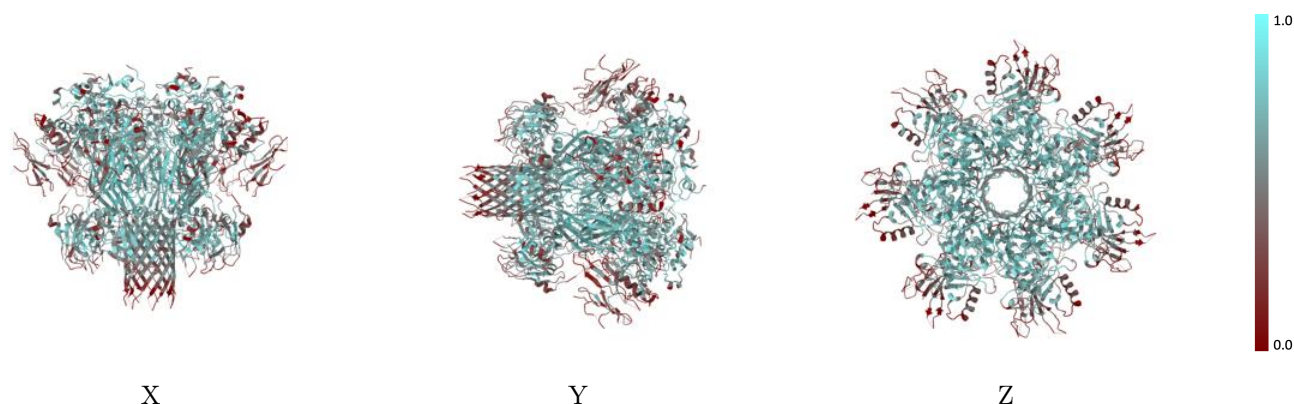

9.2 Q-score mapped to coordinate model [i](#)



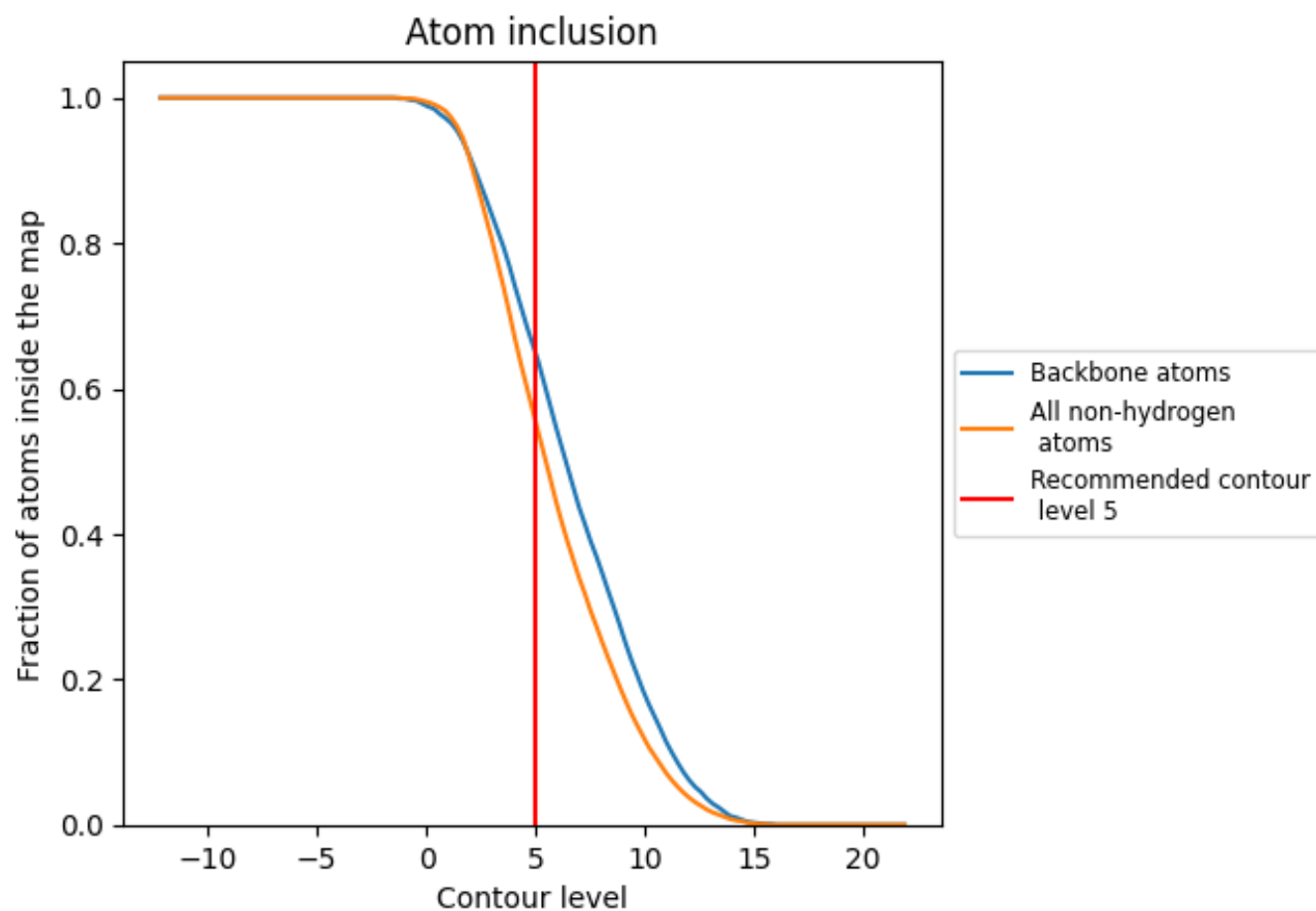
