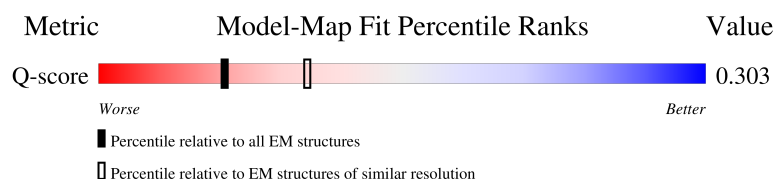
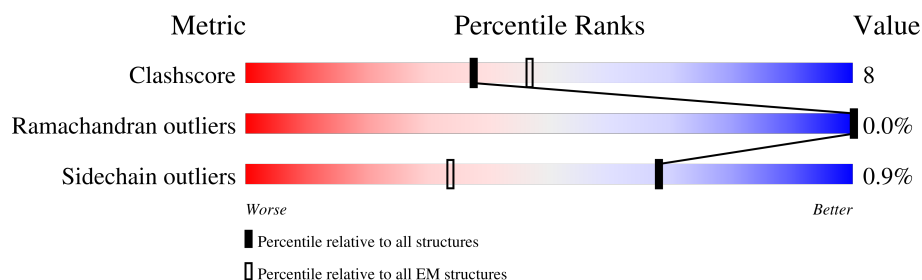

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

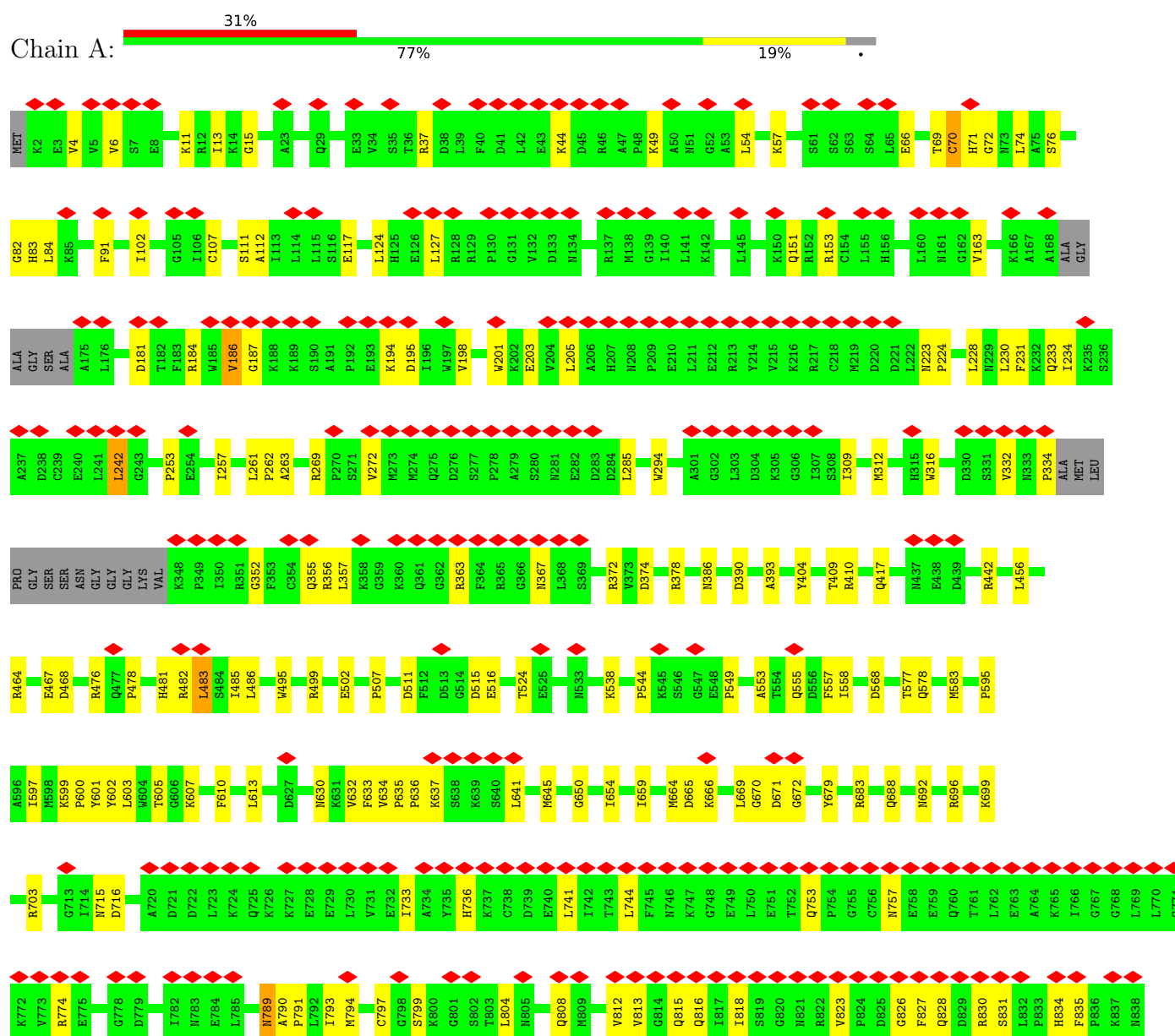

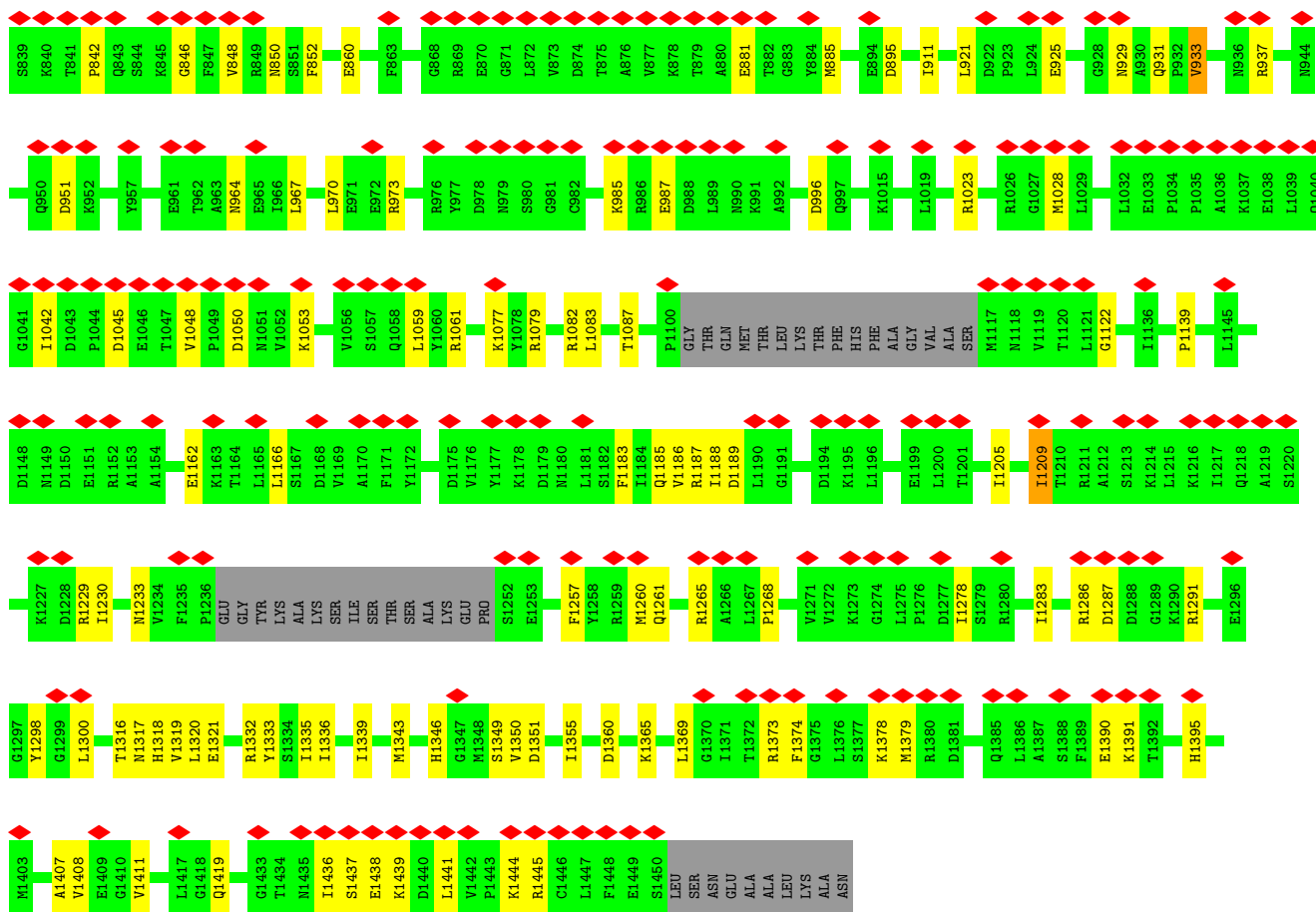

3 Residue-property plots

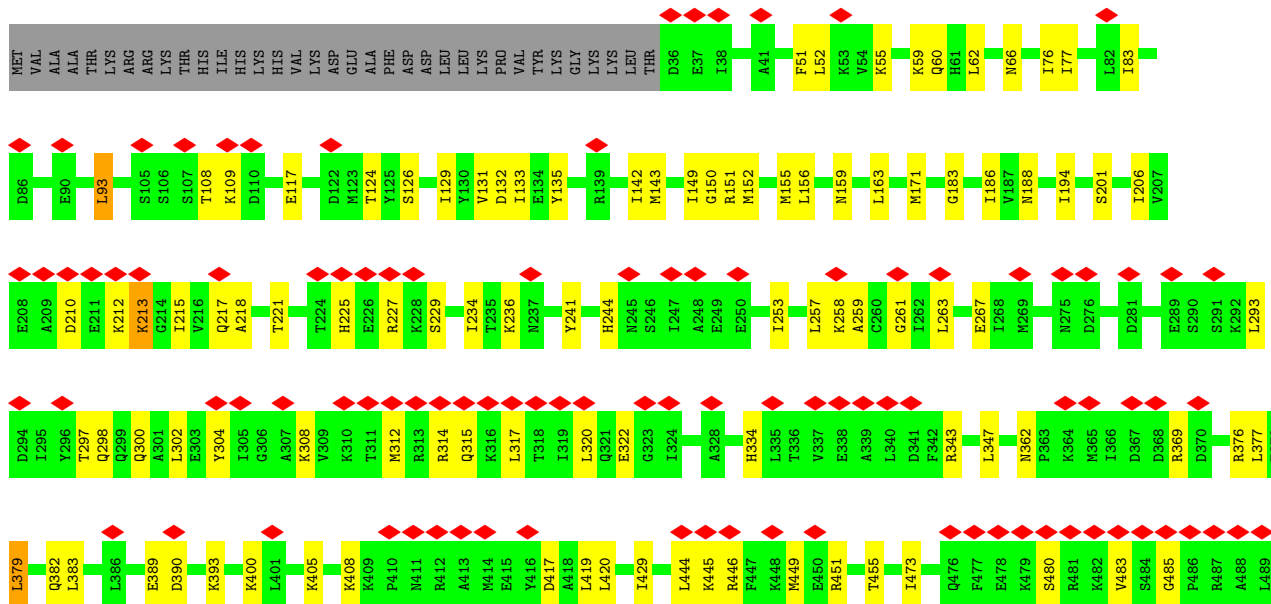
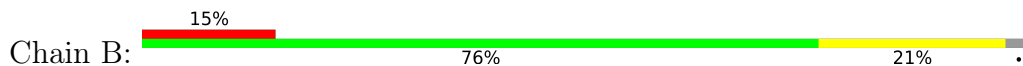
These plots are drawn for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic for a chain summarises the proportions of the various outlier classes displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry and atom inclusion in map density. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. A red diamond above a residue indicates a poor fit to the EM map for this residue (all-atom inclusion < 40%). Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.

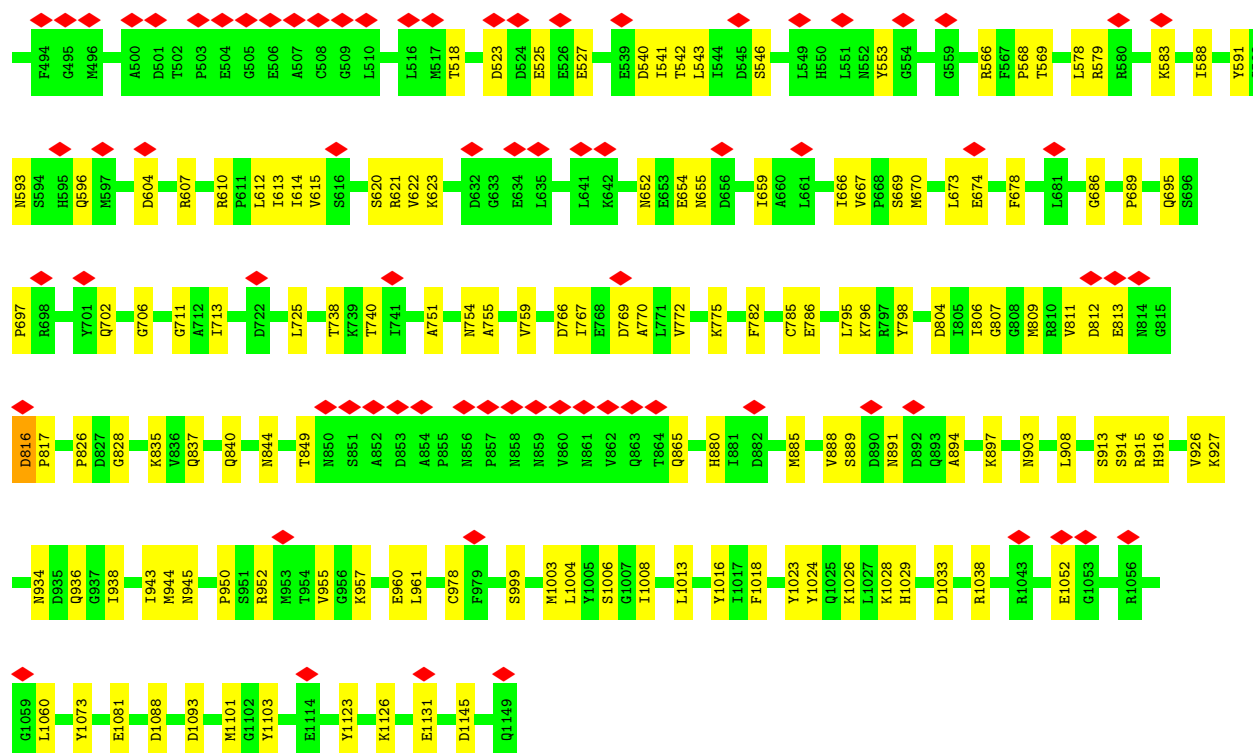
- Molecule 1: DNA-directed RNA polymerase III subunit RPC1



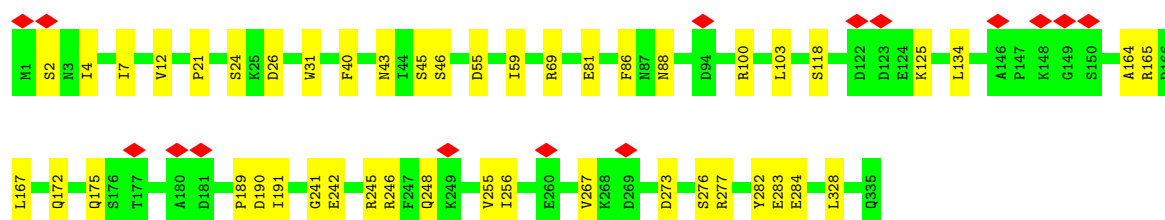
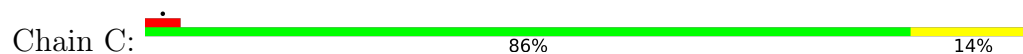


• Molecule 2: DNA-directed RNA polymerase III subunit RPC2

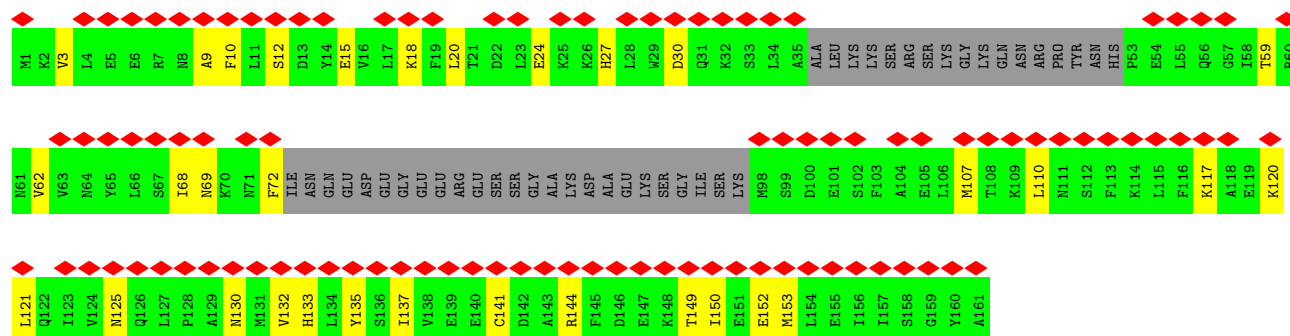




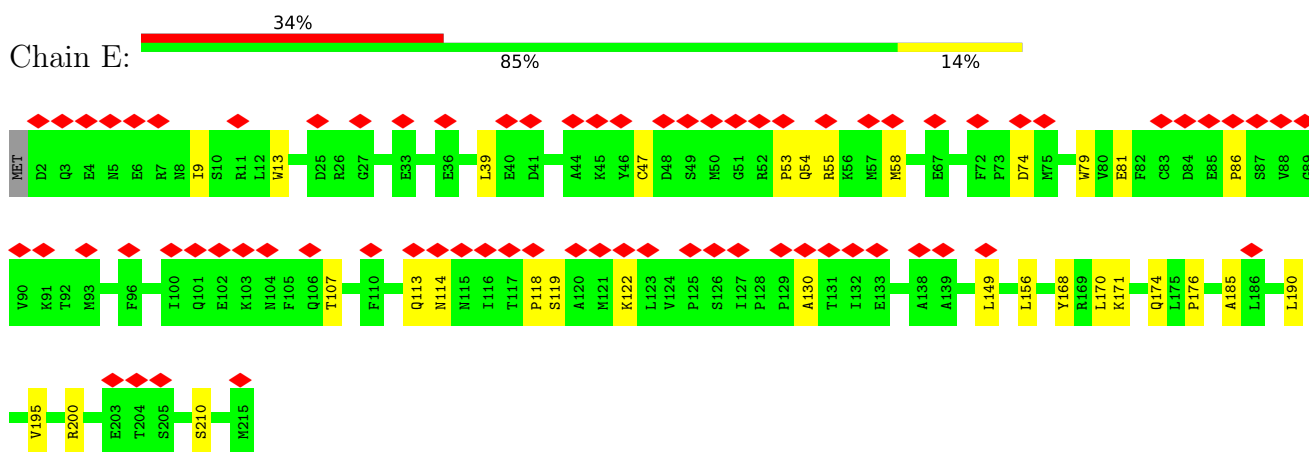
• Molecule 3: DNA-directed RNA polymerases I and III subunit RPAC1



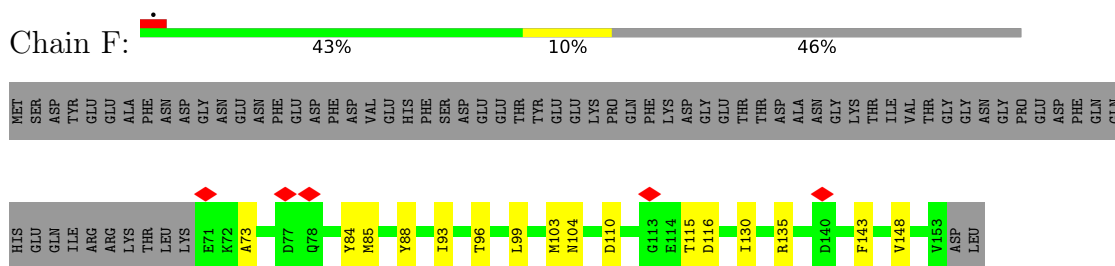

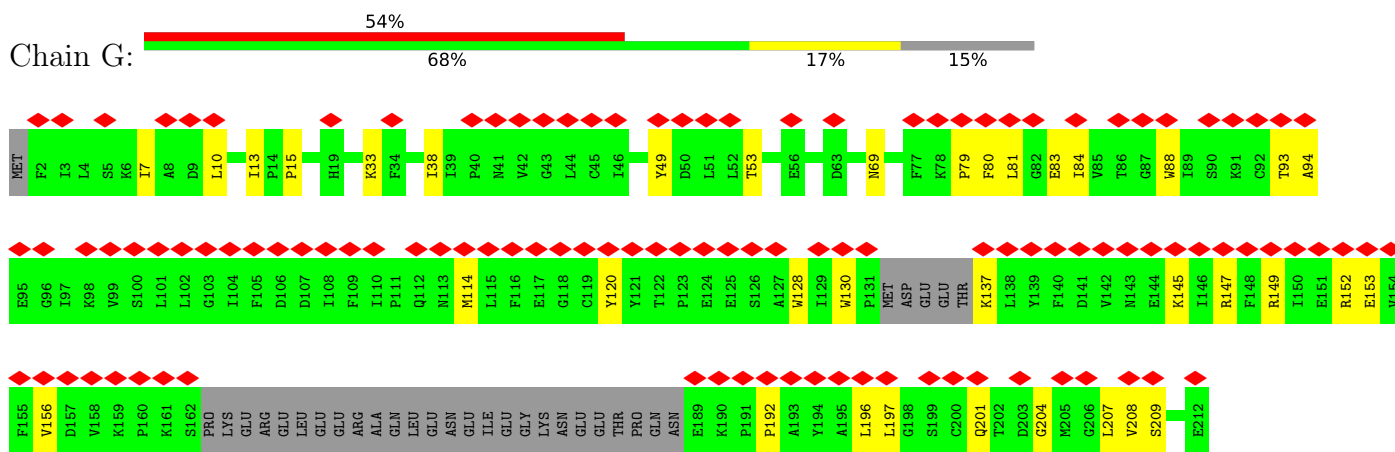

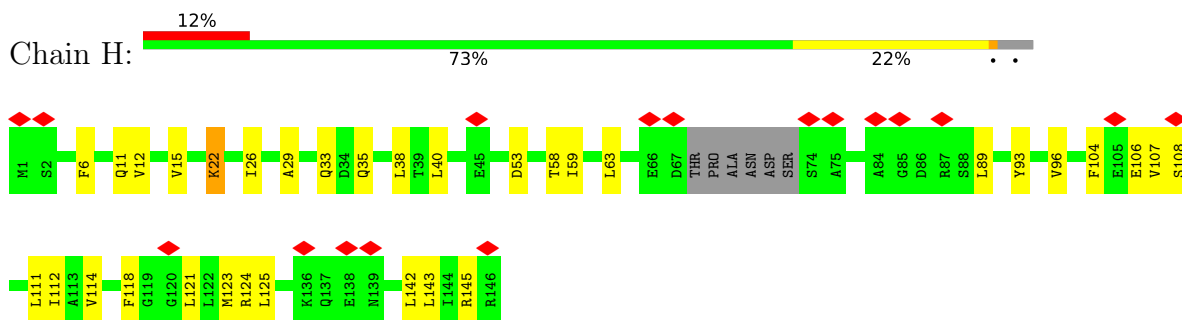

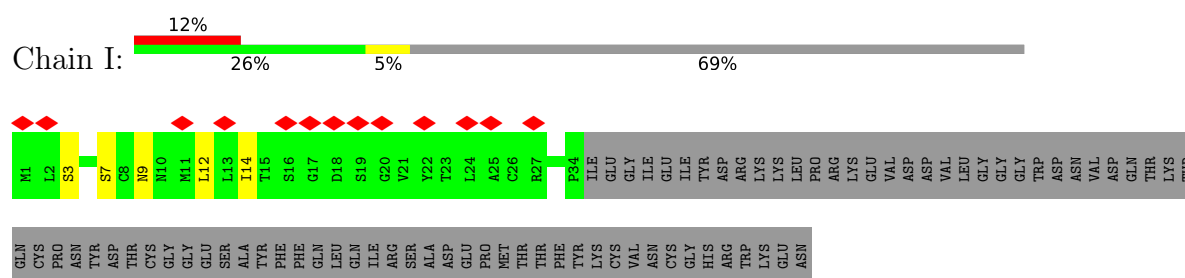

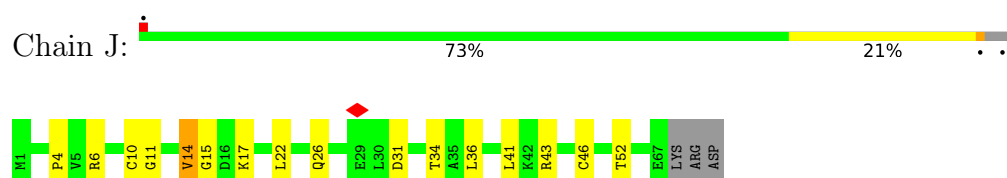

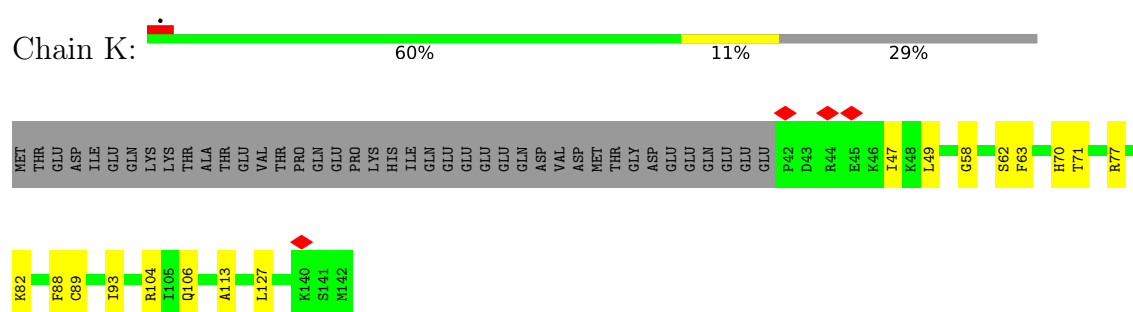

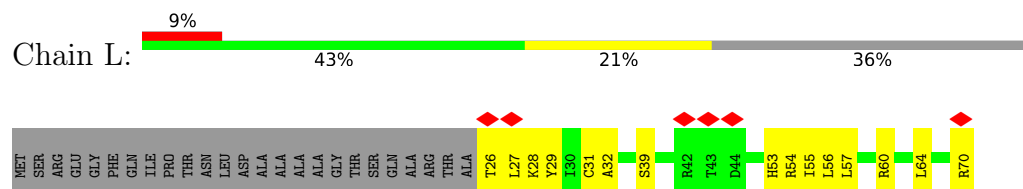

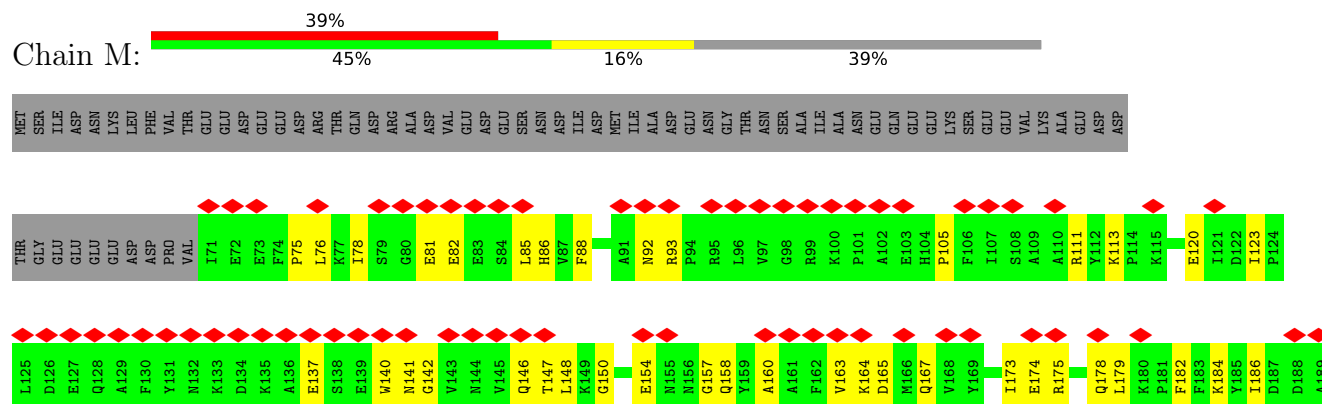
- Molecule 11: DNA-directed RNA polymerases I and III subunit RPAC2

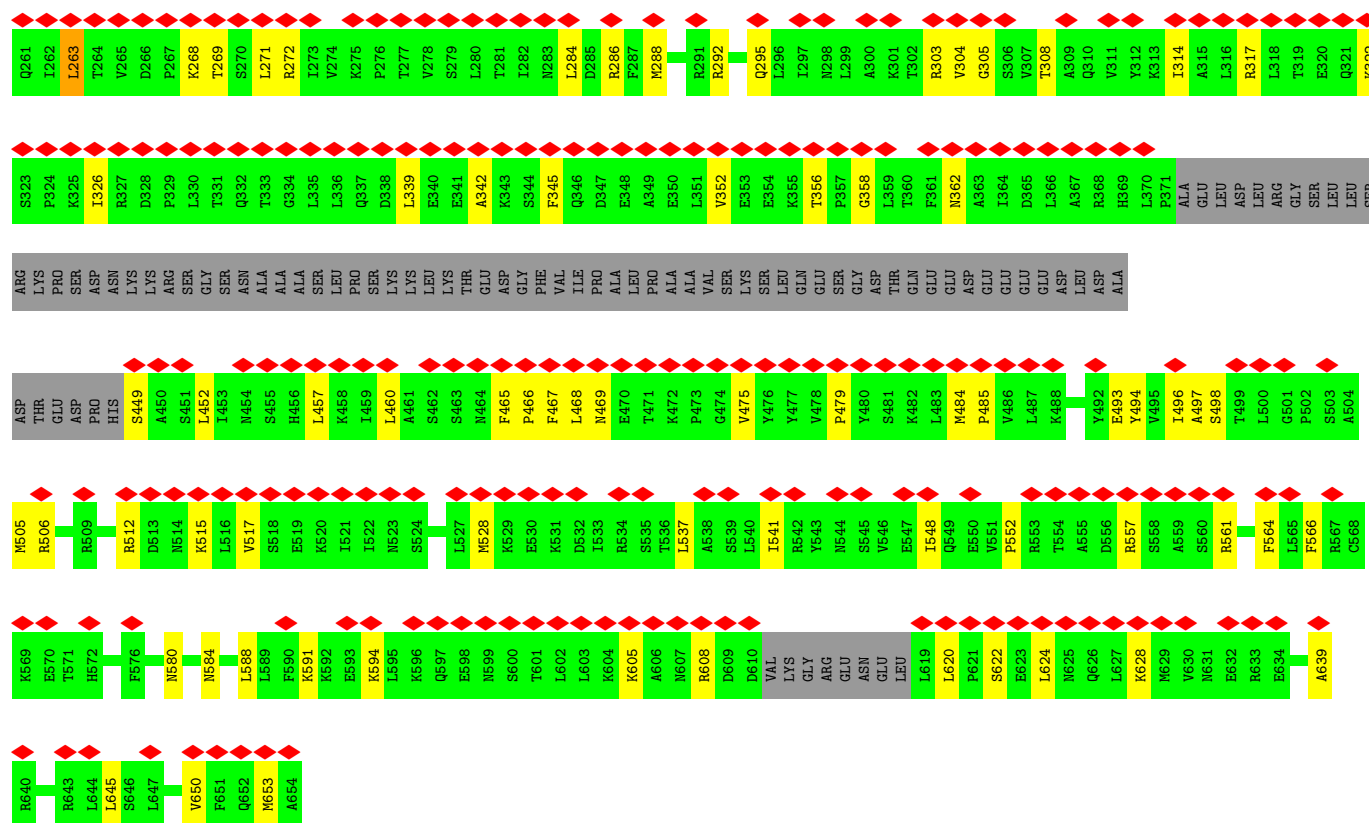


- Molecule 12: DNA-directed RNA polymerases I, II, and III subunit RPABC4

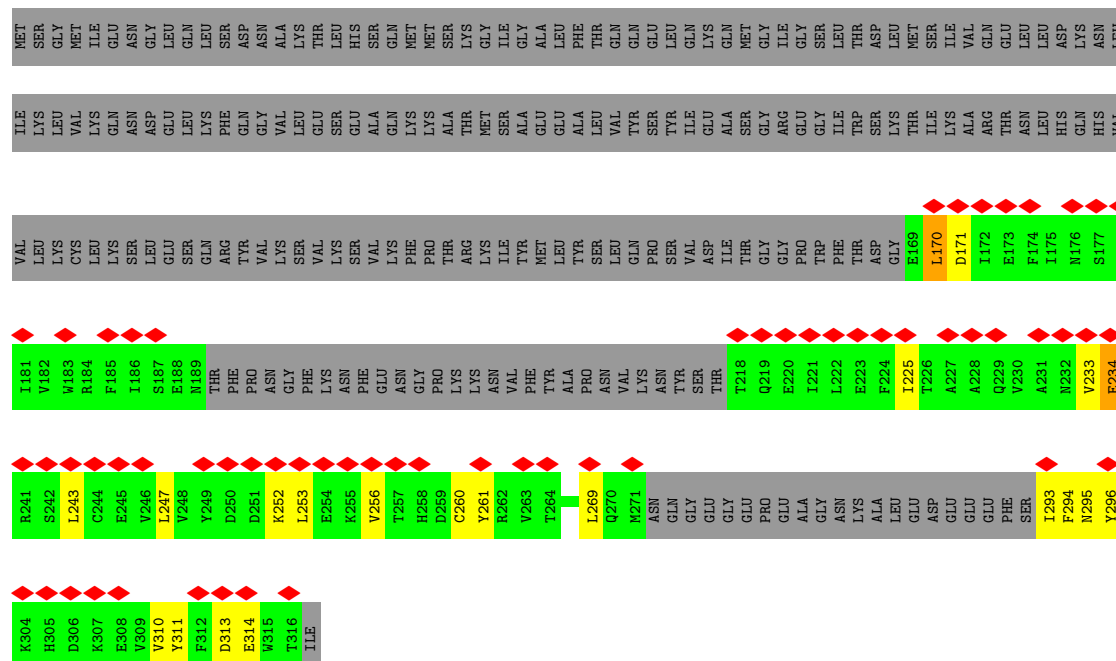


- Molecule 13: DNA-directed RNA polymerase III subunit RPC5

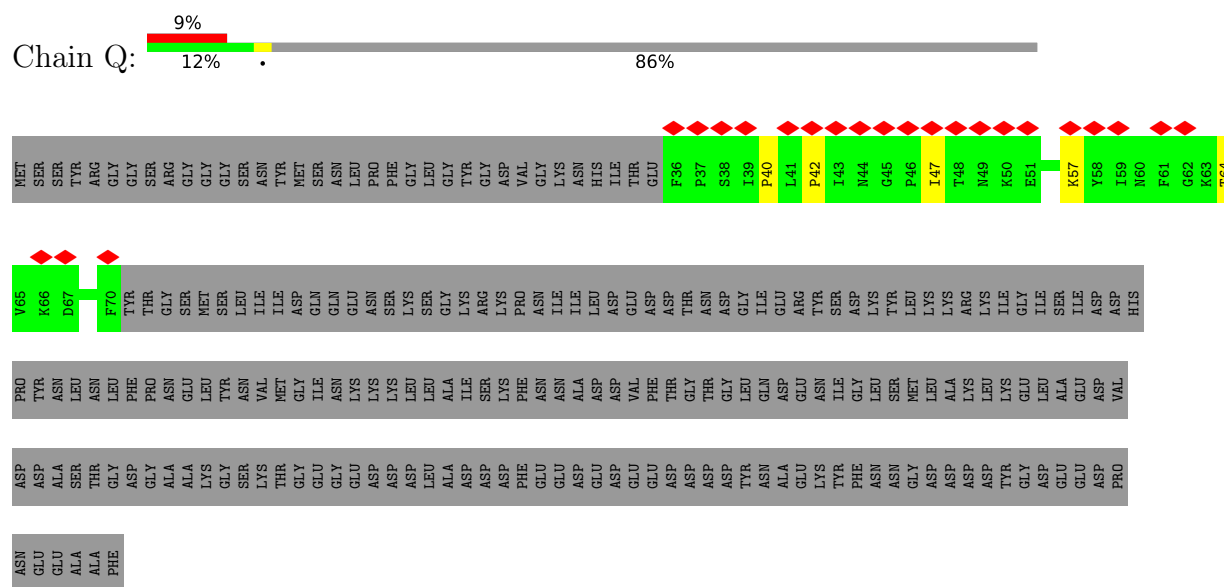




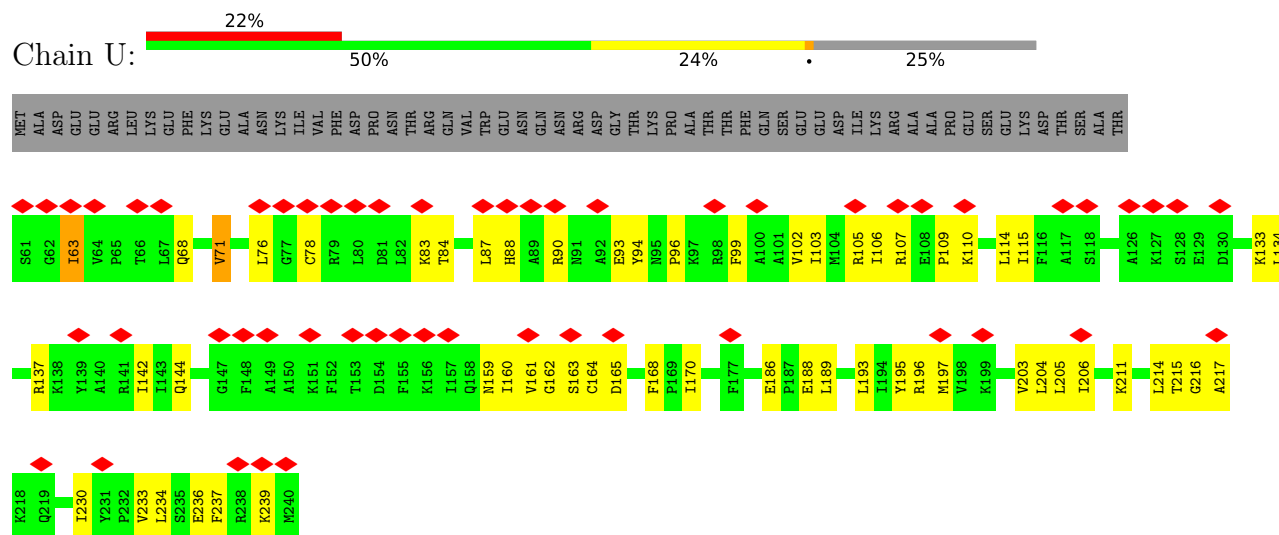

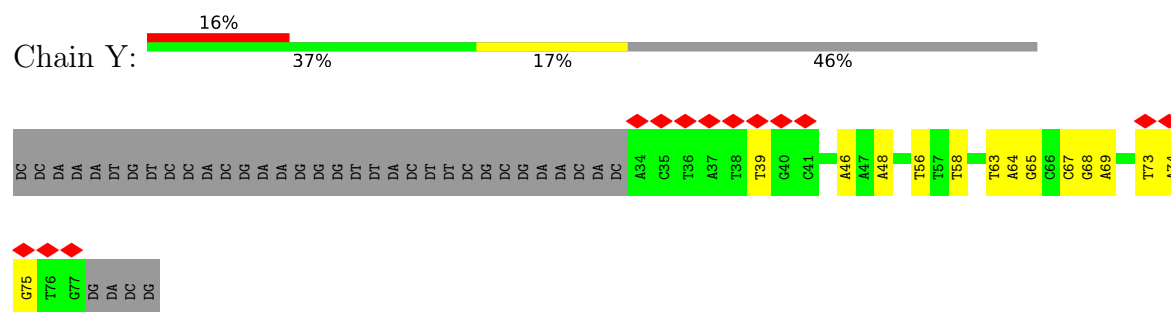
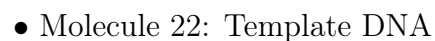


- Molecule 18: TATA-box-binding protein

5.1 Standard geometry

A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

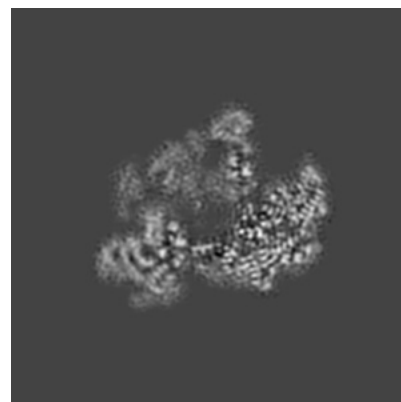

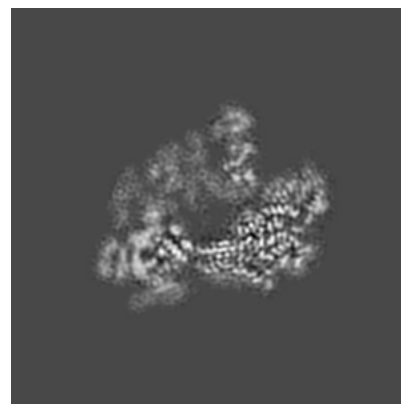

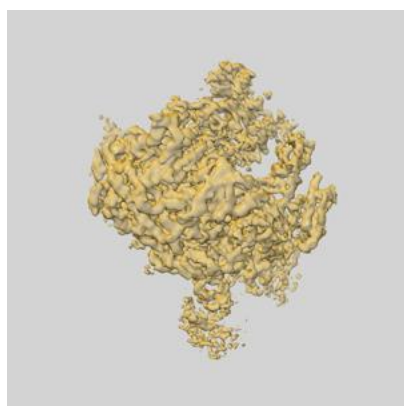

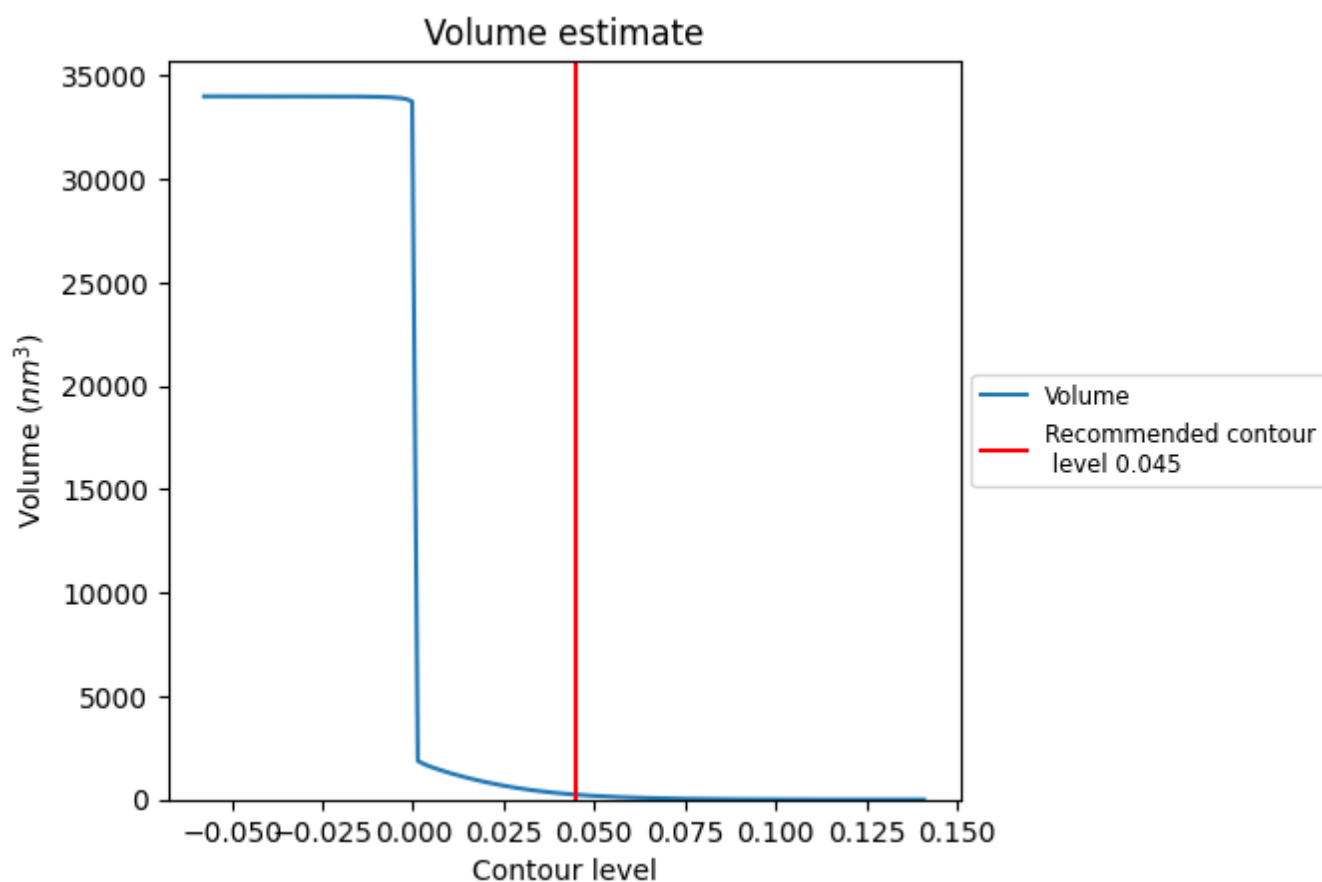

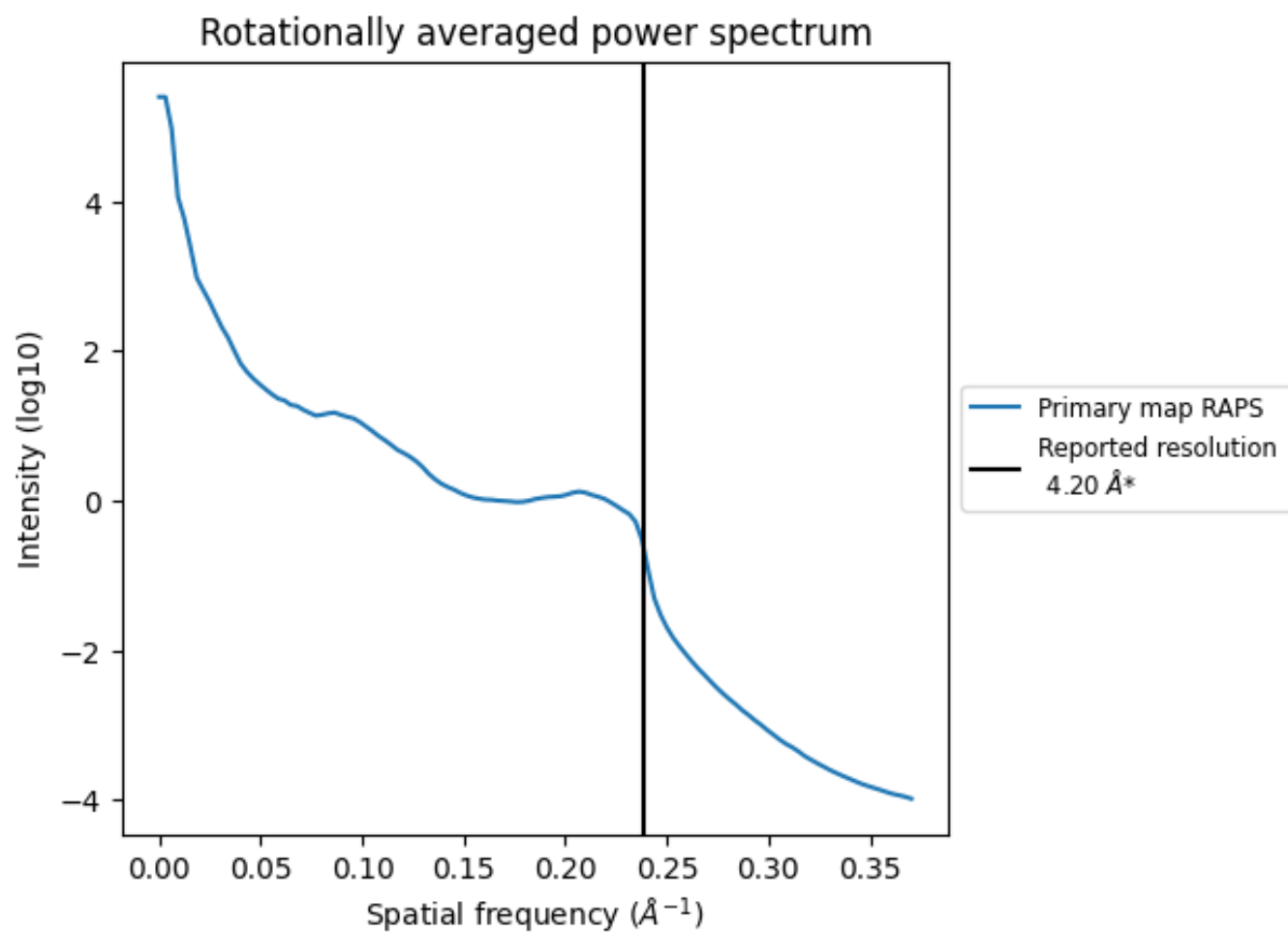

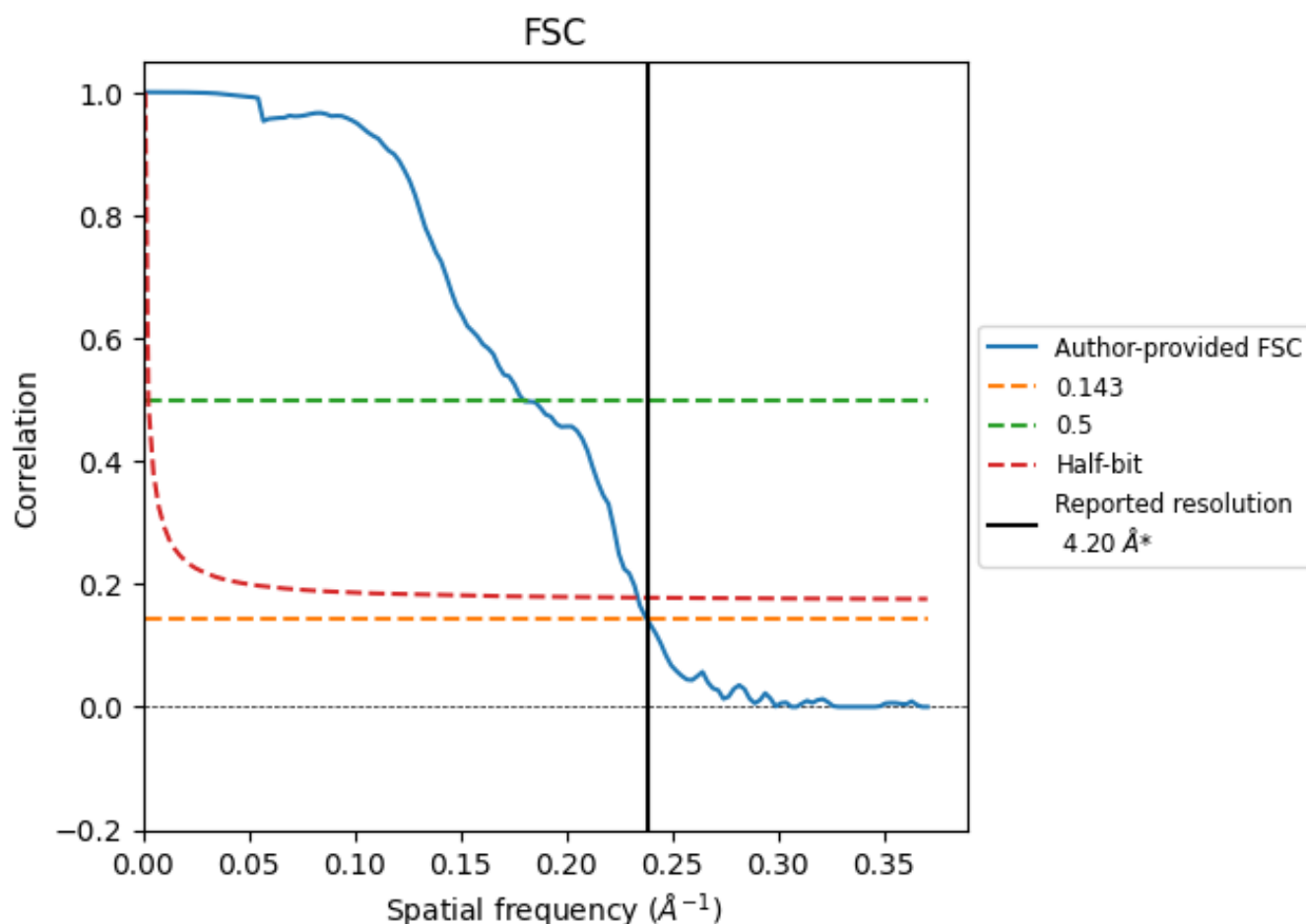

8 Fourier-Shell correlation [i](#)

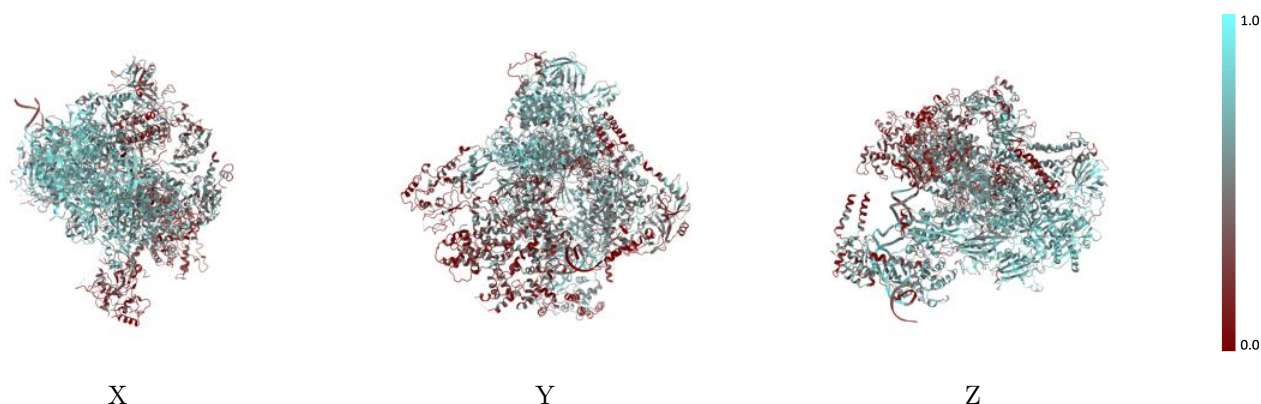

9.2 Q-score mapped to coordinate model [i](#)



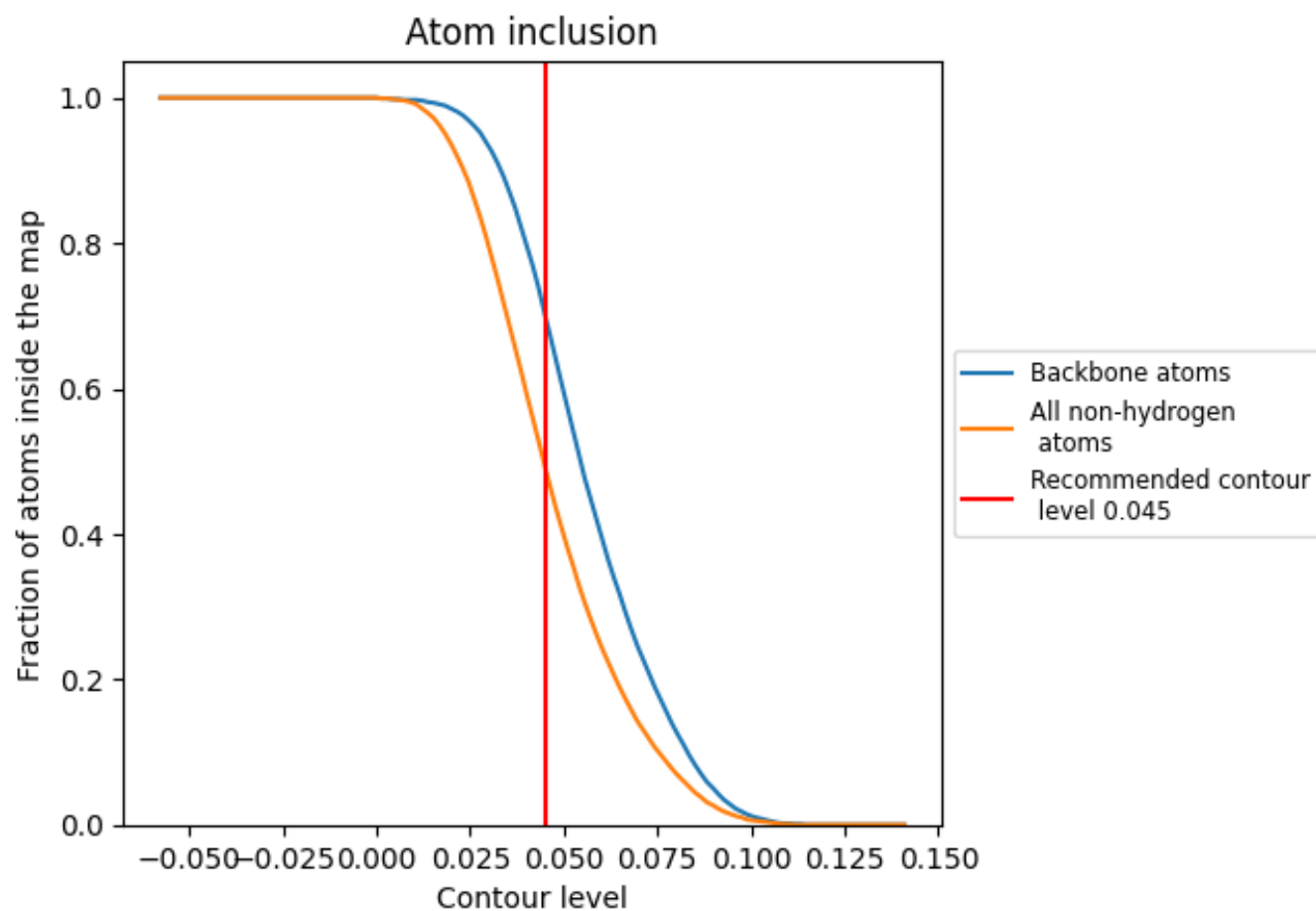
