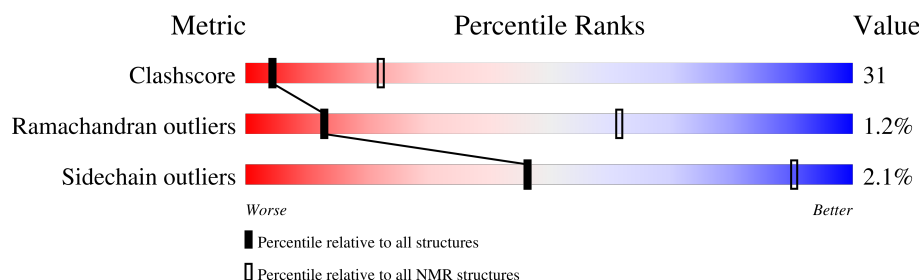
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR

The overall completeness of chemical shifts assignment is 8%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

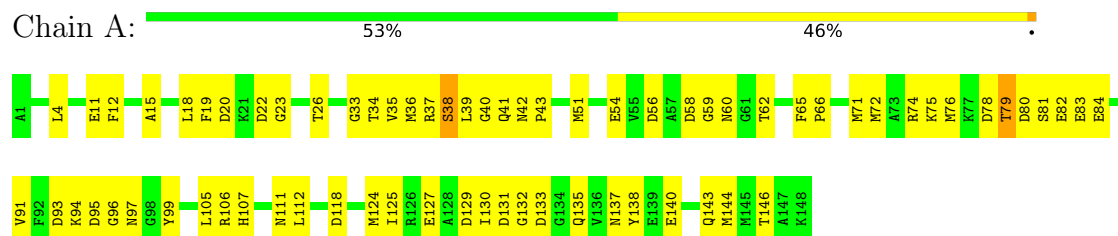

4 Residue-property plots

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

5 Refinement protocol and experimental data overview

The models were refined using the following method: *torsion angle dynamics, simulated annealing*.

Of the 100 calculated structures, 1 were deposited, based on the following criterion: *structures with the lowest energy*.

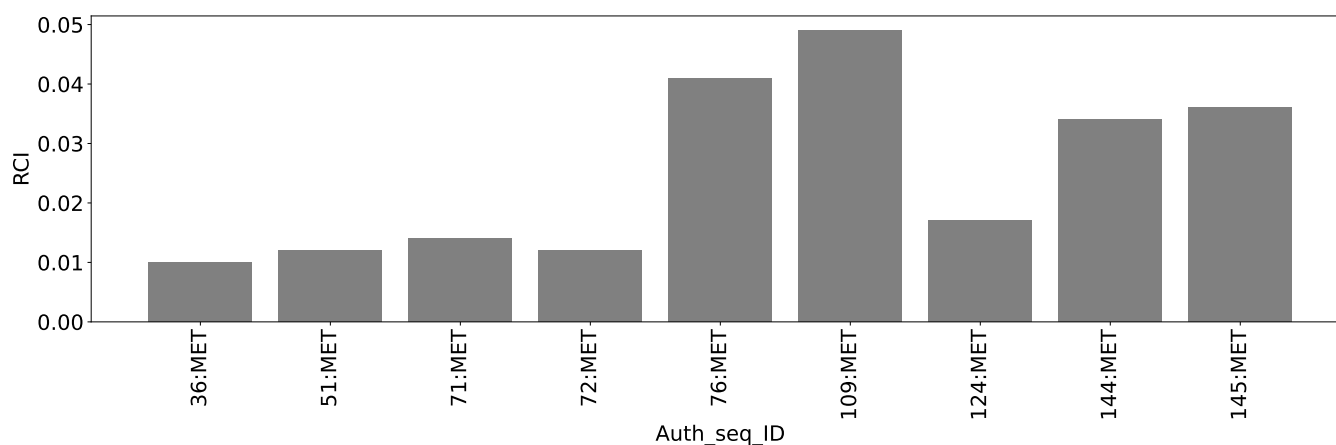

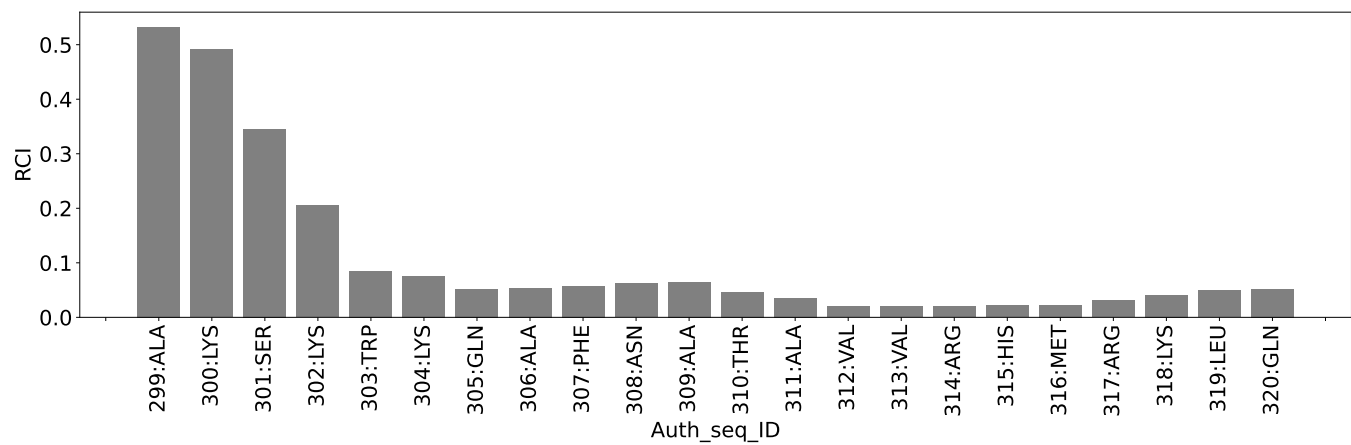
7.1.5 Random Coil Index (RCI) plots [i](#)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition. If well-defined core and ill-defined regions are not identified then it is shown as gray bars.

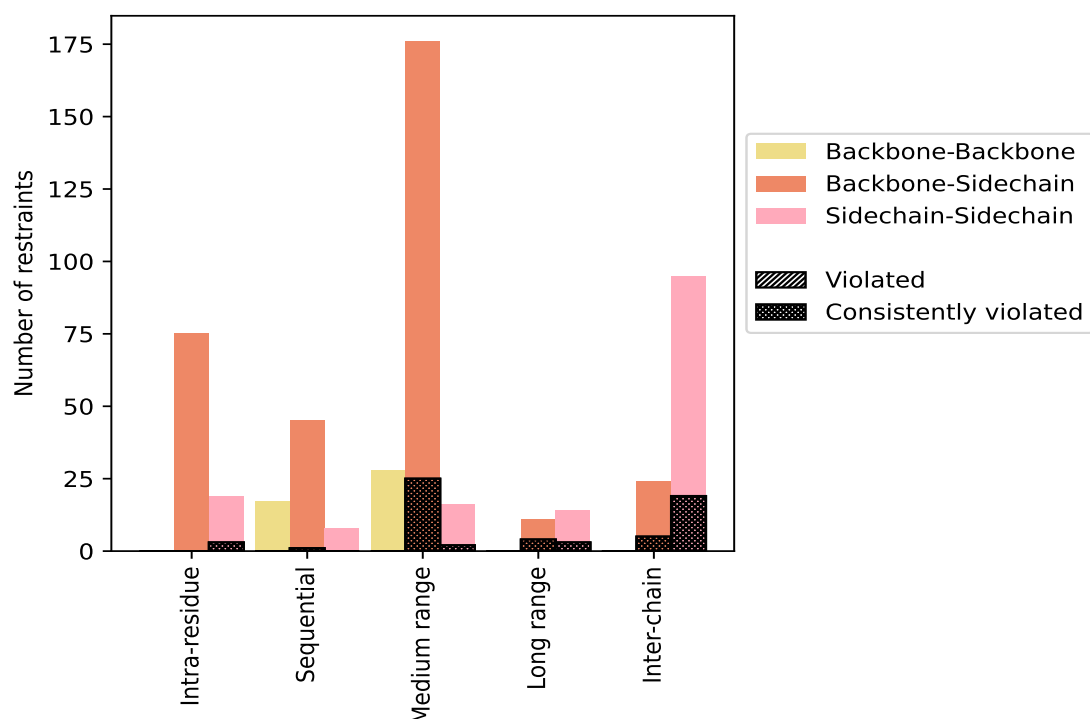

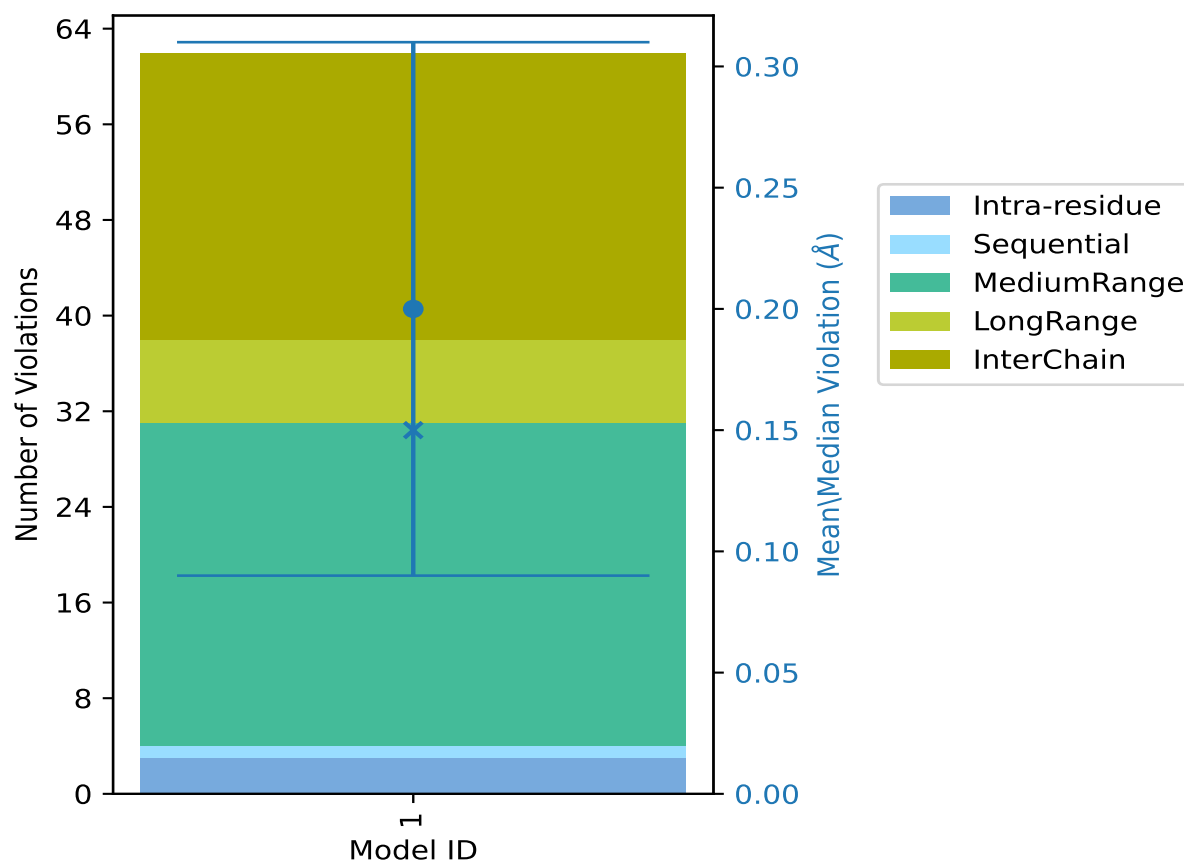

The mean(dot), median(x) and the standard deviation are shown in blue with respect to the y axis on the right

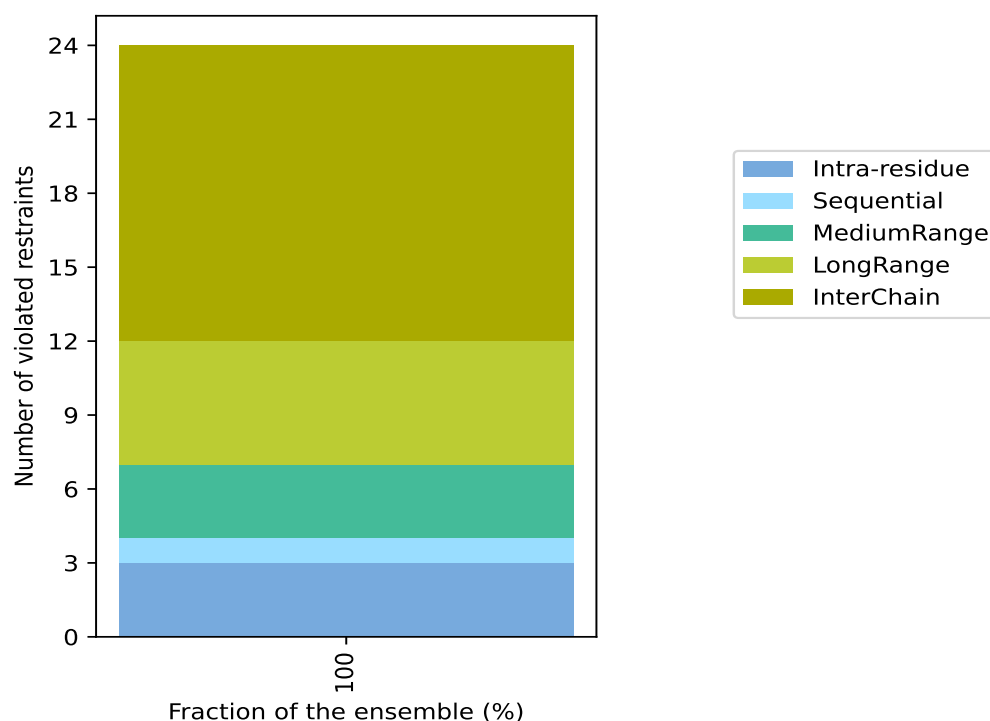
9.3 Distance violation statistics for the ensemble [i](#)

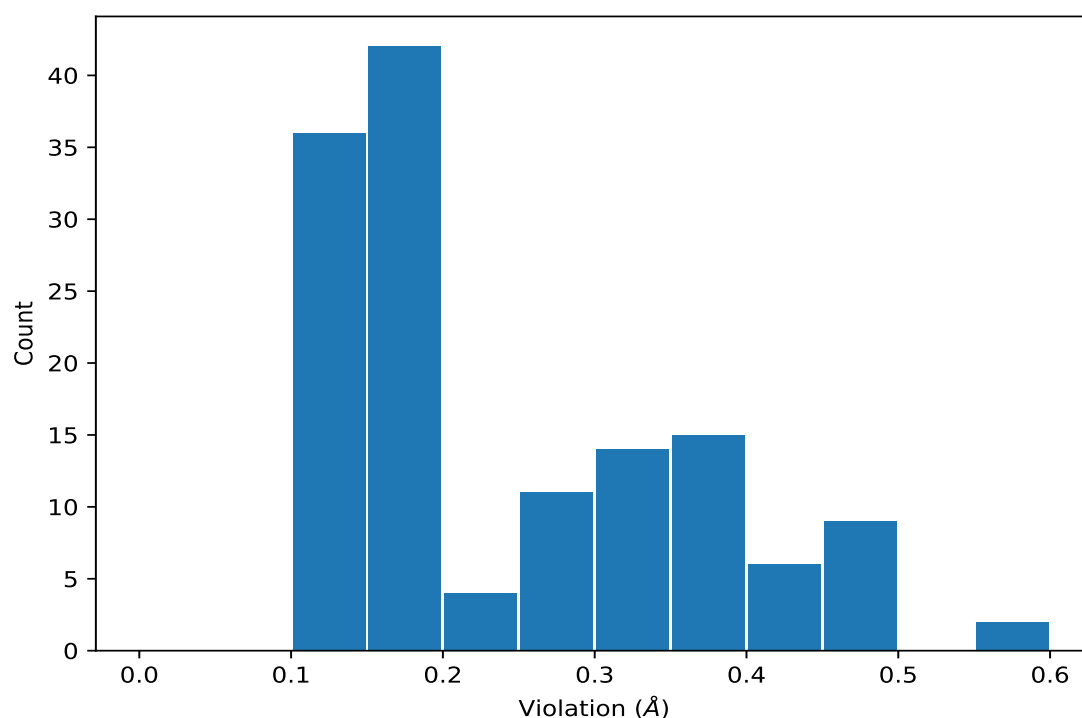

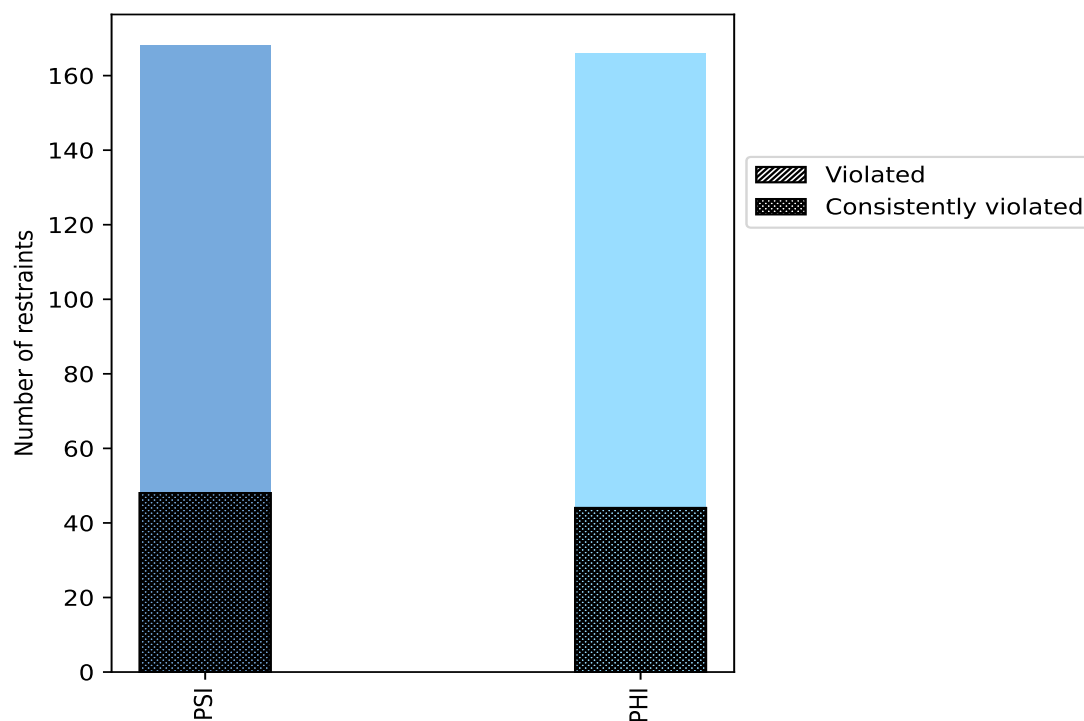

10.1.1 Bar chart : Distribution of dihedral-angles and violations [i](#)



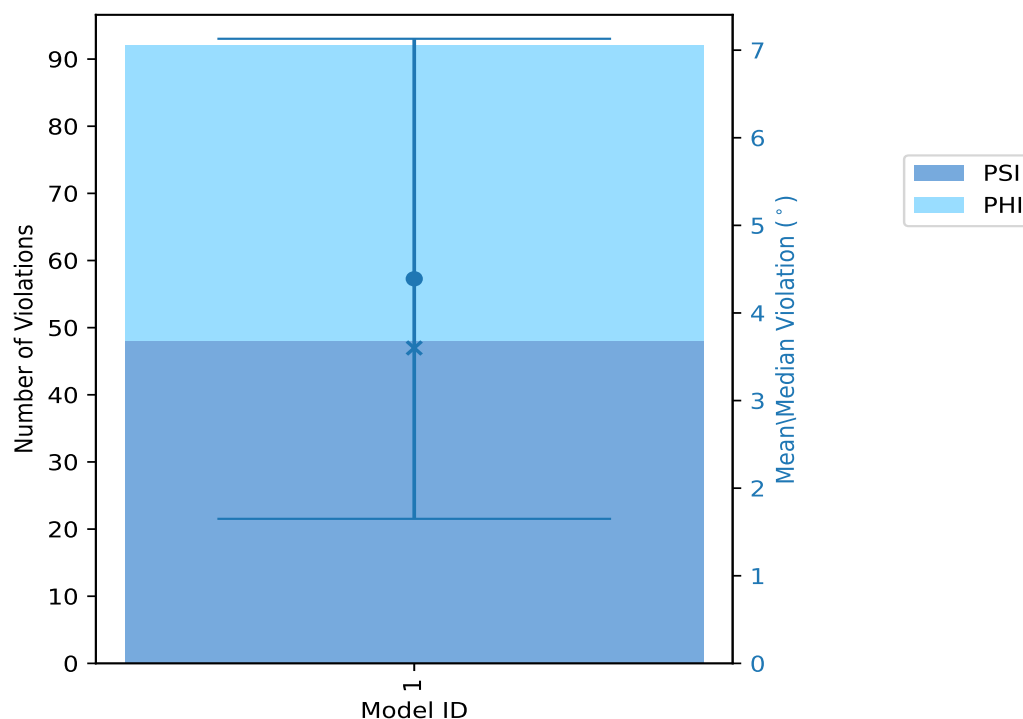

The mean(dot),median(x) and the standard deviation are shown in blue with respect to the y axis on the right

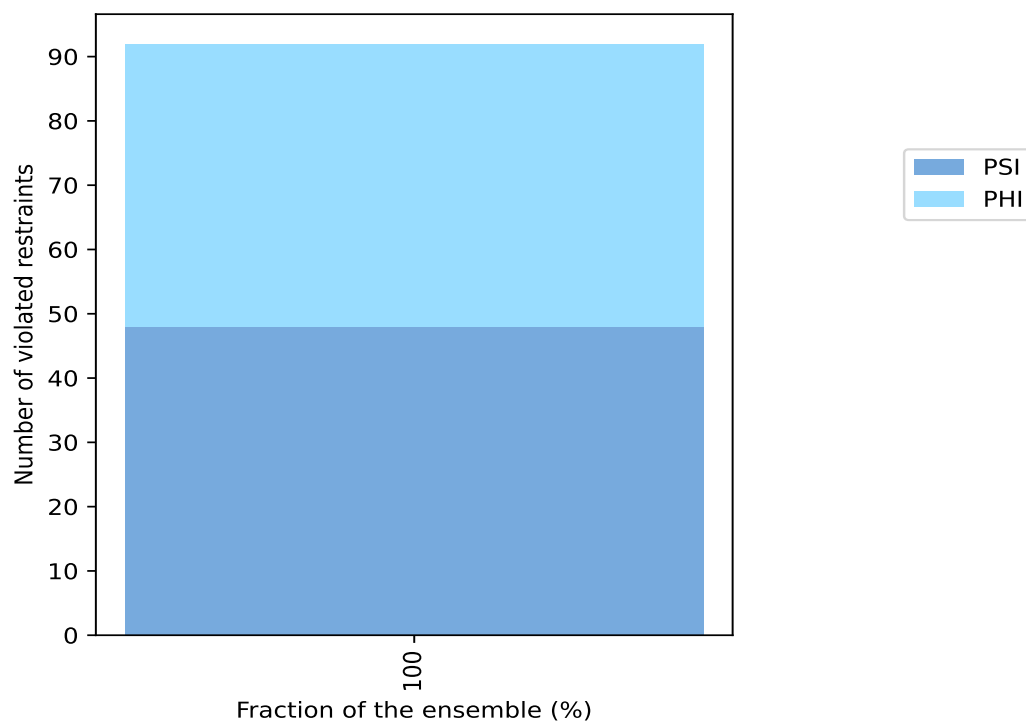

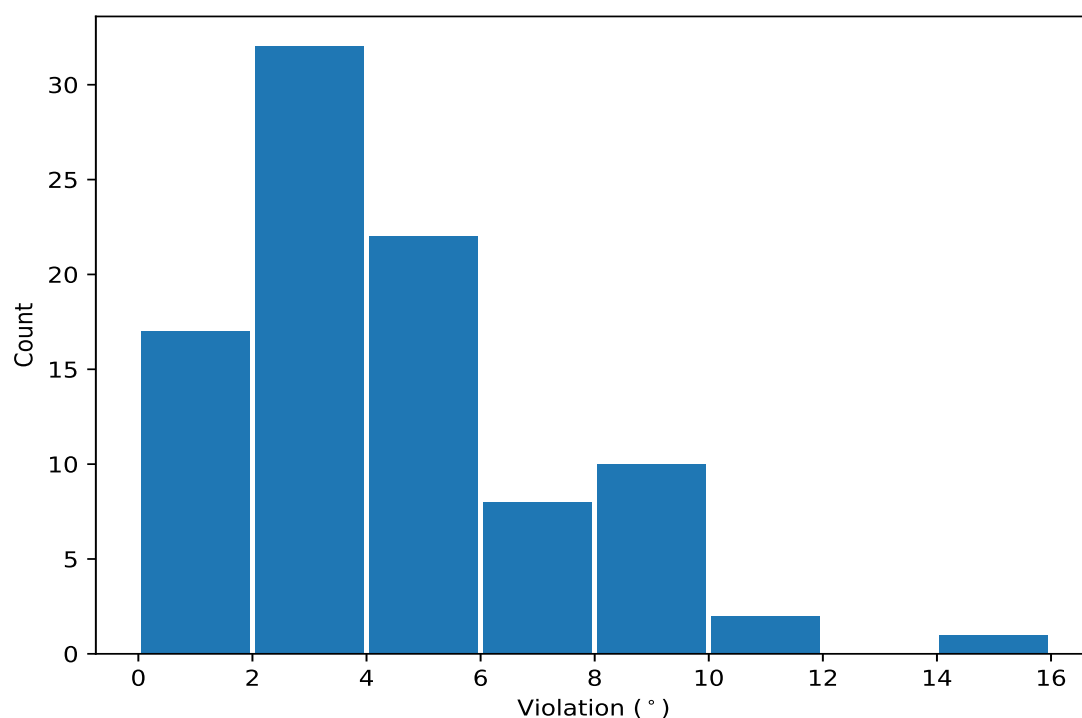
