1 Overall quality at a glance

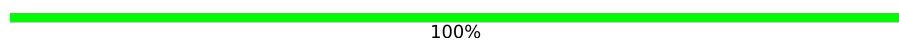
The overall completeness of chemical shifts assignment is 30%.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

2 Ensemble composition and analysis

This entry contains 1 models. Identification of well-defined residues and clustering analysis are not possible.

There are 2 unique types of molecules in this entry. The entry contains 758 atoms, of which 272 are hydrogens and 0 are deuteriums.

- Molecule 1 is a DNA chain called DNA (5'-D(*GP*TP*GP*CP*(2LF)P*TP*GP*TP*TP*TP*GP*T)-3').

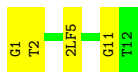

4 Residue-property plots

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

- Molecule 1: DNA (5'-D(*GP*TP*GP*CP*(2LF)P*TP*GP*TP*TP*TP*GP*T)-3')

Chain A:  67% 33%



- Molecule 2: DNA (5'-D(*AP*CP*AP*AP*AP*CP*AP*CP*GP*CP*AP*C)-3')

Chain B:  100%

5 Refinement protocol and experimental data overview

The models were refined using the following method: *simulated annealing*.

Of the 10 calculated structures, 1 were deposited, based on the following criterion: *back calculated data agree with experimental NOESY spectrum*.

6.1 Standard geometry [i](#)

Bond lengths and bond angles in the following residue types are not validated in this section:

There are no covalent bond-length or bond-angle outliers.

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

A bond length with $|Z| > 2$ is considered an outlier worth inspection. RMSZ is the average root-mean-square of all Z scores of the bond lengths.

The Link column lists molecule types, if any, to which the group is linked. The Z score for a bond angle is the number of standard deviations the observed value is removed from the expected value. A bond angle with $|Z| > 2$ is considered an outlier worth inspection. RMSZ is the average root-mean-square of all Z scores of the bond angles.
