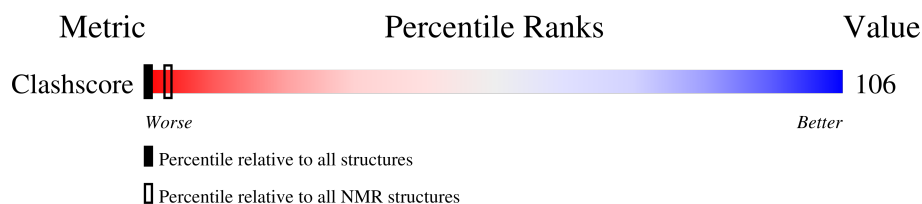
1 Overall quality at a glance

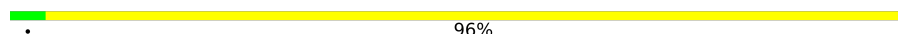
The overall completeness of chemical shifts assignment is 51%.

A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

This entry contains 10 models. This entry does not contain polypeptide chains, therefore identification of well-defined residues and clustering analysis are not possible. All residues are included in the validation scores.

- Molecule 1 is a DNA chain called DNA (26-MER).

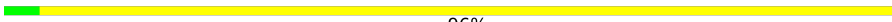

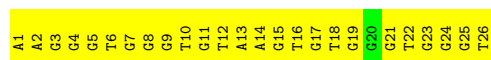
4 Residue-property plots

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

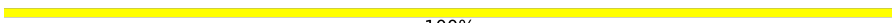

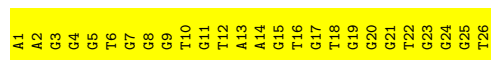

The overall completeness is 51%, i.e. 268 atoms were assigned a chemical shift out of a possible 521. 0 out of 0 assigned methyl groups (LEU and VAL) were assigned stereospecifically.

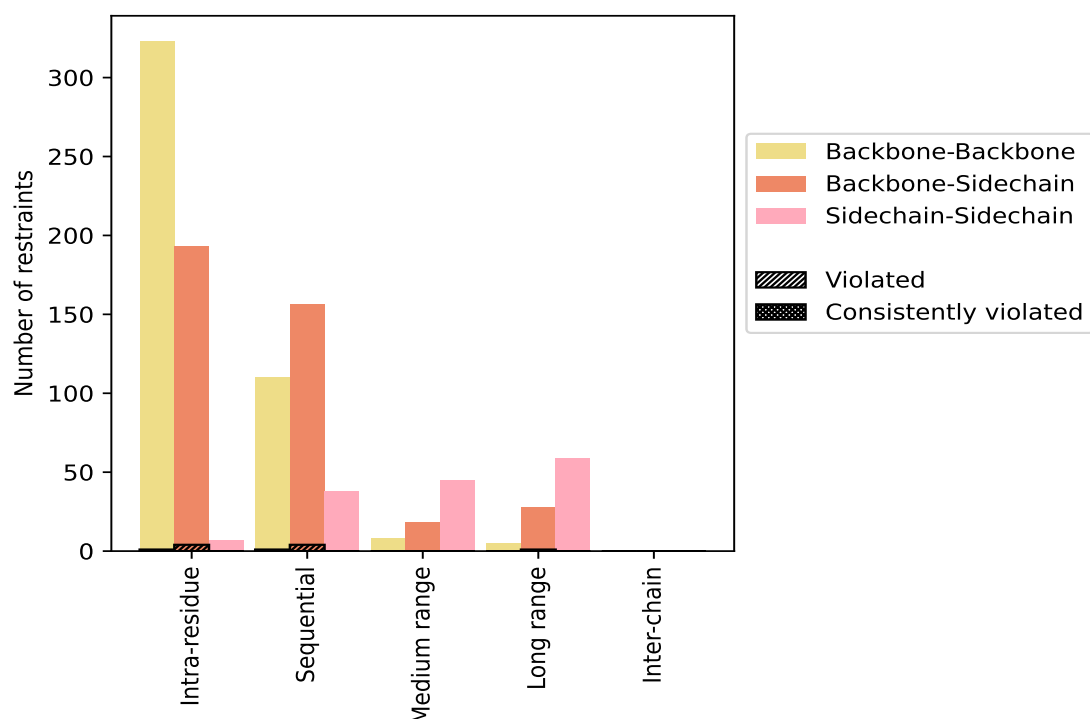

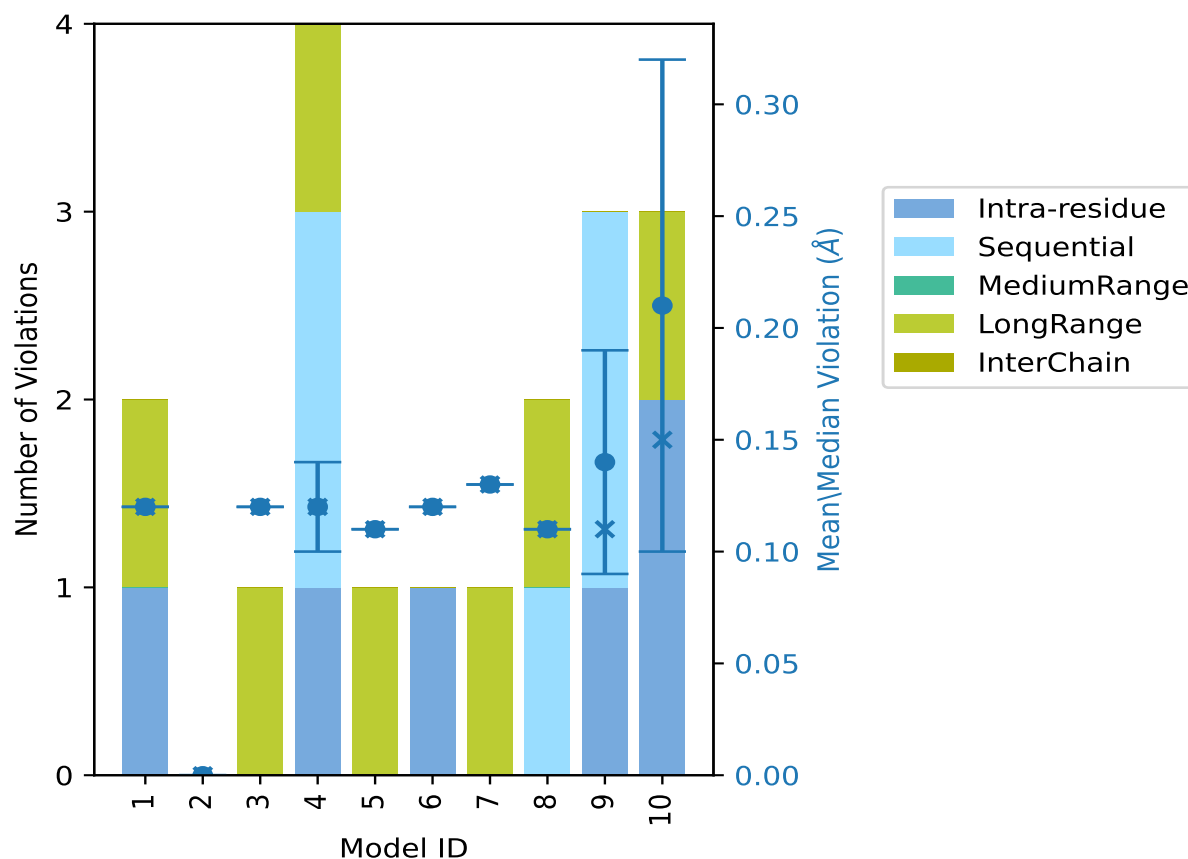

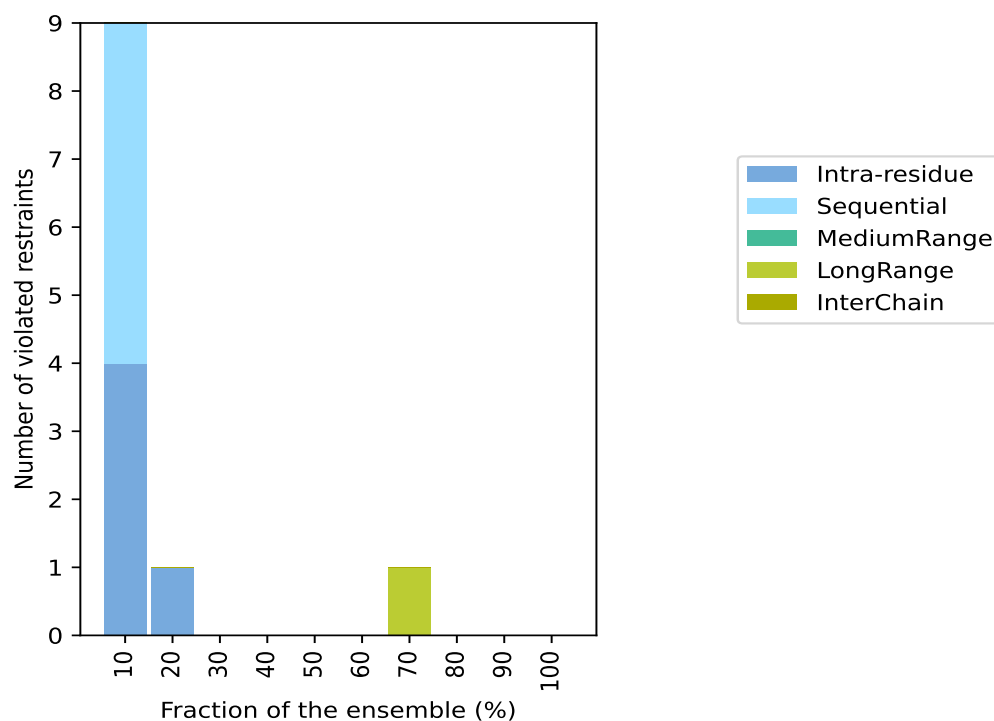

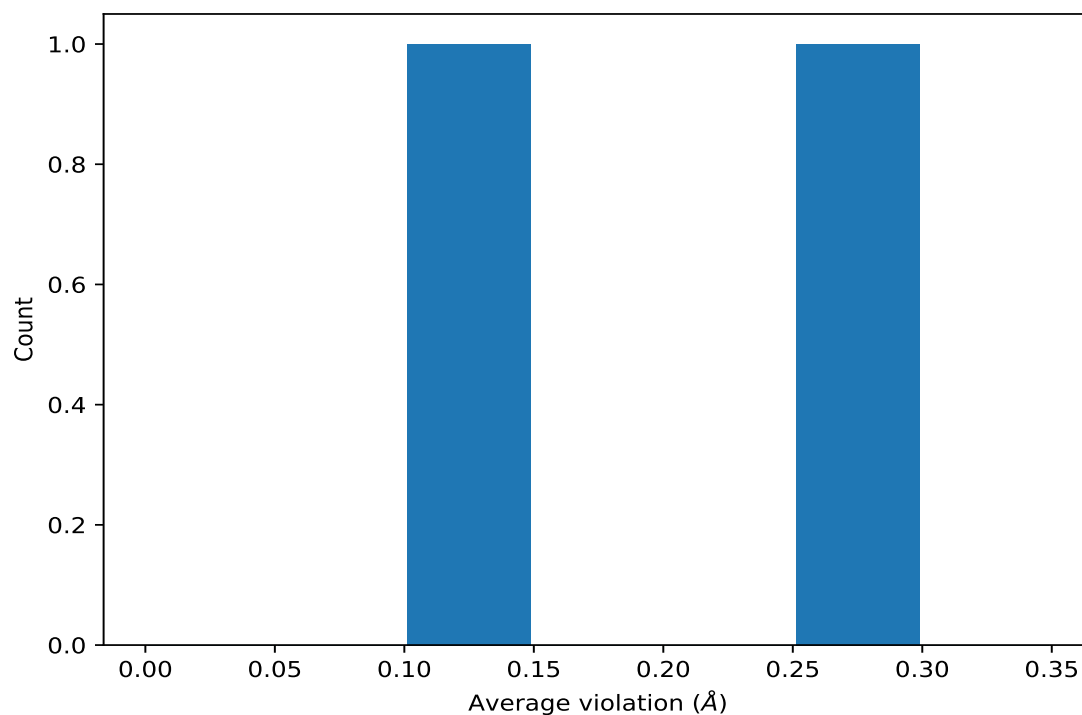

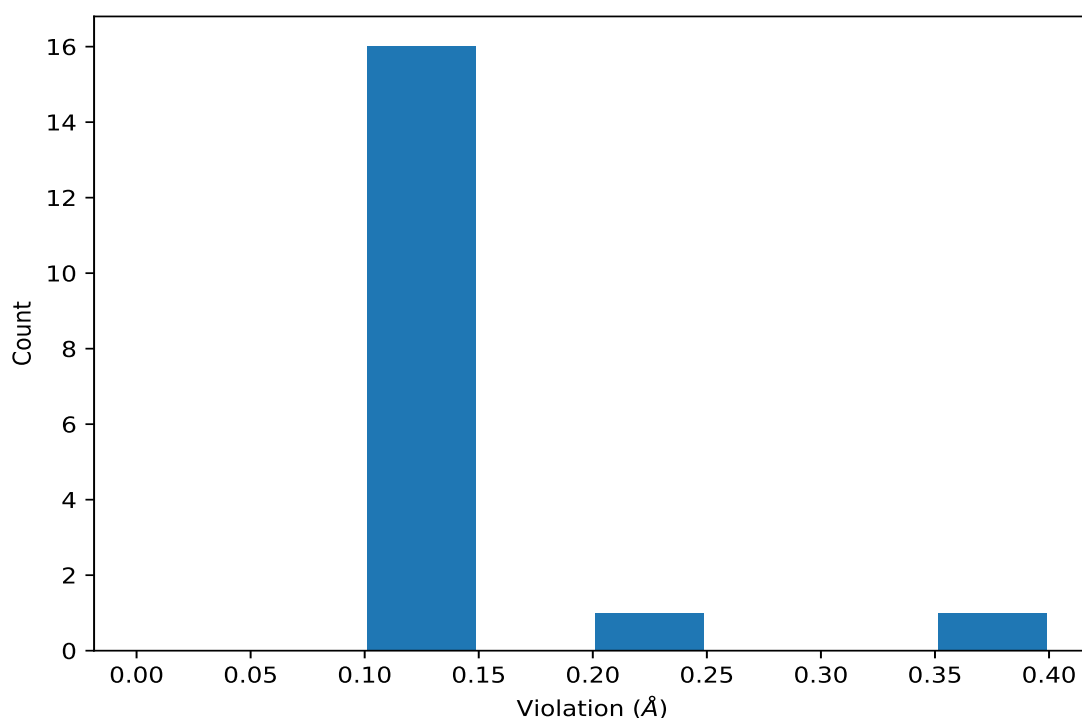

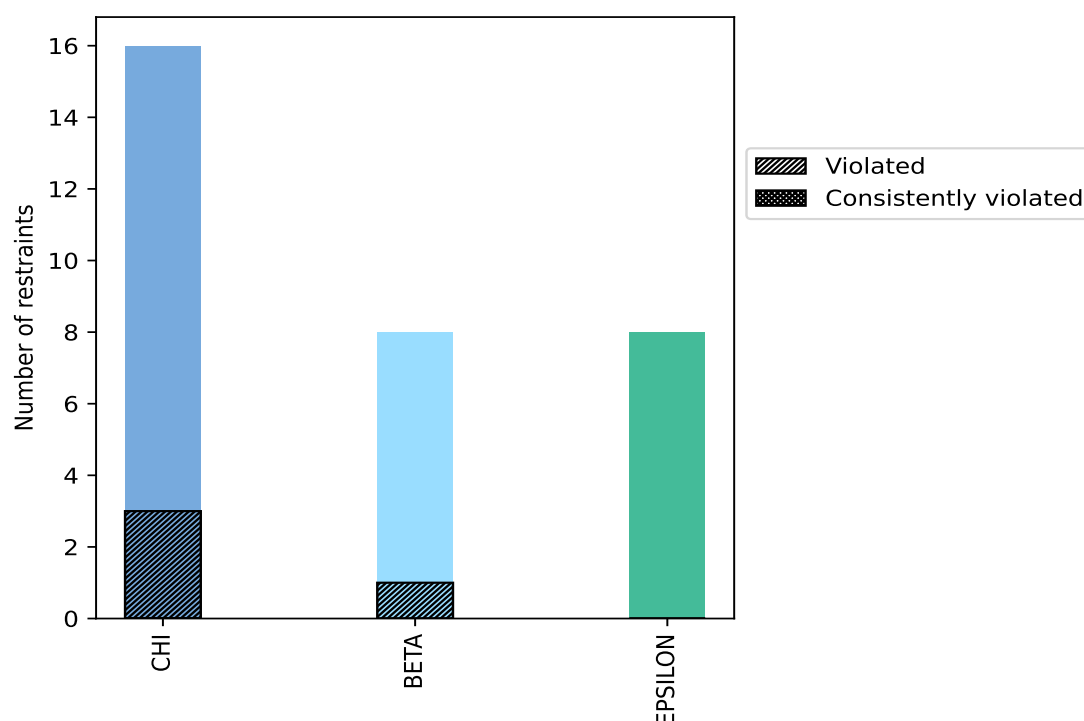

10.1.1 Bar chart : Distribution of dihedral-angles and violations [i](#)



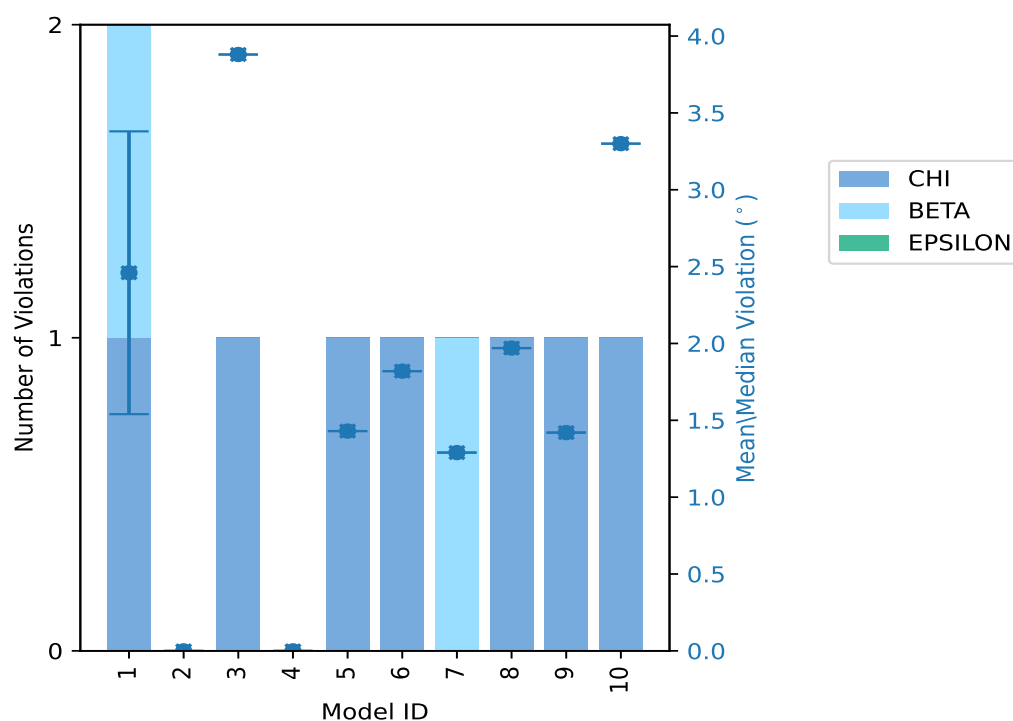

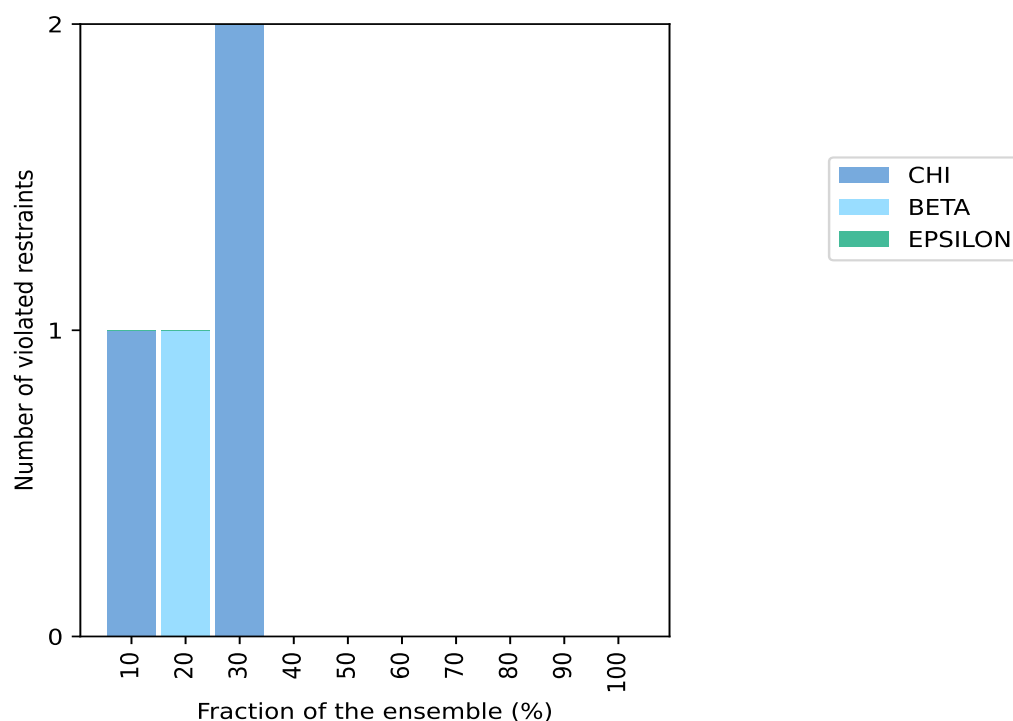

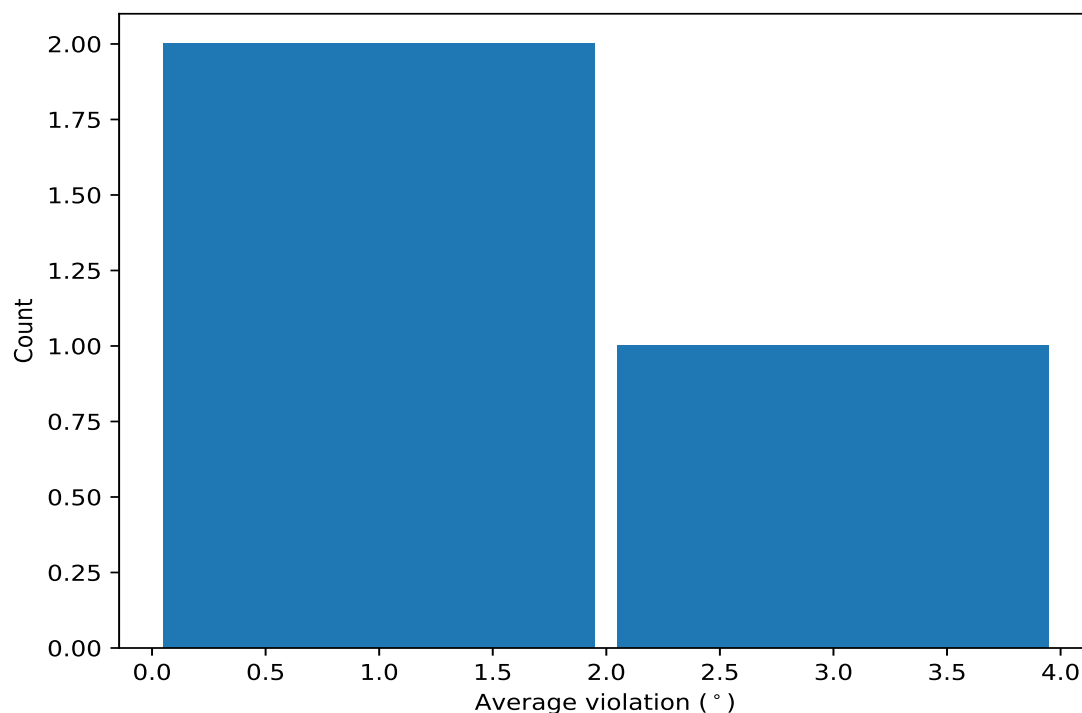

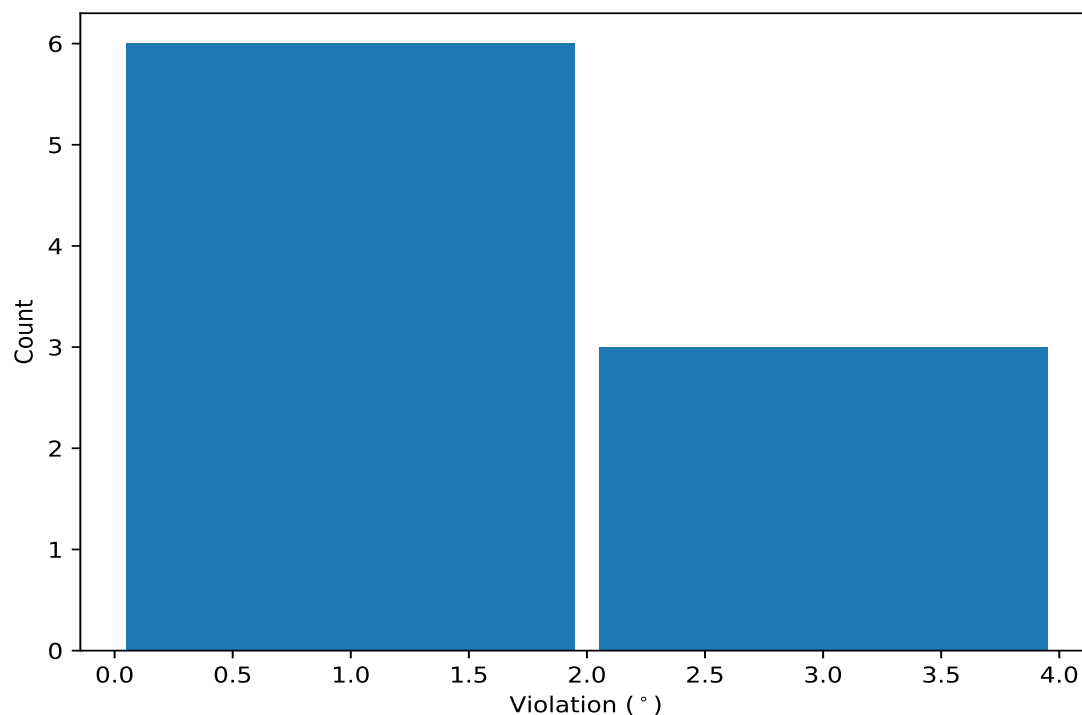
