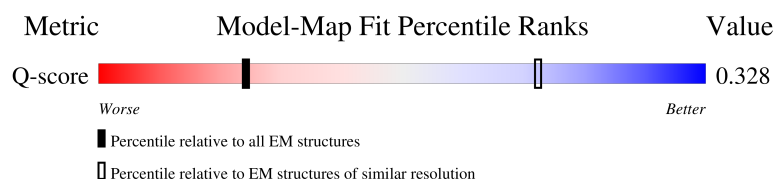
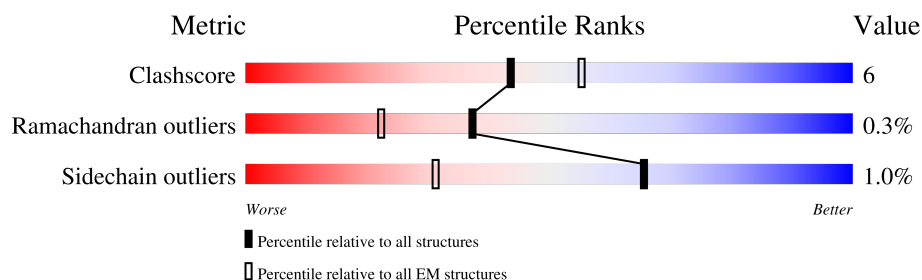

1 Overall quality at a glance

The table below summarises the geometric issues observed across the polymeric chains and their fit to the map. The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

2 Entry composition

There is only 1 type of molecule in this entry. The entry contains 18944 atoms, of which 0 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called Isoform Glur5-2 of Glutamate receptor ionotropic, kainate 1.

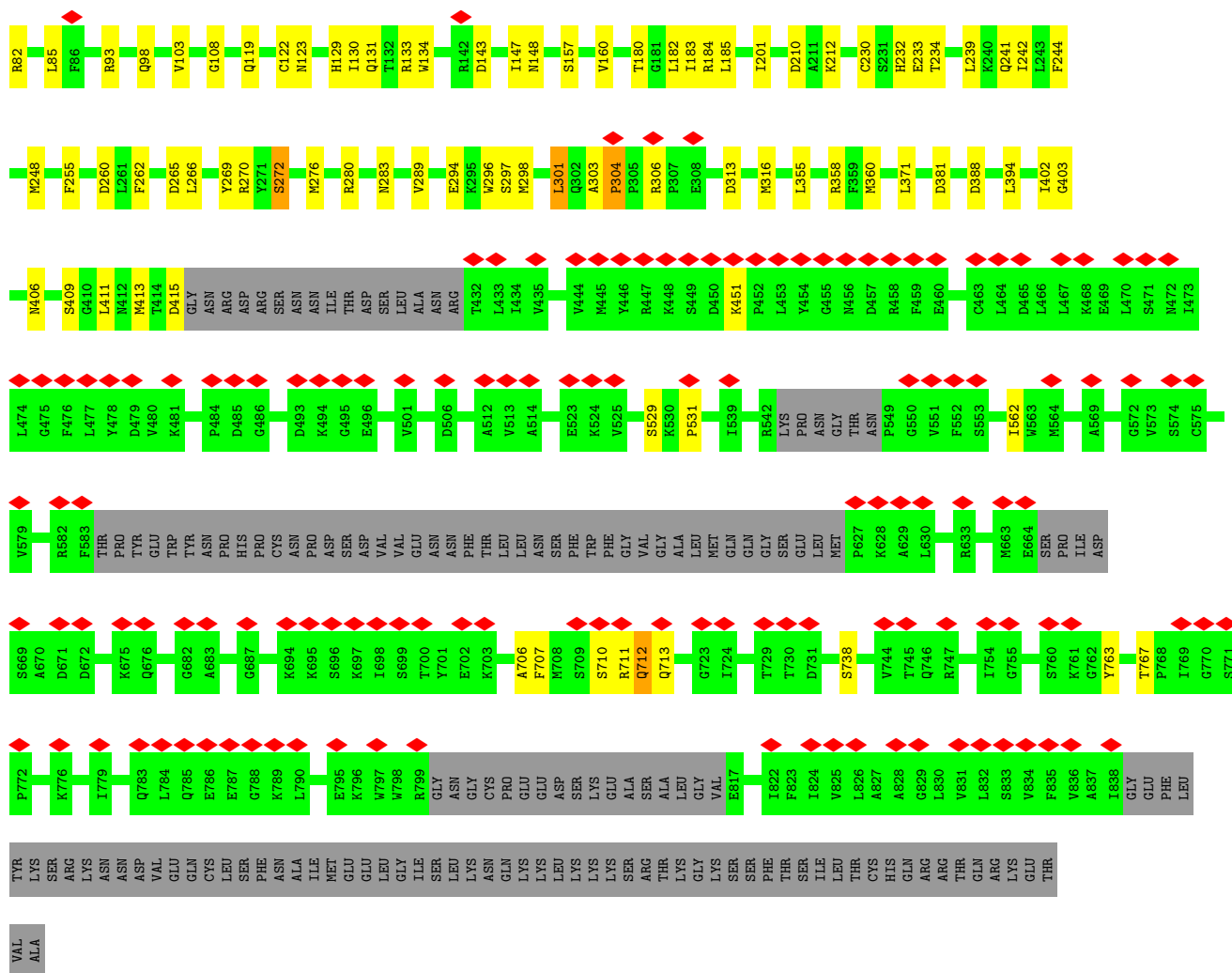

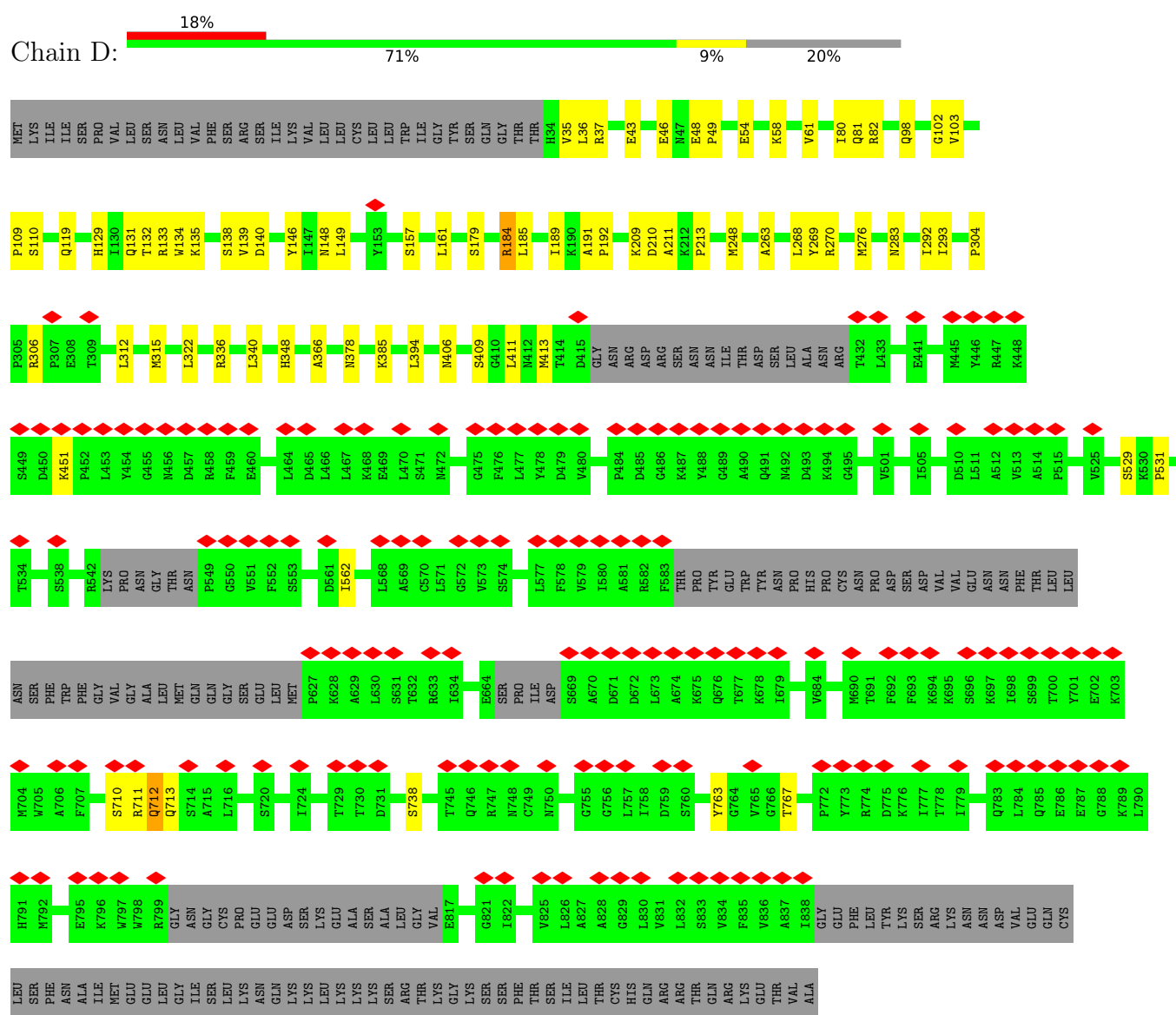


- Molecule 1: Isoform Glur5-2 of Glutamate receptor ionotropic, kainate 1

5.1 Standard geometry

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

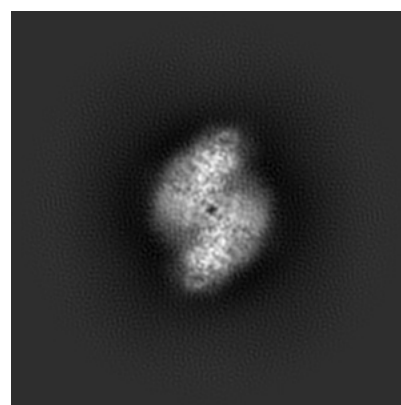

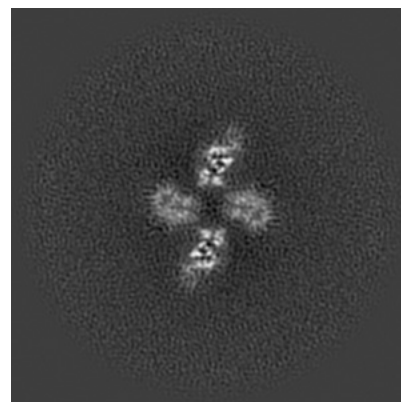

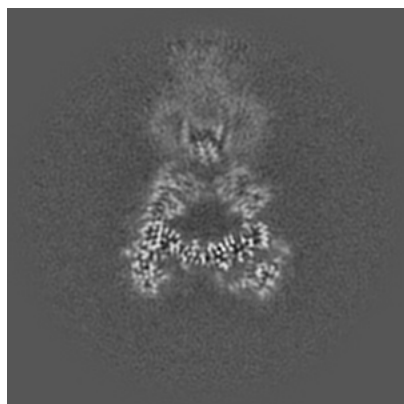

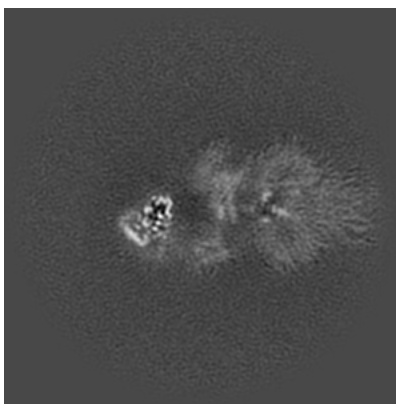

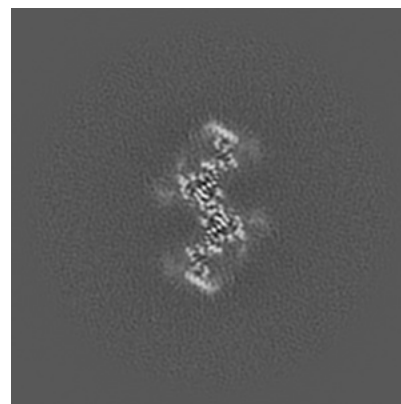

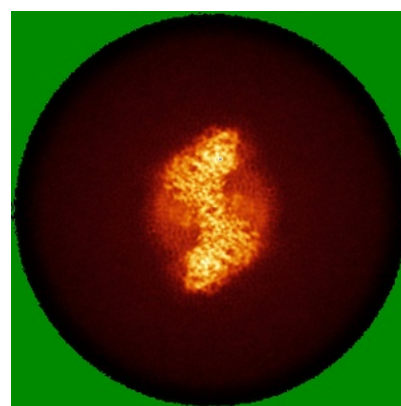

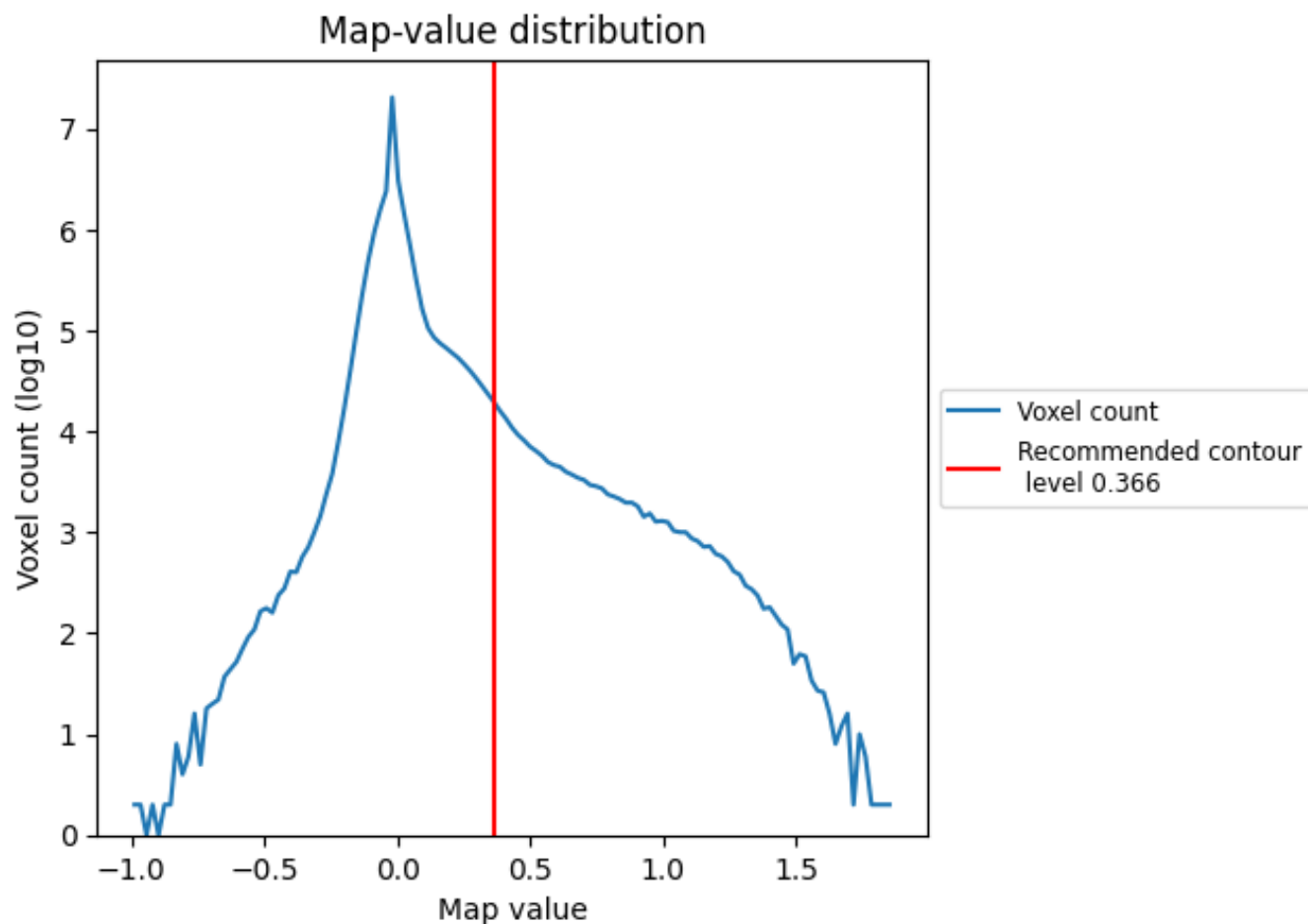

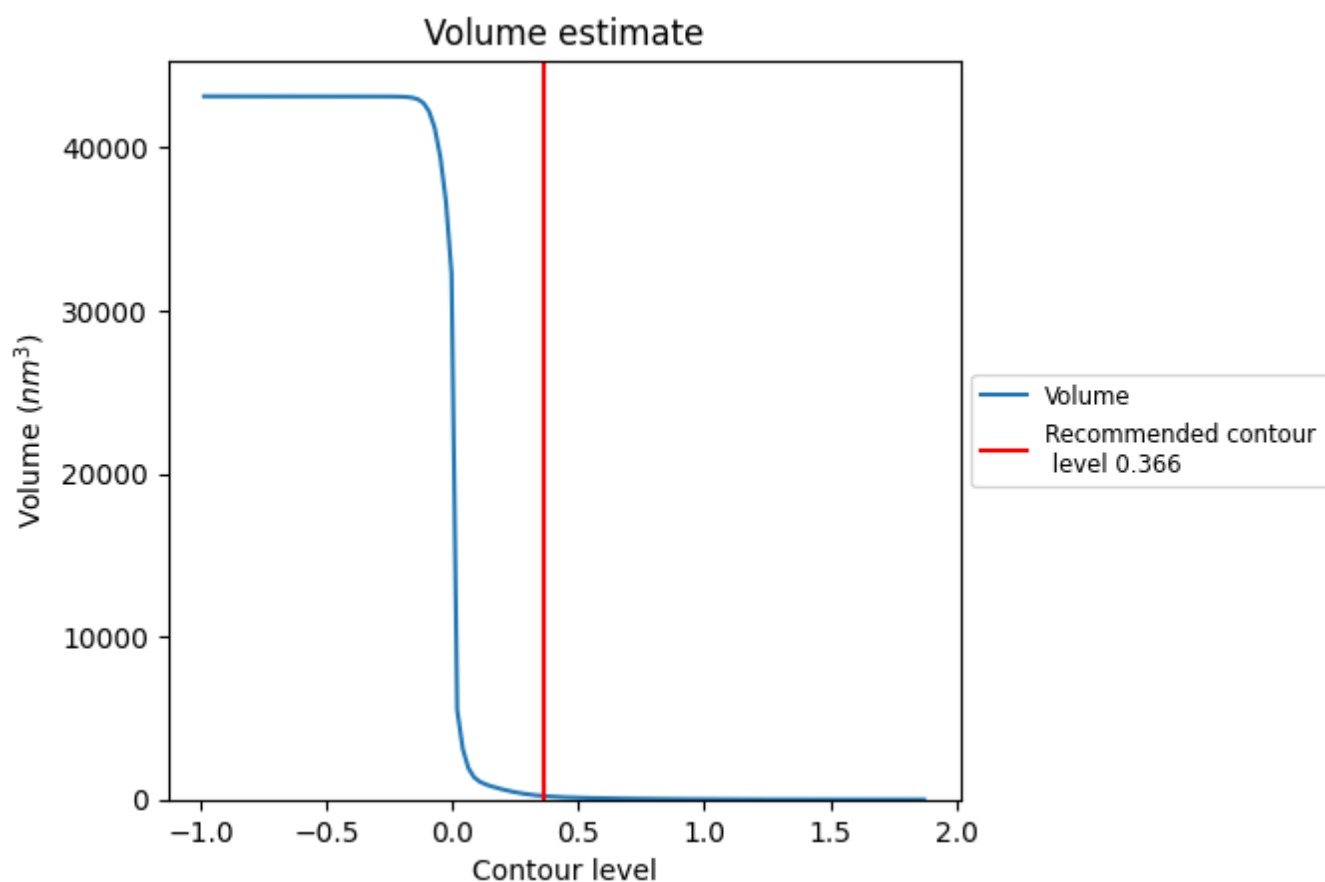

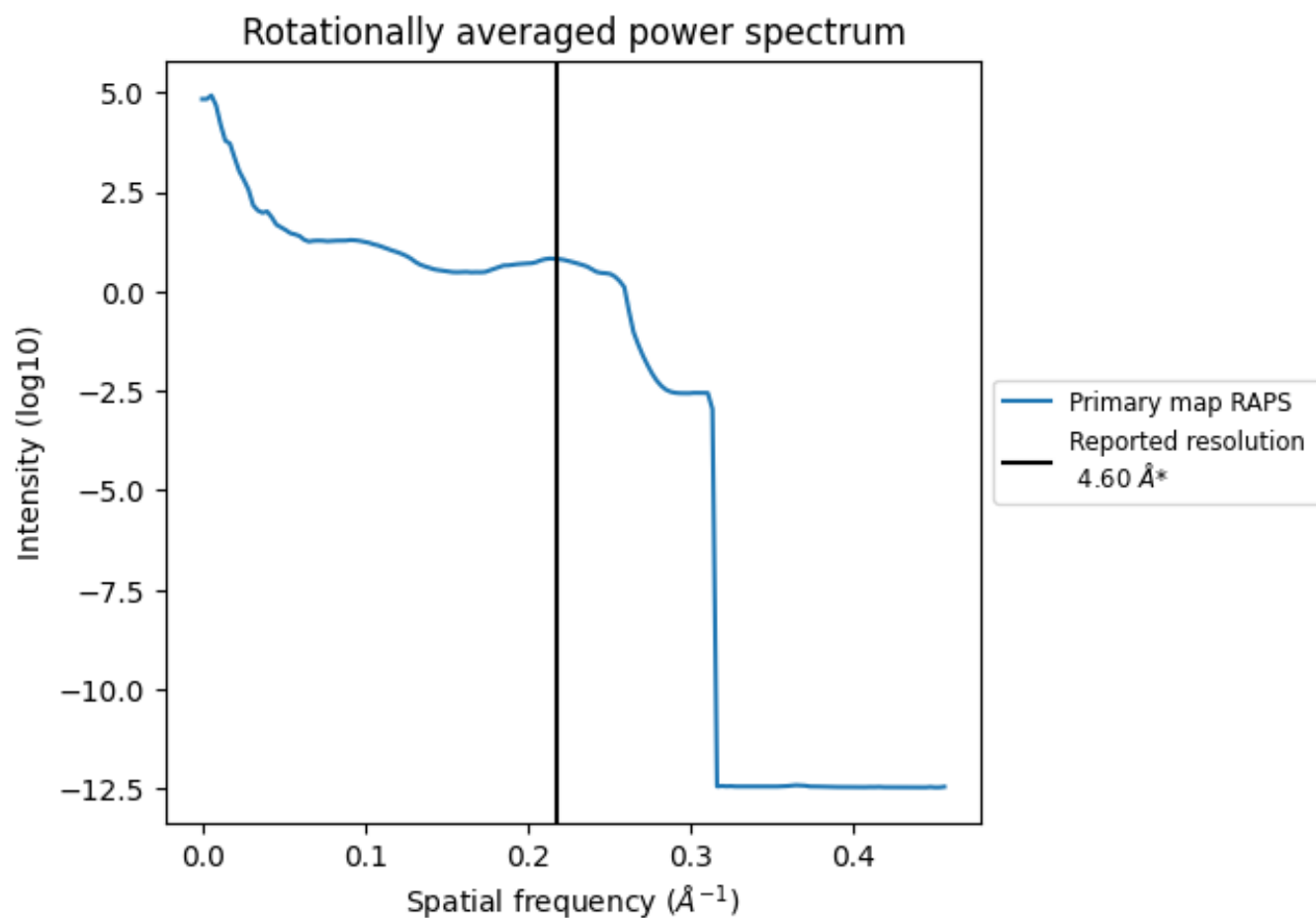

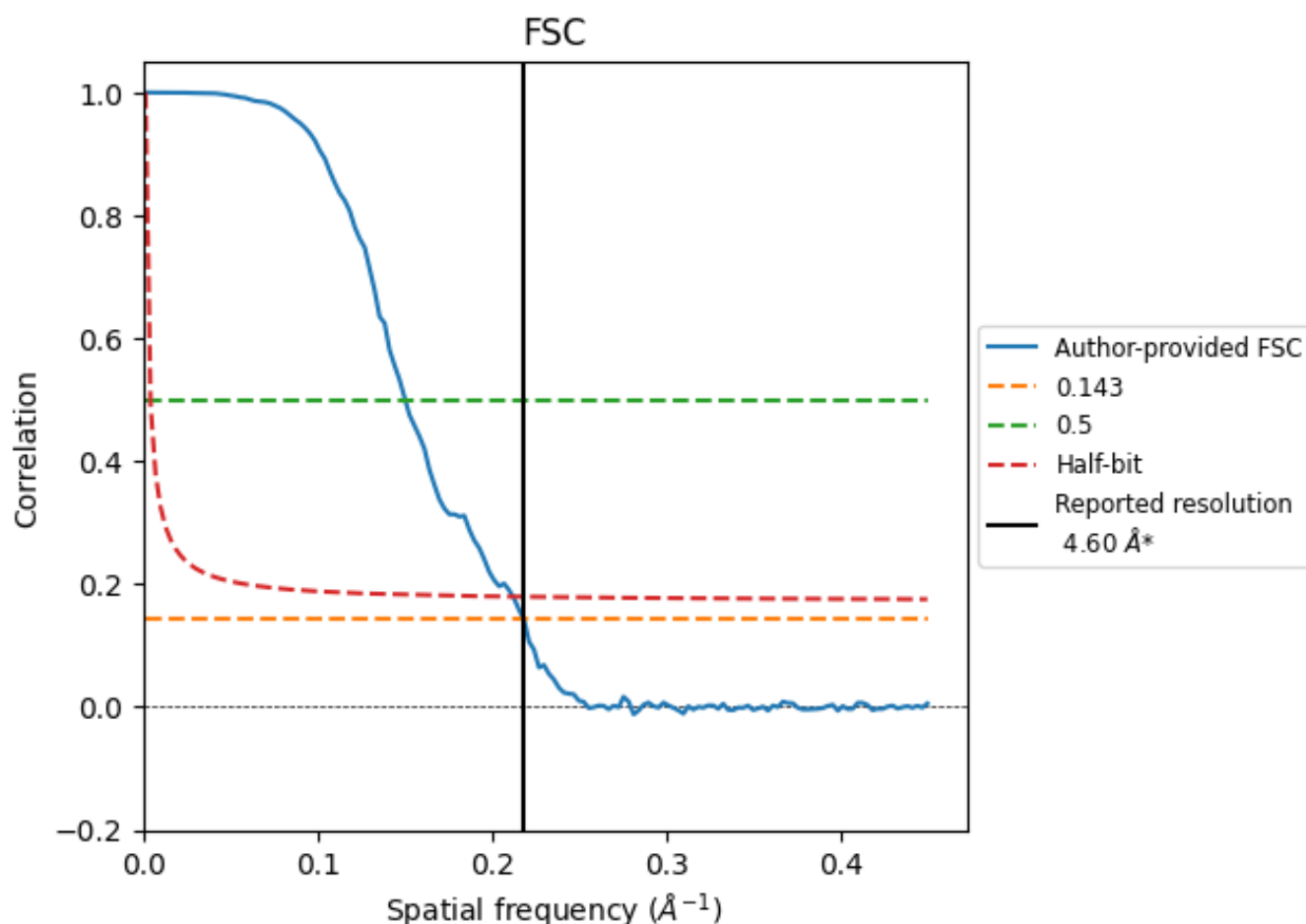

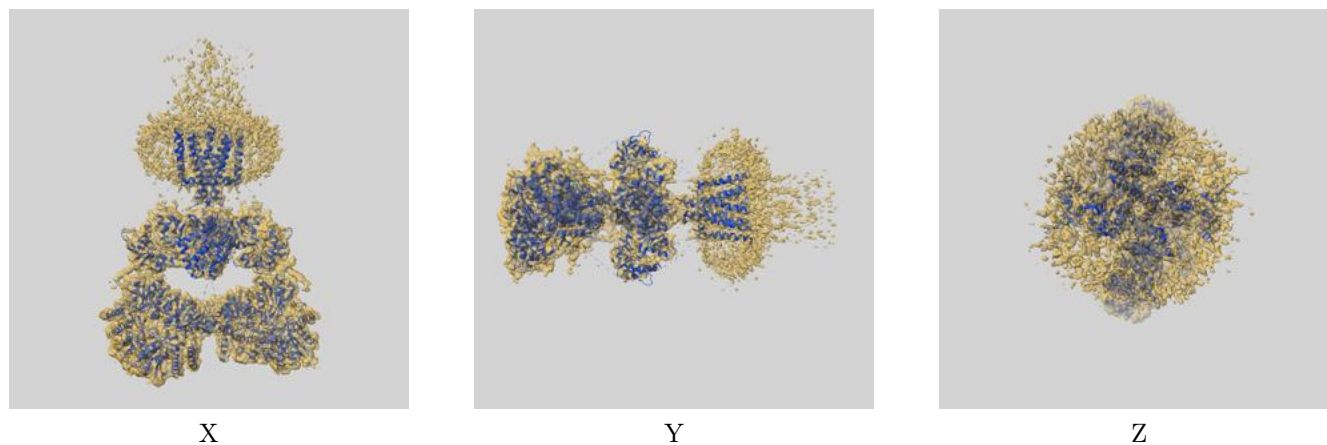

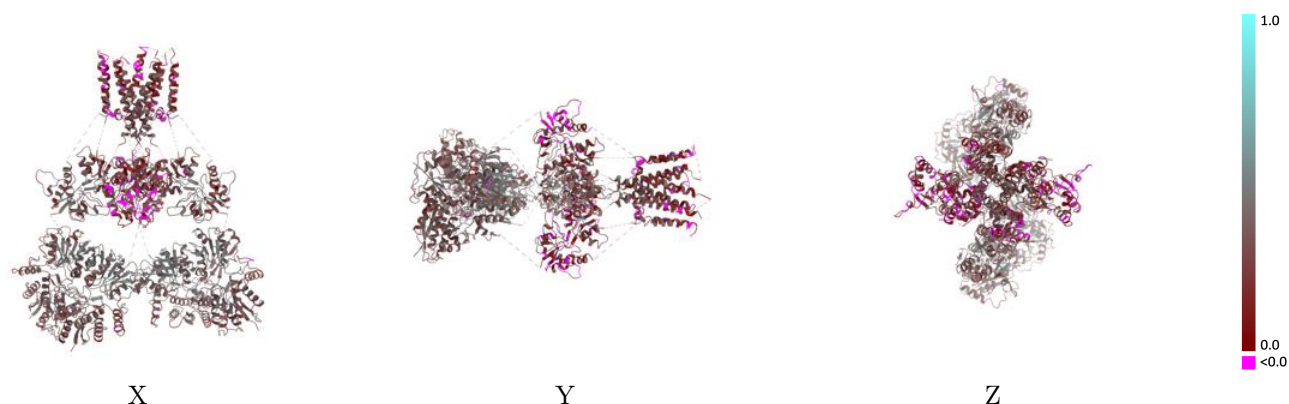

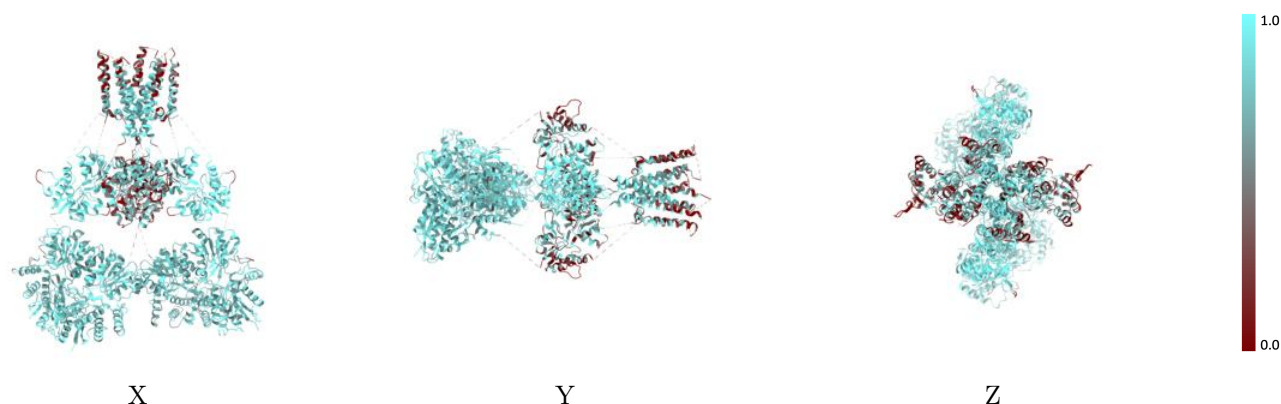

9.2 Q-score mapped to coordinate model [i](#)



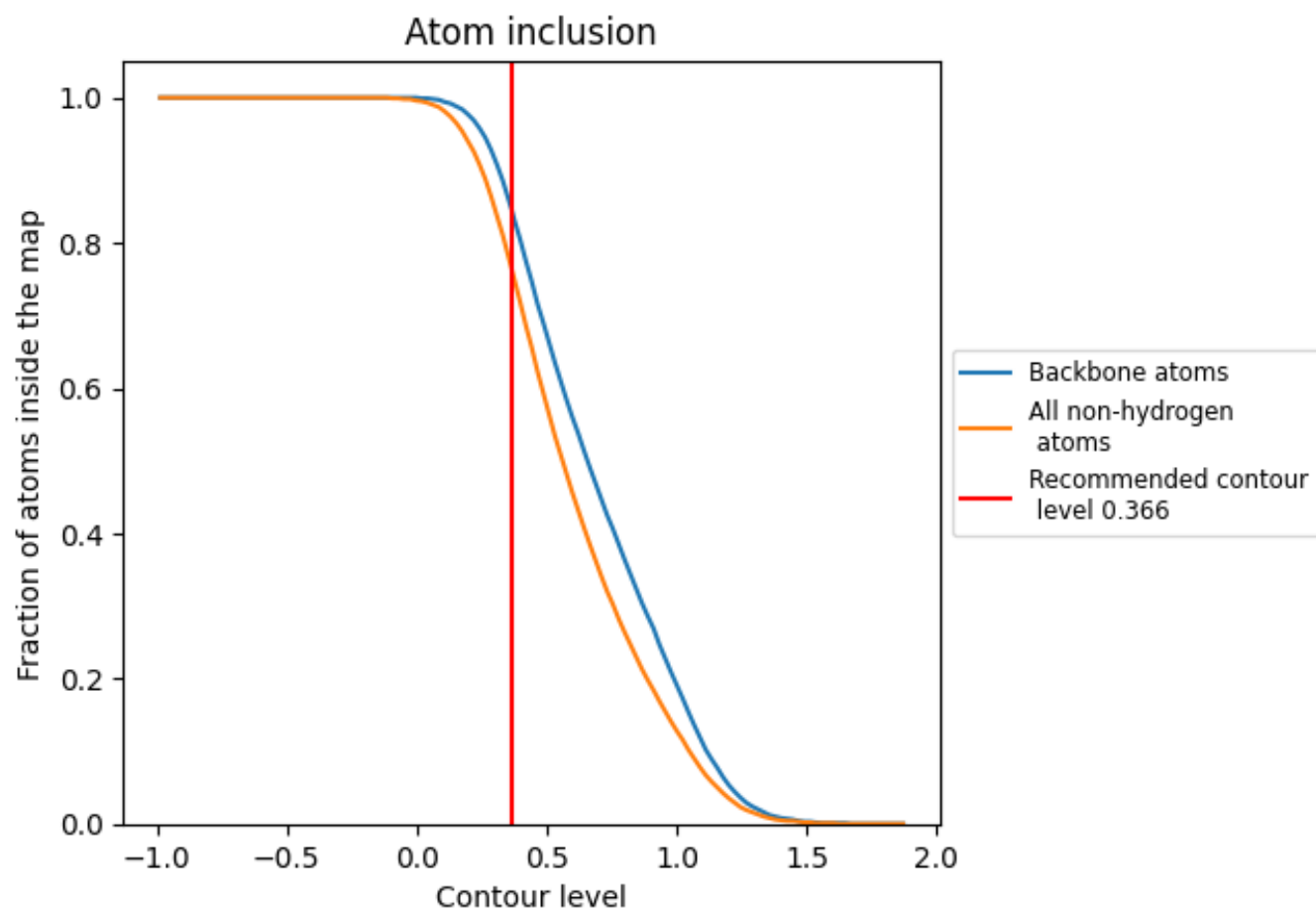
