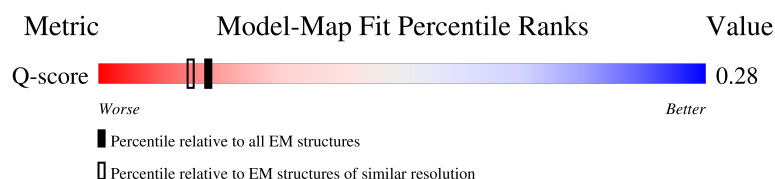
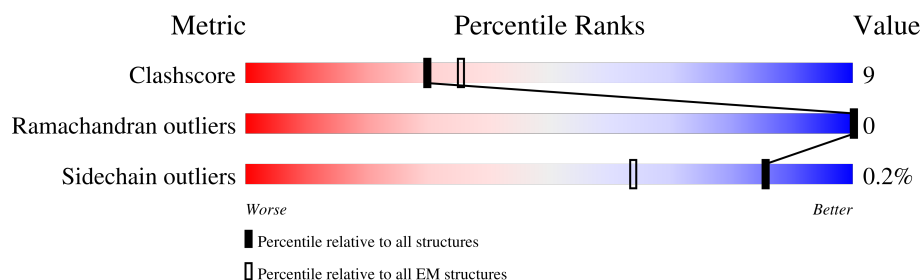

1 Overall quality at a glance

A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

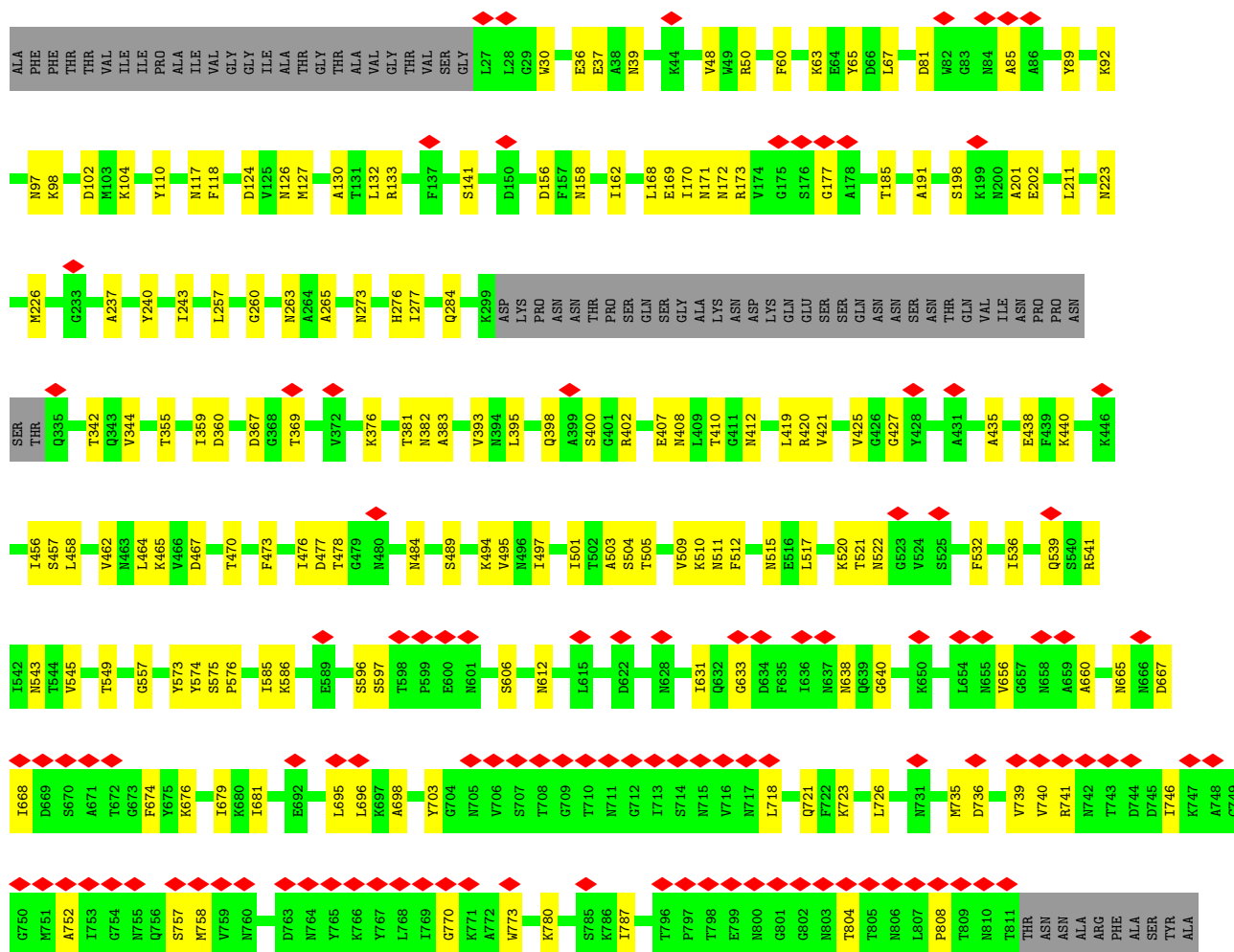
2 Entry composition

There is only 1 type of molecule in this entry. The entry contains 68664 atoms, of which 0 are hydrogens and 0 are deuteriums.

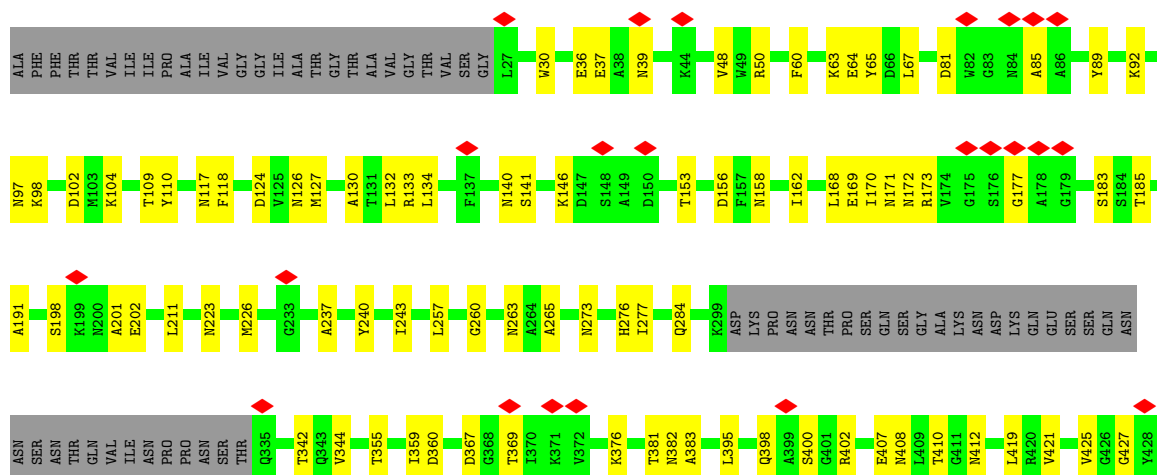

5 Model quality

5.1 Standard geometry

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

5.2 Too-close contacts [i](#)

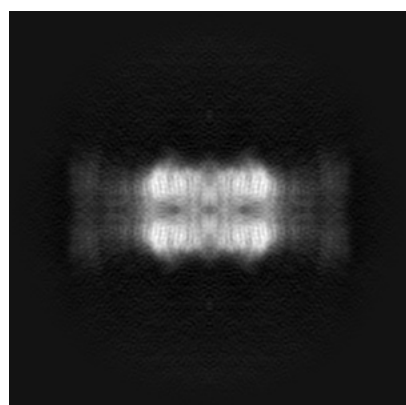

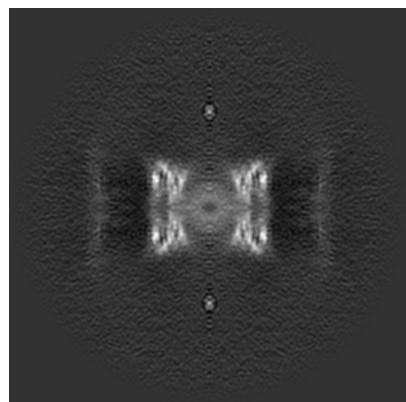

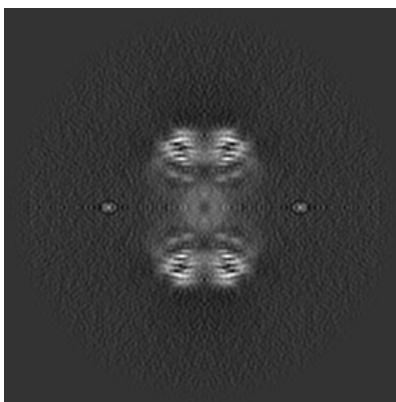

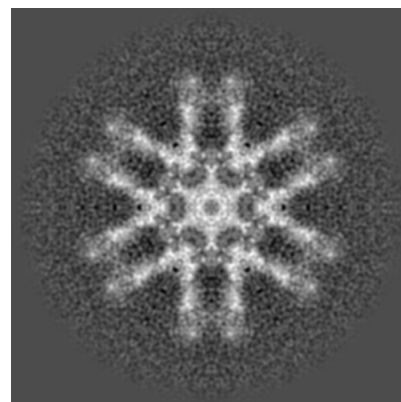

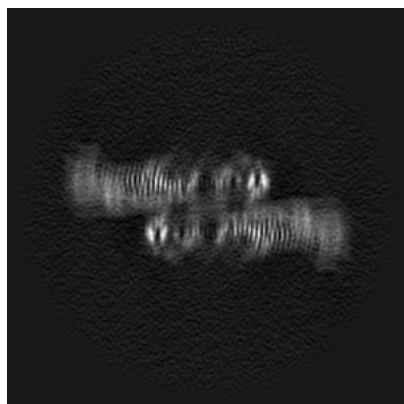

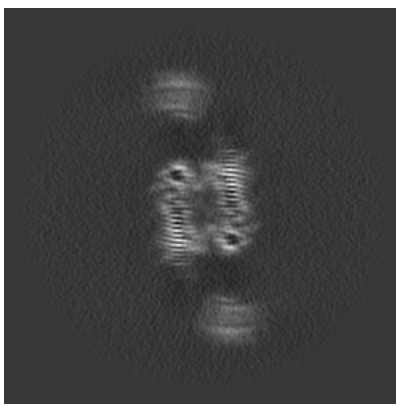
The images above show central slices of the map in three orthogonal directions.

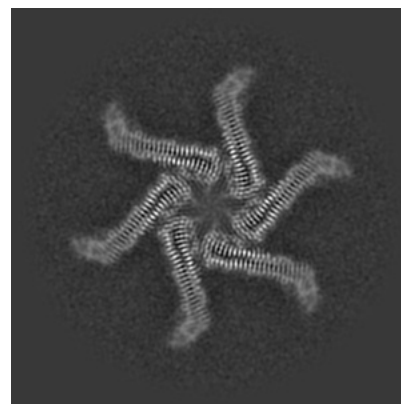

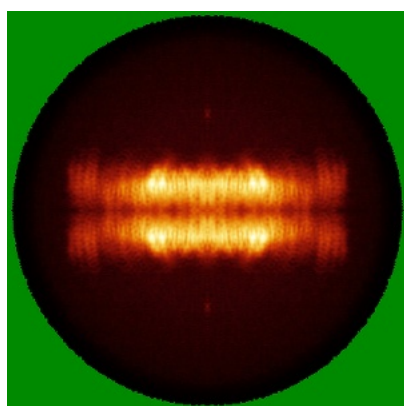

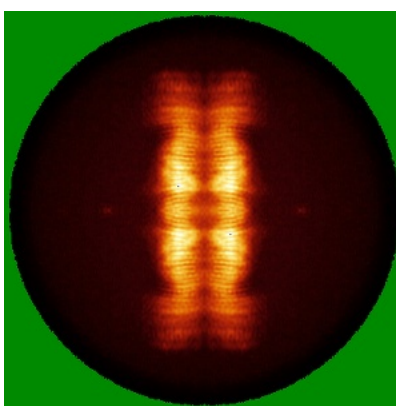

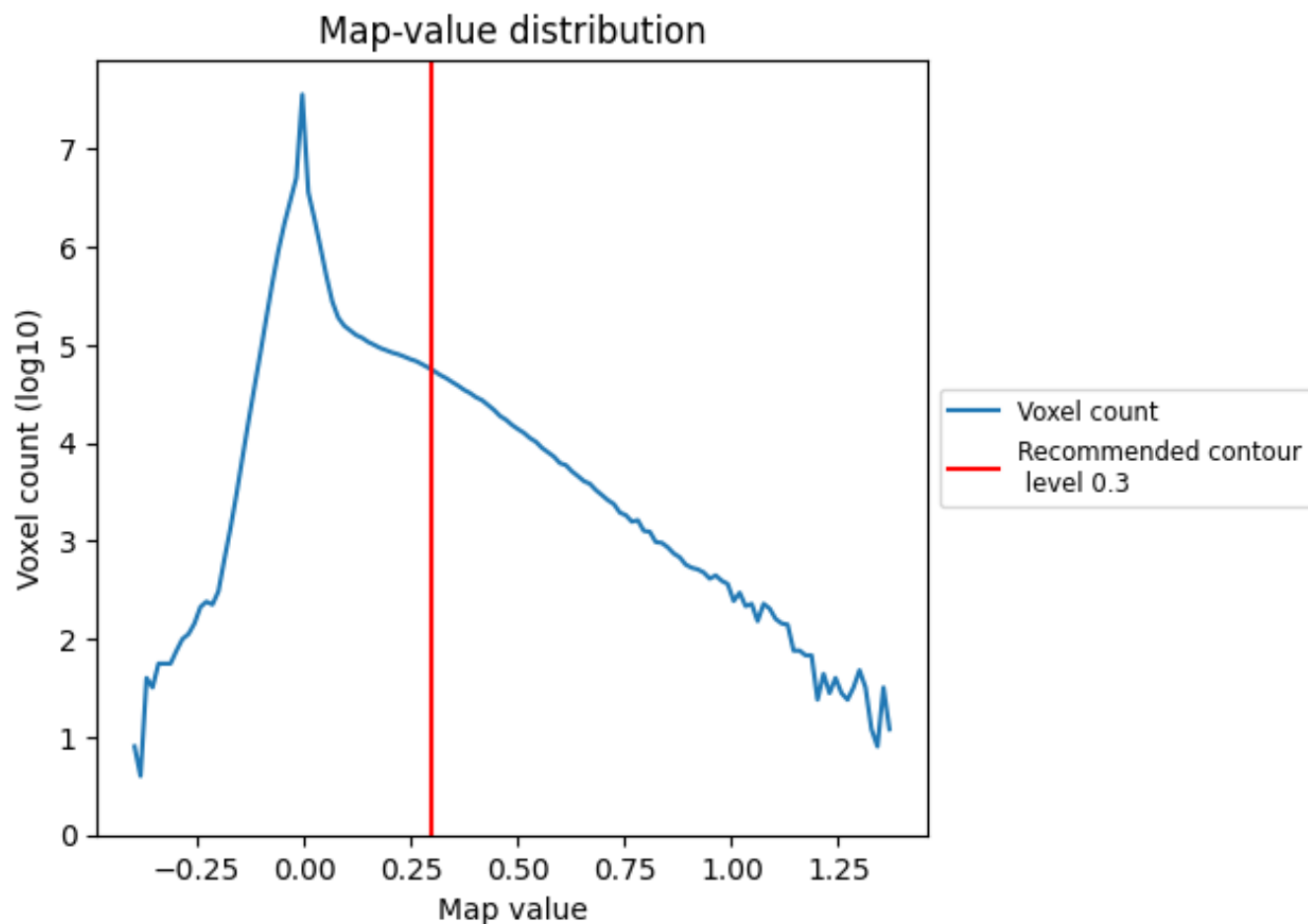

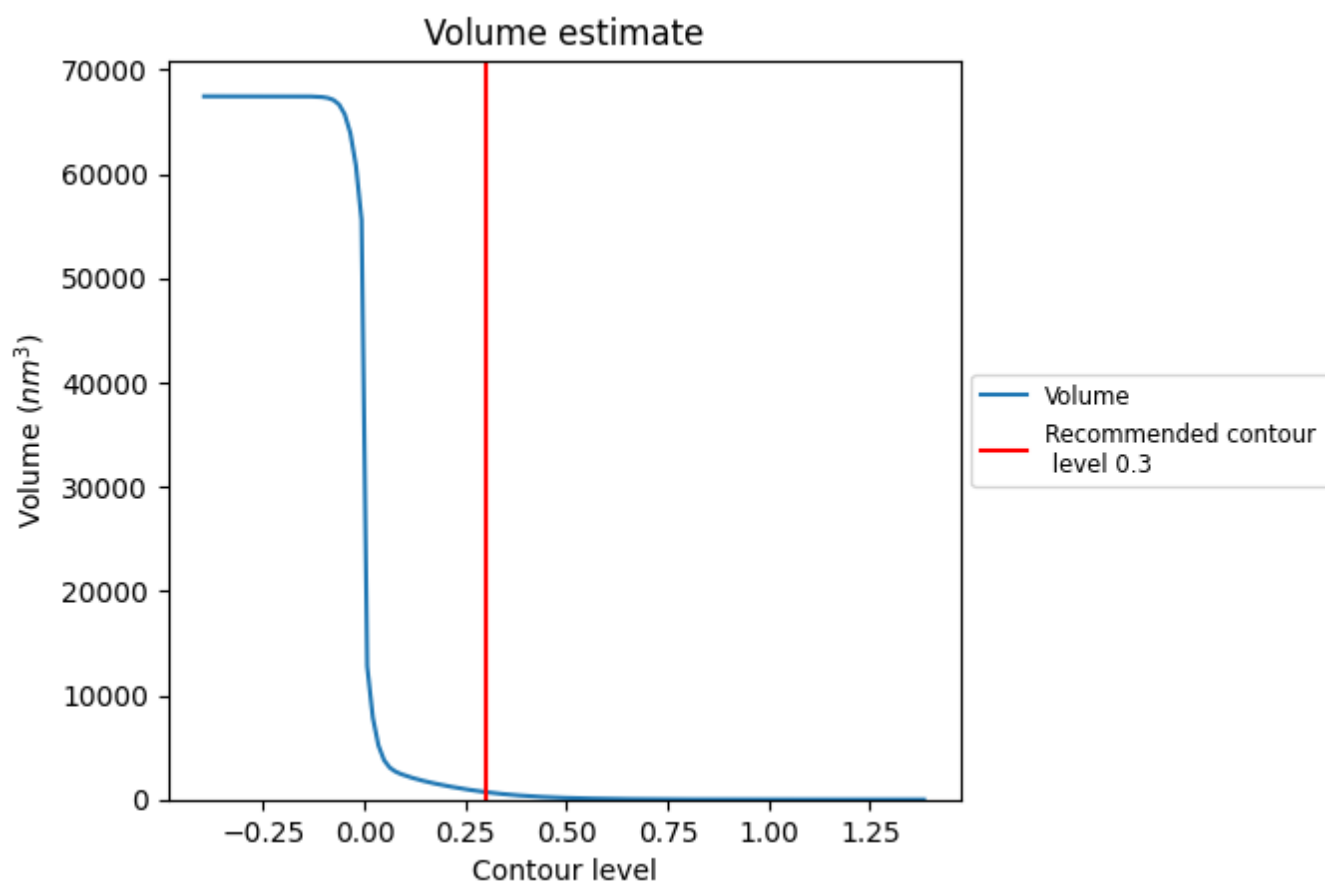

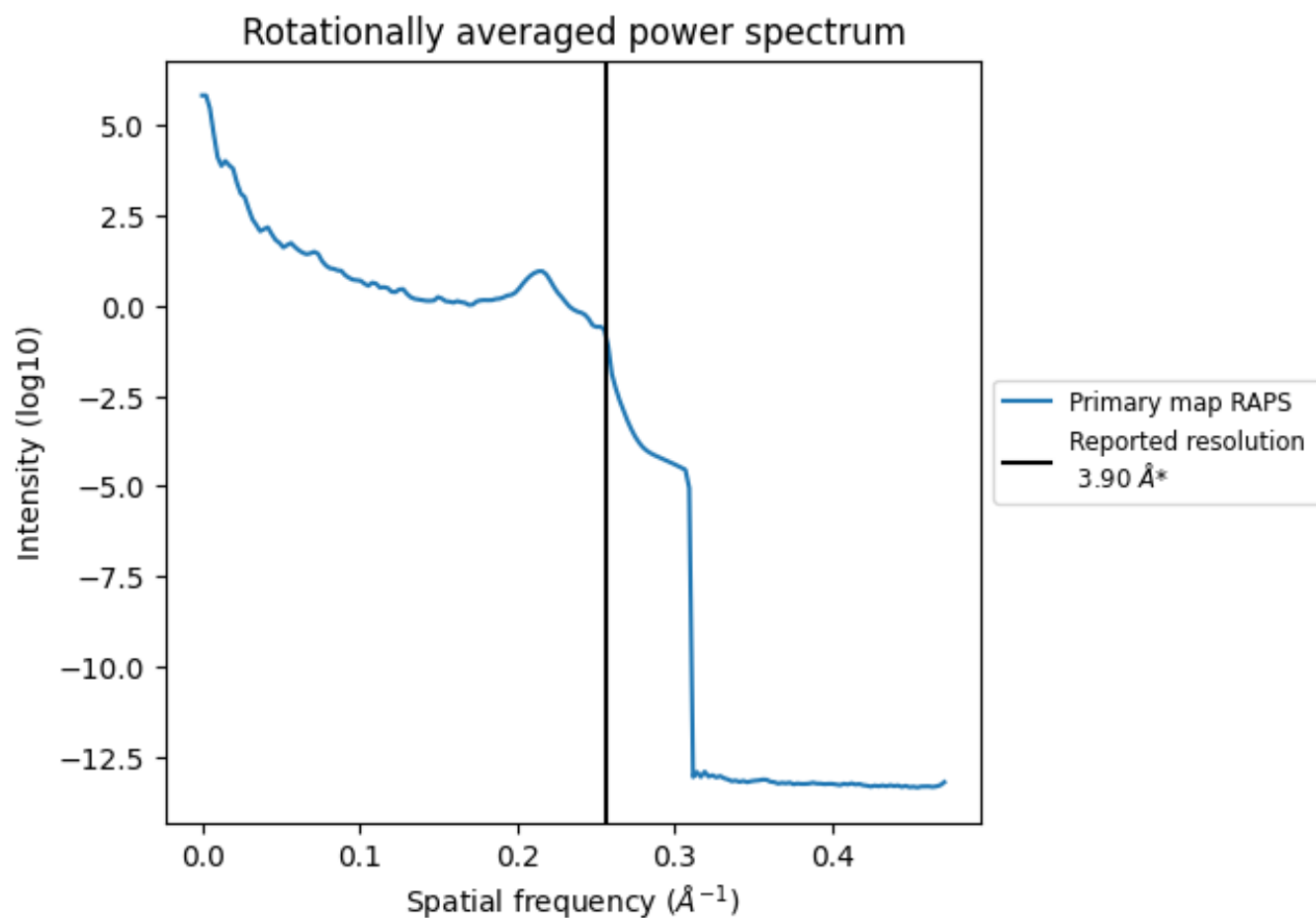
7.2 Volume estimate [i](#)



The volume at the recommended contour level is 716 nm³; this corresponds to an approximate mass of 647 kDa.

The volume estimate graph shows how the enclosed volume varies with the contour level. The recommended contour level is shown as a vertical line and the intersection between the line and the curve gives the volume of the enclosed surface at the given level.

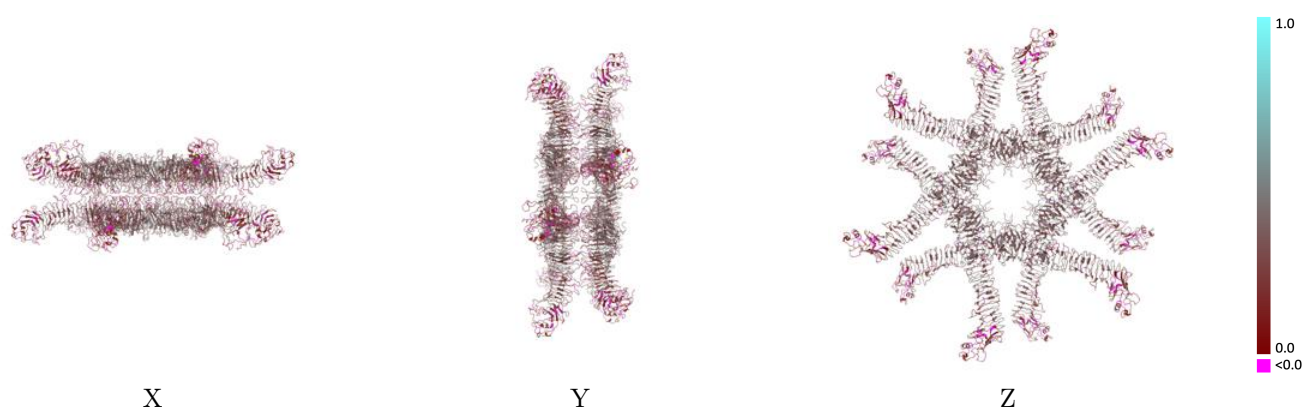

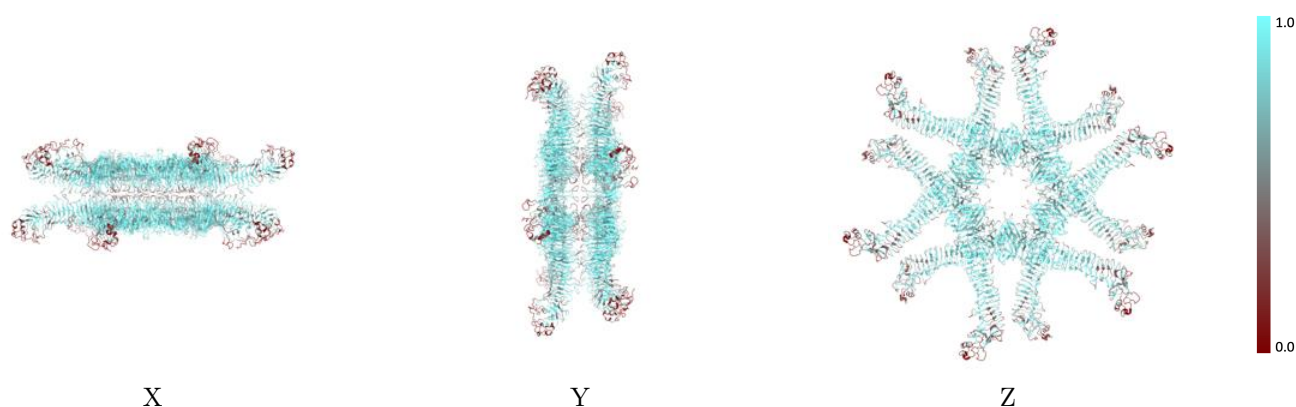

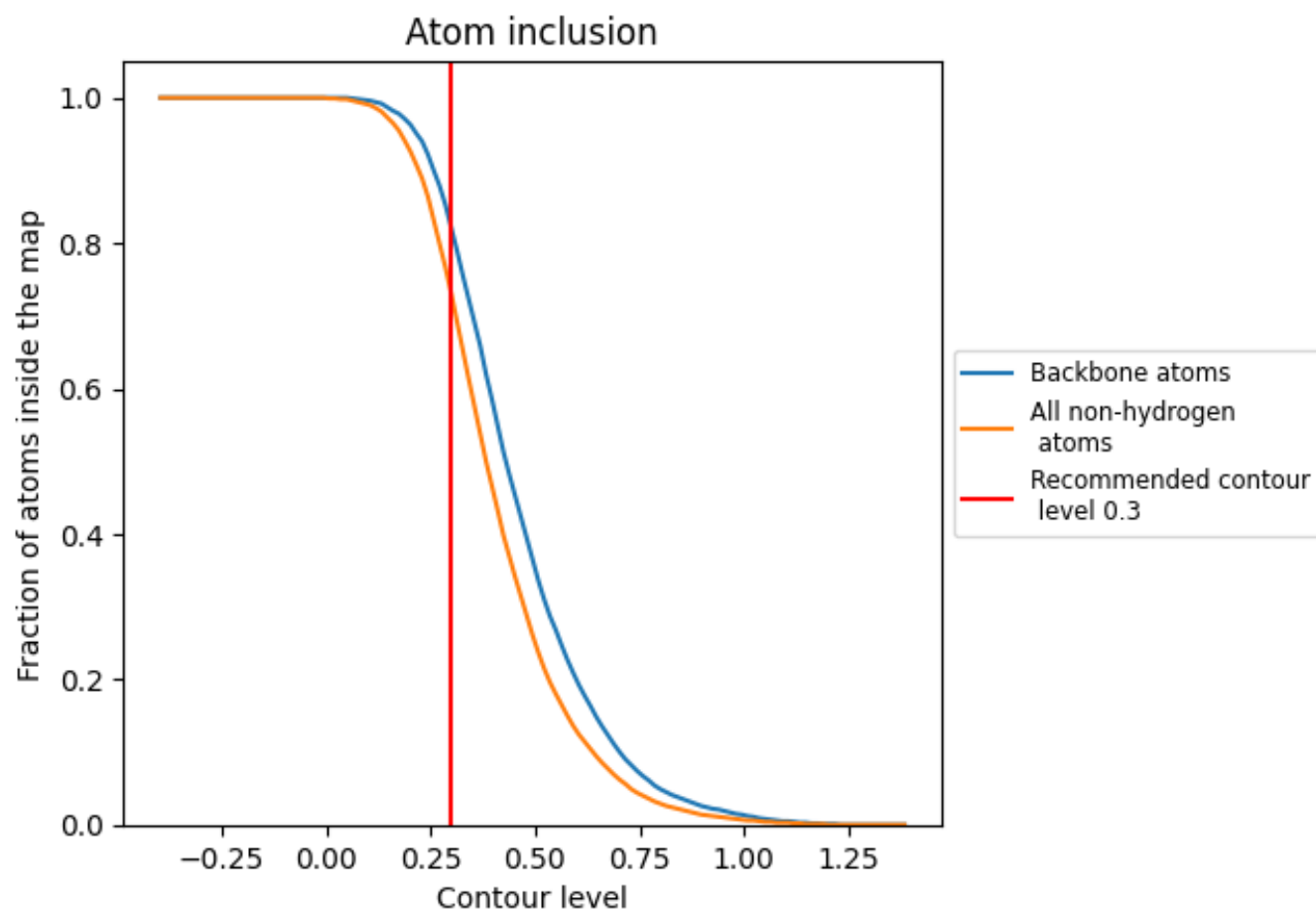
The images above show the model with each residue coloured according to its Q-score. This shows their resolvability in the map with higher Q-score values reflecting better resolvability. Please note: Q-score is calculating the resolvability of atoms, and thus high values are only expected at resolutions at which atoms can be resolved. Low Q-score values may therefore be expected for many entries.

The images above show the model with each residue coloured according to its atom inclusion. This shows to what extent they are inside the map at the recommended contour level (0.3).

At the recommended contour level, 82% of all backbone atoms, 73% of all non-hydrogen atoms, are inside the map.
