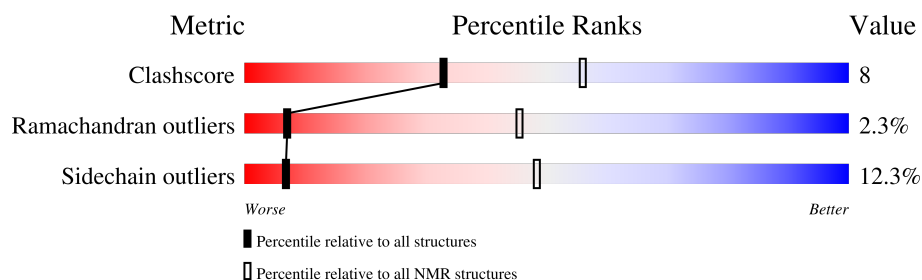
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

*SOLID-STATE NMR*

The overall completeness of chemical shifts assignment is 32%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$

## 2 Ensemble composition and analysis

This entry contains 10 models. Model 1 is the overall representative, medoid model (most similar to other models).

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 2 clusters and 1 single-model cluster was found.

### 3 Entry composition

There is only 1 type of molecule in this entry. The entry contains 4313 atoms, of which 2146 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called Voltage-dependent anion-selective channel protein 1.

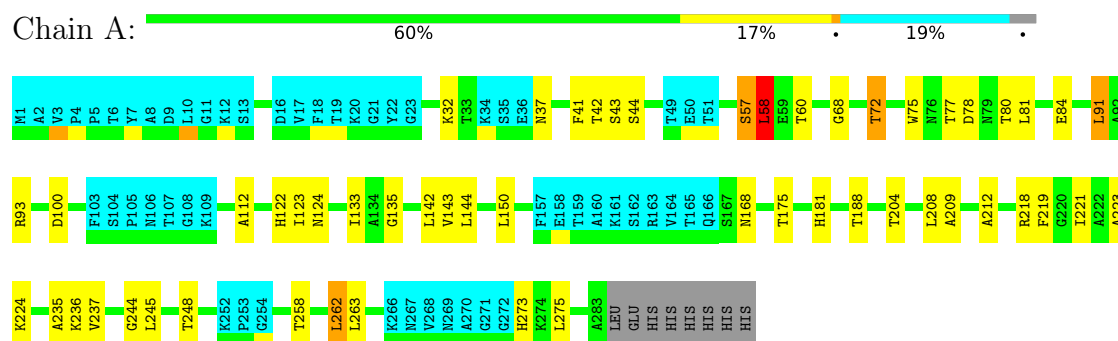

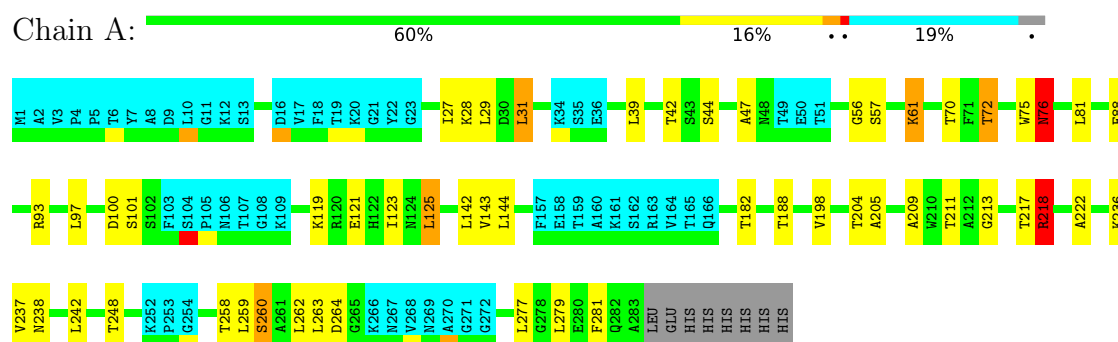

- Molecule 1: Voltage-dependent anion-selective channel protein 1



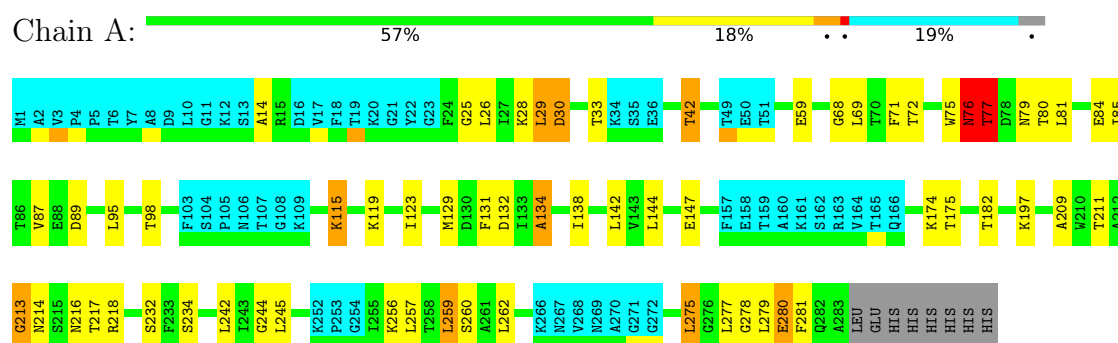
### 4.2.3 Score per residue for model 3

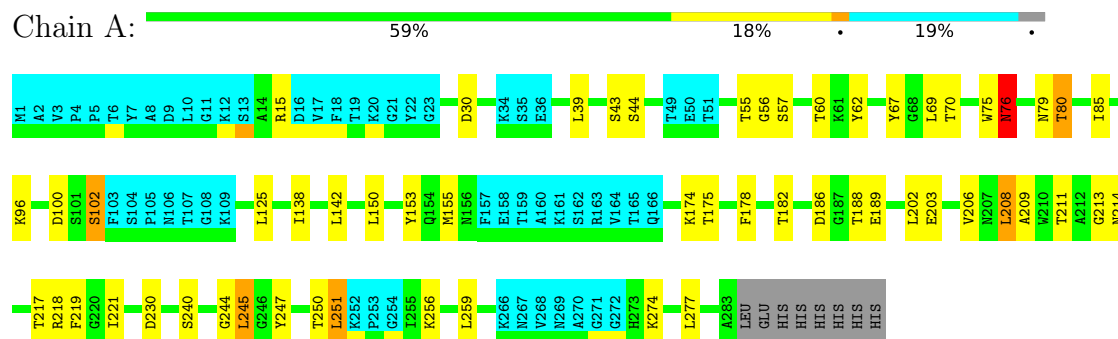

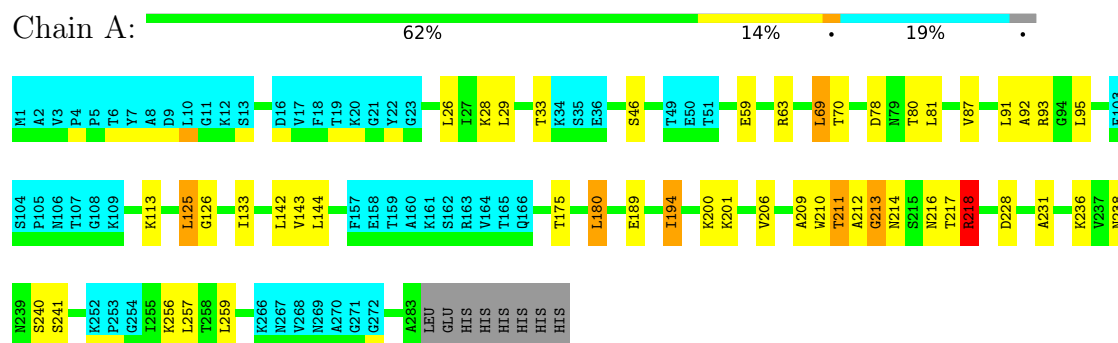
### 4.2.8 Score per residue for model 8

- Molecule 1: Voltage-dependent anion-selective channel protein 1



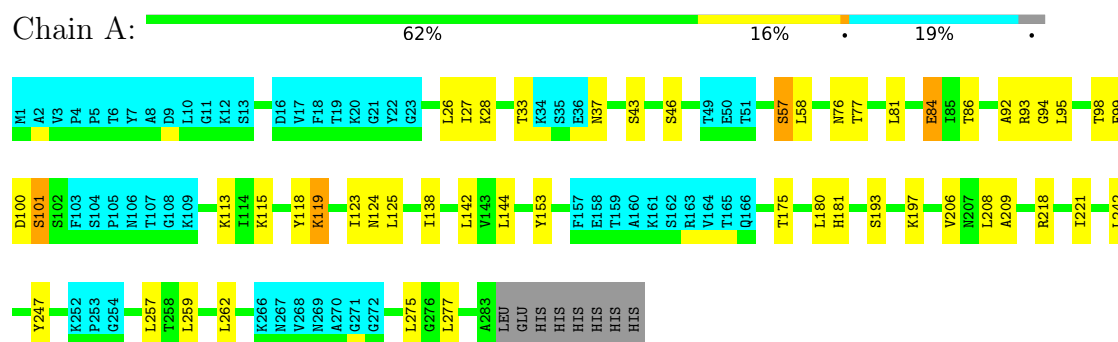
### 4.2.9 Score per residue for model 9

### 6.2 Too-close contacts

In the following table, the Non-H and H(model) columns list the number of non-hydrogen atoms and hydrogen atoms in each chain respectively. The H(added) column lists the number of hydrogen atoms added and optimized by MolProbity. The Clashes column lists the number of clashes averaged over the ensemble.

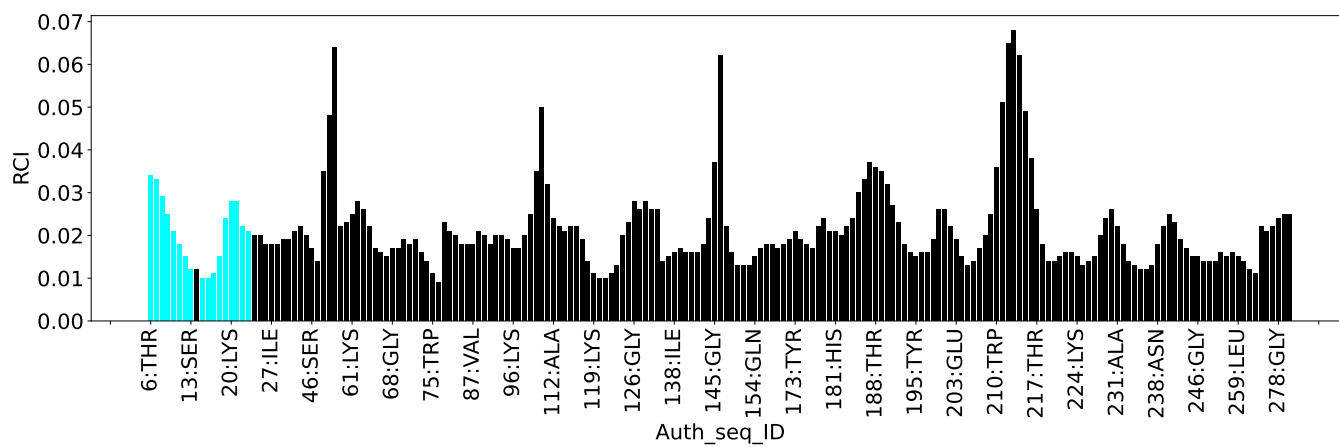

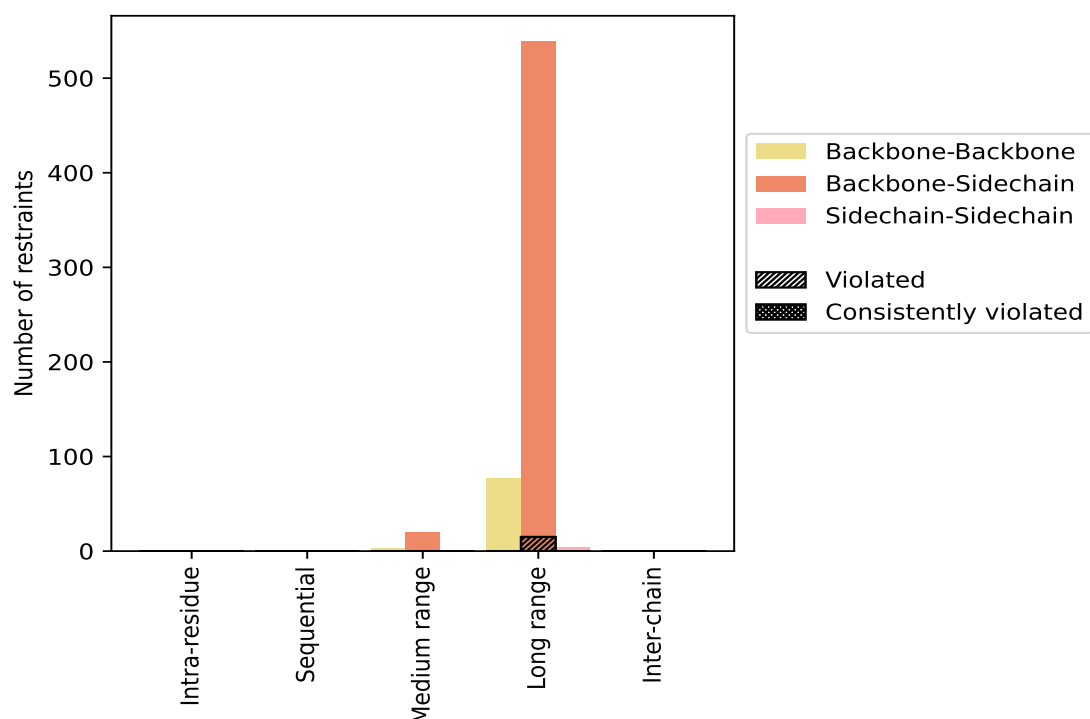

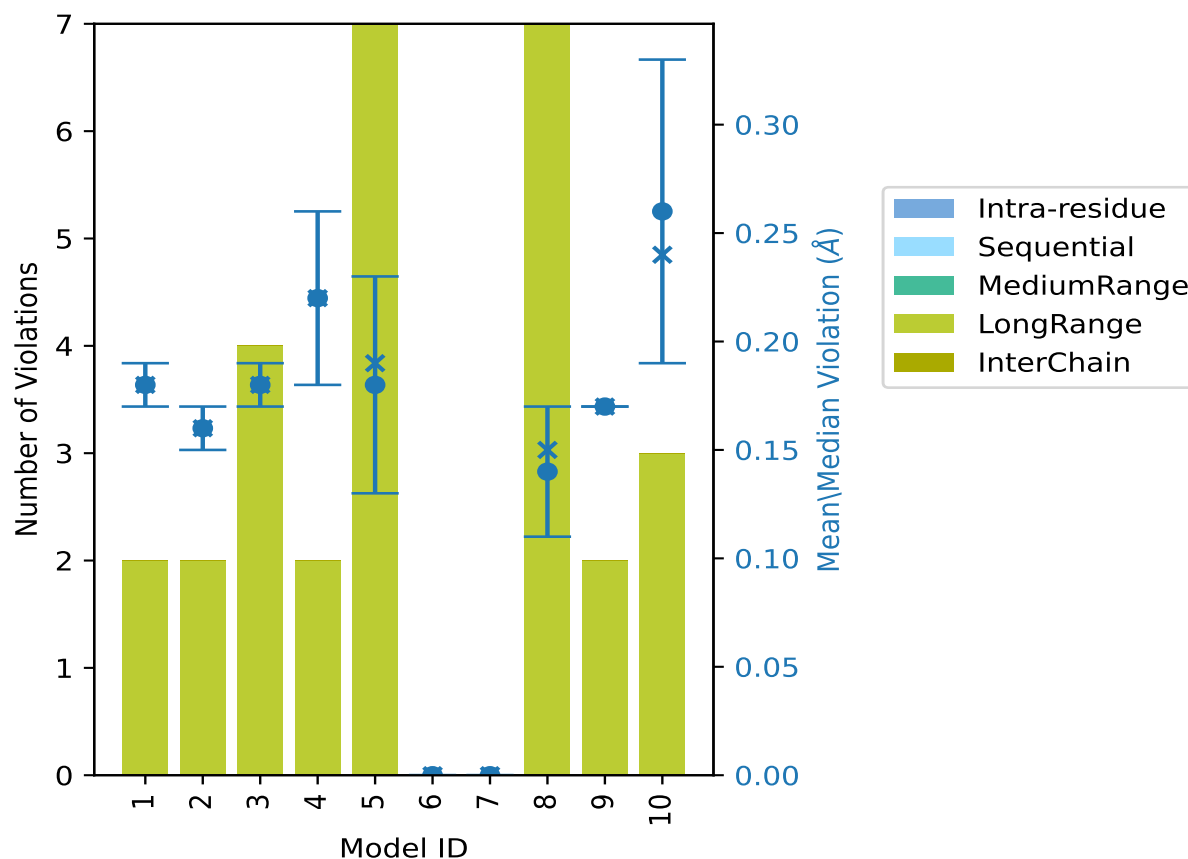

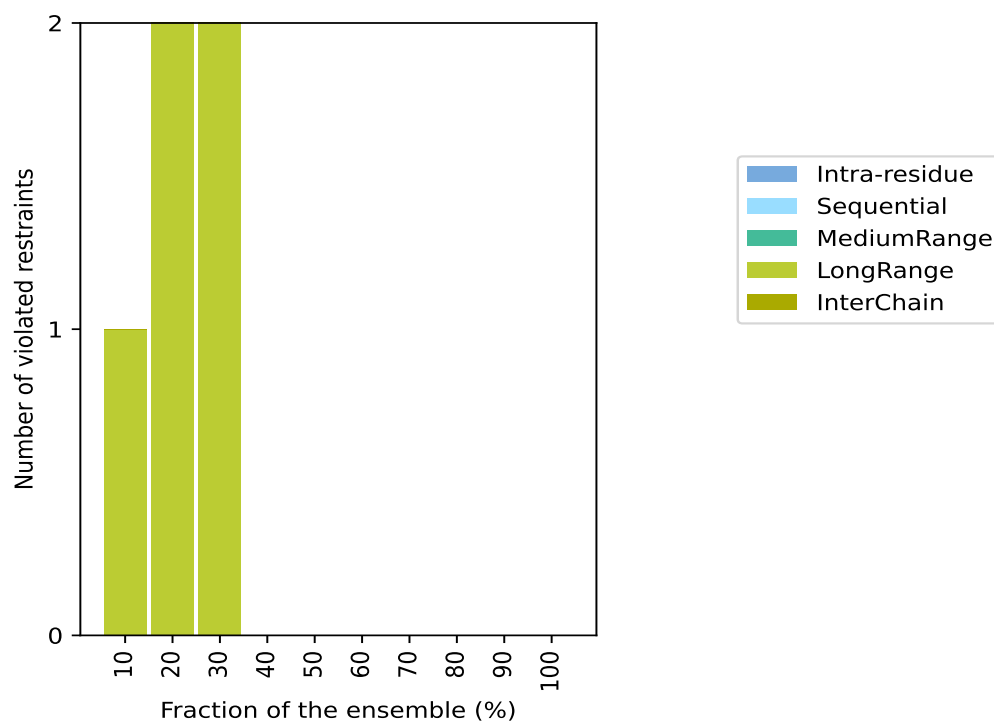

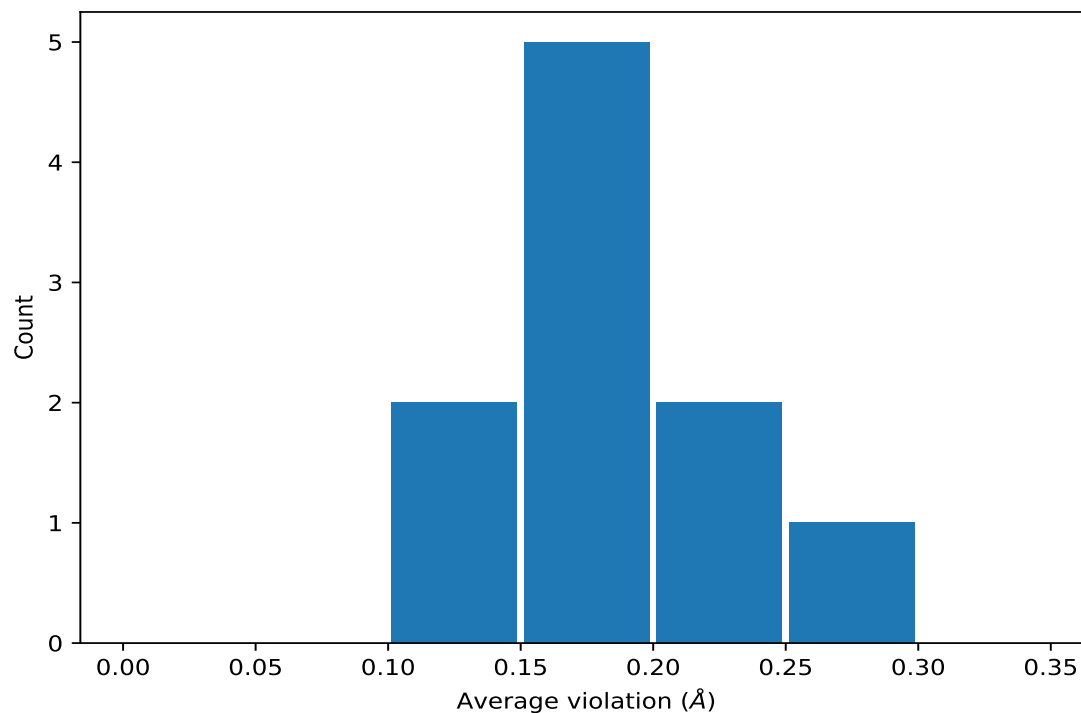

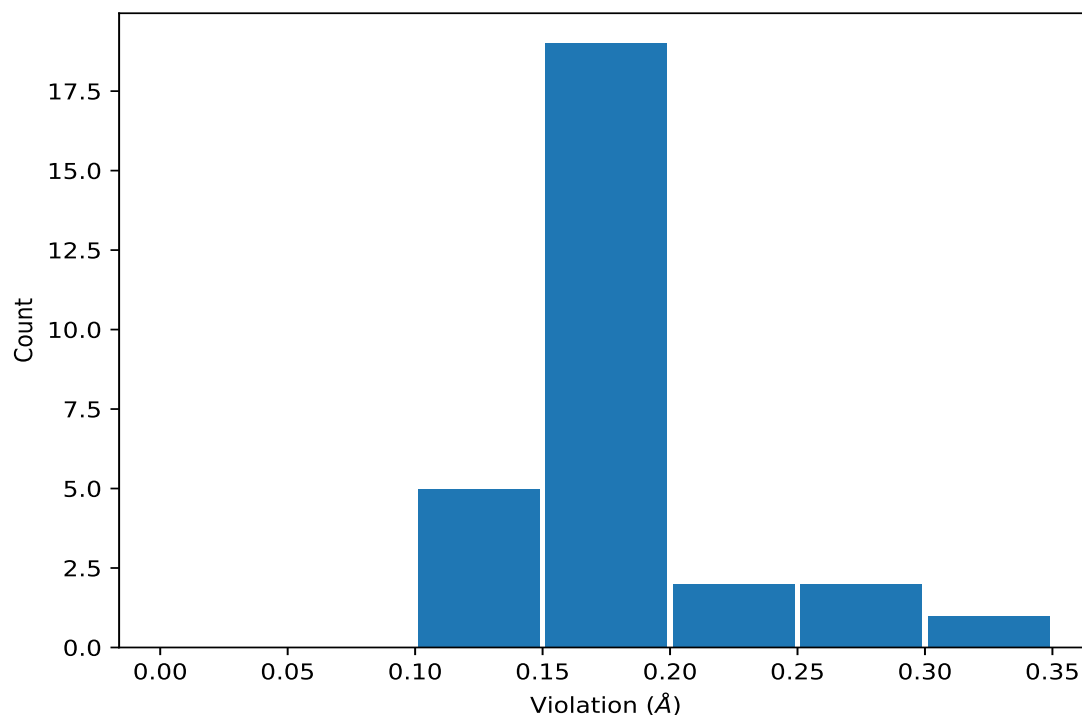

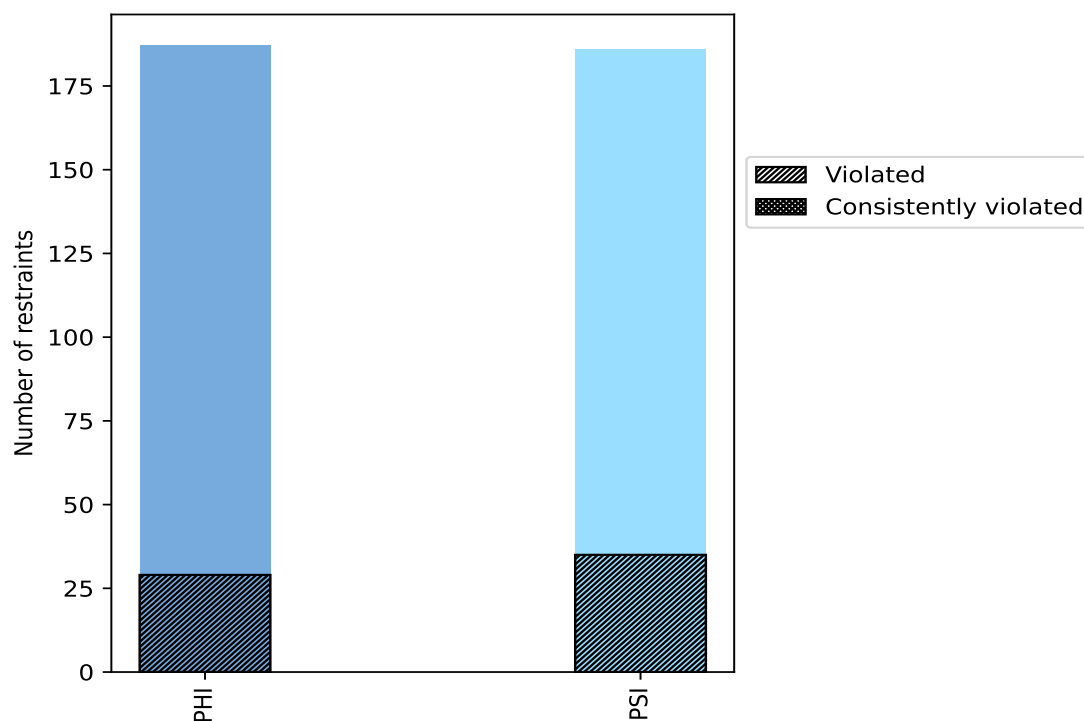

#### 10.1.1 Bar chart : Distribution of dihedral-angles and violations [i](#)



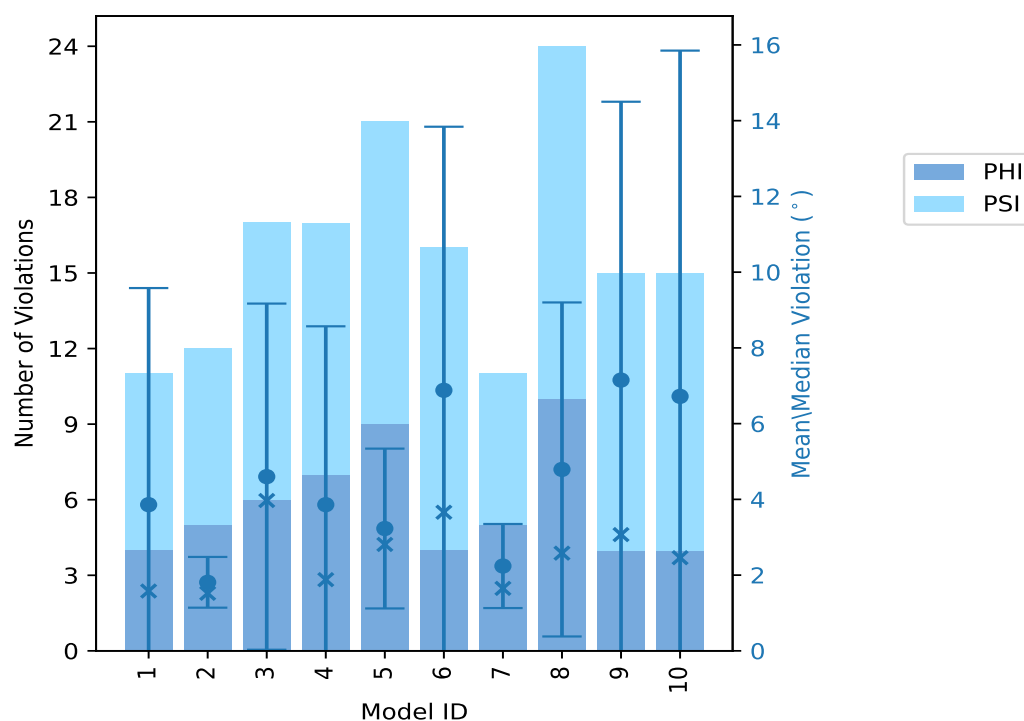

The mean(dot),median(x) and the standard deviation are shown in blue with respect to the y axis on the right

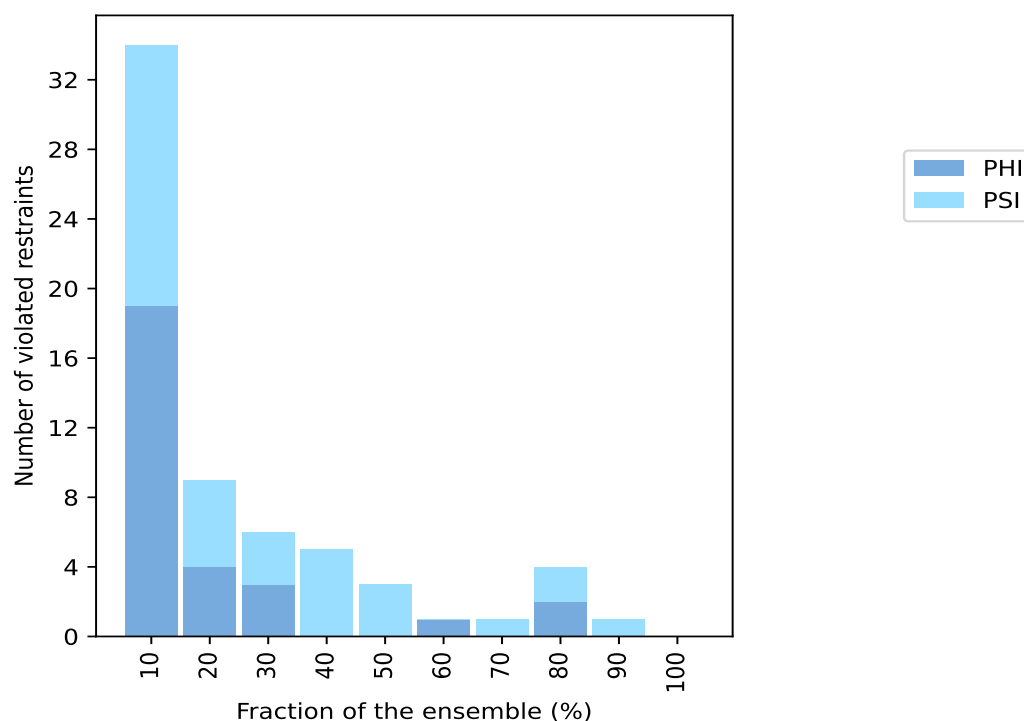

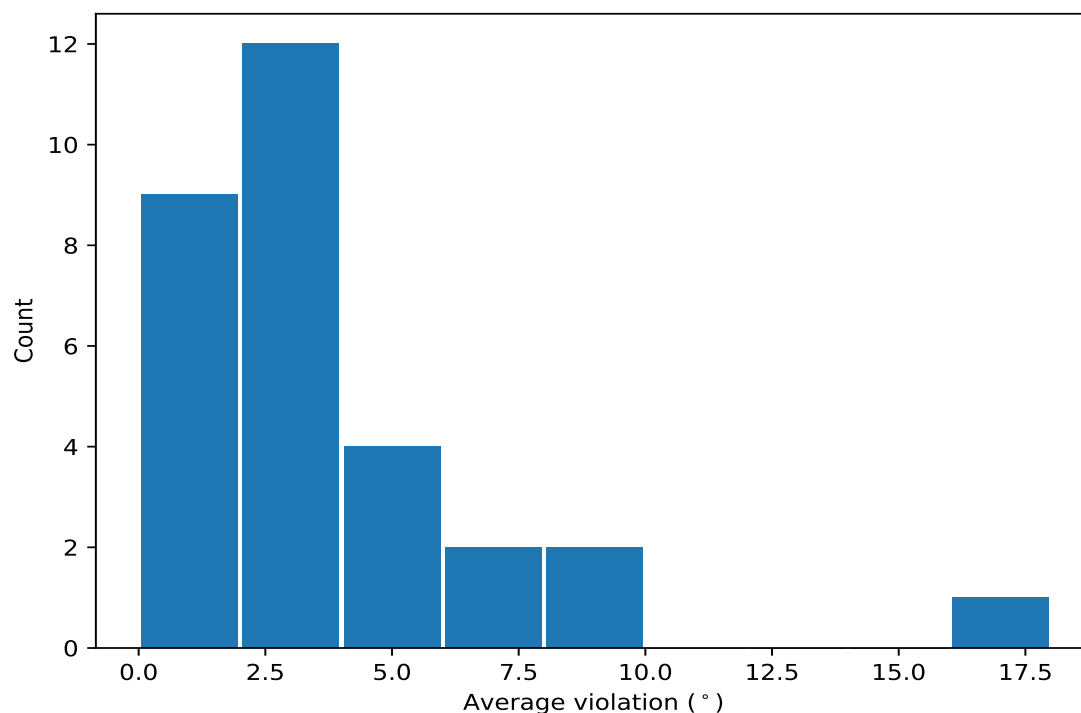

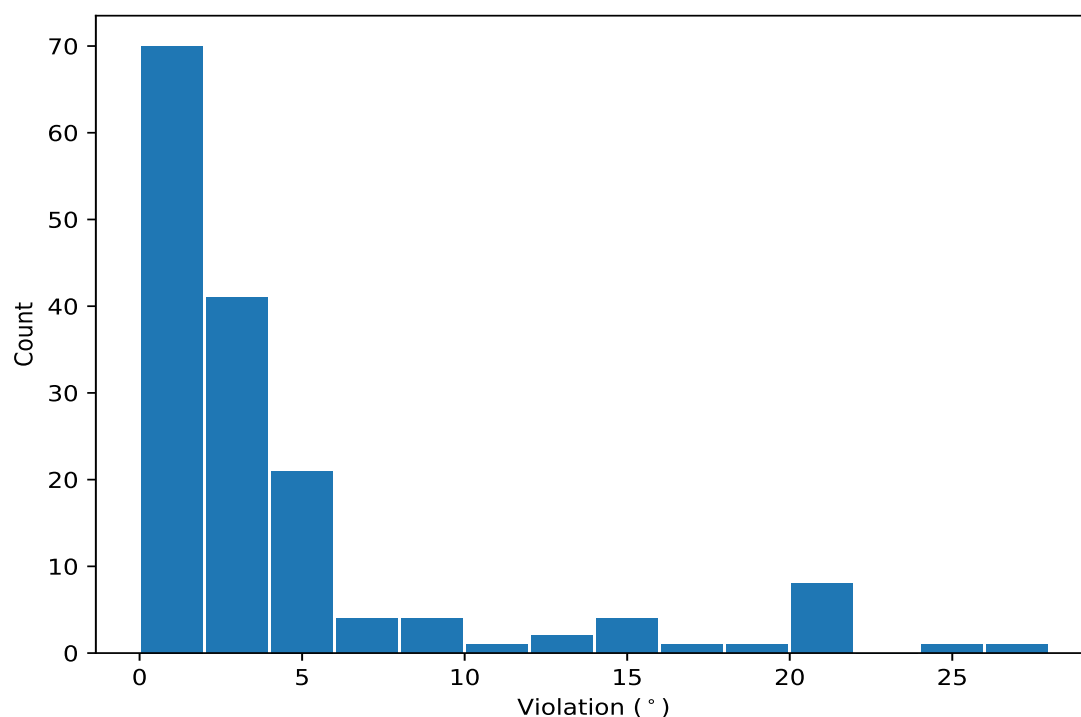
