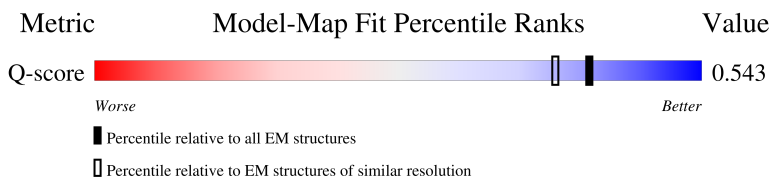
1 Overall quality at a glance

ELECTRON MICROSCOPY

A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

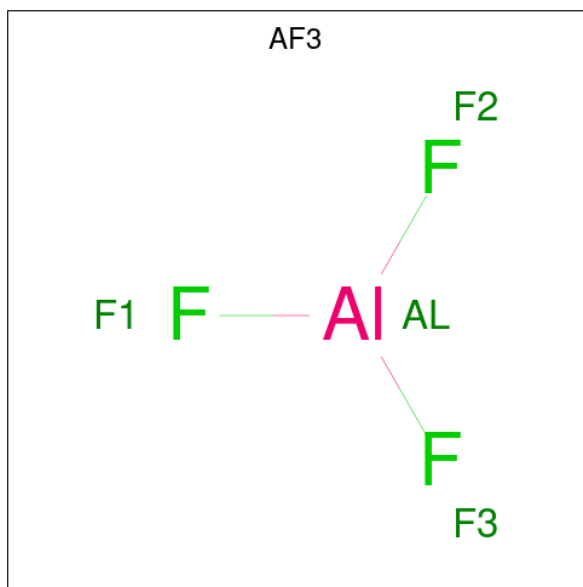

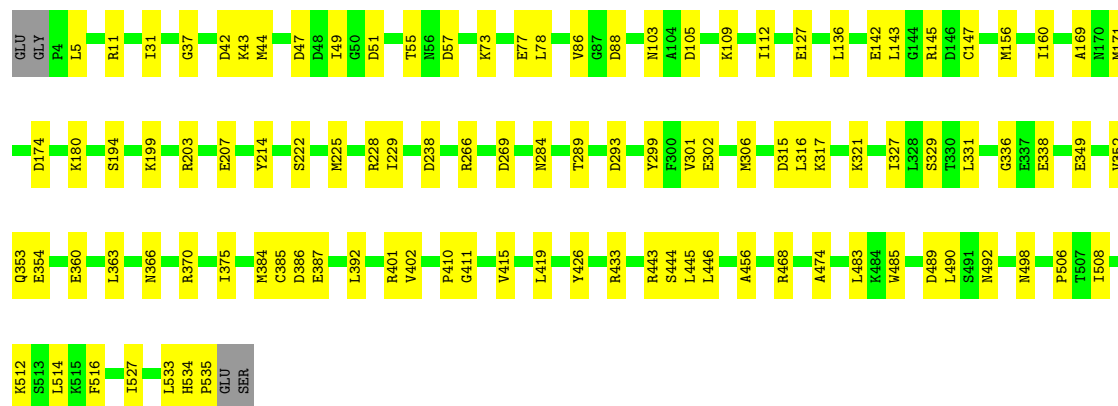

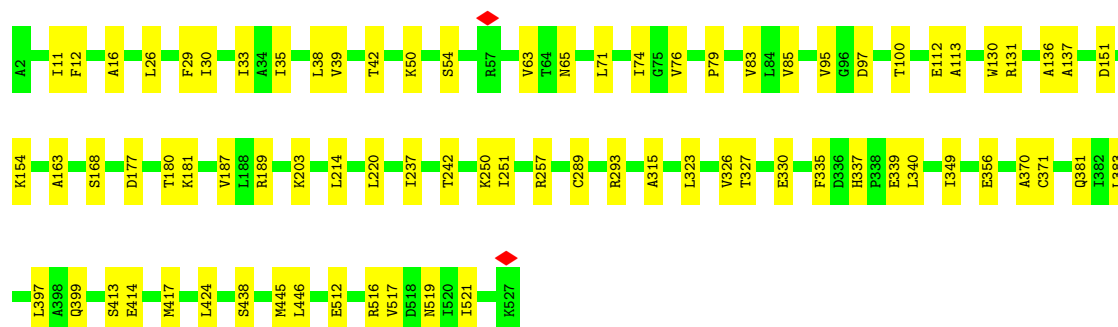
• Molecule 2: T-complex protein 1 subunit alpha

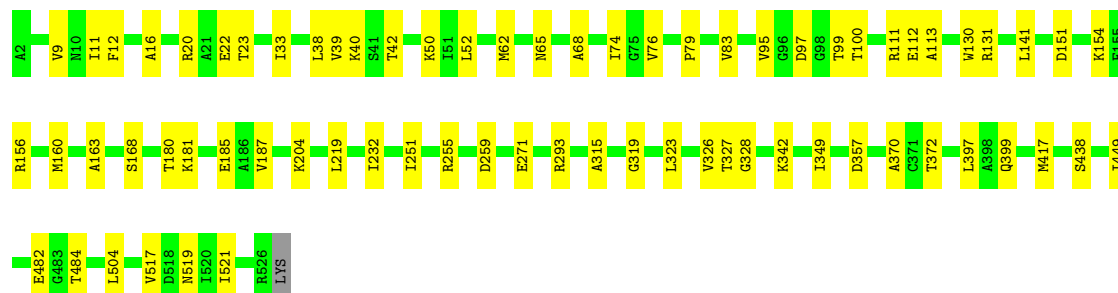
• Molecule 3: T-complex protein 1 subunit beta

Chain B: 85% 15%



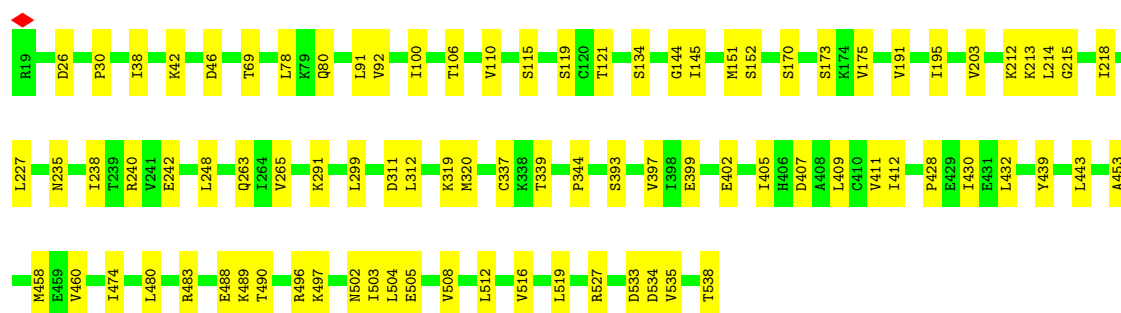
• Molecule 3: T-complex protein 1 subunit beta

Chain b: 86% 13%



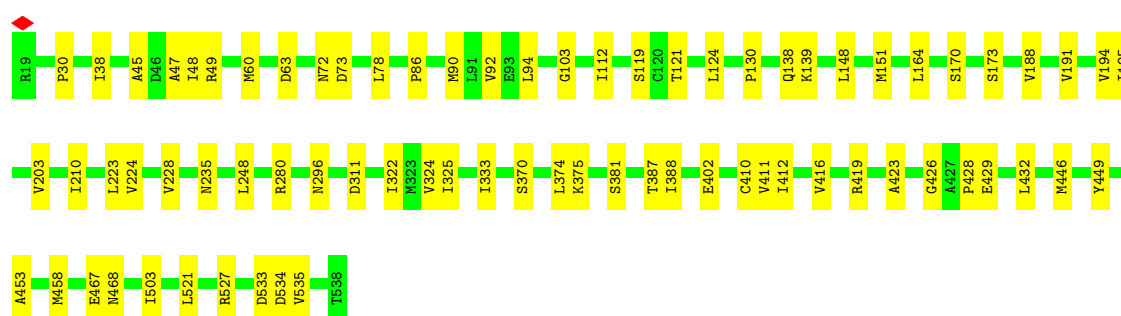
• Molecule 4: T-complex protein 1 subunit delta

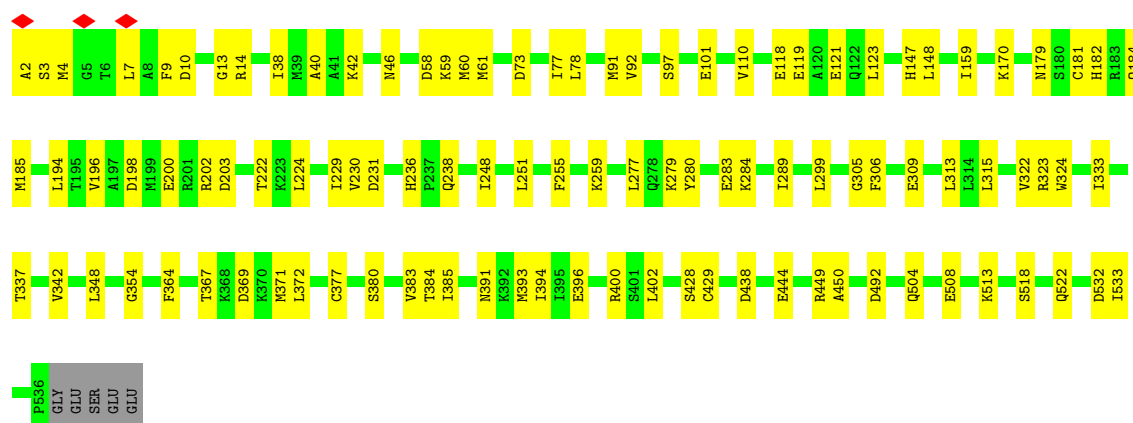

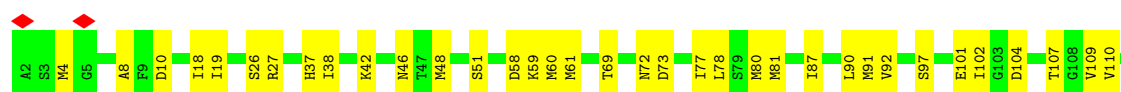
• Molecule 5: T-complex protein 1 subunit epsilon

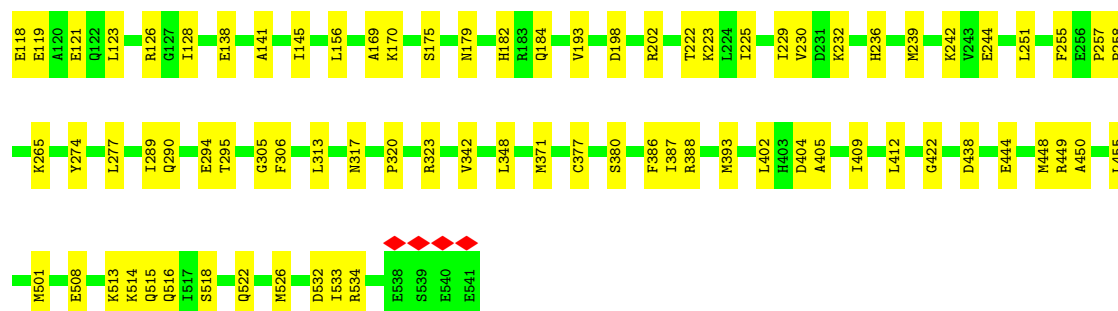

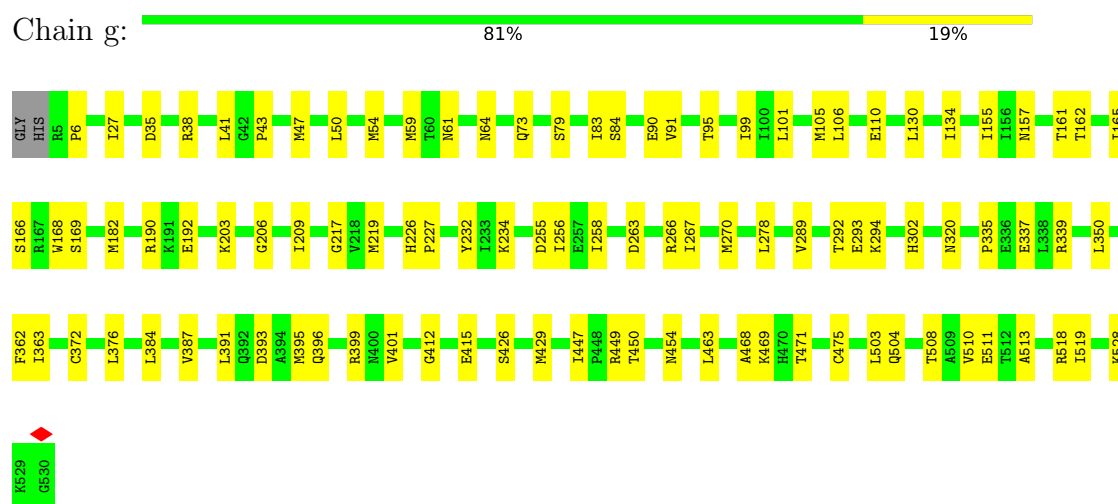




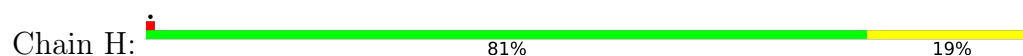
- Molecule 6: T-complex protein 1 subunit gamma

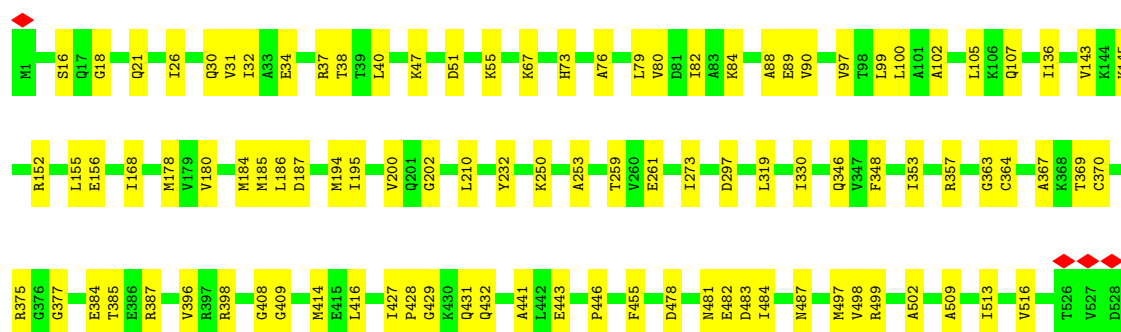

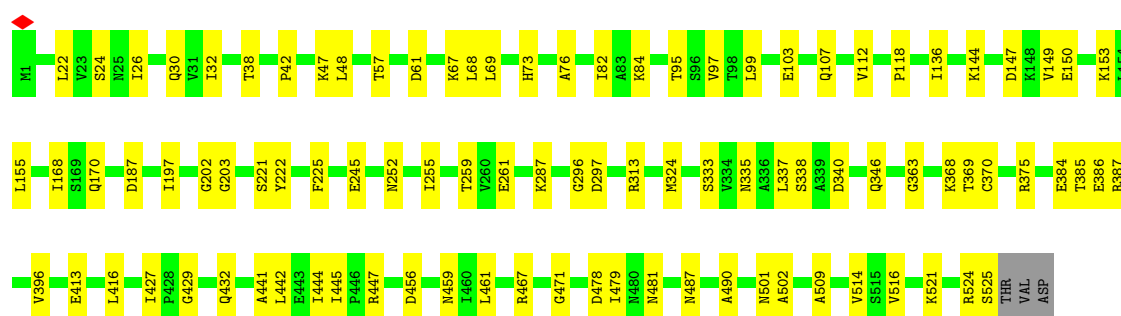
- Molecule 7: T-complex protein 1 subunit eta, N-terminally processed





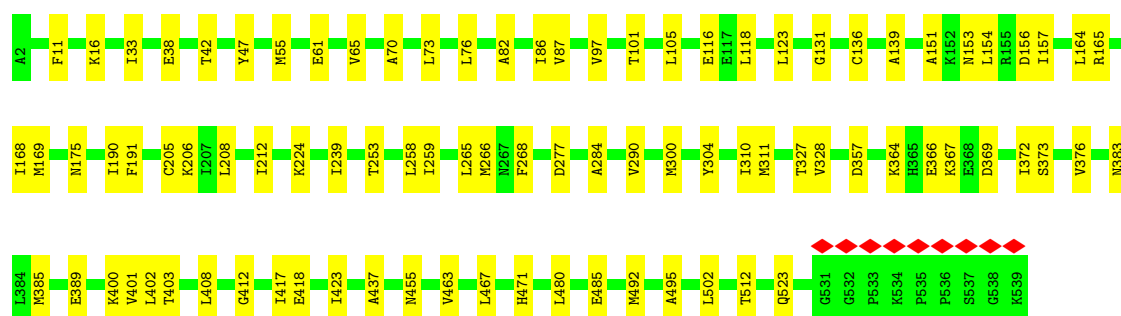

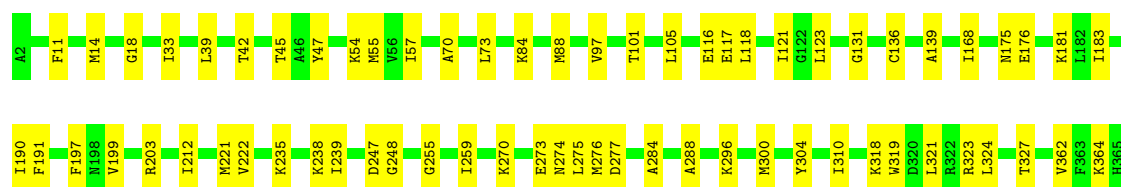
- Molecule 8: T-complex protein 1 subunit theta

Chain Q: 83% 17%



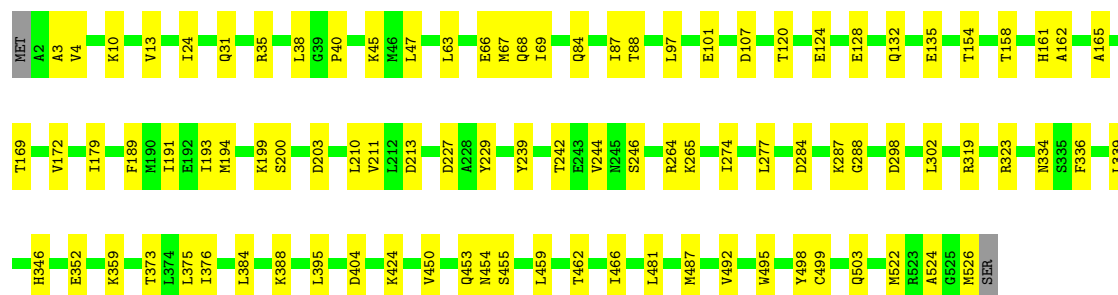

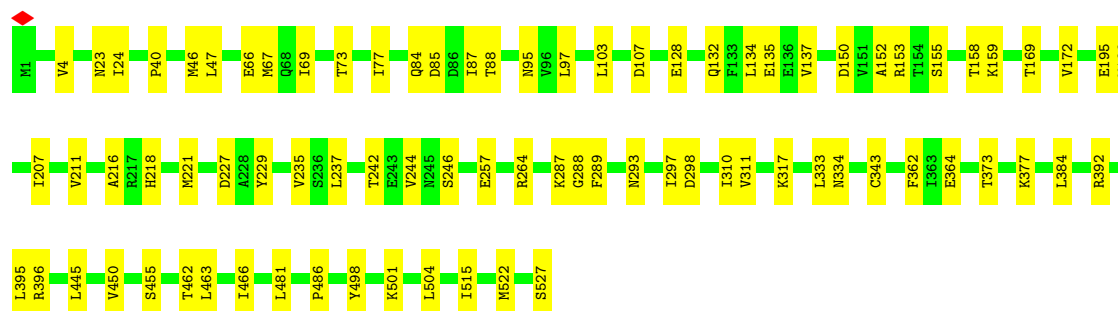
- Molecule 9: T-complex protein 1 subunit zeta

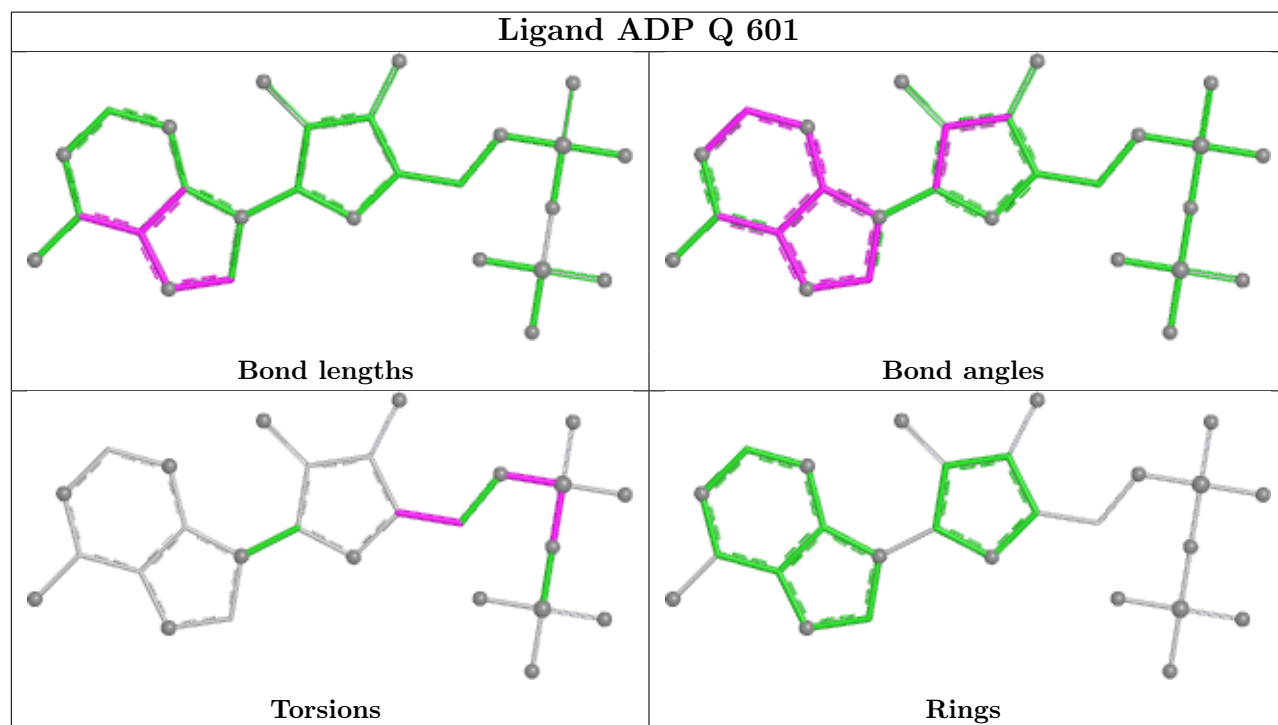
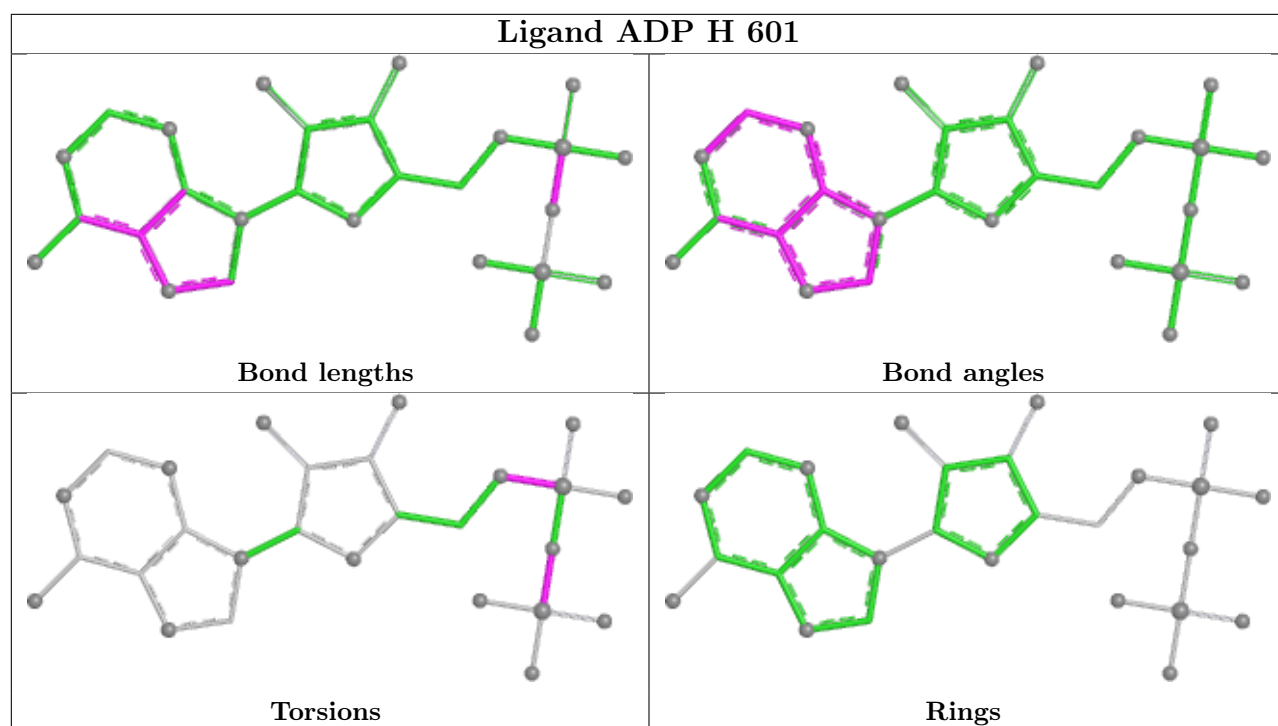
The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for all instances of the Ligand of Interest. The outliers are highlighted in purple. The color gray indicates Mogul did not find sufficient equivalents in the CSD to analyse the geometry.

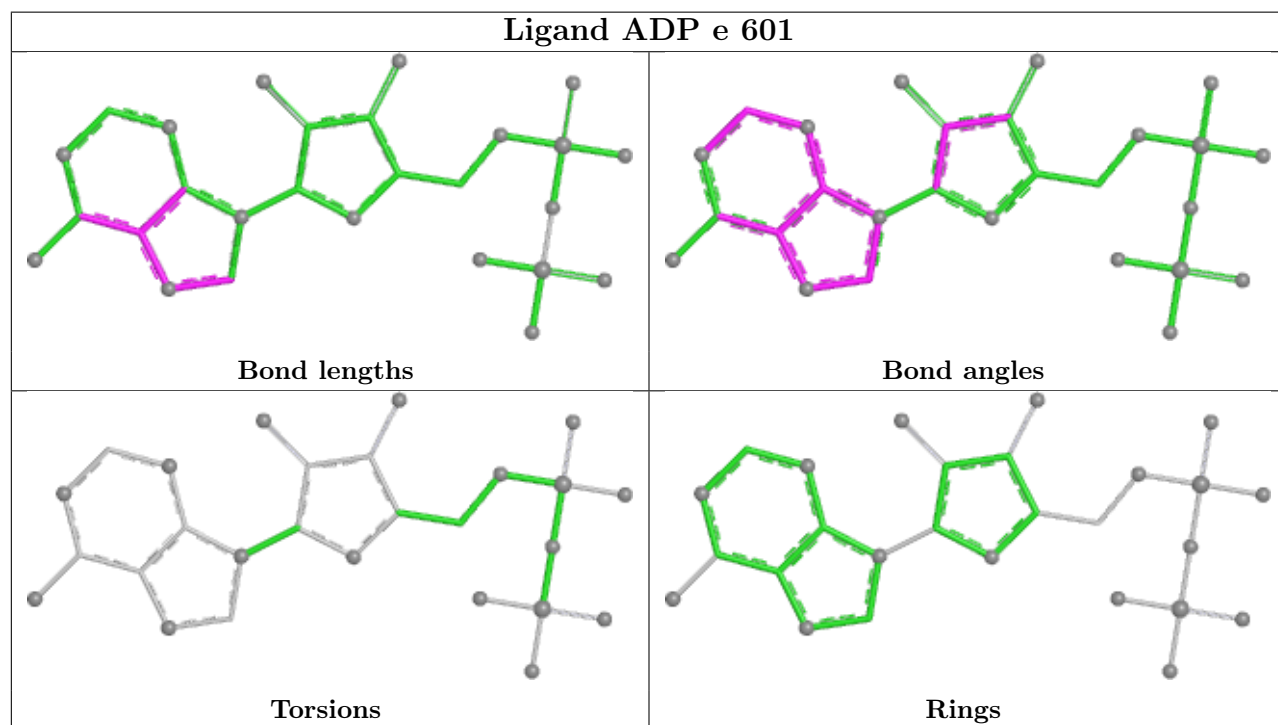
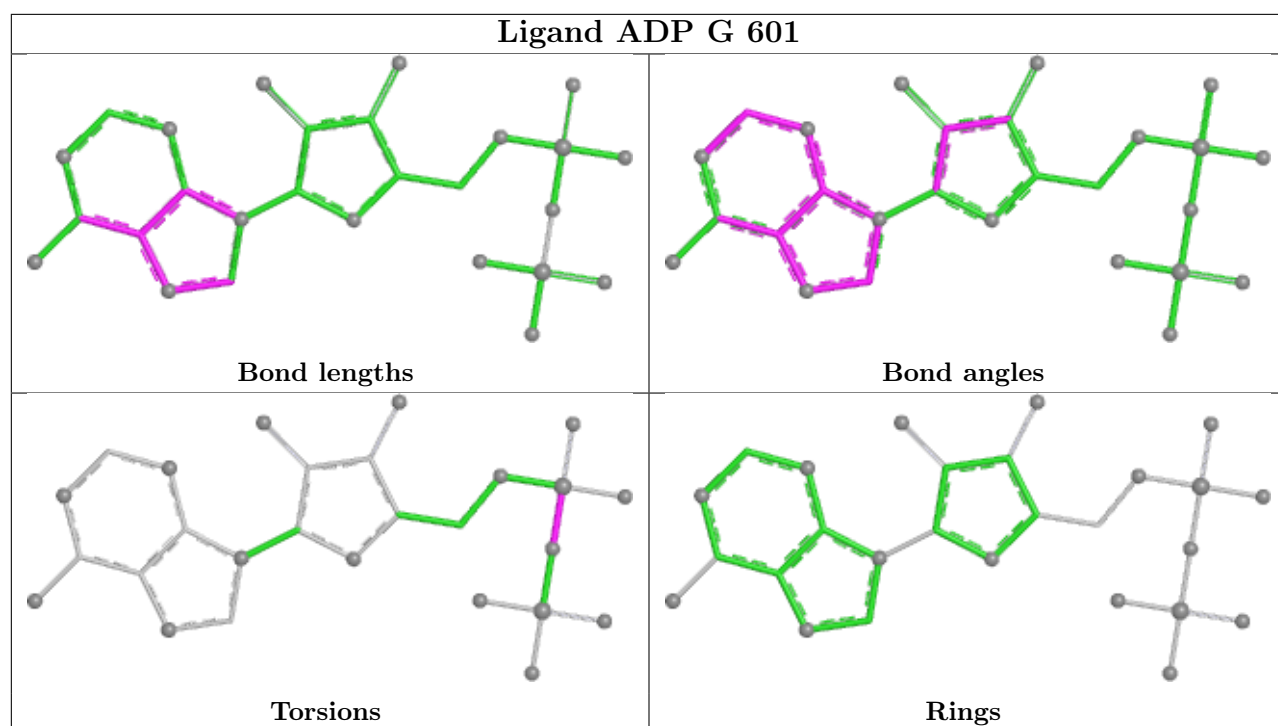


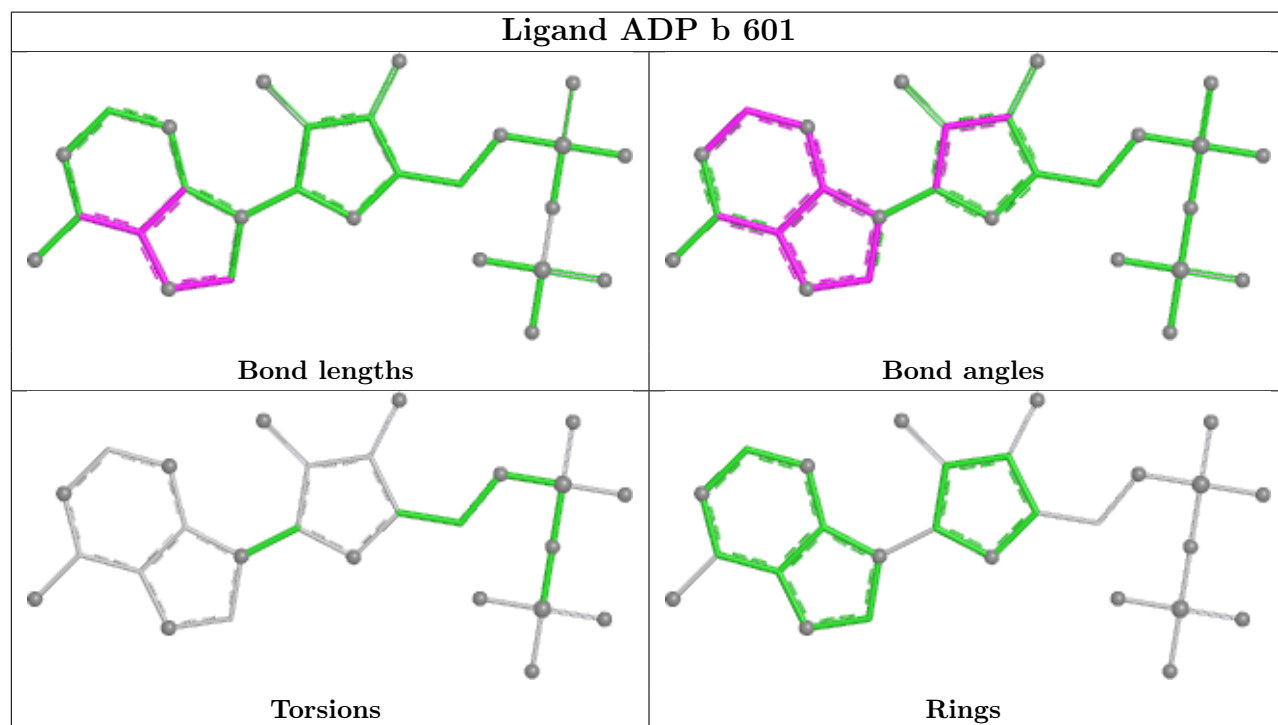
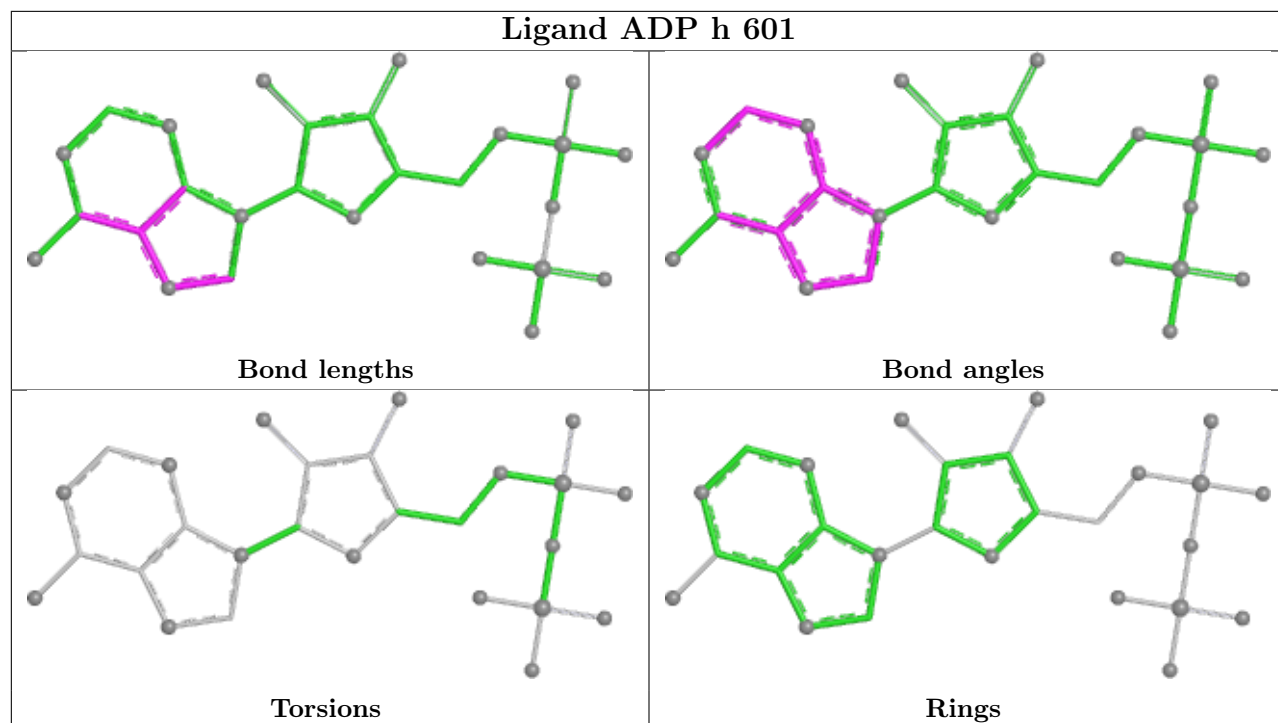


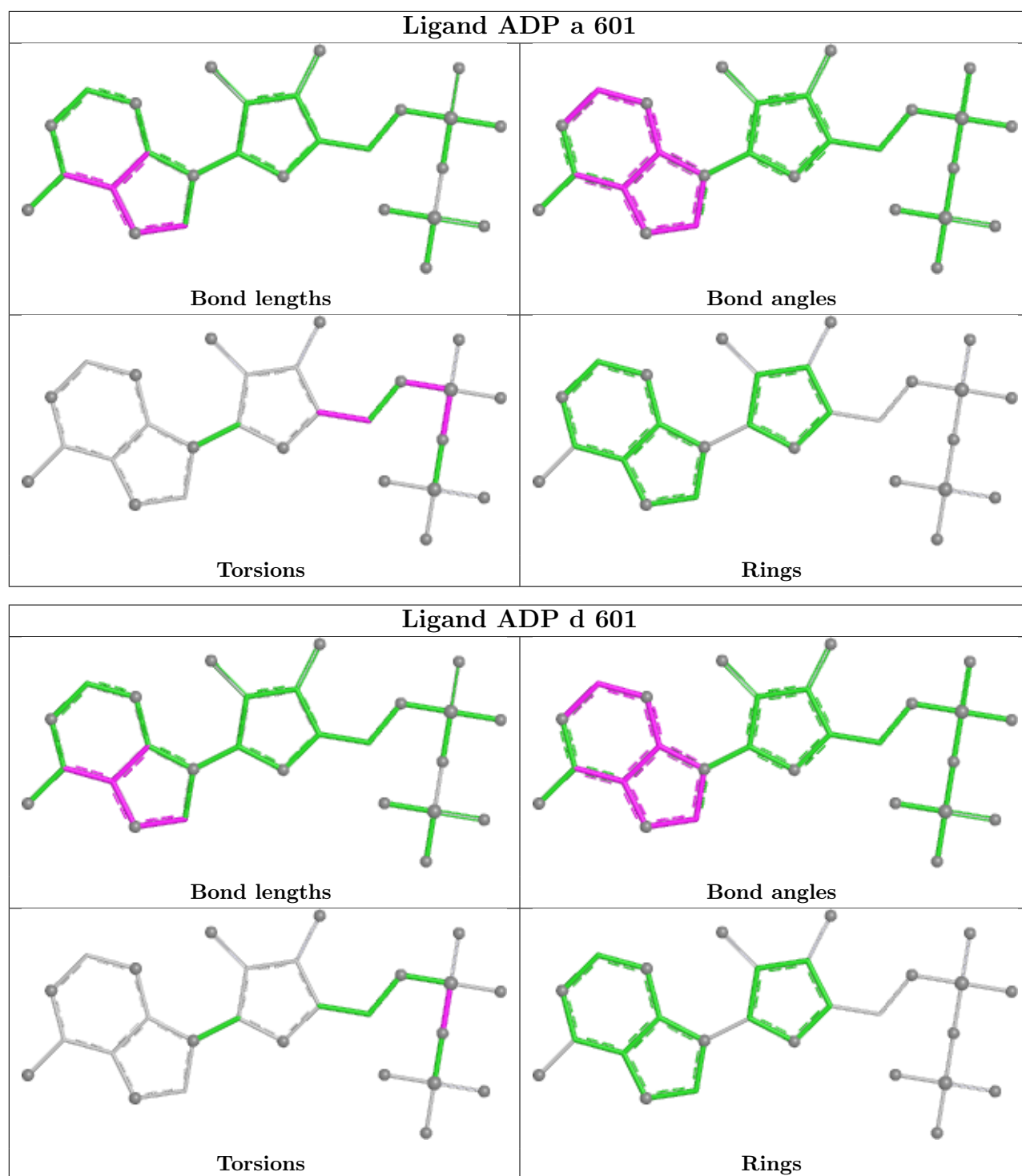

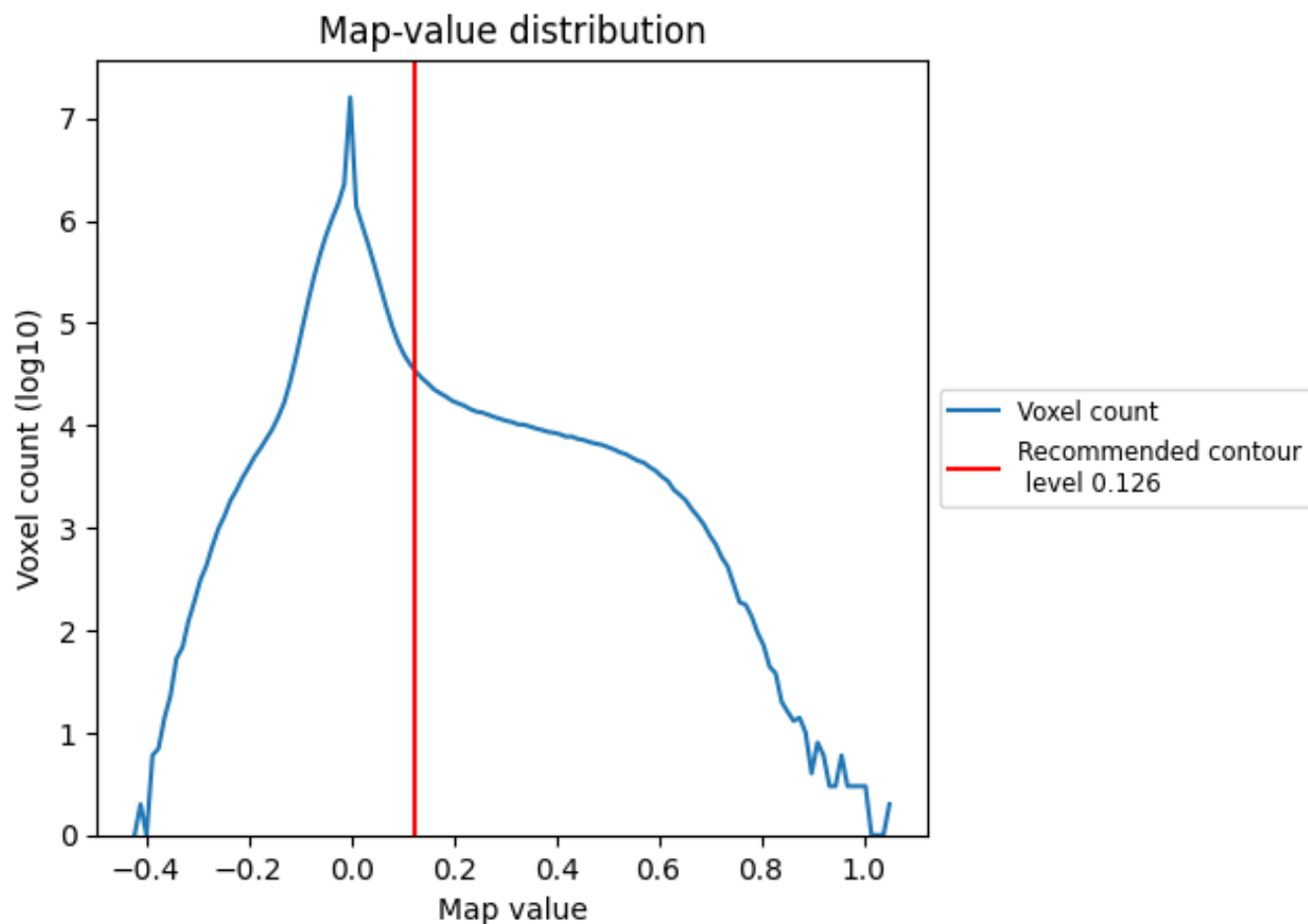

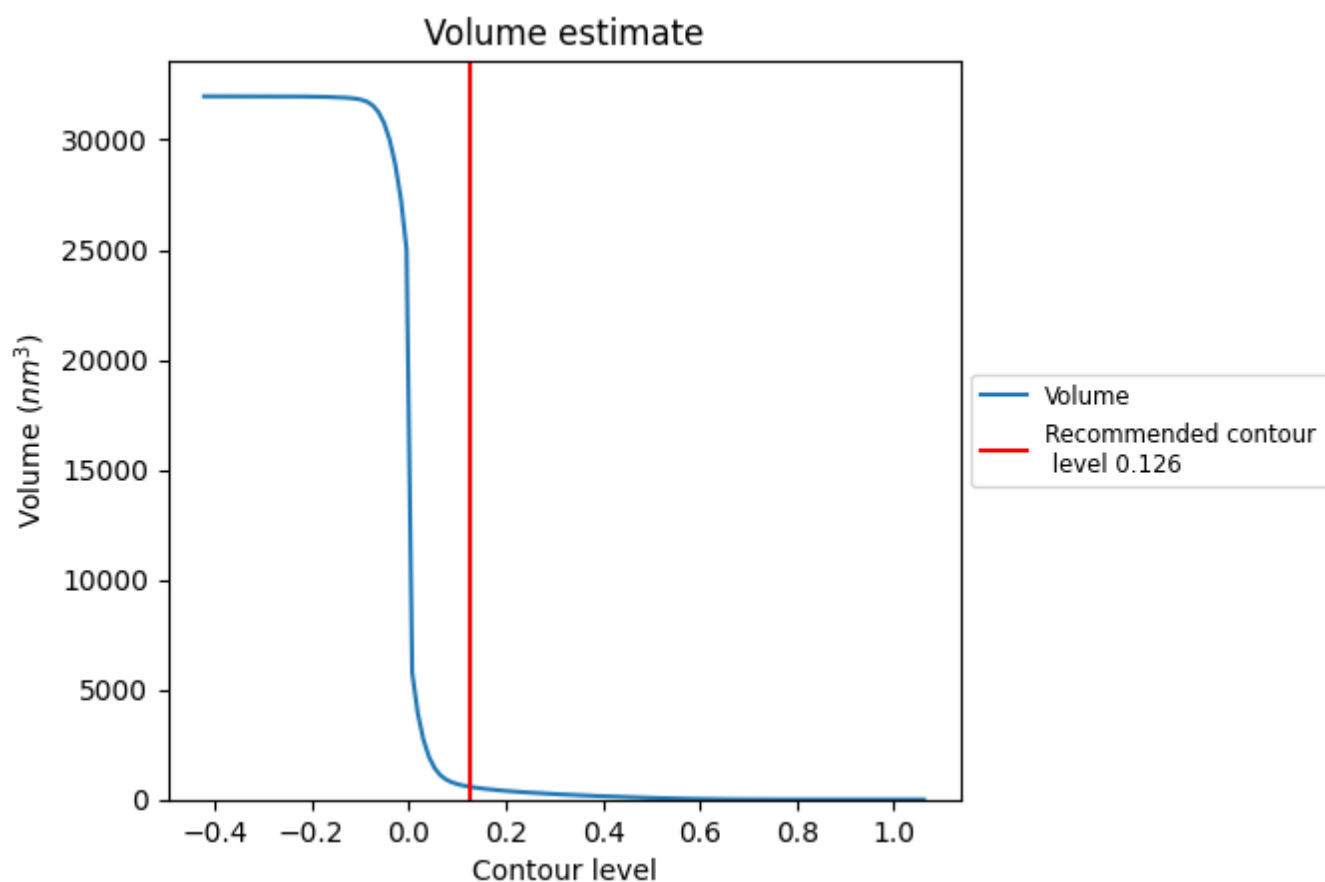

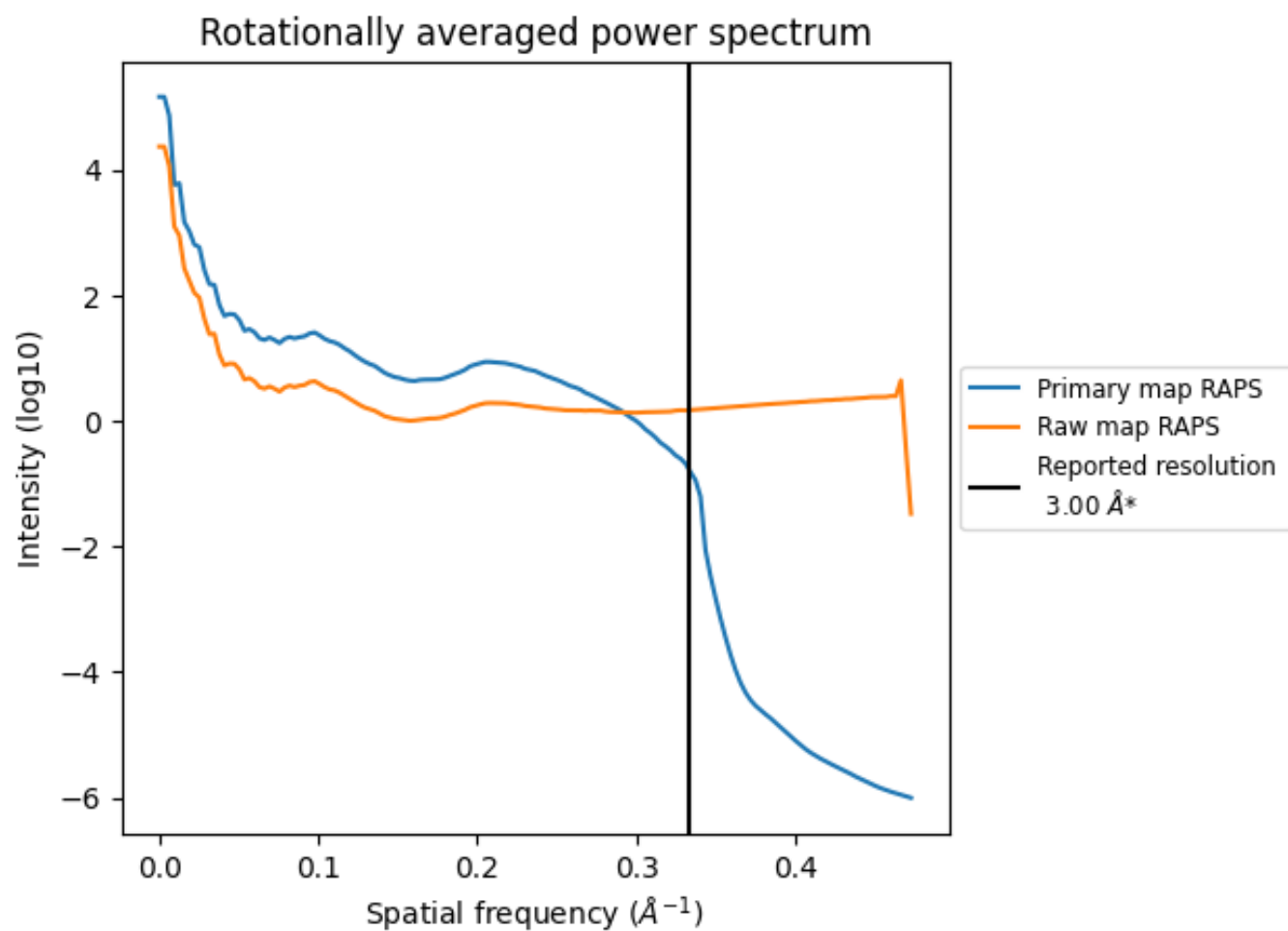

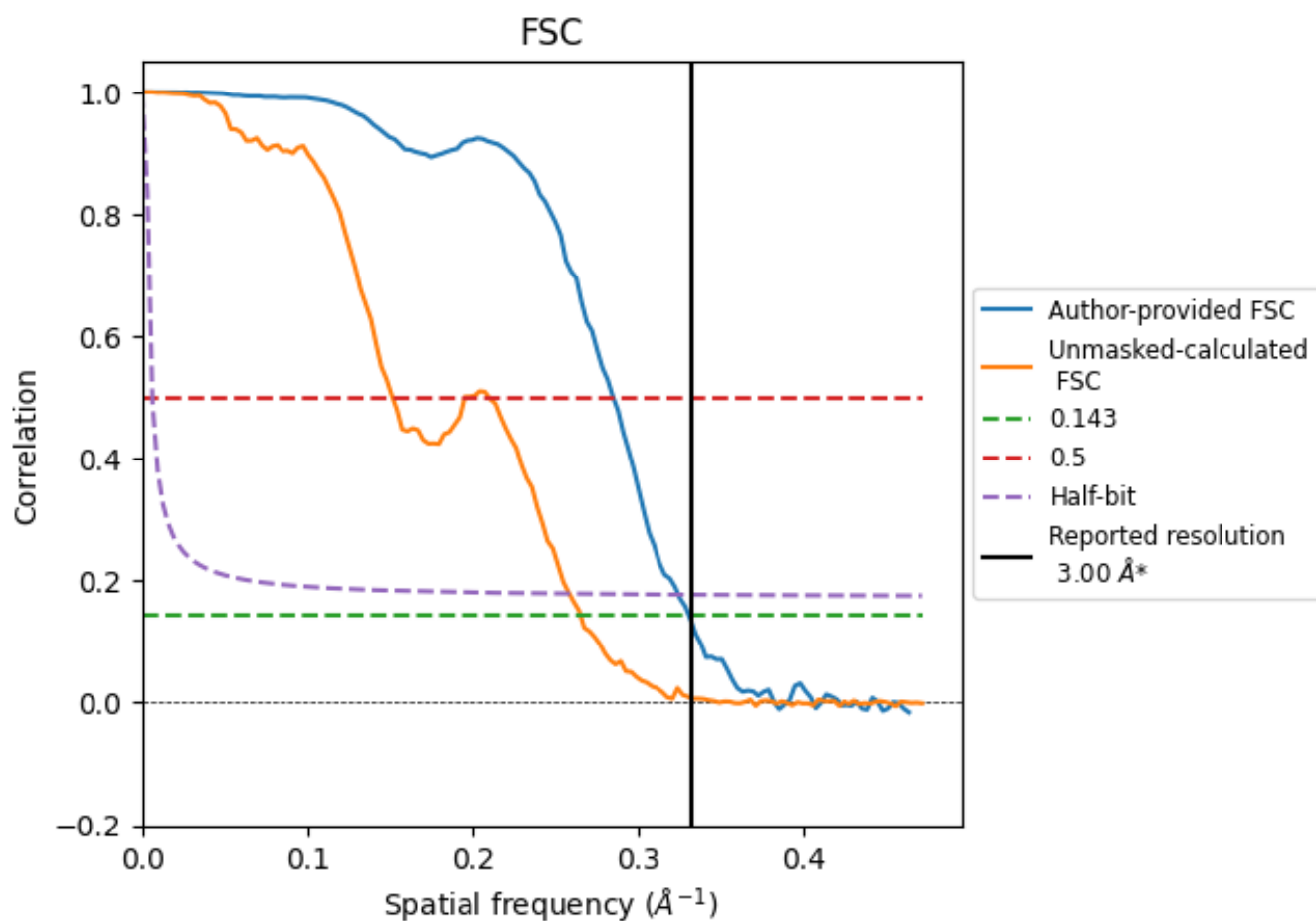

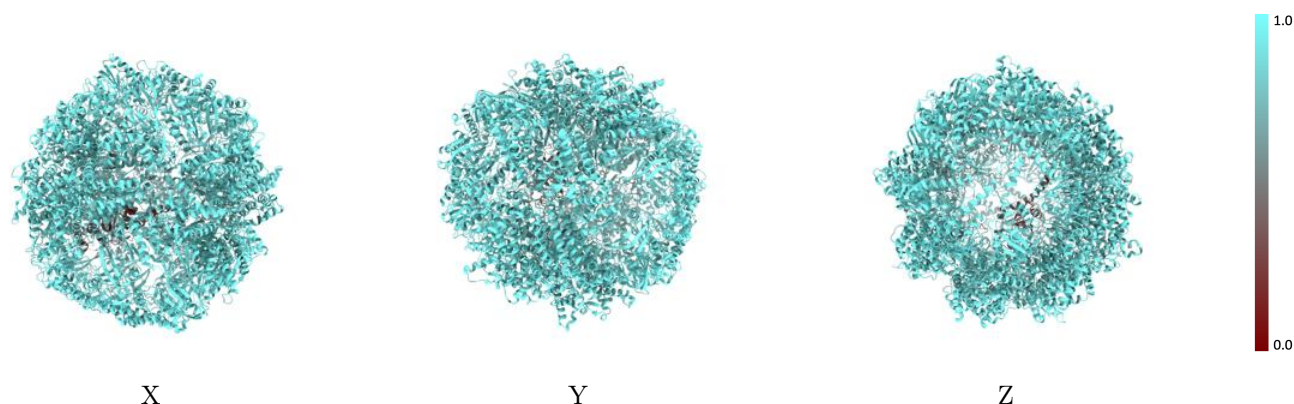

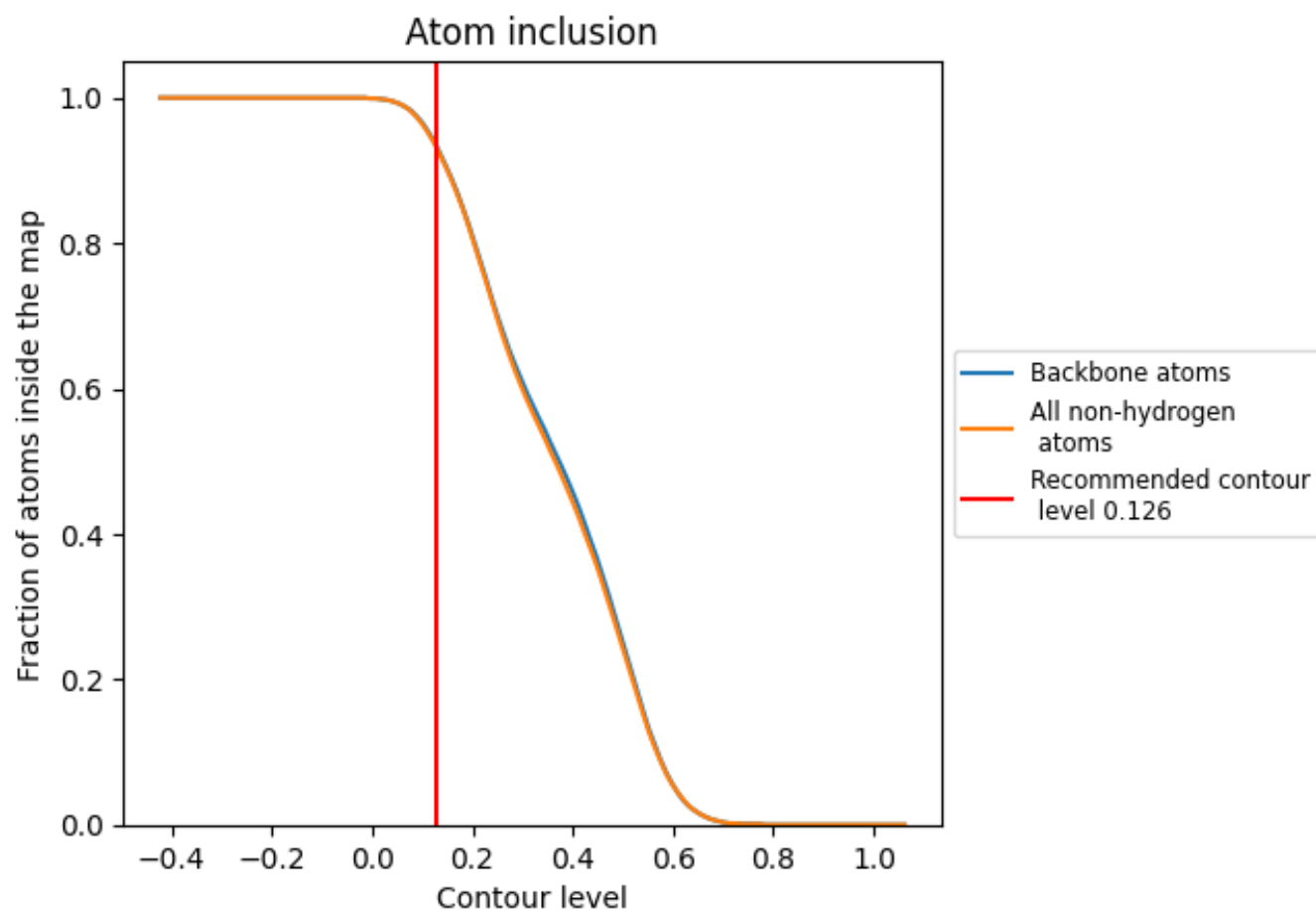
