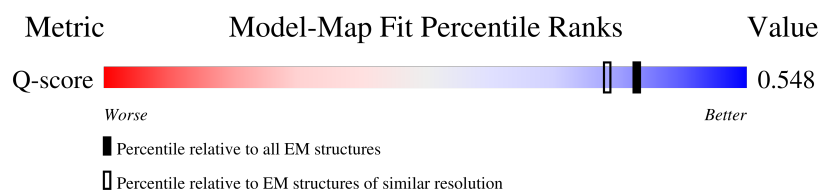
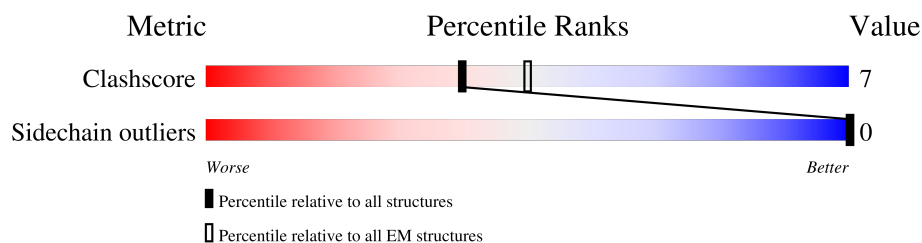
1 Overall quality at a glance

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.



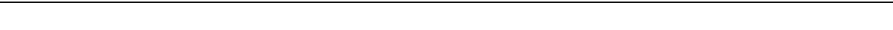

The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

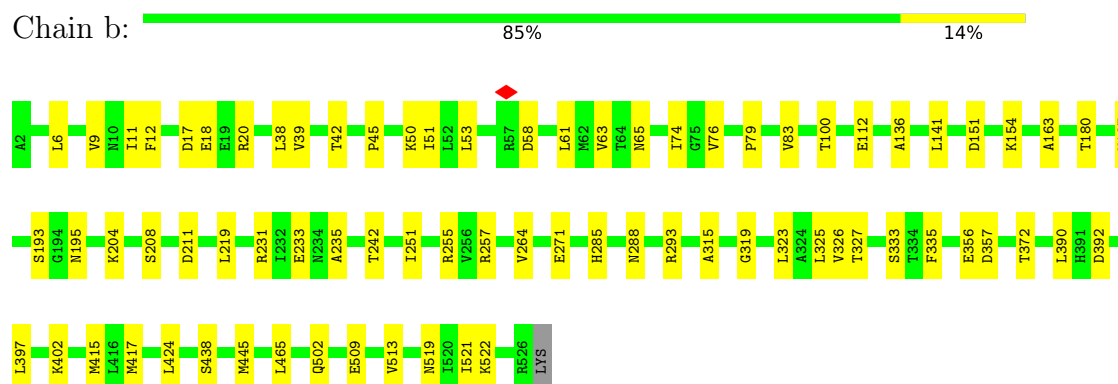

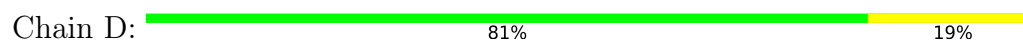
- Molecule 3: T-complex protein 1 subunit beta

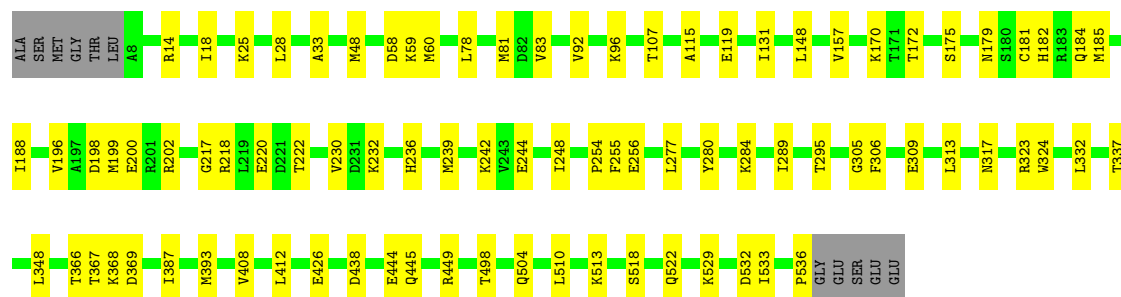

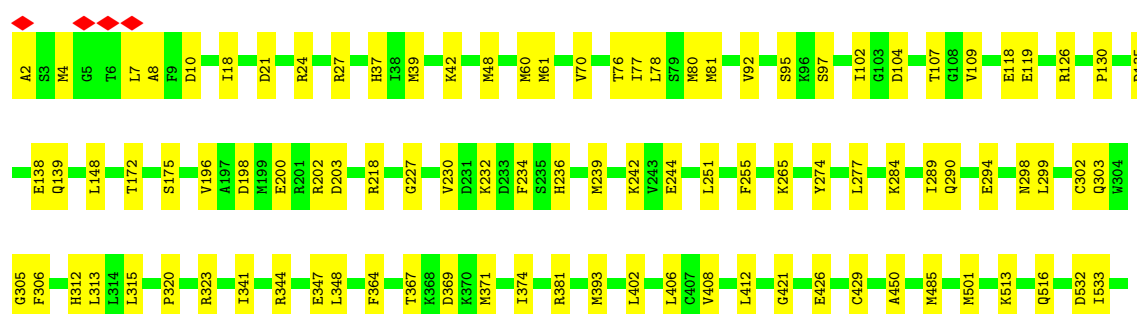

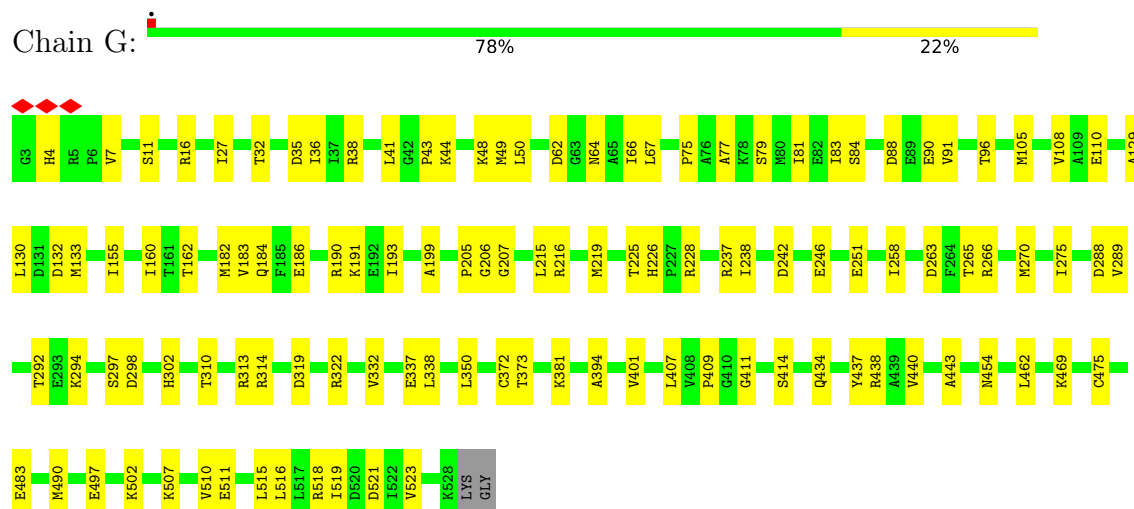

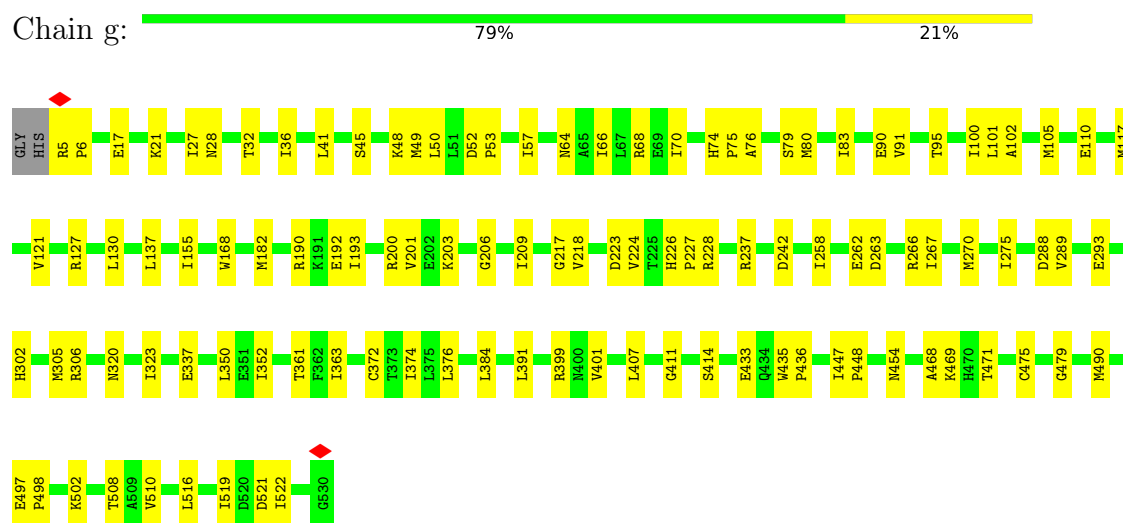




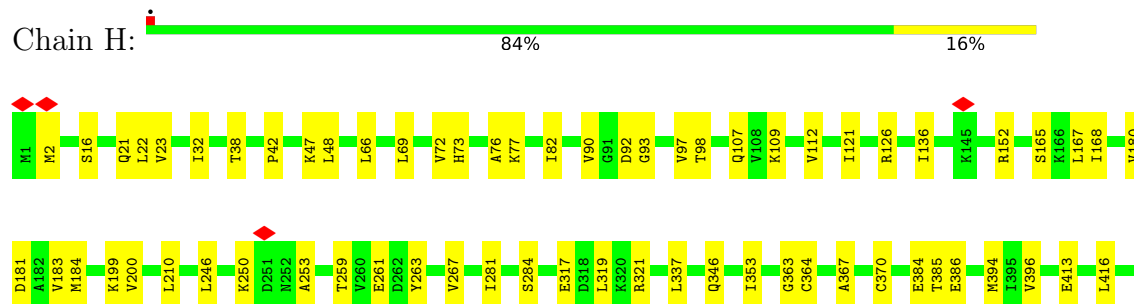
- Molecule 6: T-complex protein 1 subunit gamma

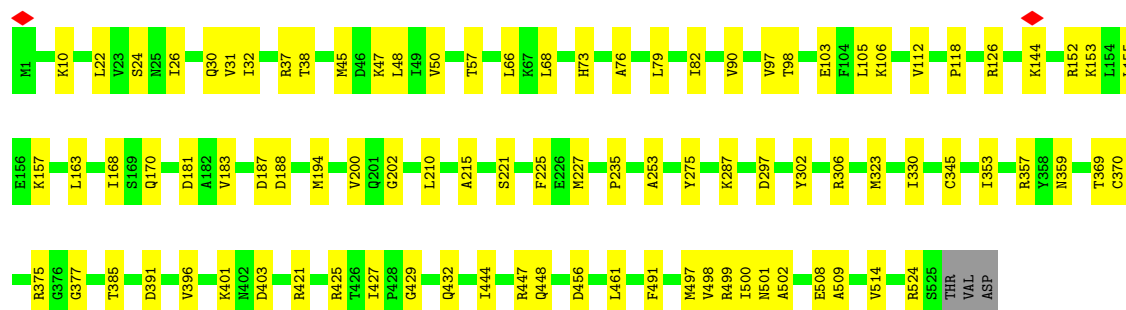
- Molecule 7: T-complex protein 1 subunit eta, N-terminally processed





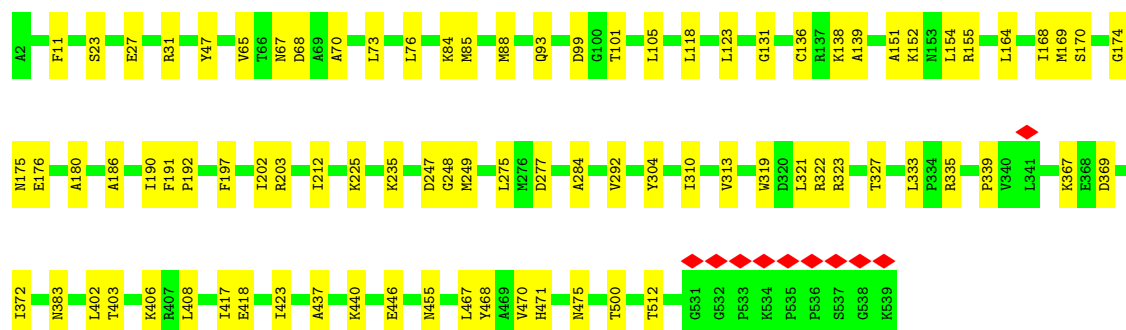

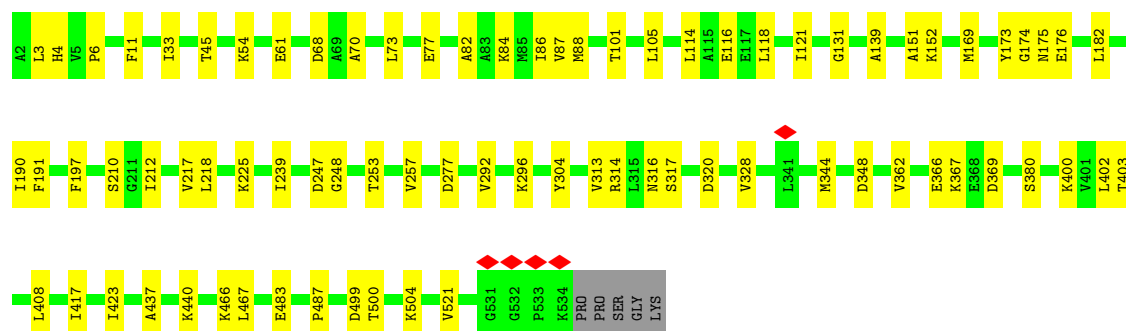
- Molecule 8: T-complex protein 1 subunit theta

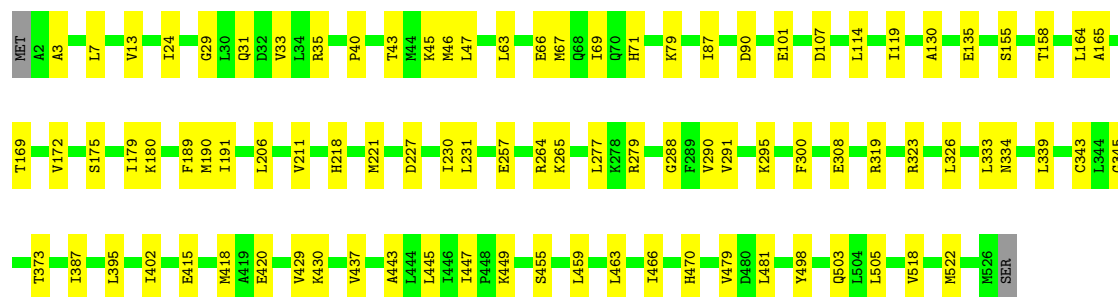

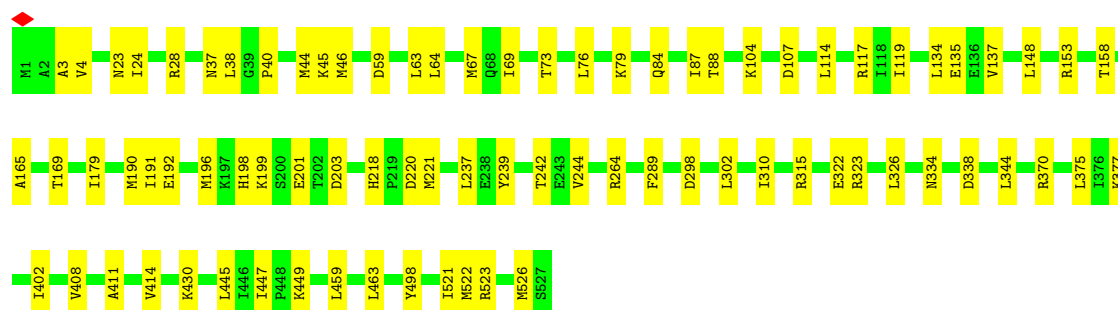
- Molecule 9: T-complex protein 1 subunit zeta

For rings, the root-mean-square deviation (RMSD) between the ring in question and similar rings identified by Mogul is calculated over all ring torsion angles. If the average RMSD is greater than 60 degrees and the minimal RMSD between the ring in question and any Mogul-identified rings is also greater than 60 degrees, then that ring is considered an outlier. The outliers are highlighted in purple. The color gray indicates Mogul did not find sufficient equivalents in the CSD to analyse the geometry.

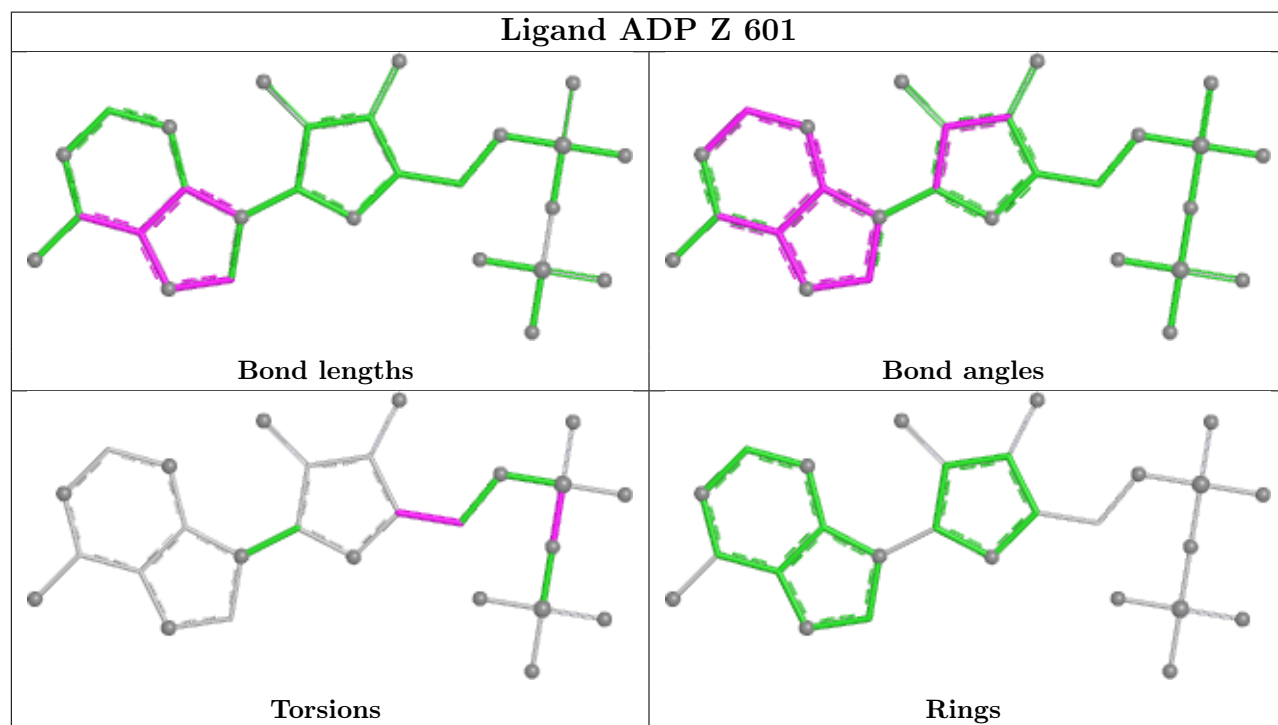
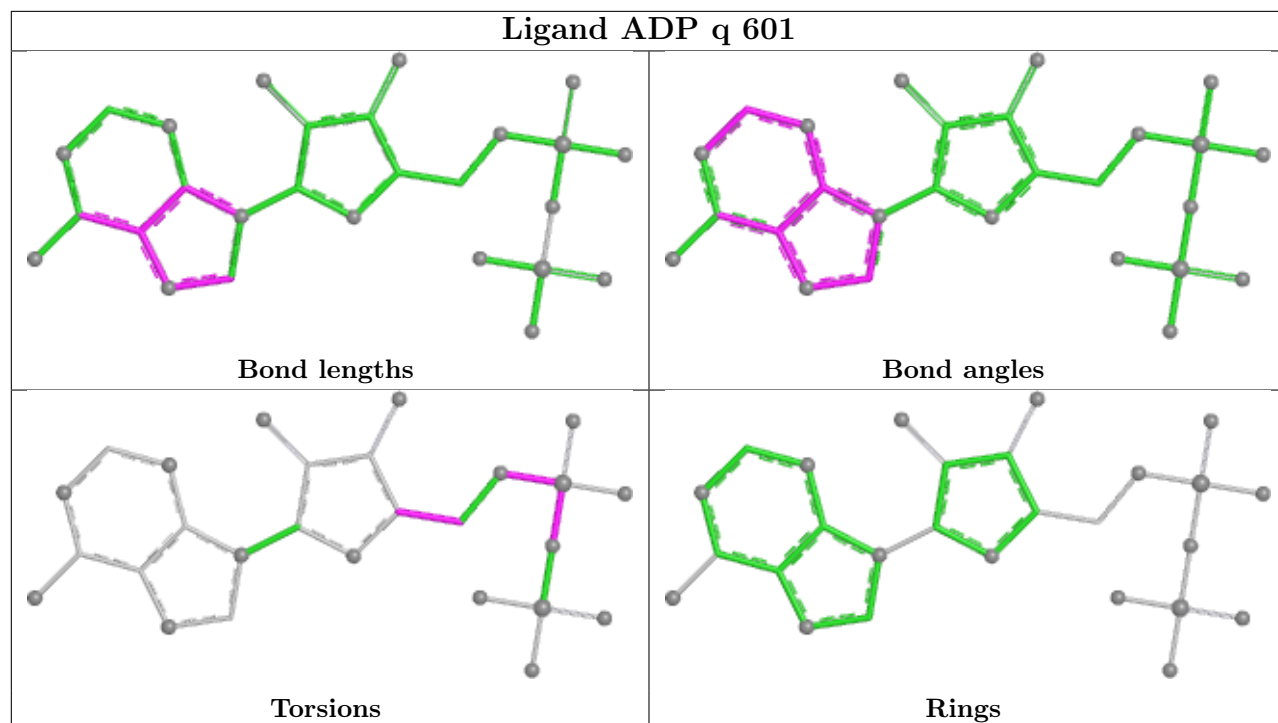


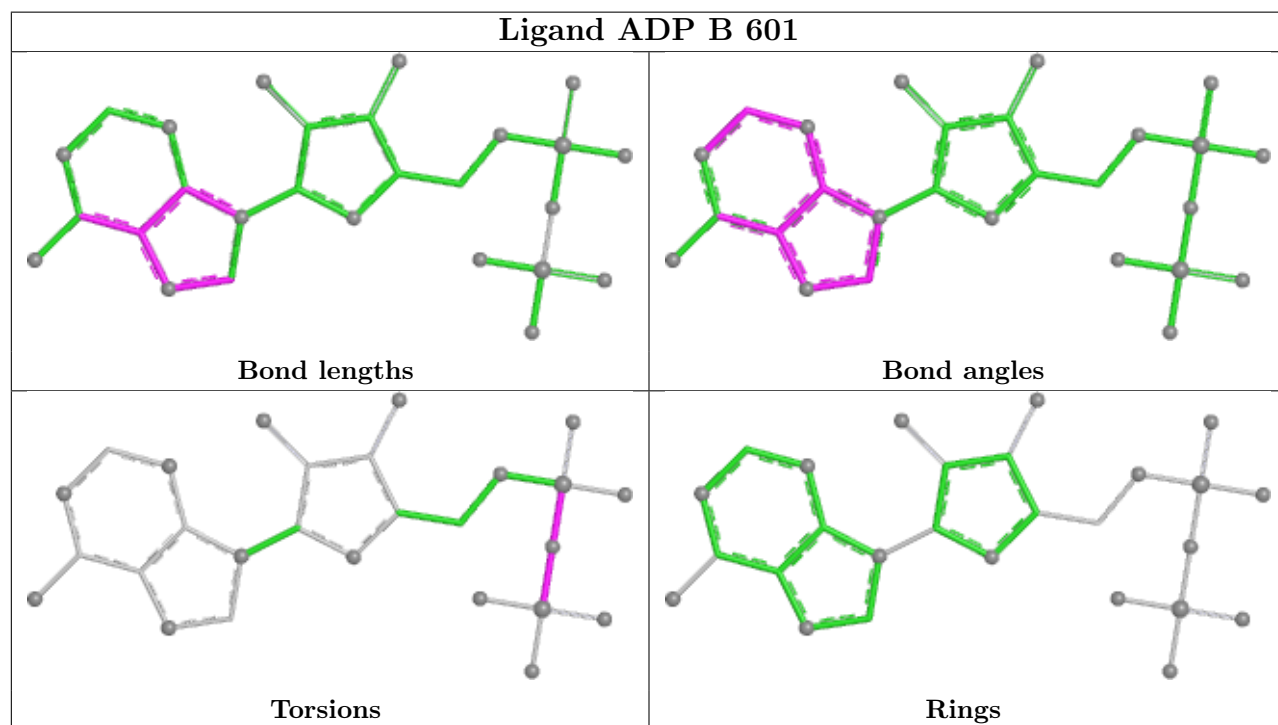
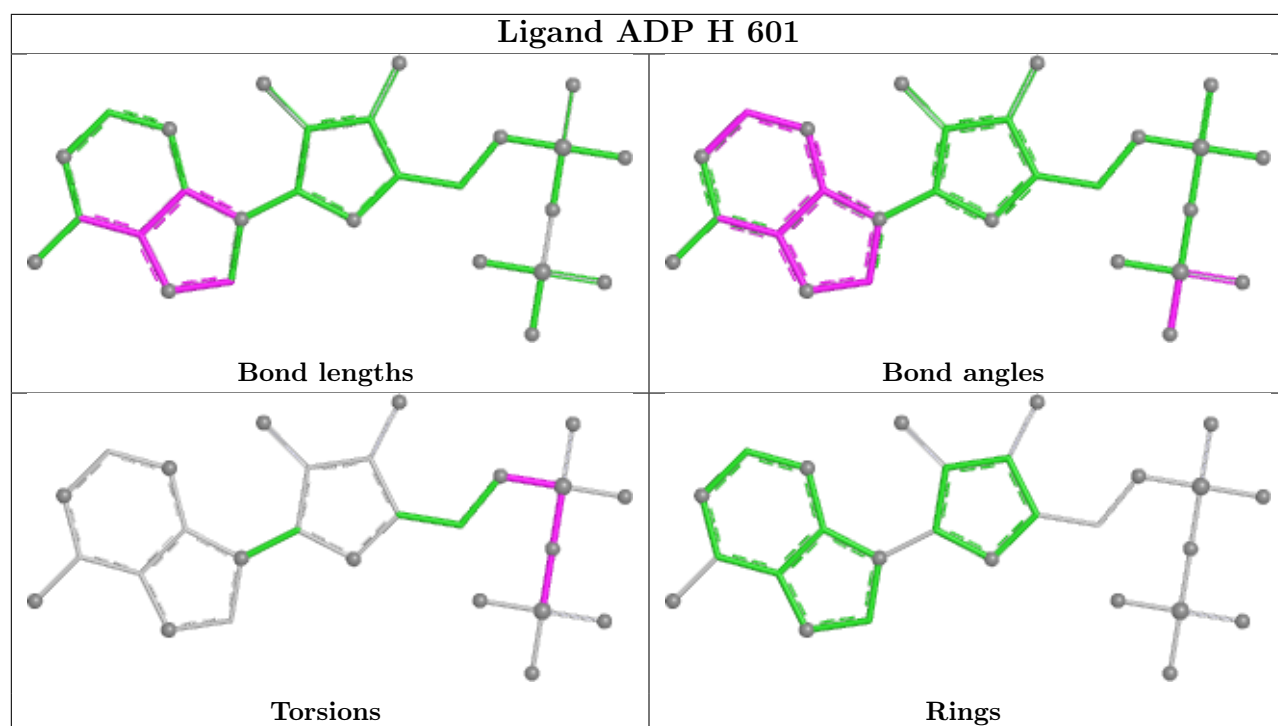


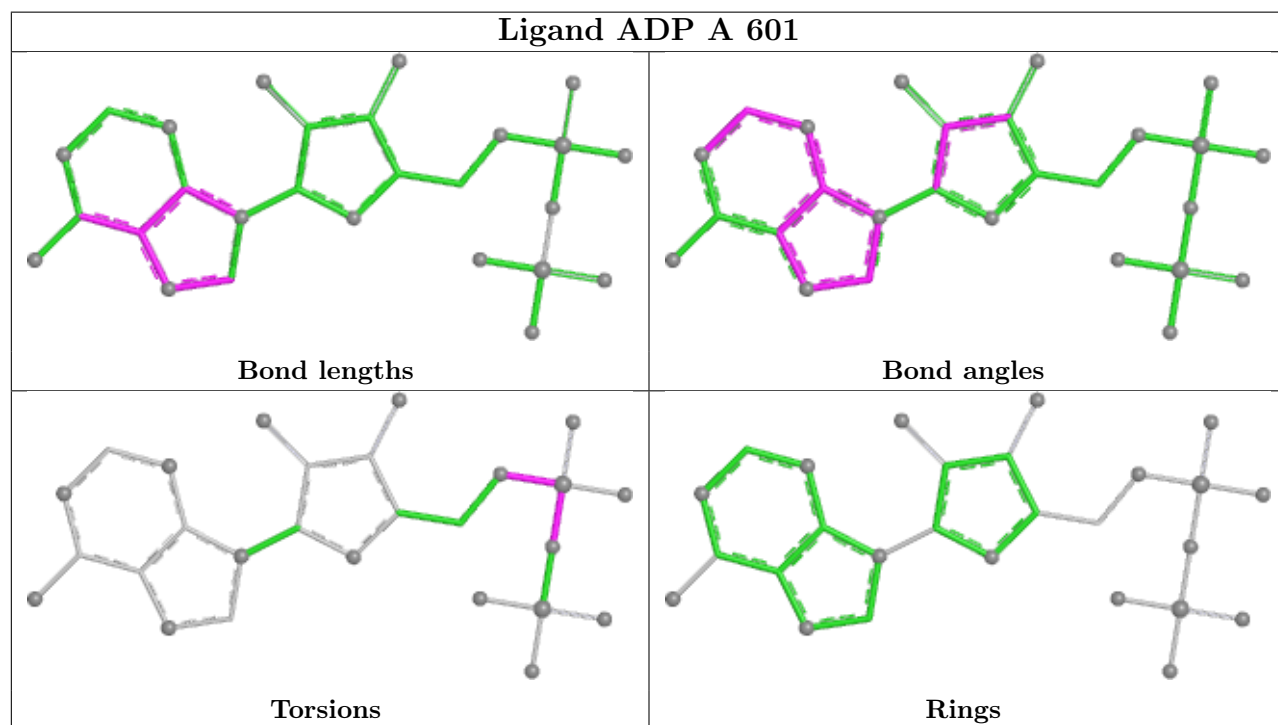
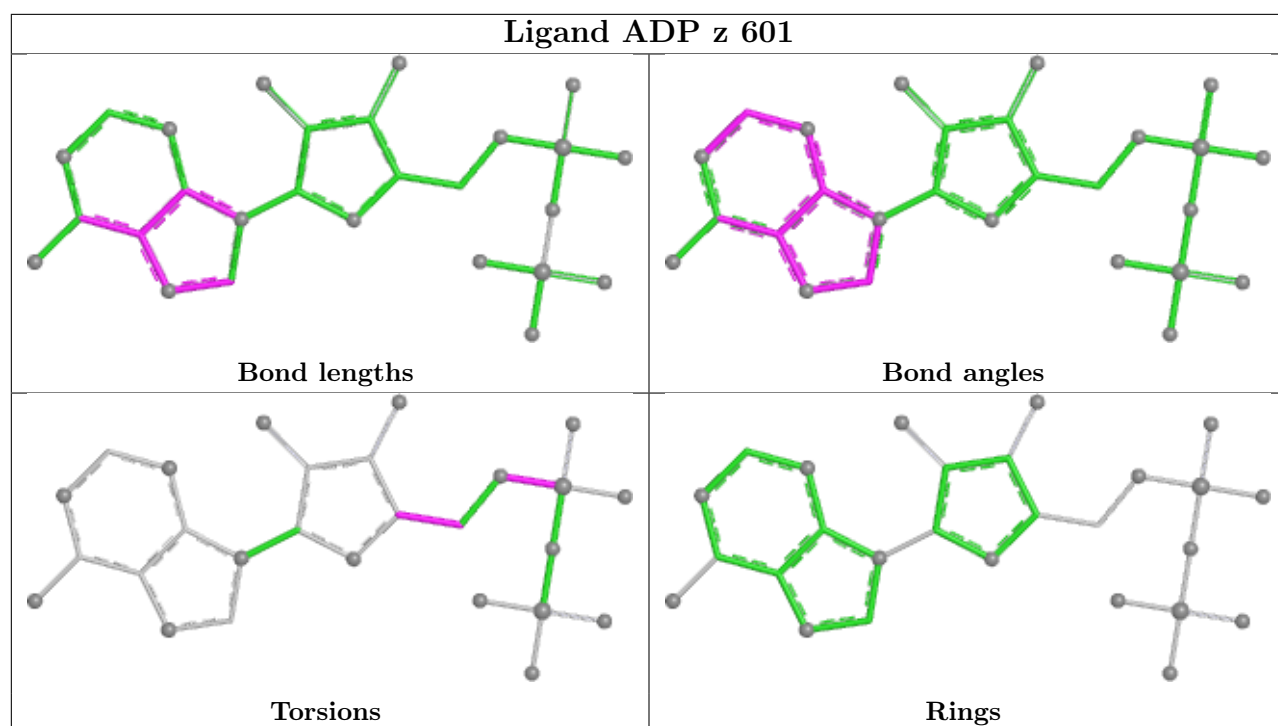


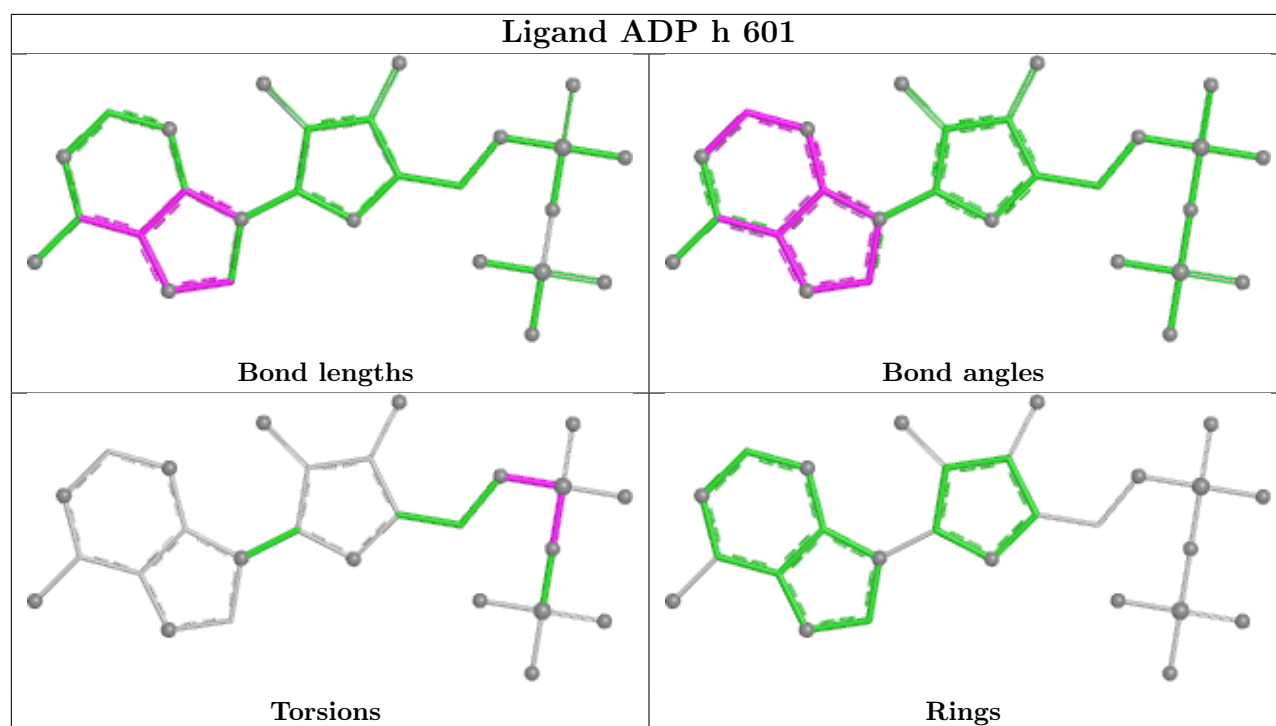

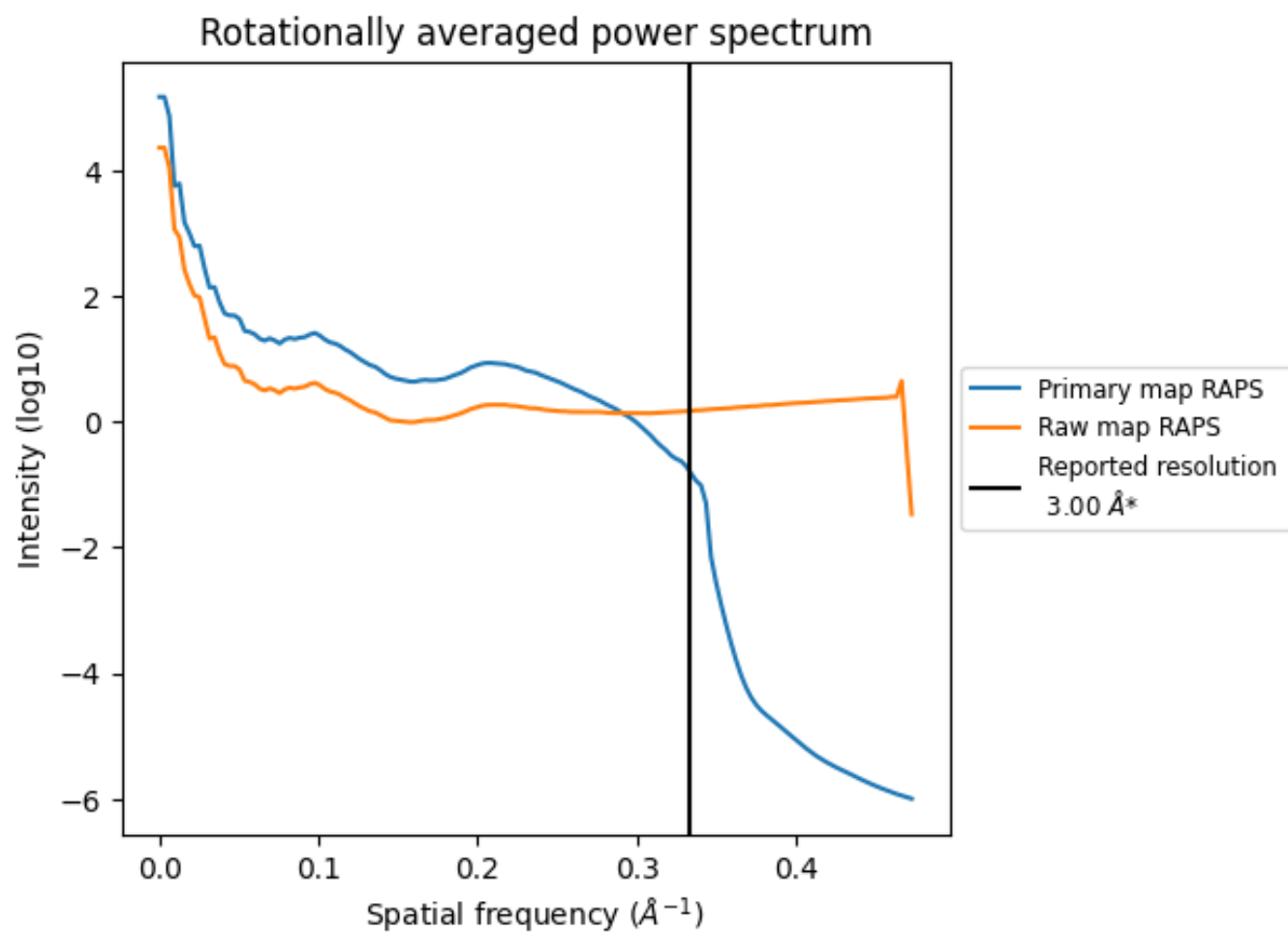

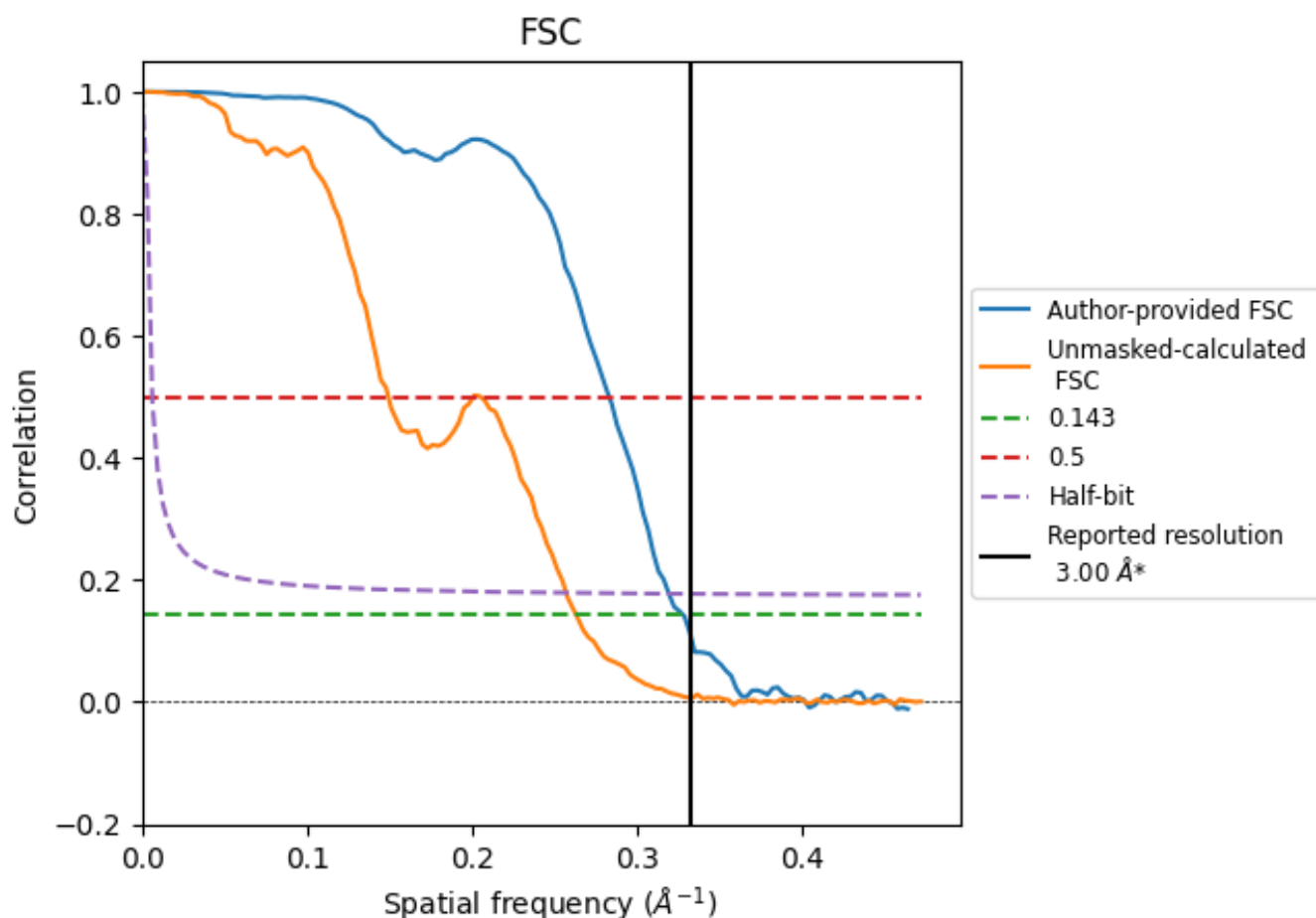

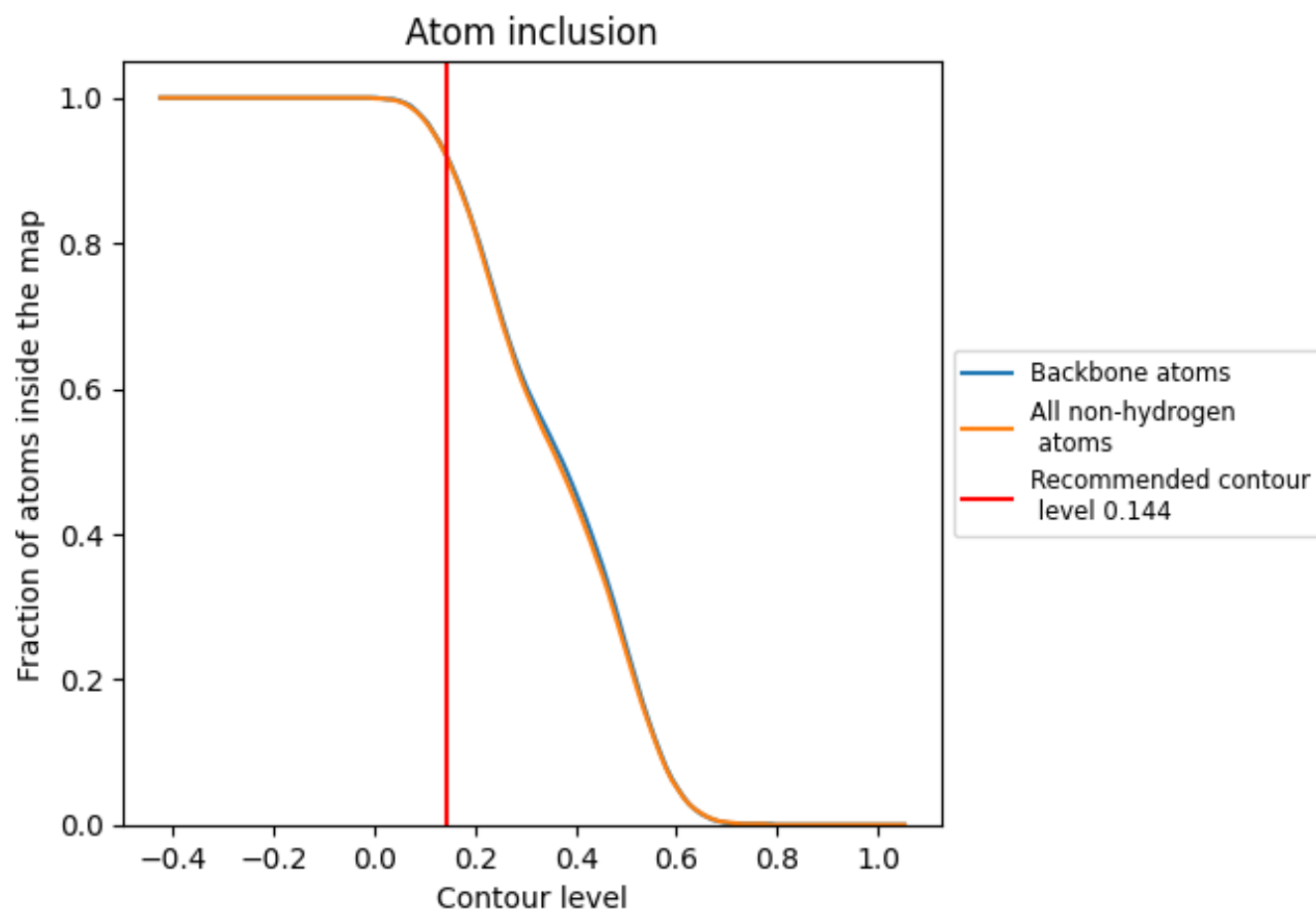
