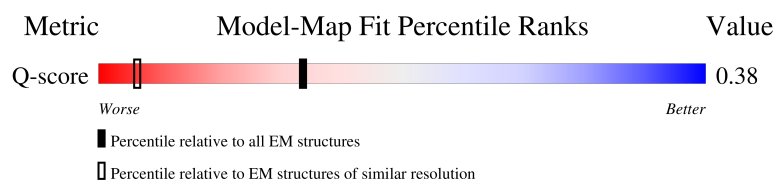
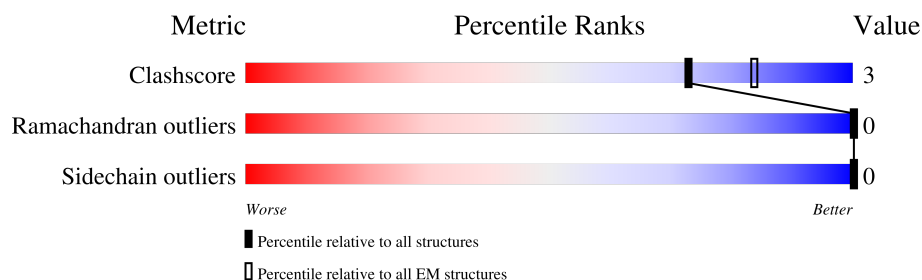
1 Overall quality at a glance

2 Entry composition

There are 4 unique types of molecules in this entry. The entry contains 26972 atoms, of which 0 are hydrogens and 0 are deuteriums.

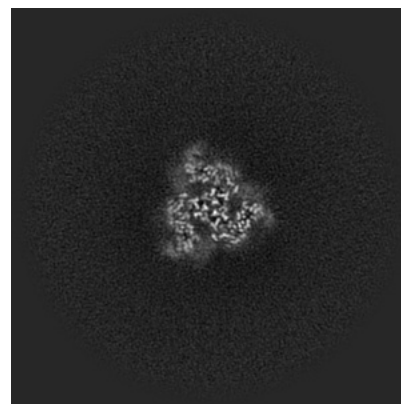

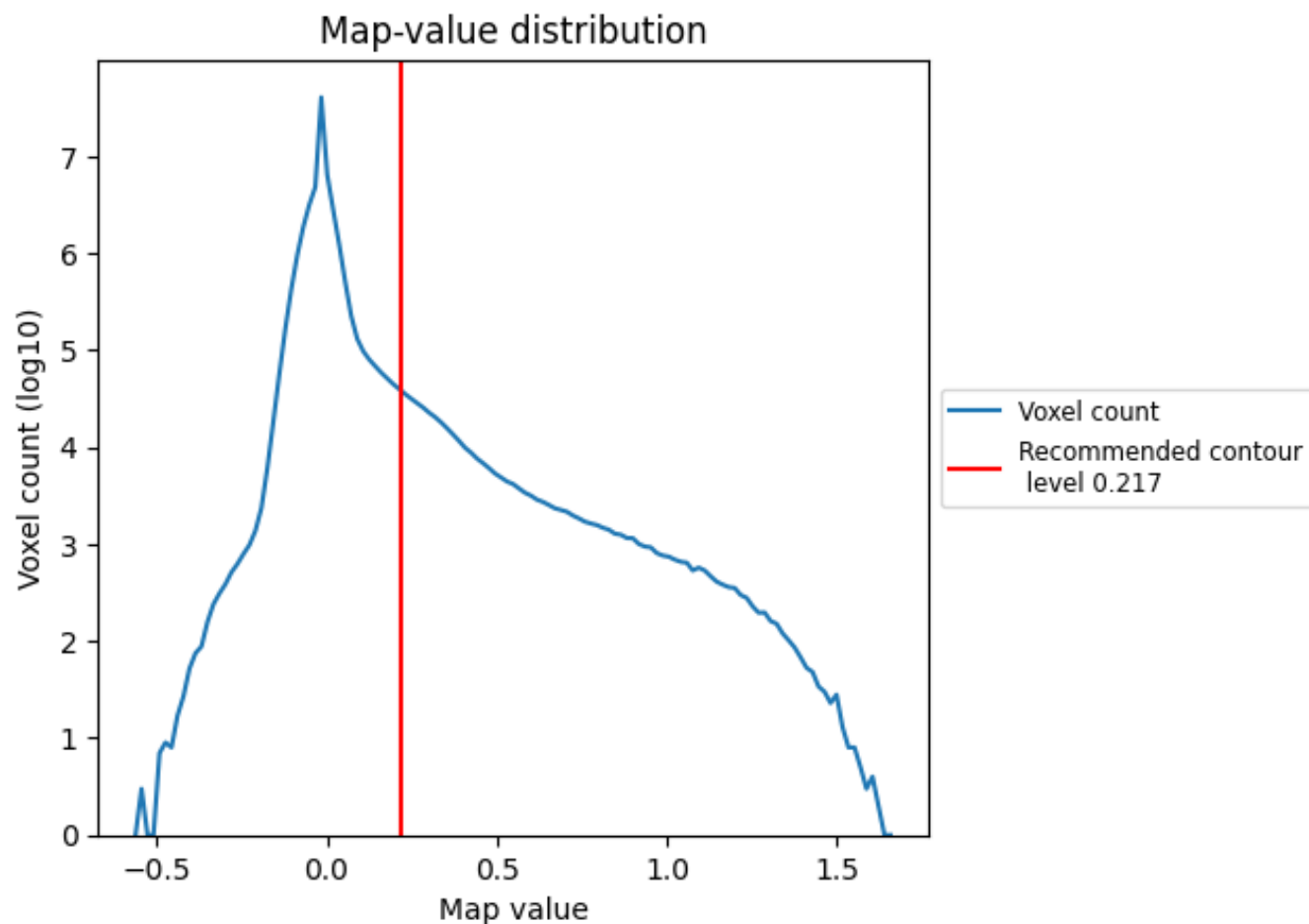

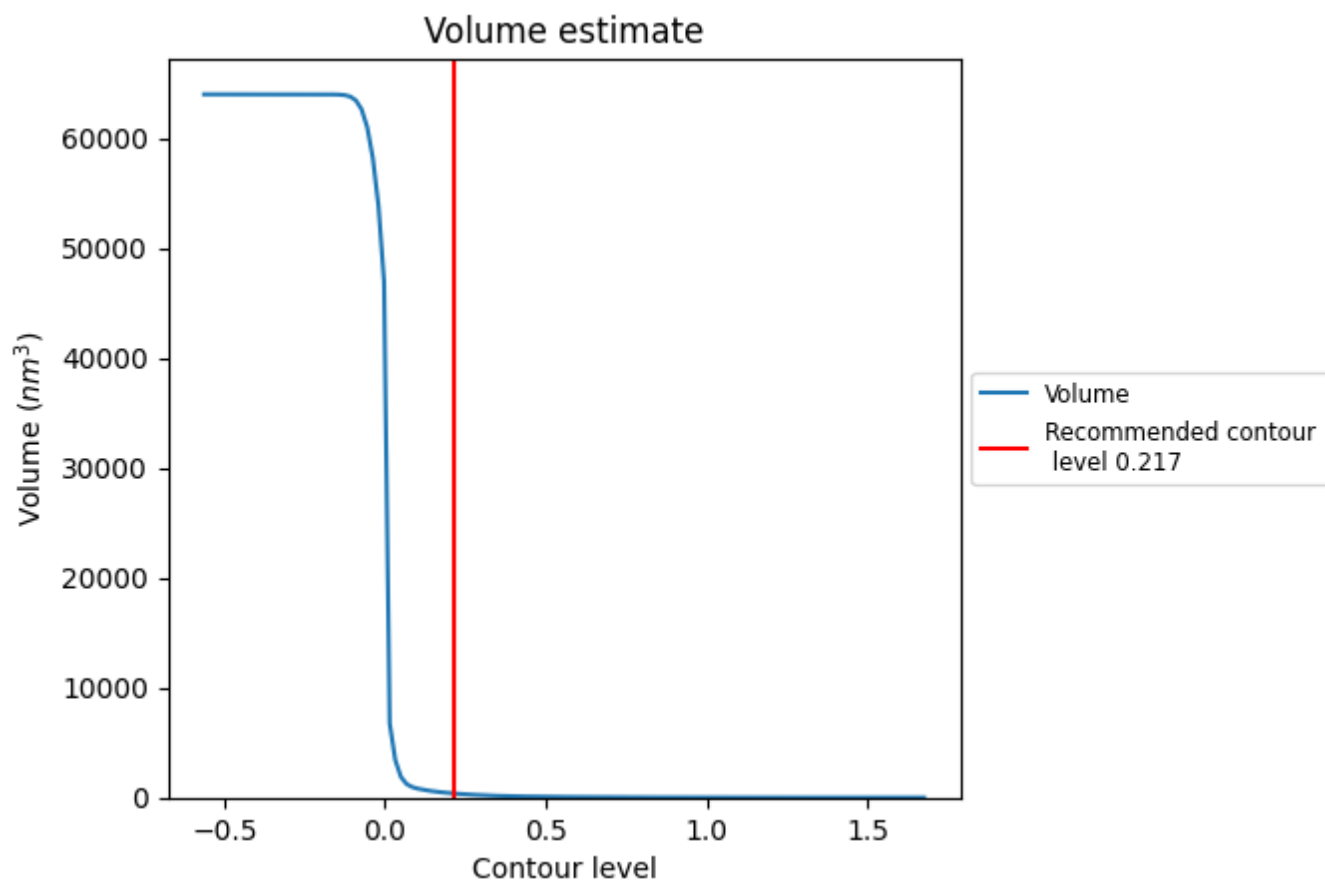

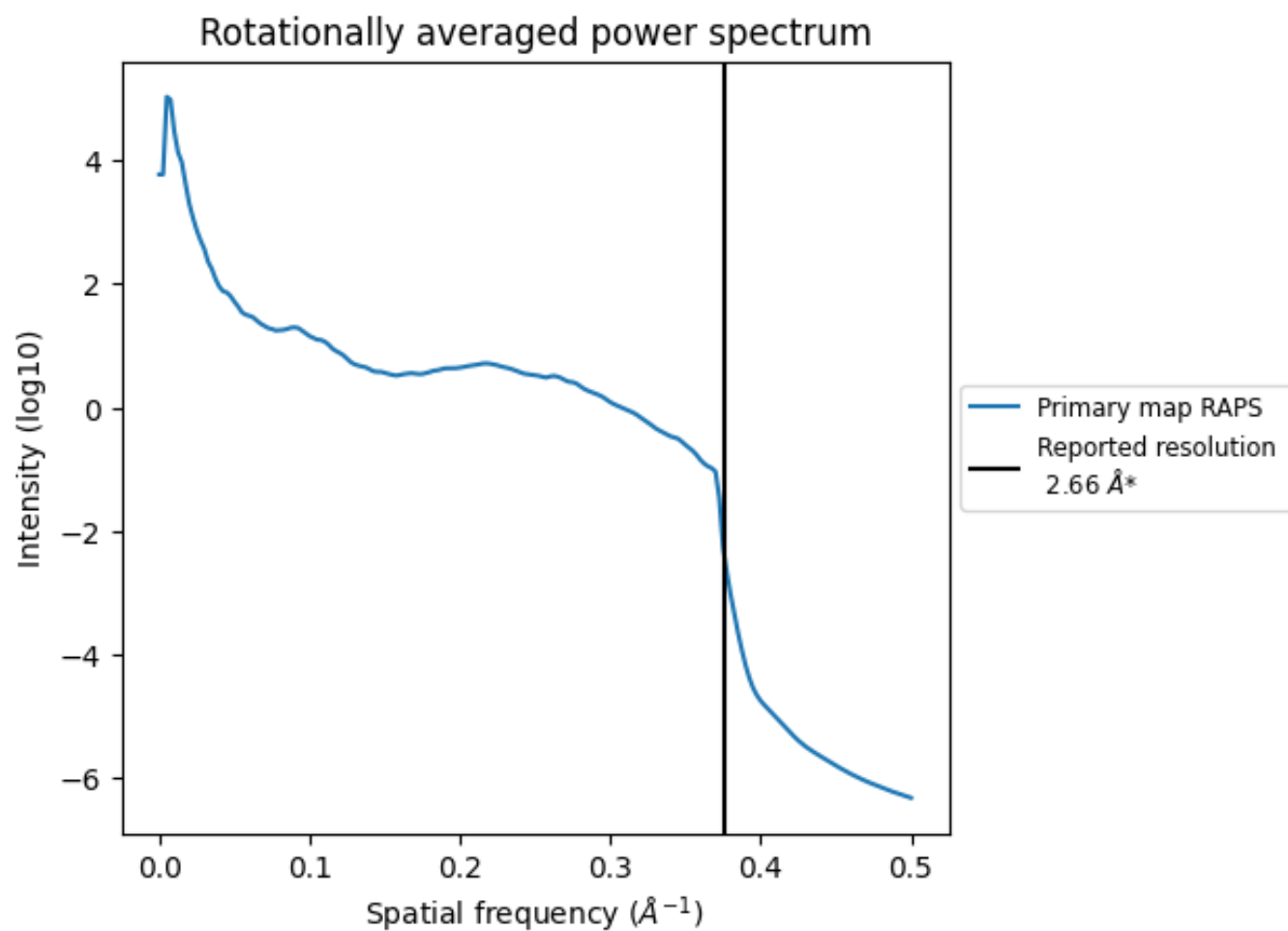

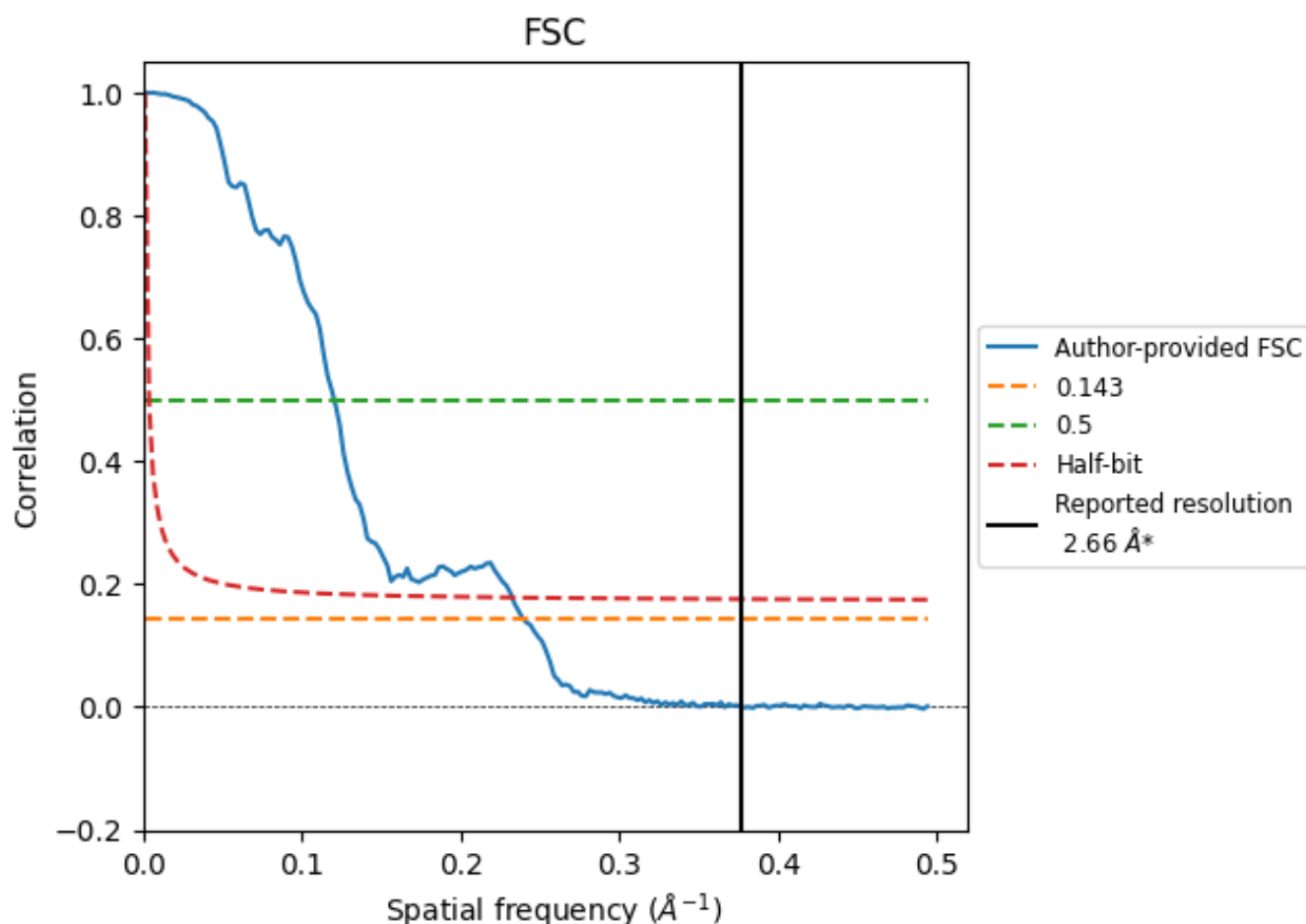

7 Fourier-Shell correlation [i](#)

Fourier-Shell Correlation (FSC) is the most commonly used method to estimate the resolution of single-particle and subtomogram-averaged maps. 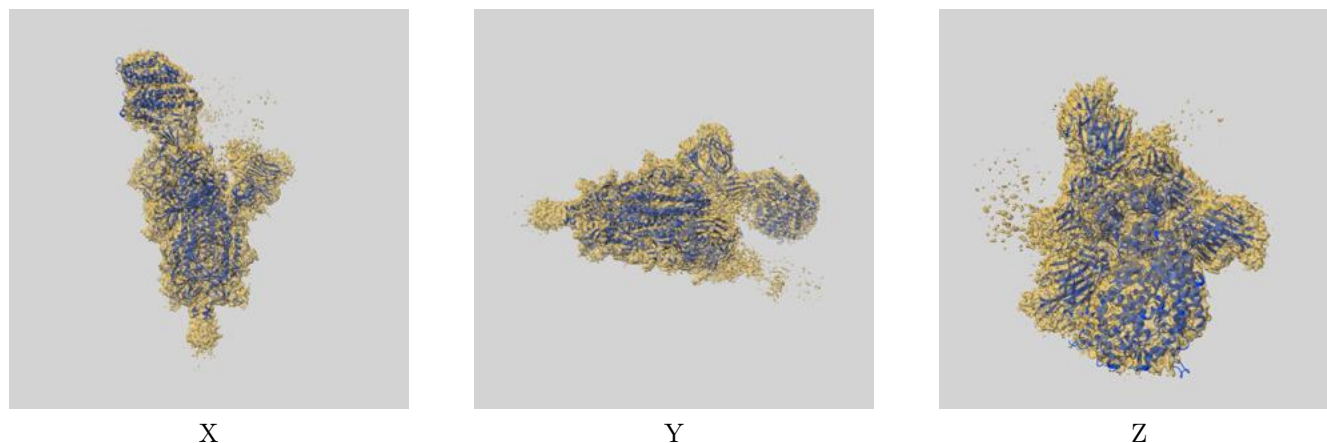

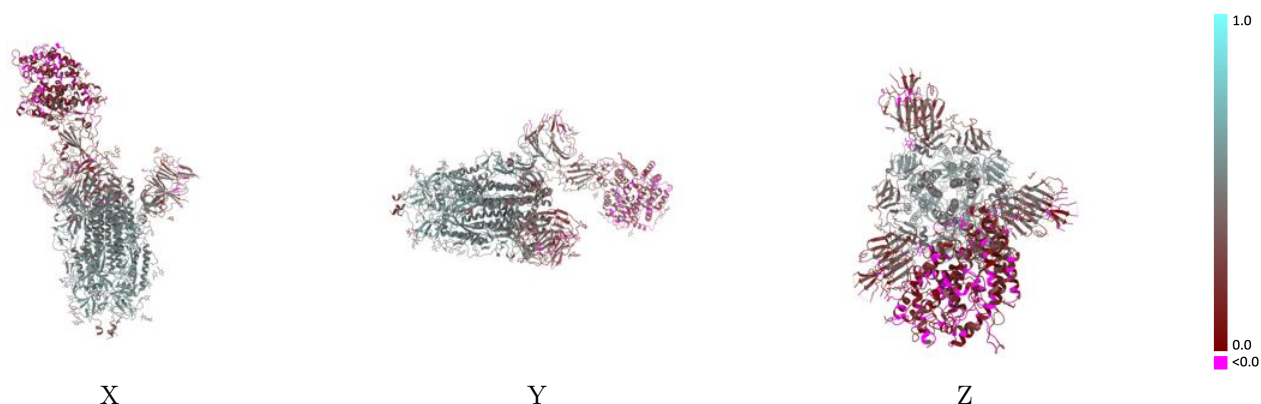

8.1 Map-model overlay [i](#)



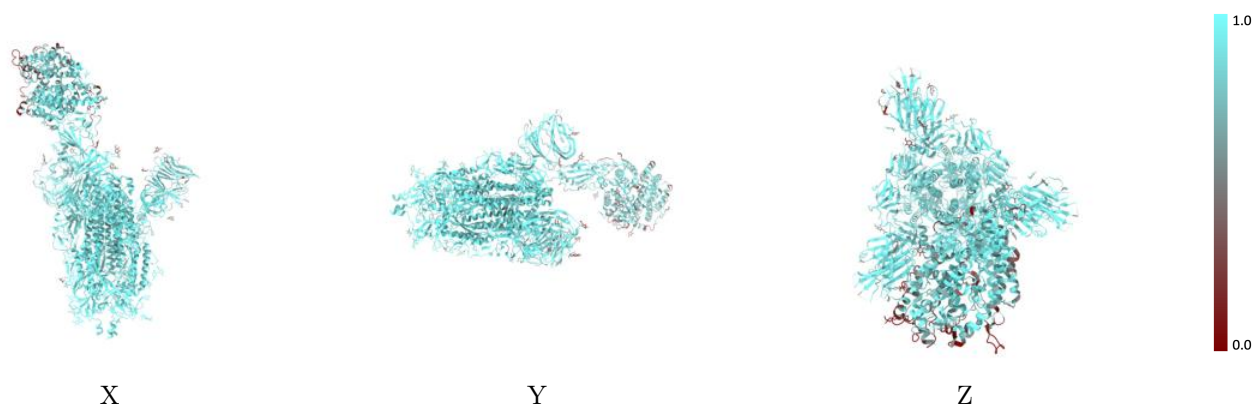
The images above show the 3D surface view of the map at the recommended contour level 0.217 at 50% transparency in yellow overlaid with a ribbon representation of the model coloured in blue. These images allow for the visual assessment of the quality of fit between the atomic model and the map.

8.2 Q-score mapped to coordinate model [i](#)



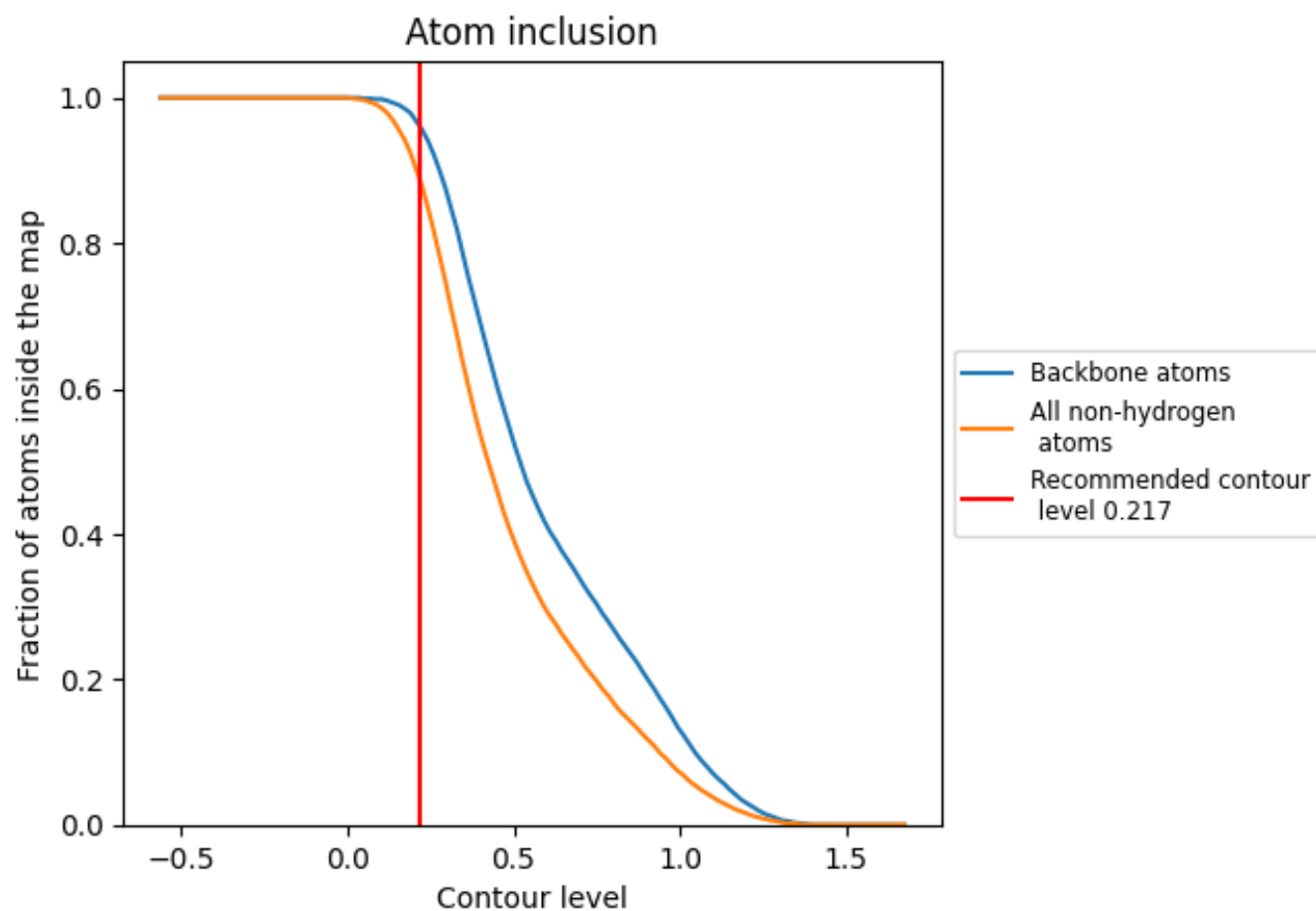
The images above show the model with each residue coloured according to its Q-score. This shows their resolvability in the map with higher Q-score values reflecting better resolvability. Please note: Q-score is calculating the resolvability of atoms, and thus high values are only expected at resolutions at which atoms can be resolved. Low Q-score values may therefore be expected for many entries.

8.3 Atom inclusion mapped to coordinate model [i](#)



The images above show the model with each residue coloured according to its atom inclusion. This shows to what extent they are inside the map at the recommended contour level (0.217).

8.4 Atom inclusion [i](#)



At the recommended contour level, 96% of all backbone atoms, 89% of all non-hydrogen atoms, are inside the map.
