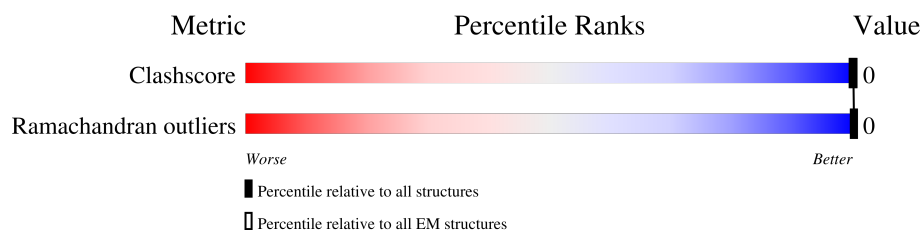
1 Overall quality at a glance

The reported resolution of this entry is 4.90 Å.

2 Entry composition

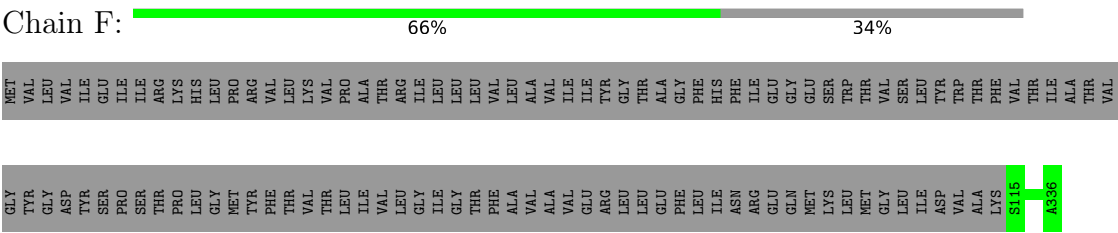
There is only 1 type of molecule in this entry. The entry contains 10344 atoms, of which 0 are hydrogens and 0 are deuteriums.

In the tables below, the AltConf column contains the number of residues with at least one atom in alternate conformation and the Trace column contains the number of residues modelled with at most 2 atoms.

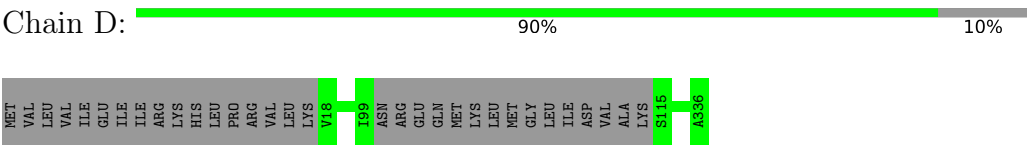

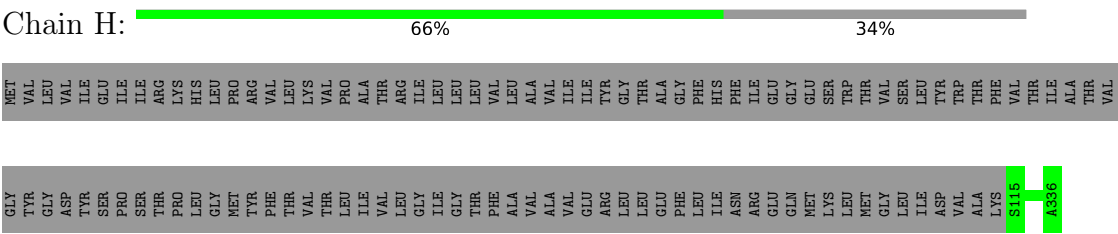
● Molecule 1: Calcium-gated potassium channel MthK
