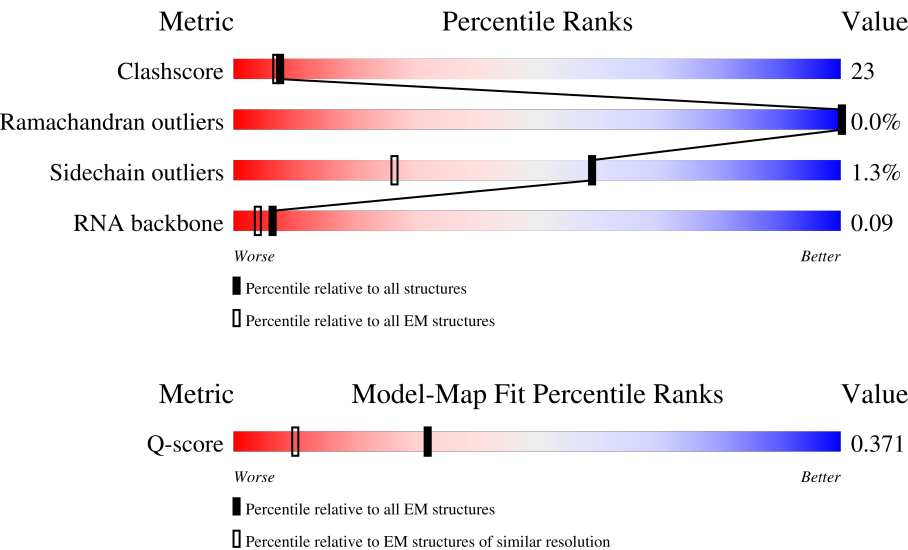

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for >=3, 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion < 40%). The numeric value is given above the bar.

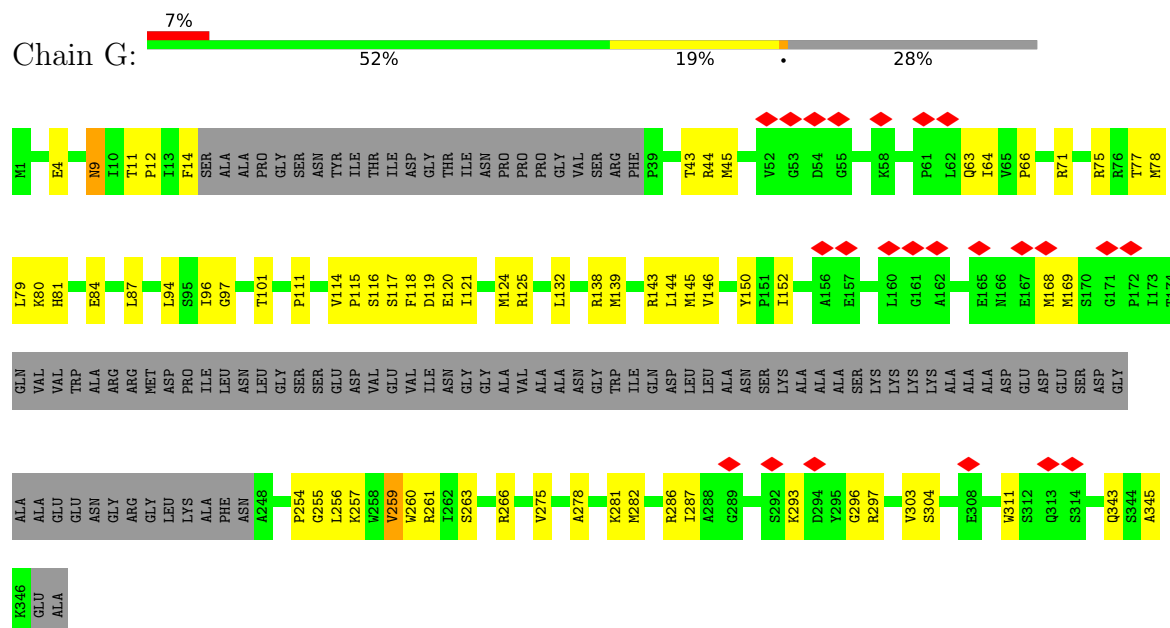

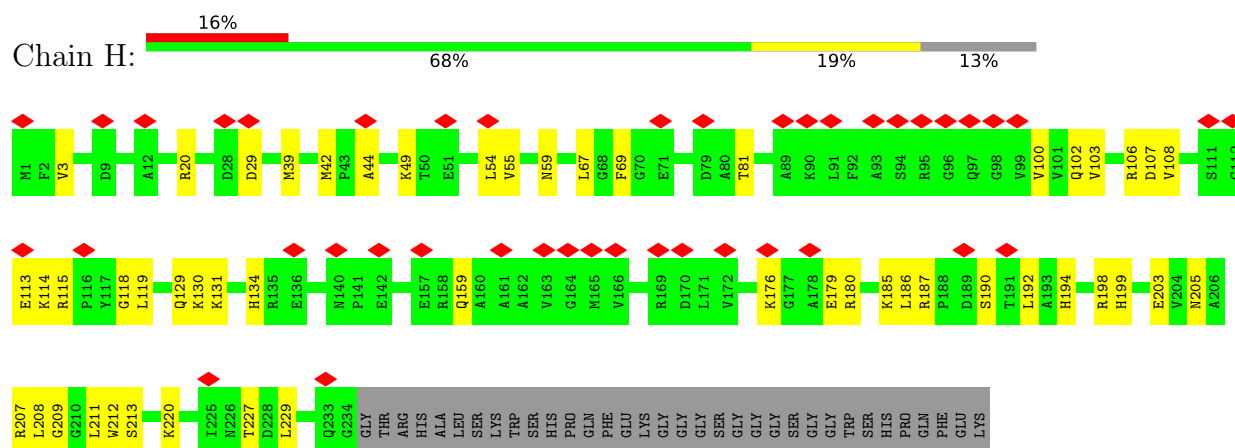

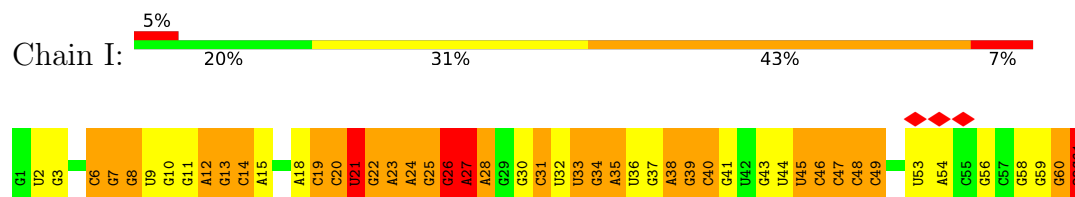

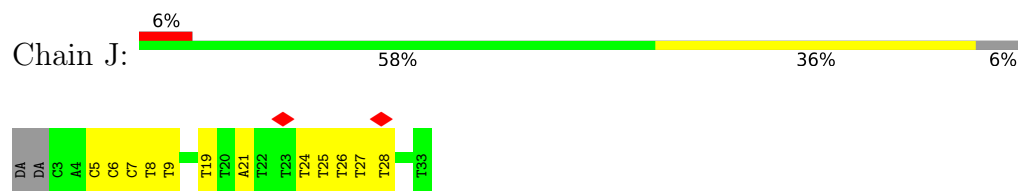

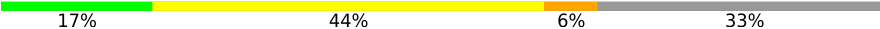

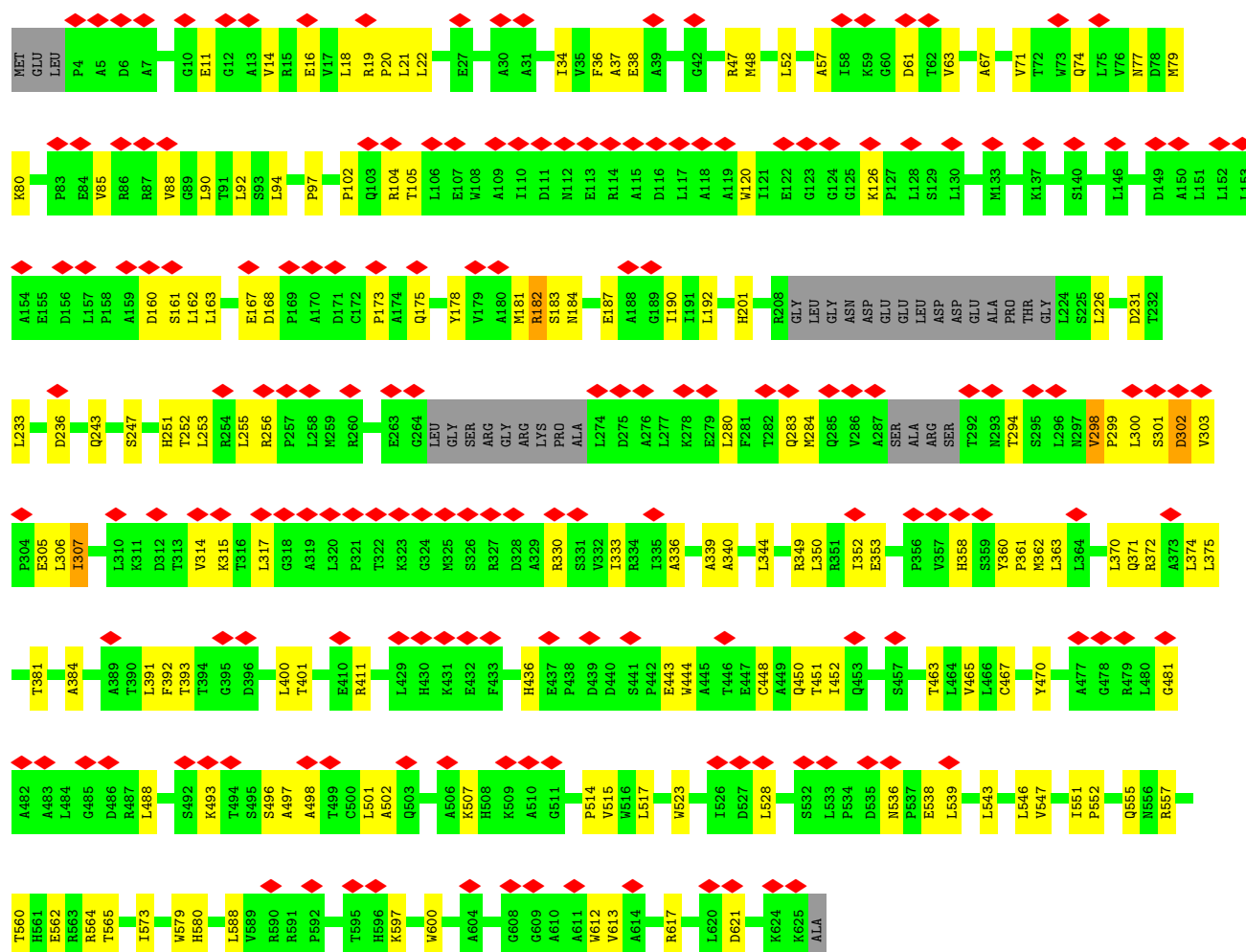

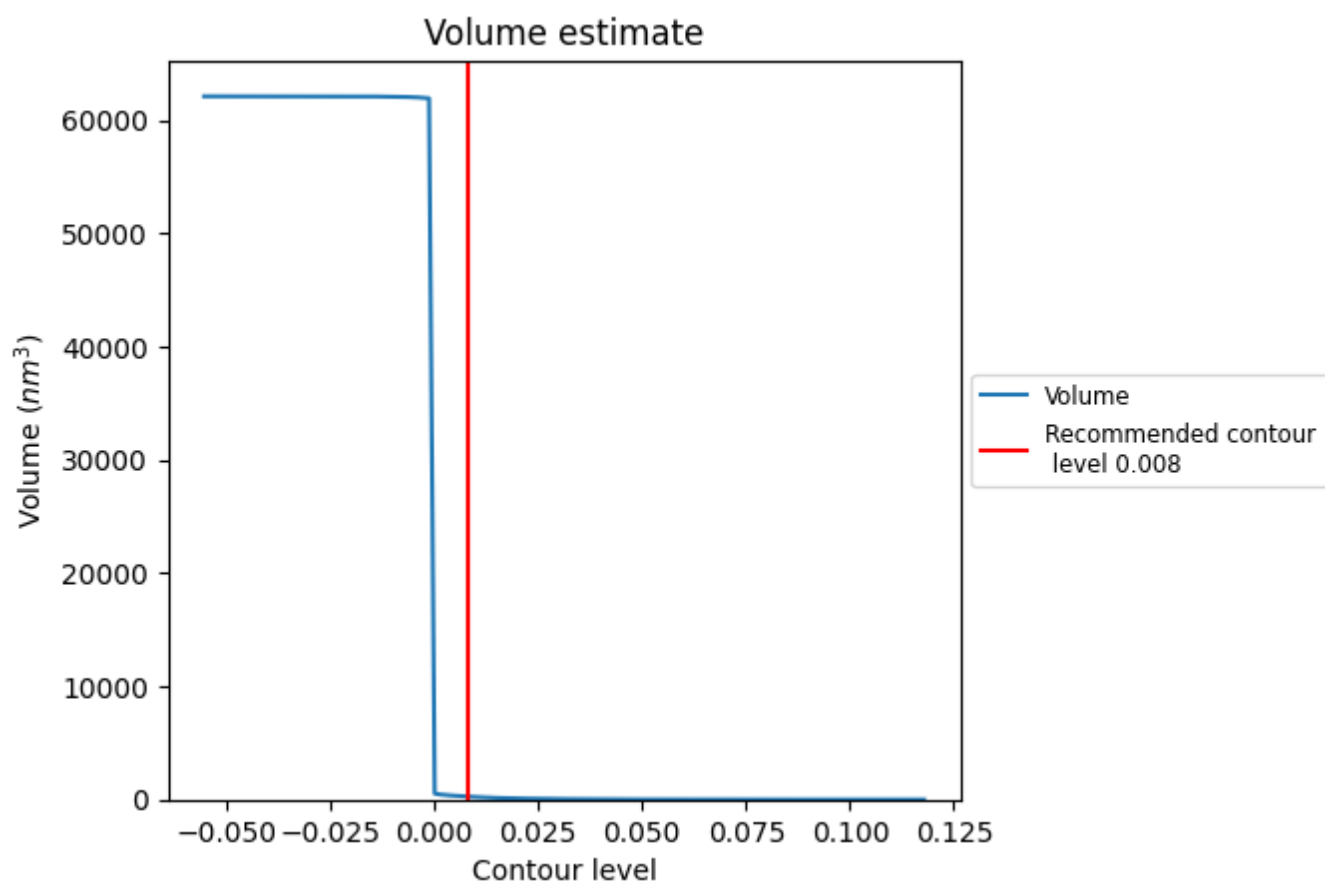

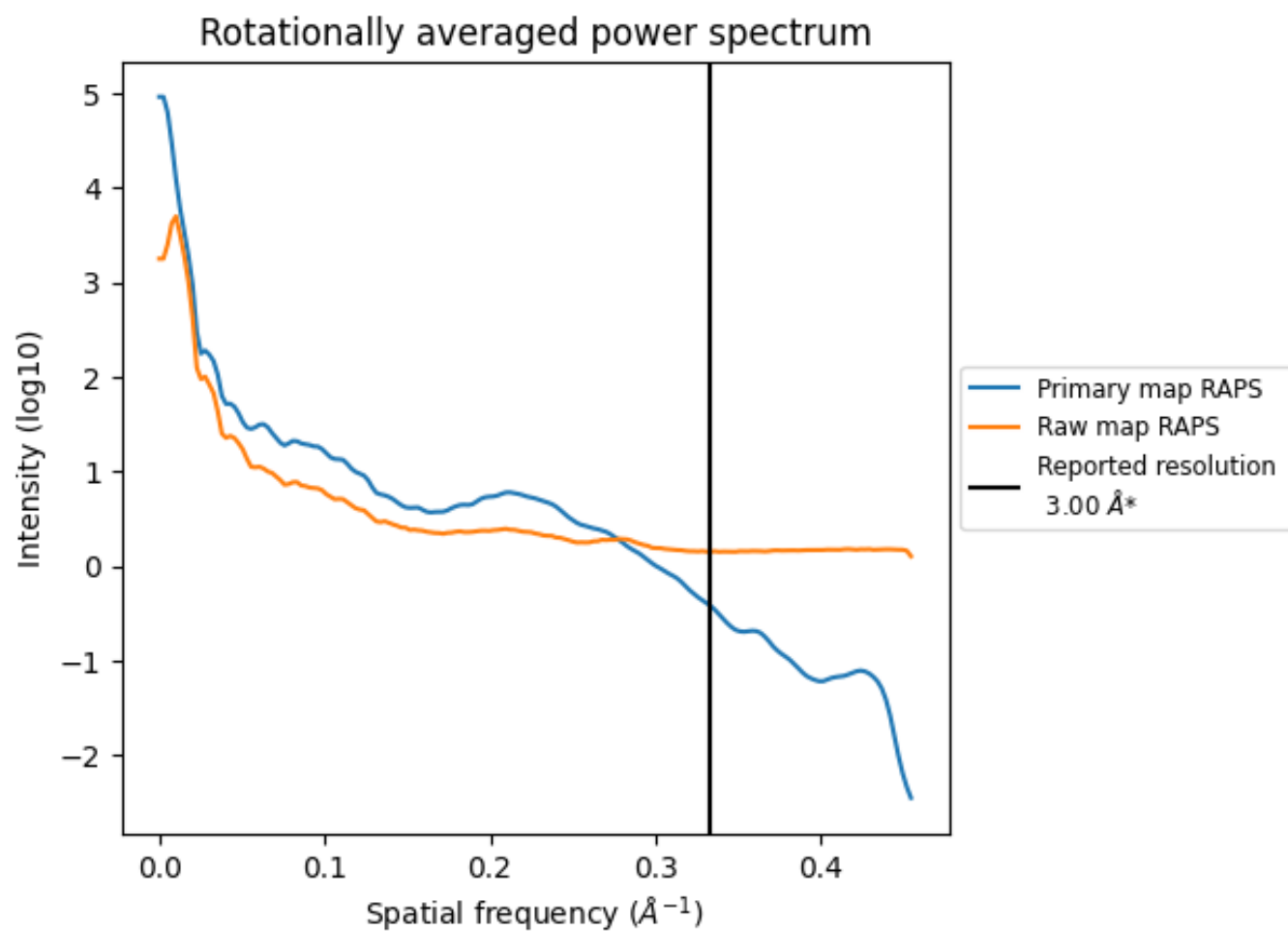

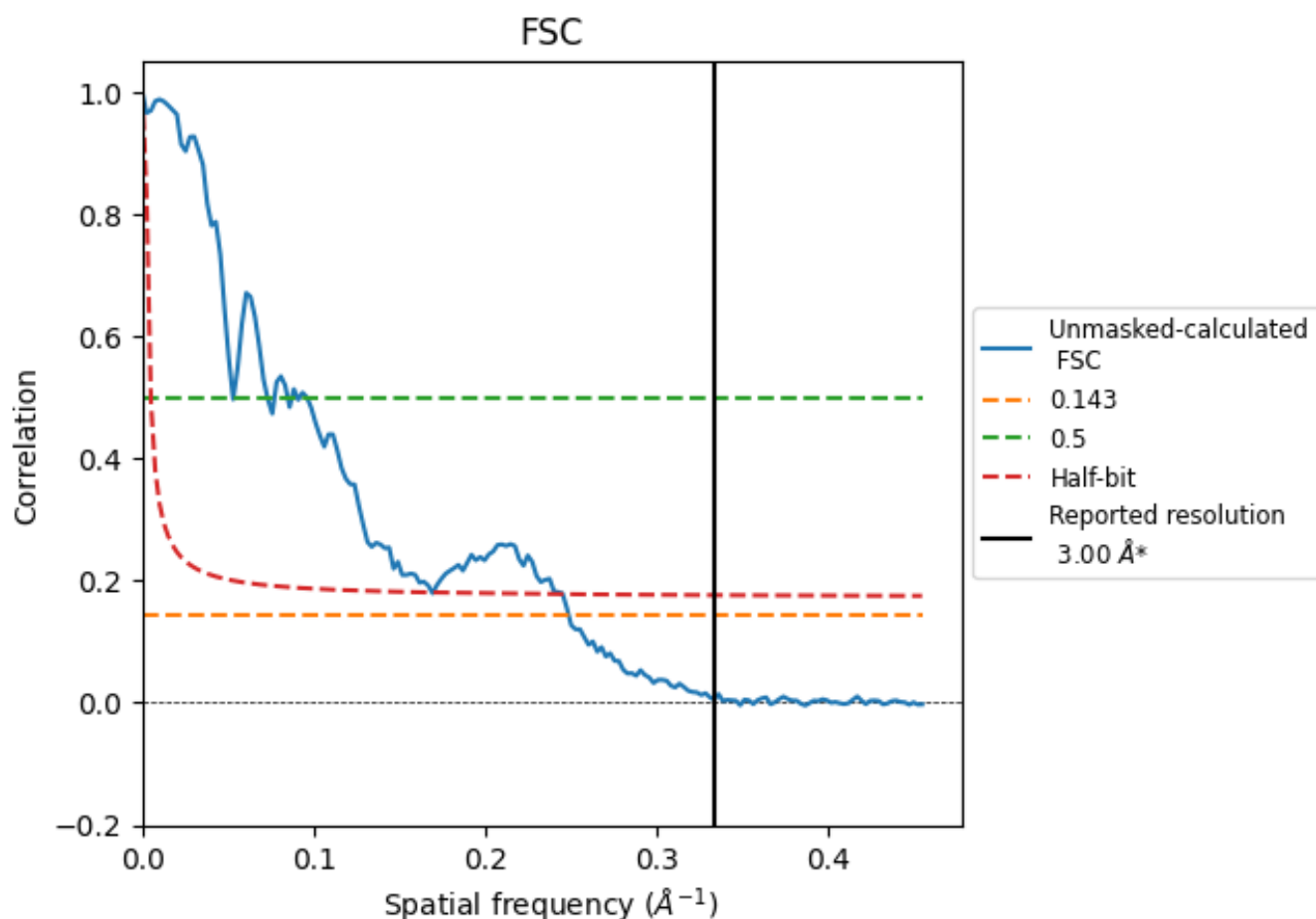

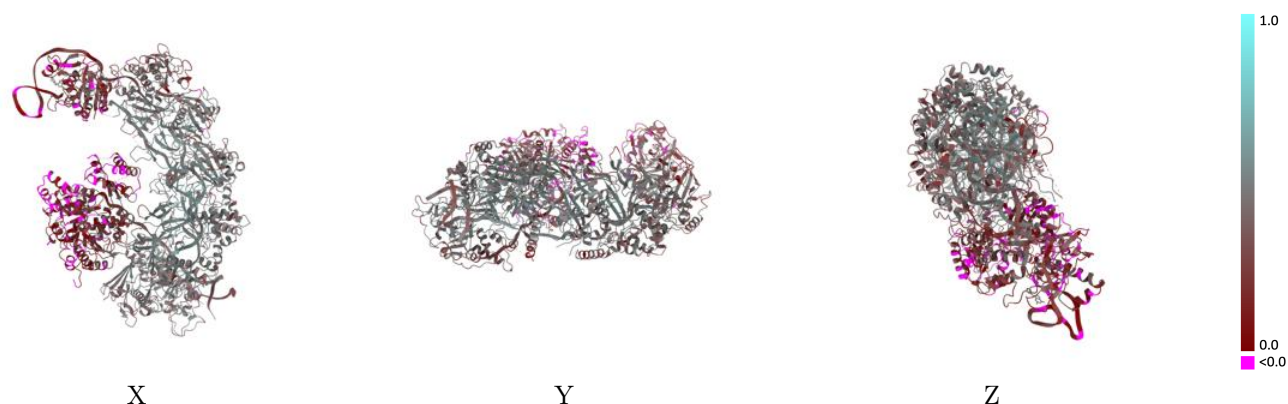

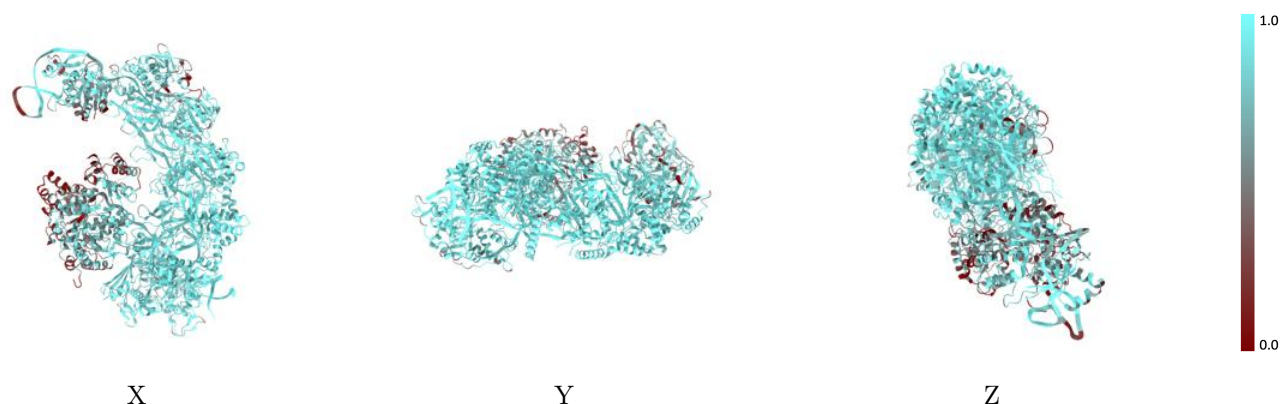

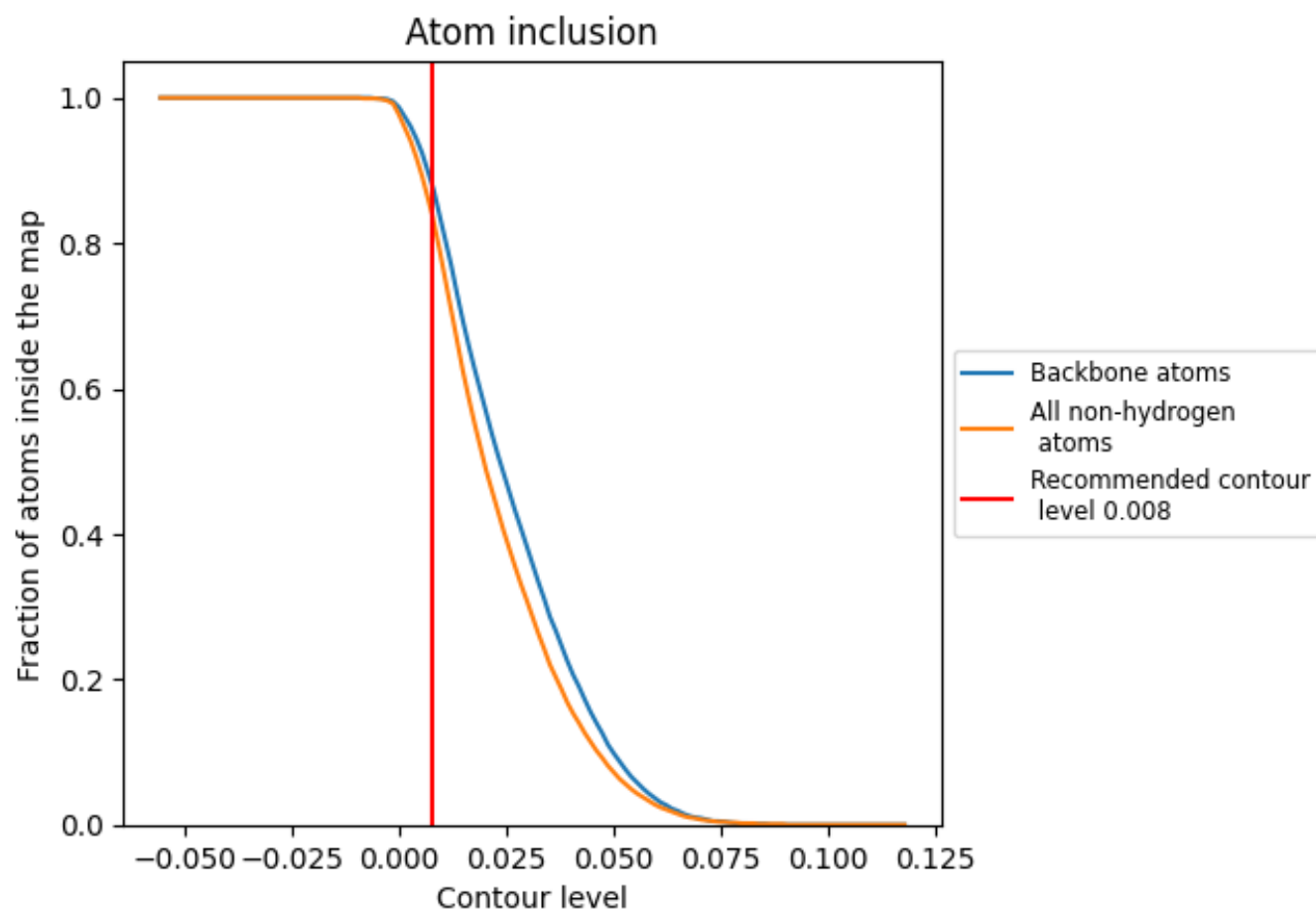
