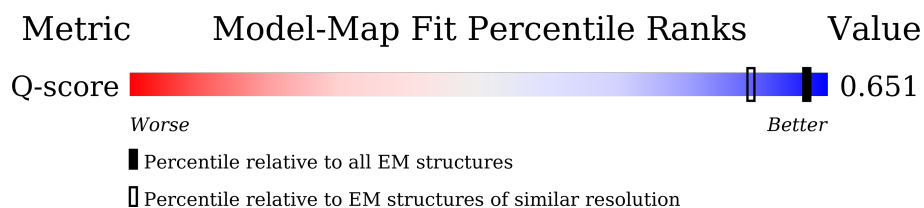
1 Overall quality at a glance

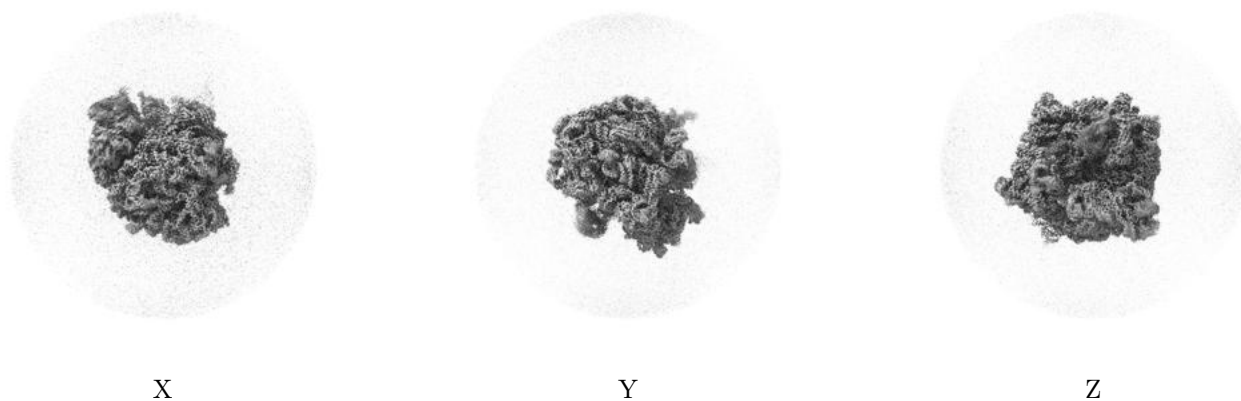

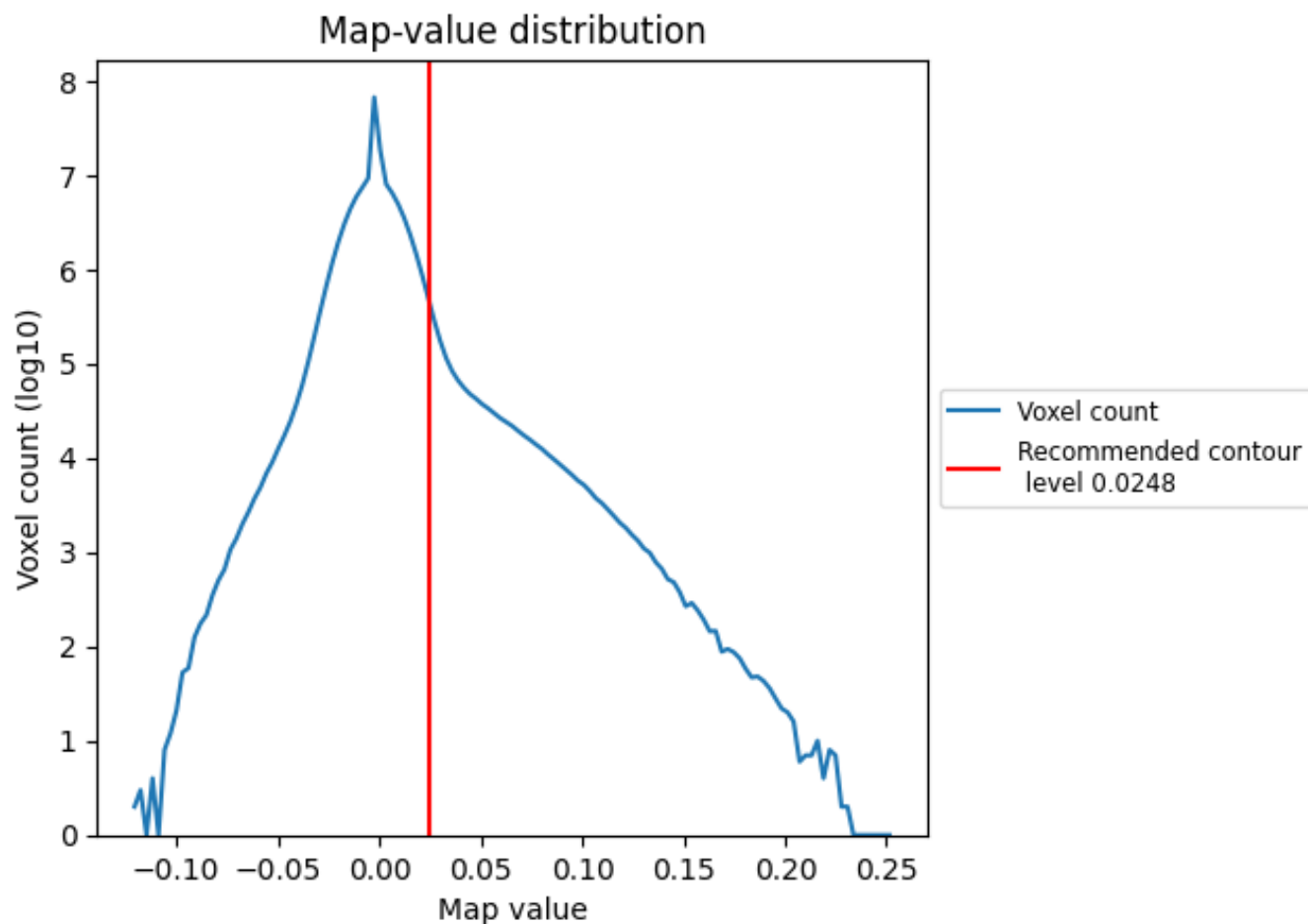

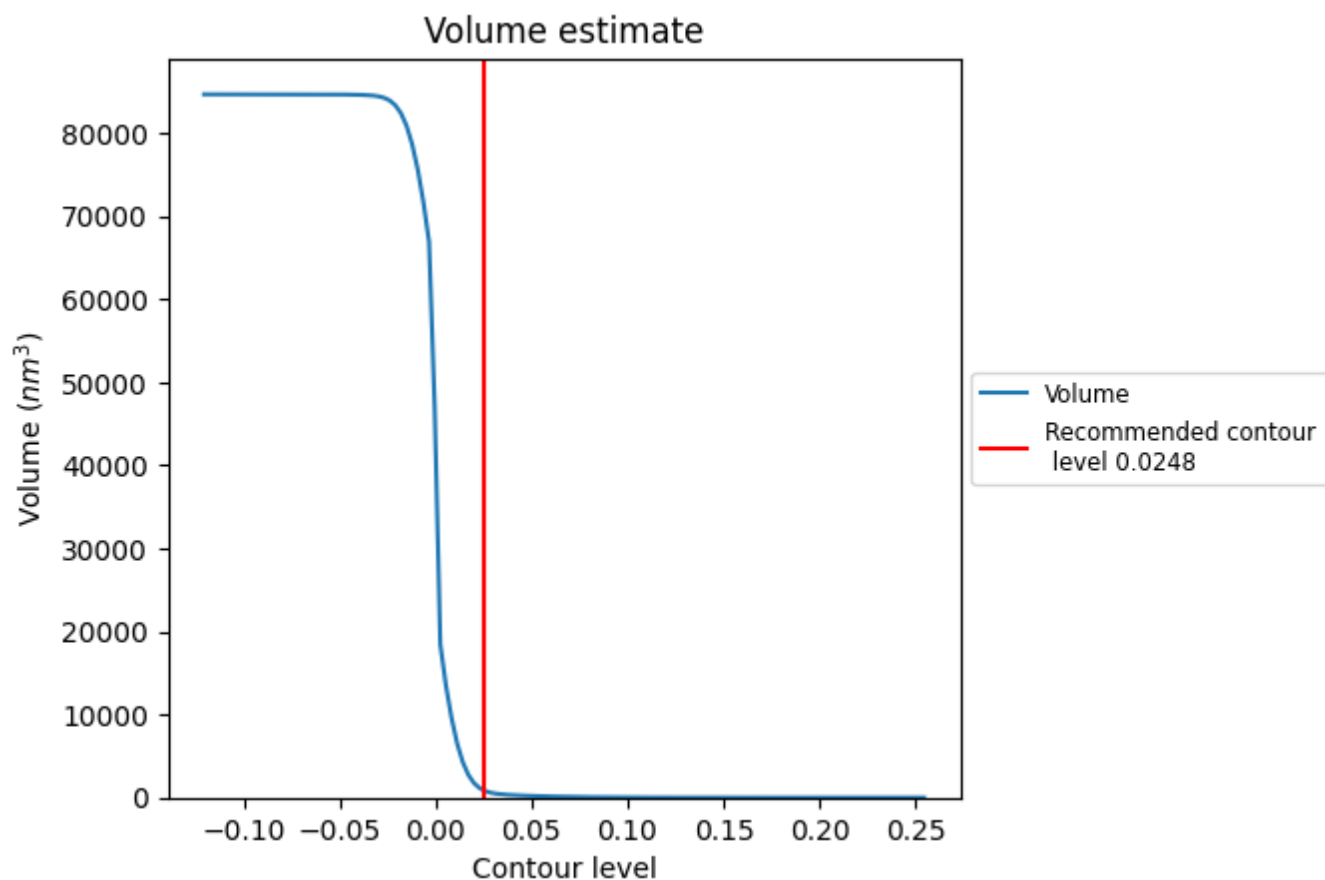

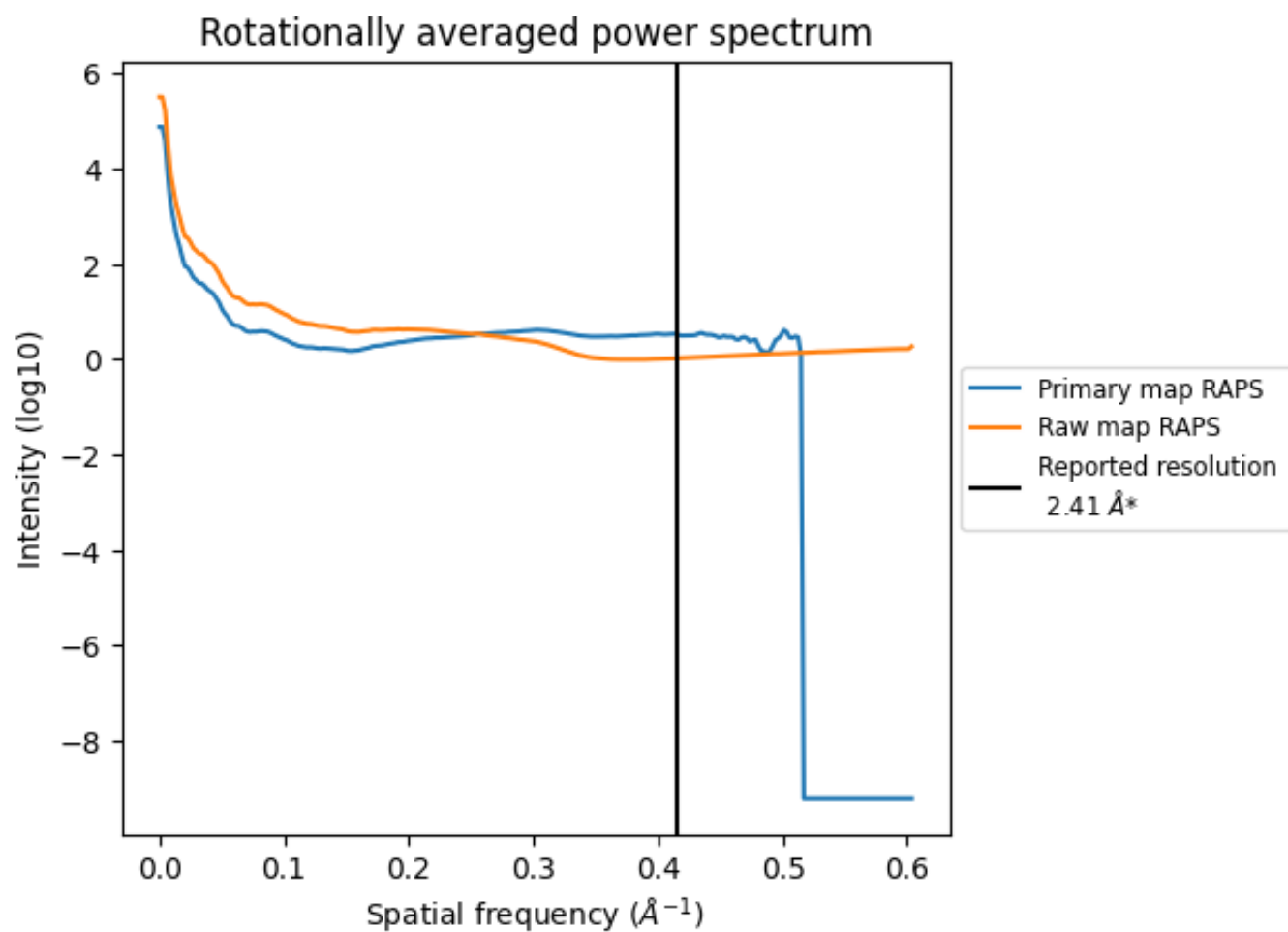

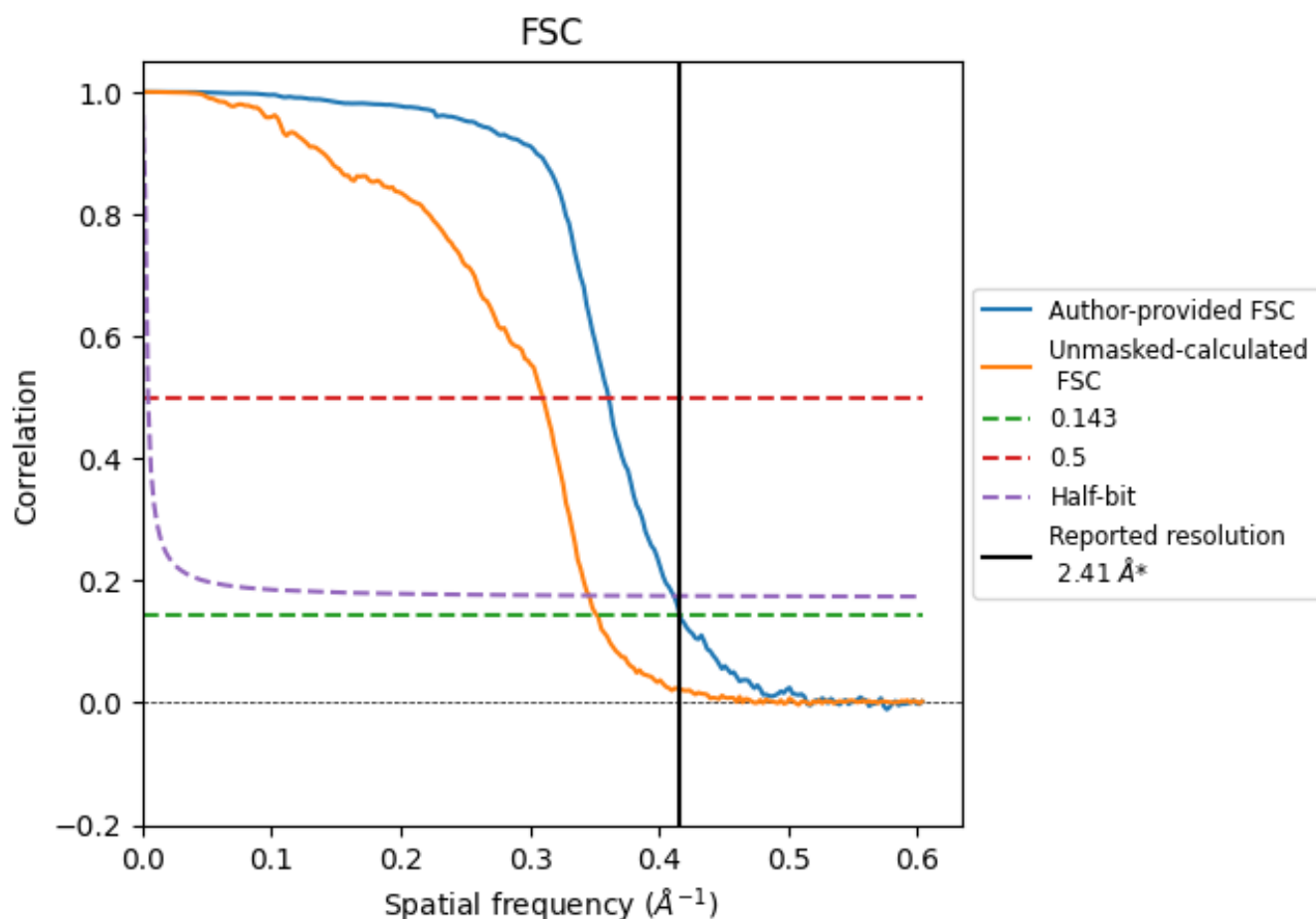

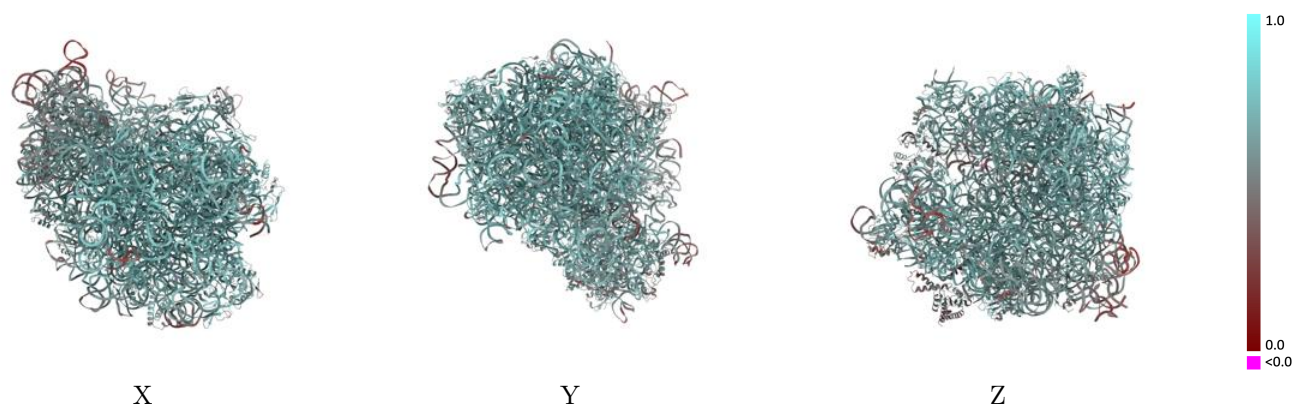

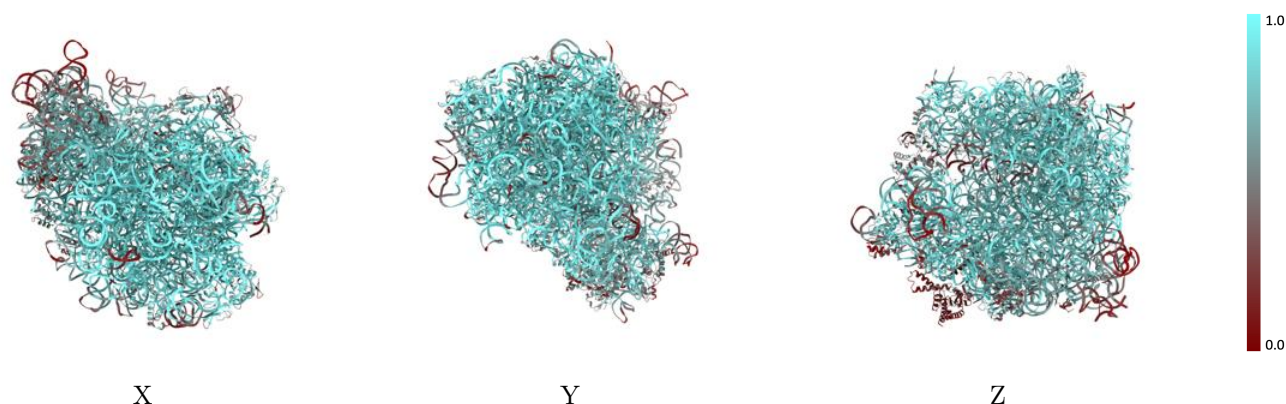

8.2 Q-score mapped to coordinate model [i](#)



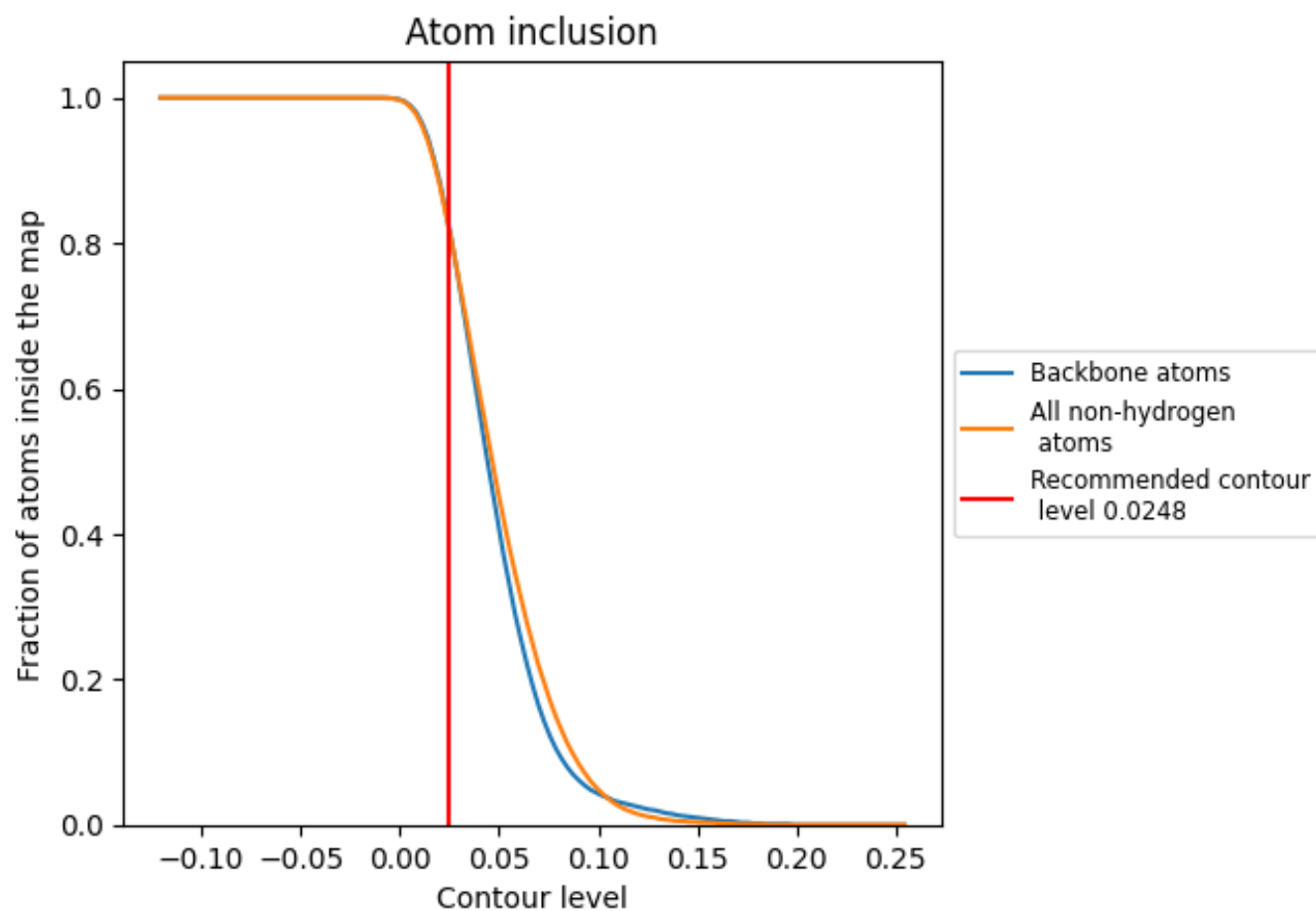
