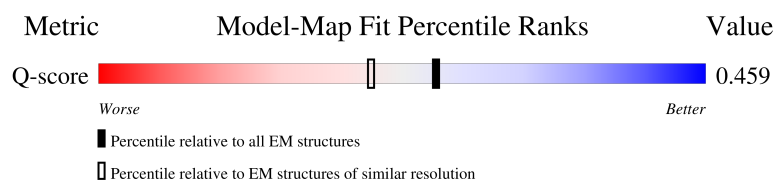
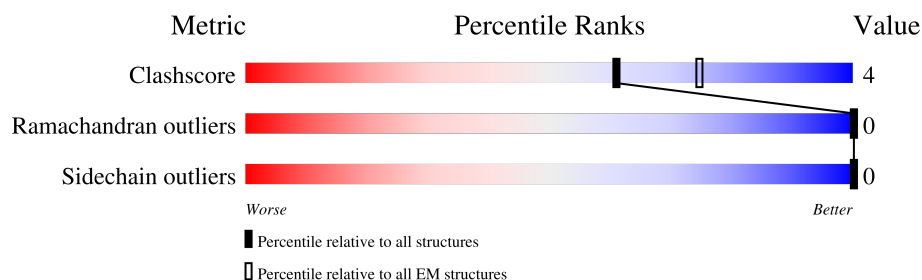
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

*ELECTRON MICROSCOPY*

The reported resolution of this entry is 3.21 Å.

## 2 Entry composition

There are 10 unique types of molecules in this entry. The entry contains 22033 atoms, of which 0 are hydrogens and 0 are deuteriums.

In the tables below, the AltConf column contains the number of residues with at least one atom in alternate conformation and the Trace column contains the number of residues modelled with at most 2 atoms.

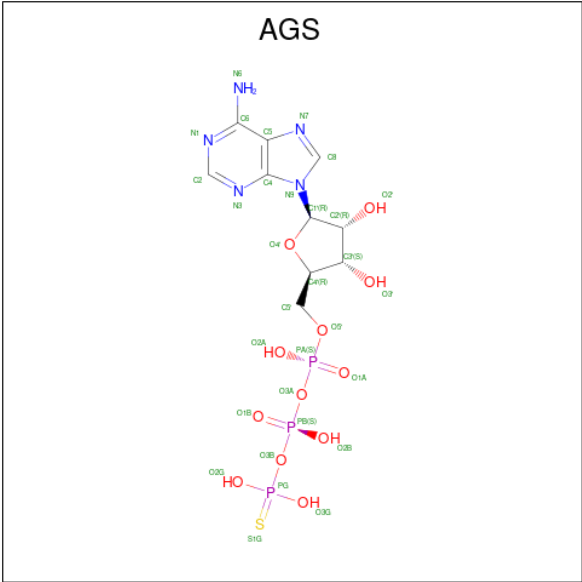

### 4.1 Standard geometry [i](#)

Bond lengths and bond angles in the following residue types are not validated in this section: AGS, MG

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with  $|Z| > 5$  is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

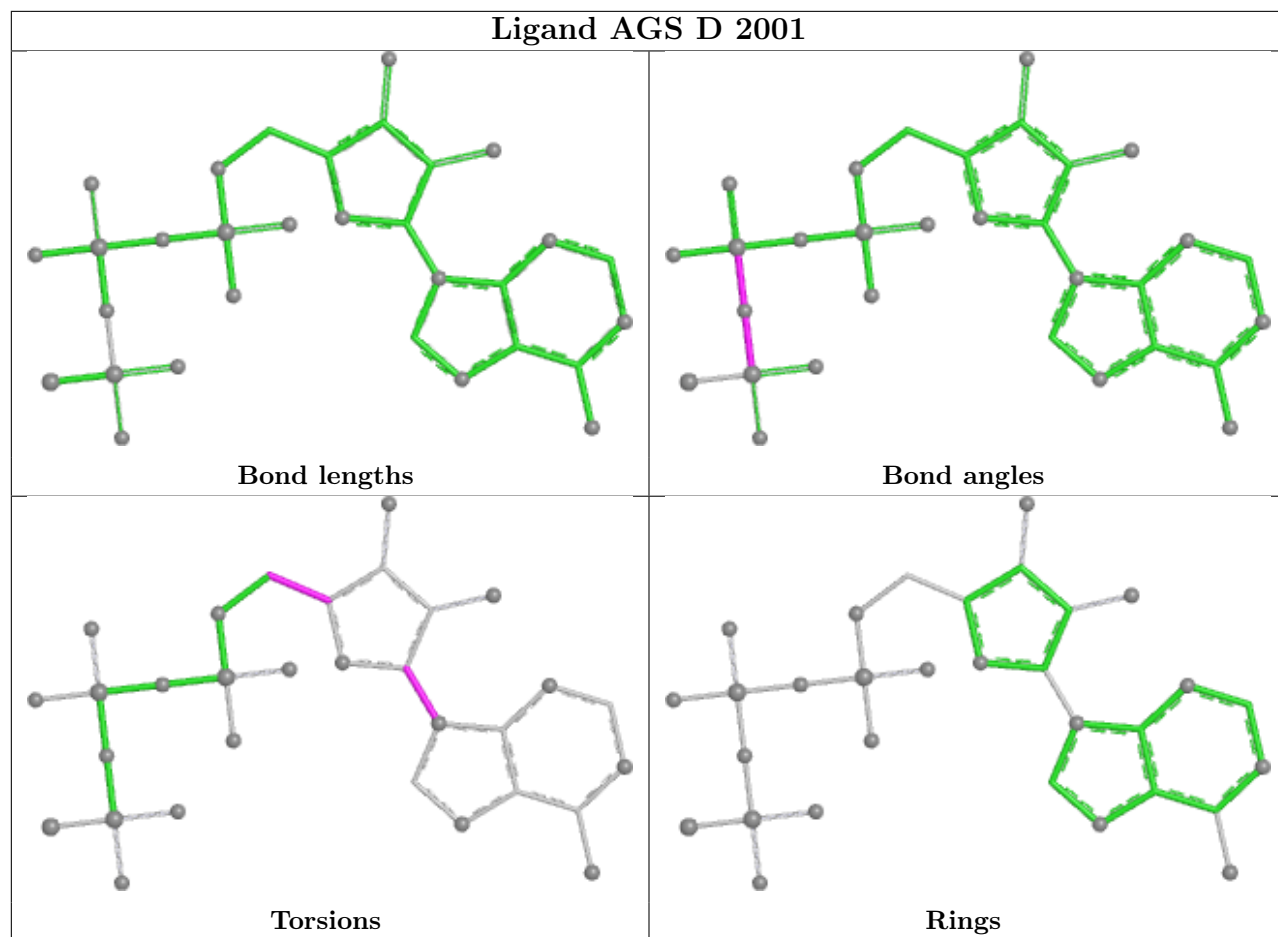

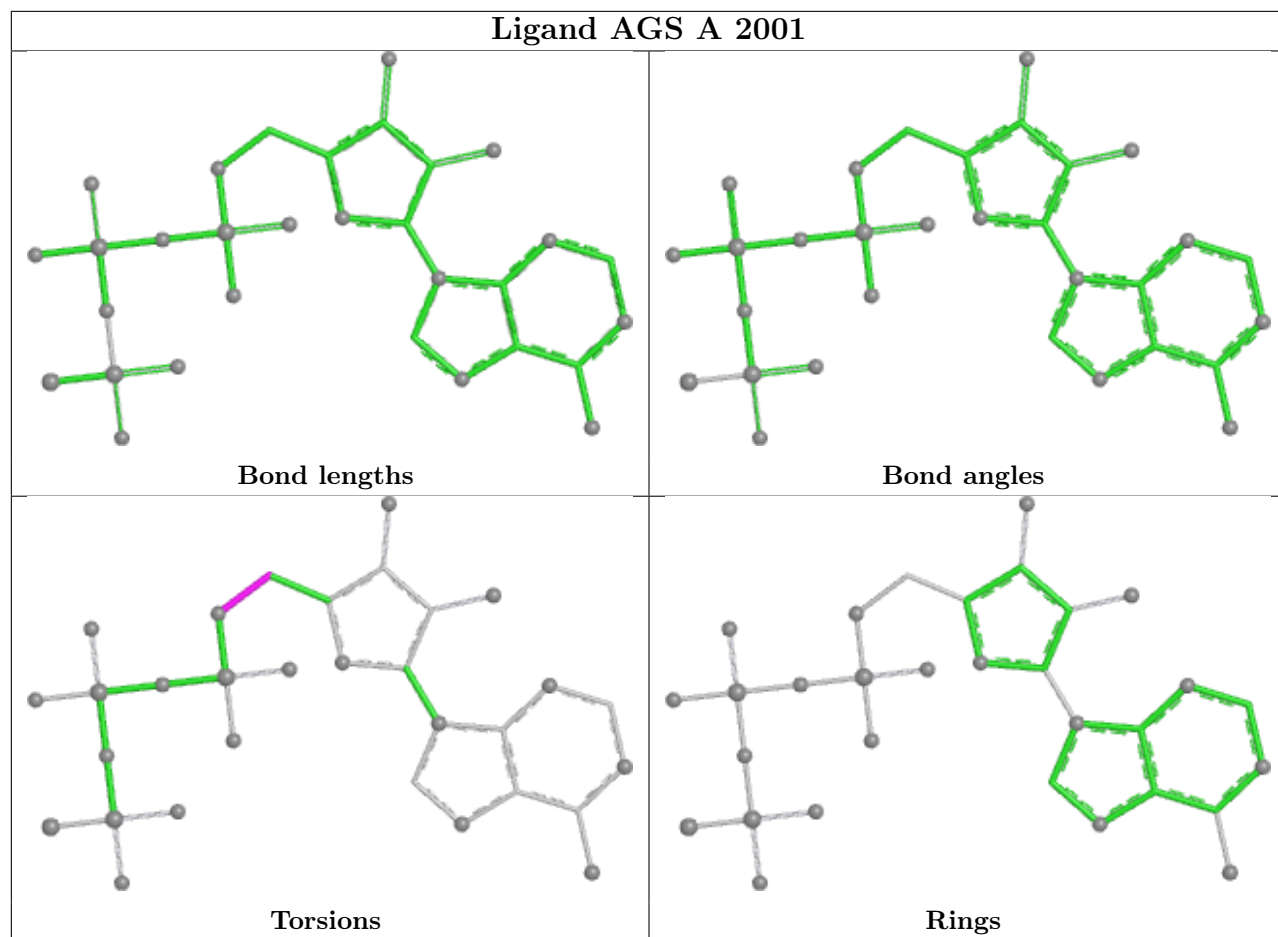

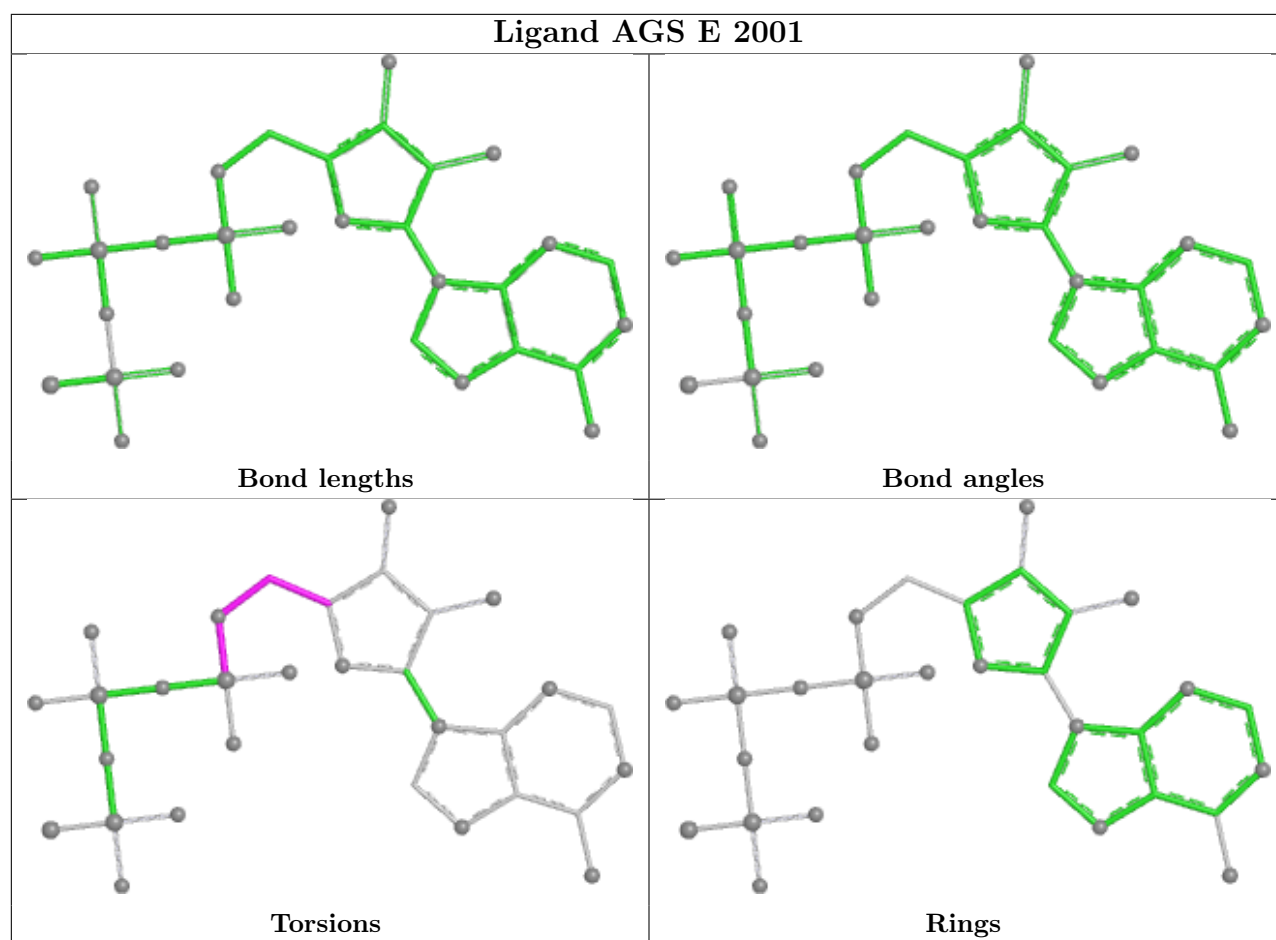

The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for all instances of the Ligand of Interest. The outliers are highlighted in purple. The color gray indicates Mogul did not find sufficient equivalents in the CSD to analyse the geometry.

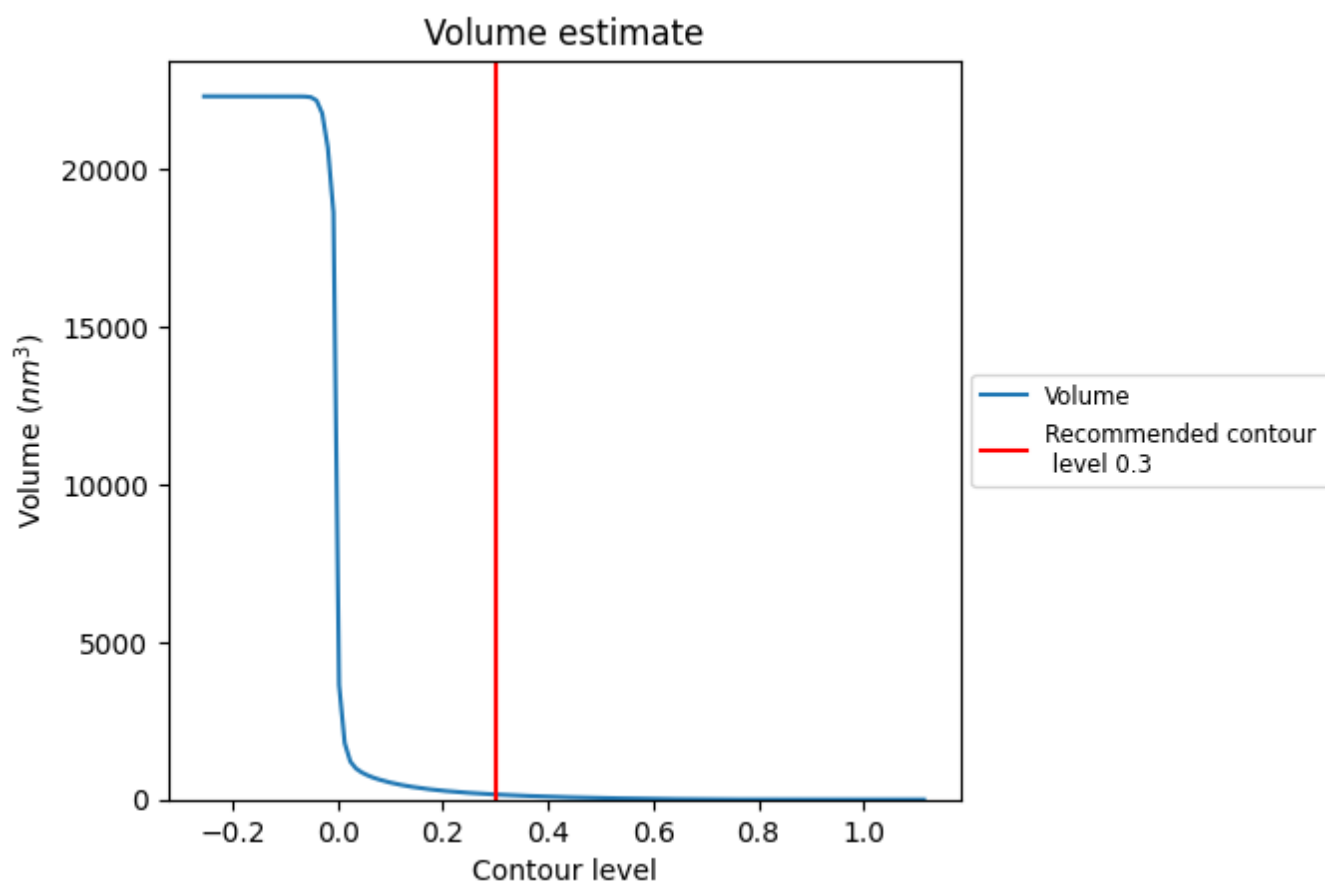

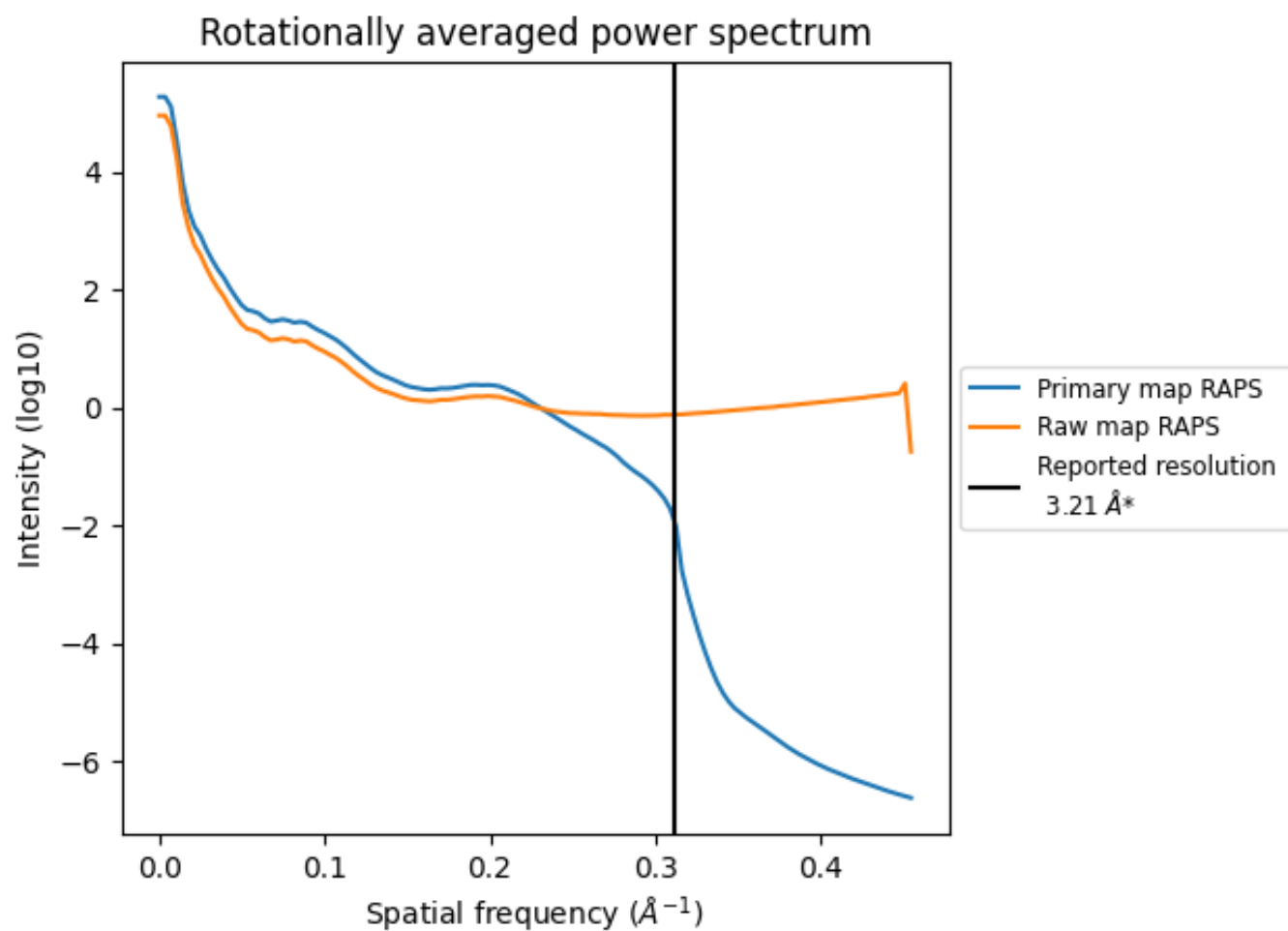

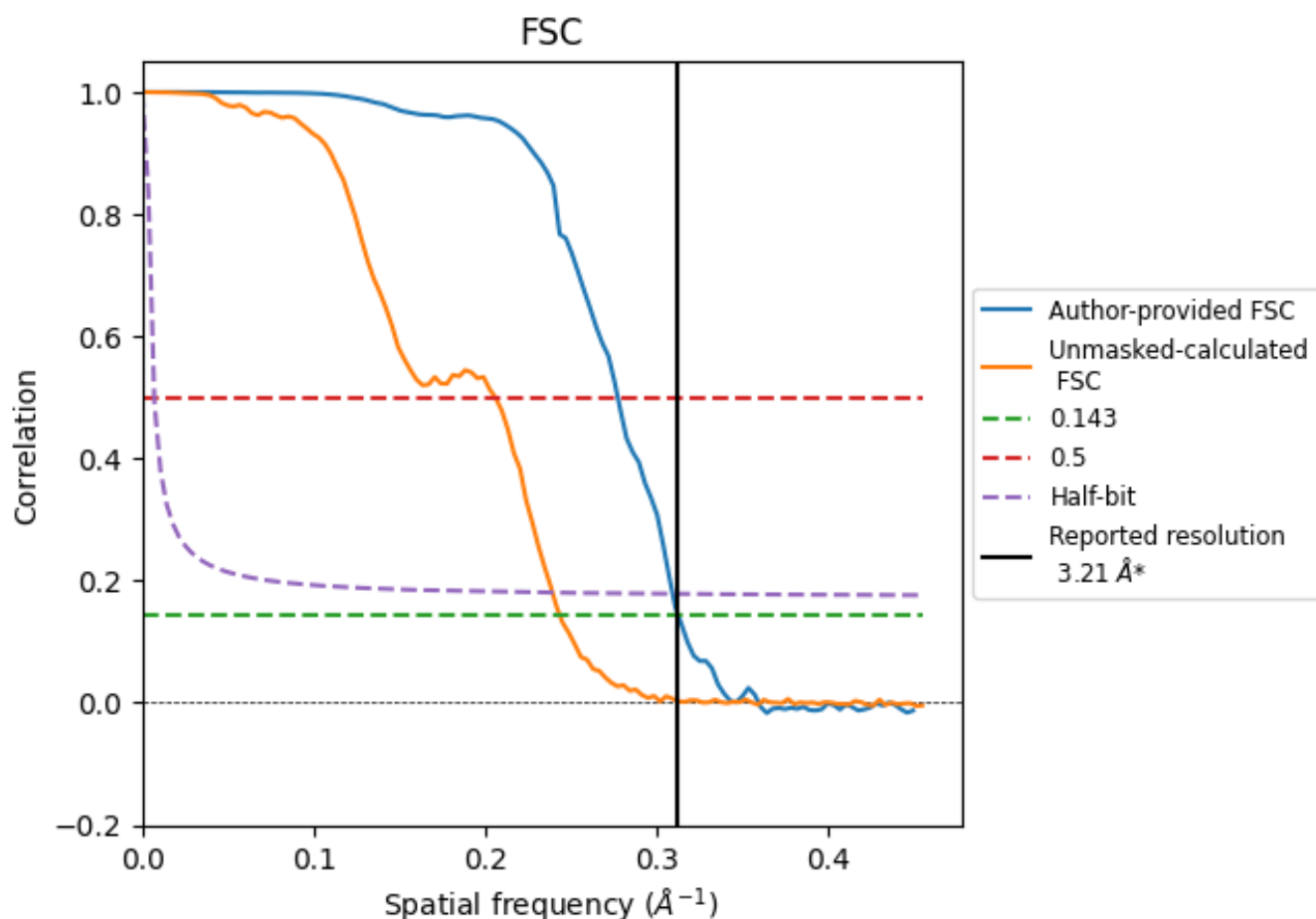

## 7 Fourier-Shell correlation [i](#)

Fourier-Shell Correlation (FSC) is the most commonly used method to estimate the resolution of single-particle and subtomogram-averaged maps. 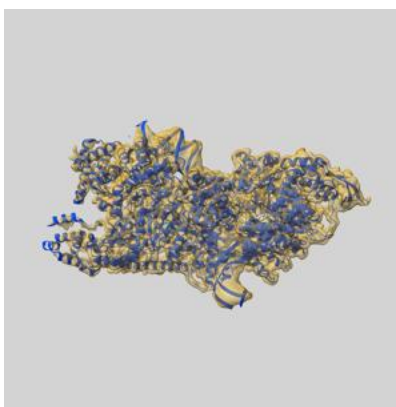

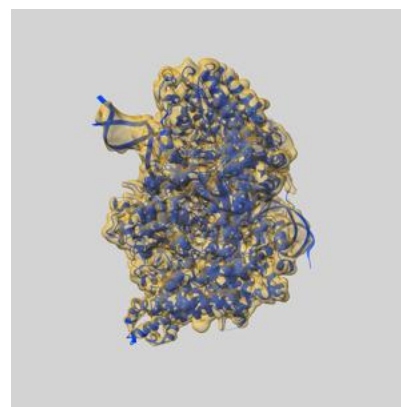

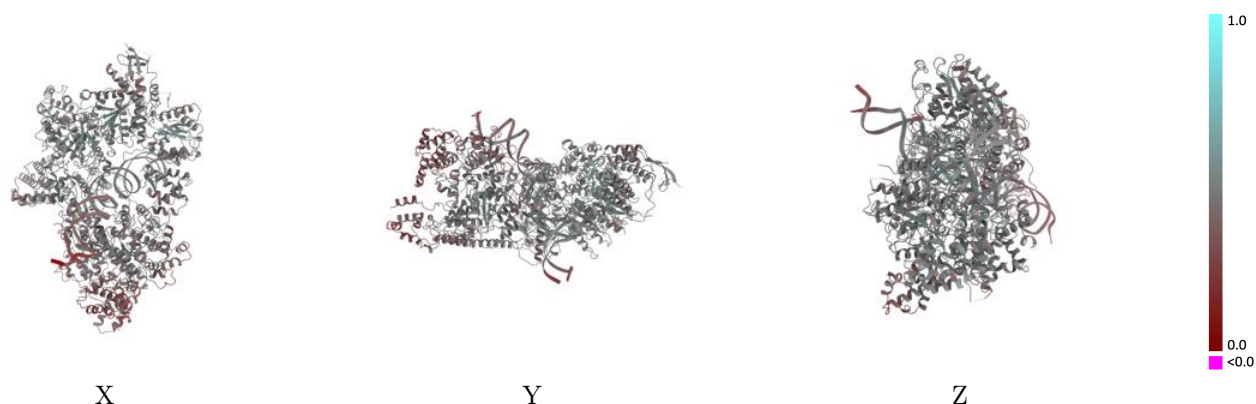

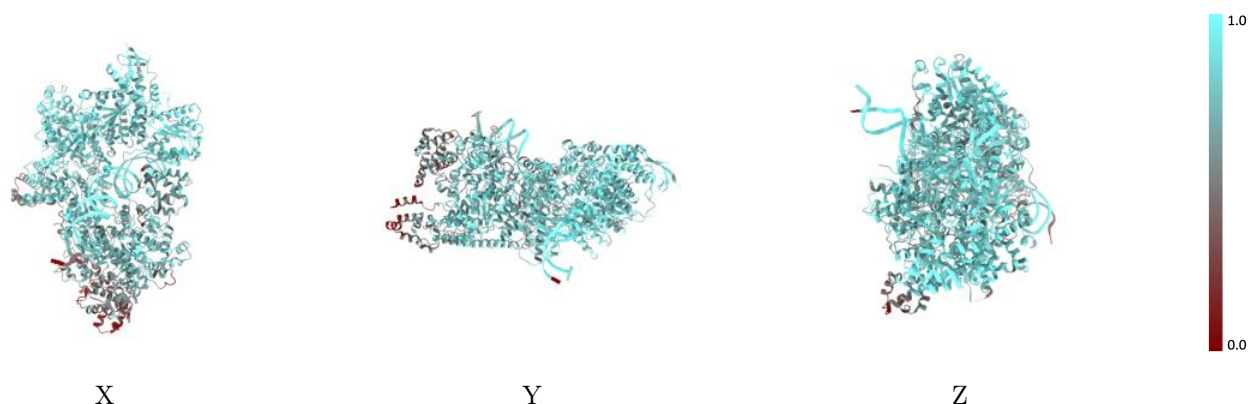
The images above show the 3D surface view of the map at the recommended contour level 0.3 at 50% transparency in yellow overlaid with a ribbon representation of the model coloured in blue. These images allow for the visual assessment of the quality of fit between the atomic model and the map.

## 8.2 Q-score mapped to coordinate model [i](#)



The images above show the model with each residue coloured according to its Q-score. This shows their resolvability in the map with higher Q-score values reflecting better resolvability. Please note: Q-score is calculating the resolvability of atoms, and thus high values are only expected at resolutions at which atoms can be resolved. Low Q-score values may therefore be expected for many entries.

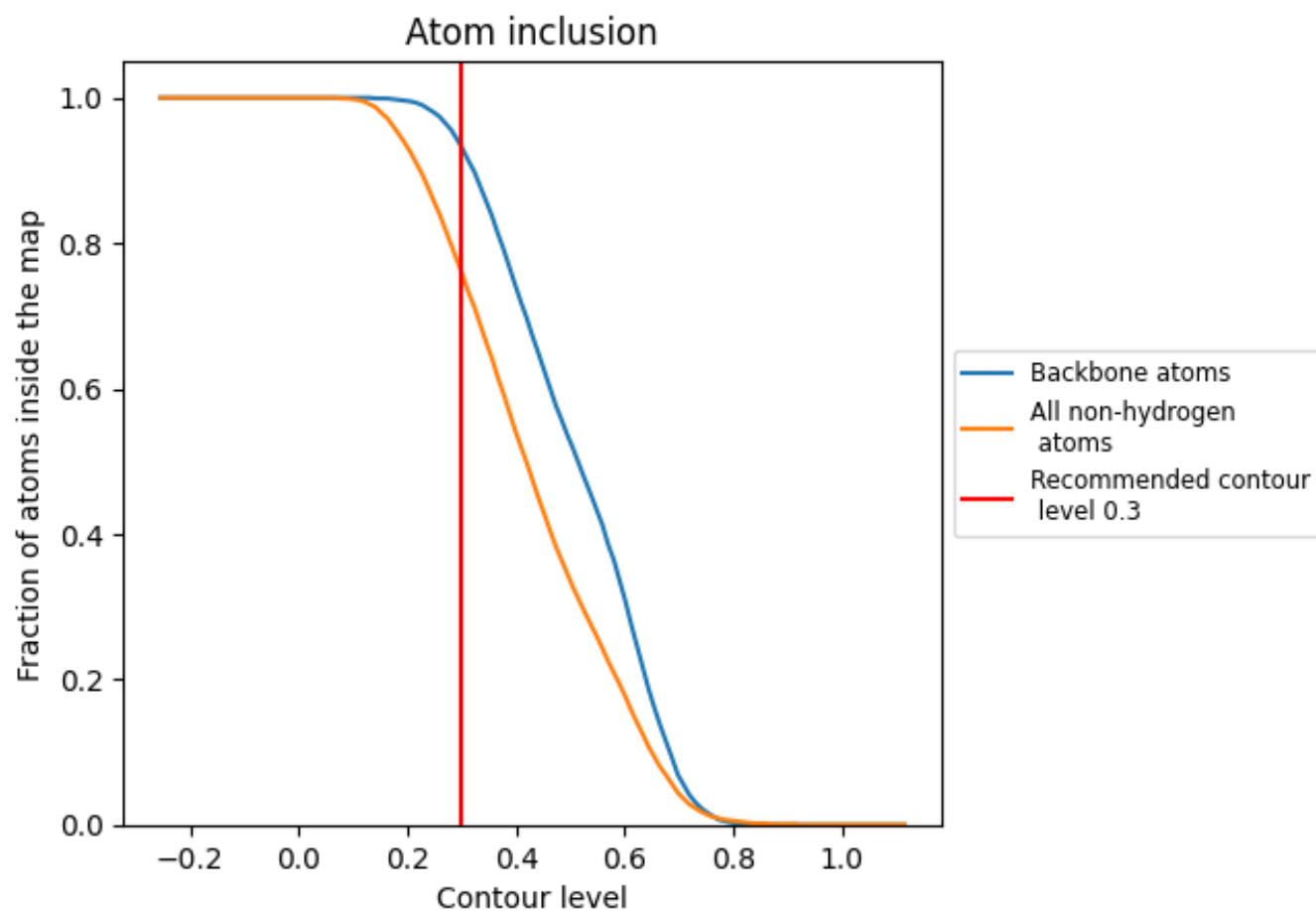
## 8.3 Atom inclusion mapped to coordinate model [i](#)



The images above show the model with each residue coloured according to its atom inclusion. This shows to what extent they are inside the map at the recommended contour level (0.3).



## 8.4 Atom inclusion [i](#)



At the recommended contour level, 93% of all backbone atoms, 76% of all non-hydrogen atoms, are inside the map.
